April 16, 2001 to the Hilo airwaves via KHLO AM 850 6:AM to 10:AM

KAHU AM 1060. The program consists of local chatter, call ins,
police blotter three times every morning, and Walter's own unique
choice of music not heard on other stations.

Sheldon Harvey *** of Greenfield Park, PQ sends along the following: I just heard an announcement on Oldies 990 CKGM in Montreal, pluggin their format change on Monday to The Team. The announcement was at 4:47 PM Eastern

The announcement mentions that "The countdown is on" to Canada's all sports radio network. They also indicate that "On Monday, everything changes".

No word yet on whether there will be any call change. Presumably not, but they will most likely become a non-IDer, most likely with generic "The Team" IDs. There will be a local Montreal morning show on the station, where we would probably hear Team 990 IDs. If you don't have this 50,000 watter logged with their CKGM Oldies 990 IDs, you better try to do it soon. The changeover takes place Monday

morning. I am not sure yet, but I have heard that it may be effective at 7 AM eastern.

Nigel Pimblett of Medicine Hat, AB. sends along the following: CKGY 1170 khz, Red Deer, Alberta made the official switch to FM this morning at 7:30 local time. Until 7:30 they had been relaying the AM on 95.5 MHz during a 3 week test period. Now the reverse is true, with the AM relaying the FM. That will likely be the case for about 3 months, until the AM is turned off. Unlike some of the switches to FM we've seen, this move doesn't involve a format or call change.

At the switchover time they ran a short feature on the station's 28 year history, including a few words from the original owner, and also the mayor.

Now IDs are generally "KG Country 95-5", though they still give the CKGY call letters at times.

Signal change could improve classical radio sound Tests under way at 1660-AM

Radio lovers may have noticed a "new" classical station way up at the high end of the AM dial. It's not exactly a station, at least not yet. It's KXTR-AM (1250)'s possible future location at 1660-AM, a more powerful alternative. The new frequency is now being tested, sans advertising, for a few hours each day. The new position might mean clearer sound. "It is our intention to put KXTR on 1660," said Bob Zuroweste of Entercom, the broadcast giant that bought KKTR-FM (96.5) last year and moved the powerful classical station to AM. "Our goal is June 1. As a matter of fact, it could be earlier." Entercom must wait for the FCC to license the new station after field tests have indicated its full range and cleared it of potential interferences with other stations. Those in Johnson County are already reporting a better reception than 1250 provides. For now, 1660 is sending the same feed from Boston that fills KXTR's broadcast hours when 1250 is not occupied with local programming. Though some music lovers might not find it within themselves to say "thanks" to Entercom, which in September killed one of the nation's most powerful FM classical stations, it's at least a step in the right direction. Patrick Neas, whose drive-time Morning Show has calmed many a case of caffeine-induced morning jitters, remains one of the nicest things about Kansas City's musical life. For Neas, the new frequency is a sign that things are not as gloomy as we all assumed last fall. "It shows that Entercom is committed to the format and that moving us to AM wasn't just the first step to killing us altogether," he said. The new nondirectional broadcast means you don't have to be directly in the path of the "wave" to get a good signal. "This station will radiate in all directions," Neas said. "With this move, a bigger swath of the city will be covered." Because 1660 lies in a little-occupied part of the AM band, the station can get better coverage with about the same amount of power. There's a financial end to it all, too, Neas said. "It means also it'll be more attractive to advertisers." Zuroweste emphasized that the move was to provide "enhanced coverage and enhanced quality" for classical listeners - and particularly for those in Johnson County, where the 1250 signal has proved especially weak. "This is a

commitment to serve the community," he said, adding that the switch will cost Entercom at least \$200,000 and probably much more.

Pat Martin of Seaside, OR. passes on the following:

Apparently CHWK (1270 Chilliwack, BC.-ye ed.) is indeed CKSR according to the CRTC in Ottawa on 1270 and CKMA-850 is also CFSR. I don't know why the CE QSL'd my report as CHWK.

Sheldon Harvey *** (locale unknown) sends along the following:
OK, now I have more information on this CHUM sports radio network
called The Team.

Here are the stations I know for sure which are going to become part of The Team network on Monday, May 7th.

CHUM 1050 Toronto ON

CKLC 1380 Kingston ON

CFGO 1200 Ottawa ON

CKPT 1420 Peterborough ON

CKKW 1090 Kitchener ON

CJCH 920 Halifax NS CKGM 990 Montreal QC

There are supposedly two other stations, one in Winnipeg, MB and one in Vancouver, BC, which are also part of the network, but I am not sure at this point which ones they are. They may actually be FM stations from what I have been reading. (CFAC-960 AB. and CKST-1040 BC. Now on net-ye ed.)

Pat Martin of Seaside, OR. adds to the above:

CKST is sure promoting after every 2 or 3rd song. Apparently CFAC-960 is also going to be on the CHUM Sports Net. Some station in Winnipeg, but I don't know which one on AM or FM there.

Anyway I checked them and they are indeed all Sports talk "AM 1040 Vancouver's The Team" IDs. I will try TOH, but don't be surprised if they do not give a call letter ID. Canadians are getting terrible about giving call letter IDs.

At 1 PM there was no ID, just a promo for "The Sporting News" (10n1 Sports), apparently they run, Many 1040-Vancouver IDs along the way. That is the way most Vancouver area stations are going, no legal IDs. I got a letter from Dan Sys and he said the same thing.

Deane D. McIntyre *** of Calgary, AB. adds to the above: CFAC-960 Calgary is also "The Team" now, also changing at 1500 EDT 5/7. No legal ID heard yet.

Mike Brooker of Toronto, ON. adds to the above:

At 1500 EDT/2000 UTC today, CHUM became Team-1050 along with Team 990 (Montreal), Team 1200 (Ottawa) and the other Team stations across Canada. Their last hours as CHUM, before the switchover, consisted of former jocks Bob Laine and Duff Roman sharing memories, interviewing former CHUM personalities, and playing oldies. Also played carts of many old jingles and promos. There was actually more talk than mx. The last song to air on CHUM, a few minutes before 1500 EDT, was the song that was #1 on the CHUM chart when they went Top-40 in 1957: Elvis Presley's "All Shook Up".

Call letters, and legal IDs? To quote Toronto Raptors play-byplay man Chuck Swirsky, "ARE YOU KIDDING ME????"

This has been quite an eventful year in the Toronto market thus far. Three new stations have hit the air: Prime Time-740 (MoYL/nostalgia), Joy-1250 (REL), and Flow-93.5 (urban/R&B); and there have been two major format changes: Team-1050 and testosterone-laden MOJO-640.

Ye editor adds the following:

Per calls to both CFAC-960 and CKST-1040 on 5/8, both are still these sets of call letters, and neither has any plans to change call letters in the near future despite format change to Sports. CFAC mentioned their calls are 'legendary' in the Calgary market...

Pat Martin adds to my comment above:

There has not been any mention on a call change on either station on any of the lists and there are regular dxers from Canada that report CRTC info. I heard the same IDs here.

Pete Taylor *** of Tacoma, WA. sends along the following:

An article in Sunday's Post-Intelligencer noted that KKMO-1360 will be carrying Spanish language programming from 3-6PM PLT as of this past Monday 4/30 on an "experimental basis." Otherwise, the station remains totally a relay for KGNW-820 and KLFE-1590. It has carried some local high school sports in the past but has cancelled that.

Hispanic programming has bounced around in this area. As KZTS, the calls between the two KKMO assignments, the station tried full time Spanish programming for less than a year a couple of years back. Some Spanish programming has been heard on KZIZ-1560 from 3PM PLT to local sunset when DST is in effect. It also seems to pop up on KNTB-1480/KBRO-1490 from time to time.

KXPA-1540 still has some non-conforming brokered programming on Sunday (and maybe at other times, who knows) but other than these, is fulltime Spanish. It no longer relays KSUH-1450's Korean programming 10FM-6AM PLT. The owner of KSUH, Jean Suh, moved the studios from an office space into a private residence and the city of Federal Way, where the station is actually located (not Puyallup), was not pleased. There was talk of forcing the station off the air, but the city relented and gave them until August to get new studios. It is a well run tight operation and tries to do a good job covering the Korean population (mostly Federal Way and Lakewood). I believe the money crunch made it impossible for them to continue buying the KXPA air time. KSUH does get into English language pops occasionally, but more often than not, you'll hear coverups in Korean. Jean Suh used to be on the air on KBS.

John Sampson *** (locale unknown) sends along the following:
While driving back to Arizona from two weeks dog sitting in San
Francisco yesterday, we passed through Laughlin, Nevada. About 25
miles northwest of Laughlin, in Searchlight, I could hear a fairly
weak SS on 870 and figured it was KLSQ. However, when we were in
Laughlin, itself, (for as short a time as possible, which any of
you who have visited there might understand), there was nothing
audible on 870. I'm guessing that what I heard in Searchlight was
KLSQ from Las Vegas and that they've turned the SK transmitter in
Laughlin off. I didn't have any time to pursue this and am
wondering if anyone on this list knows more about this situation.
Have been trying to verify this station for several years, too,
without success

David Gleason *** (locale unknown) adds to the above:

I know that HBC applied to turn off Laughlin (KLSQ-870-ye ed.) ast
year. I'll check with our corporate CE Monday and find out for sure.

Bob Galerstein *** of Maywood, NJ. passes along the following: While driving in Newburgh, NY, Friday during the day, there was no sign of WGNY-1220. So, SILENT, for now. Pat Griffith *** of Westminster, CO. passes on the following:

I talked to Cris from Crawford Broadcasting engineering today. He reports that the 560/1220 (KLZ/KLVZ Denver, CO-ye ed.) frequency swap on May 21st is planned to occur at 0500 MST. (MDT?-ye ed.)

After the swap 1220 with the Legends format will also be simulcast on KCMN/1530 in Colorado Springs during mid-day and afternoon drive. They are also seeking a power increase for 1220. (I'll be in Colorado Springs 5/21-5/24, will check this out!-ye ed.)

The days are getting longer, and we're getting rolling blackouts in California as the days heat up! Hope my radio stays powered up for all that good DX still sitting out there, hi. 73's.

Ye editor adds the following:

Noted at 1100 5/17 KUET 710 Black Canyon City, running OC tests. Pretty good sized signal in Mesa. S9 +20. Its running 22 kW right now. Looks like another freq for DXing goes by the wayside since at night its supposed to run 7.5 kW. Its not a total blowtorch but its gonna be pretty close to it.

The male ancr listed 4 stations, all with freqs, some with powers (XEAI-1470, XEZ-600, XEIZ-1240, XEBON-1280). Ancr closes out the network ID by saying that they are broadcasting from "Cuidad de Mexico, Colonia Trinidad." Note that there is no mention of 740. I might note that the IRCA Log listing of Radio Fortula station on 740 in Los Mochis, Sin. in not listed on the current website. (JB-OK)
- MEXICO, Cancun, QR, XECAQ 4/13 1100. I reported this one as a strong presumed logging recently. The Radio Formula website revelrf that, unlike the other stations of Radio Fortula's three AM Networks, XECAQ produces about 20% of its own programming. In reviewing my recordings of Radio Fortula stations, the s/on pattern of XECAQ is unique to it and they use the slogan "Radio Formula, Cadena Nacional." (JB-OK)

I was fortunate to DX from Grayland, WA last 17 and 18 March, using a 1000' Beverage antenna, and as we were set up in the Grayland Motel, I was also able to run a signal strength recording package based on my NRD-525 receiver and a PC. As a result, I recorded a fine post-sunrise enhancement in signal strength which we heard on many East Asian signals; when I say post-sunrise we are talking about signals which peaked at 1546 UTC, 75 minutes after local sunrise at Grayland. If you turn your web browser to http://www3.telus.net/7dxr/ircatech/postsunrise.pdf, you will see a graph of the reception of HLAZ-1566, displaying what I believe was true signal strength at the receiver antenna terminal as well as the signal to noise ratio of HLAZ vs. local splatter and electrical noise. This signal strength graph is confused by the fact that HLAZ uses a directional antenna towards Japan (and Grayland) from 1230-1345 UTC which explains the signal enhancement during that period. A different directional antenna is used at 1630 UTC, so there is a signal increase at that time also. Post sunrise enhancement may not be that uncommon on the Pacific coast, at least around the equinoxes, but I'm normally not able to record signal strengths from there. Recently, however, I was able to put a recording system in a house on the beach south of Tofino, BC, so I'm hoping I'll have six weeks of data from there by early June when I will retrieve the unit. The morning that I set it up (April 12) looked promising; the second graph on the web site is of 4QD-1548, also showing a signal enhancement peaking at 1452 UTC, about 70 minutes after local sunrise there. It seems that true signal strength is greater before sunrise, but there is still a surprisingly good signal which returns after sunrise, and with the lower noise levels at that time, the DXer may be surprised at how readable such signals can be. If there are any questions or comments about this, I'd be pleased to address them. In the meantime, hope that you have good late spring DXing.

We all have heard the hype on the Art Bell show "Coast to Coast" and the Rush Limbaugh program about the "Best AM radio ever", the CCRadio. If you go to www.ccrane.com, heres what they say. "Never before has a radio been specifically designed for talk radio, news, sports and weather. Twenty years of dreaming, planning and engineering went into the development of this radio. Audio has been specifically tailored for the human voice."

The claims of "The Most Powerful AM / FM Radio Ever Made" and "Hear Radio How It Was Meant To Be" are now gone from the site where they were once prominently shown.

This is a very good radio for a casual listener and not a serious DXer. Anyone who expects otherwise is going to be sadly mistaken. I would classify this radio as one that is a fair to good radio that can do some nice domestic DXing. If you purchase it with that in mind, then you will not be disappointed.

Let me describe the radio to you. The CCRadio is smaller than the GE Superadio III. It is 11"W x 6.5"H x 4"D. There is a very large LCD display with large numerics shown on the screen. It is even easy for my 45 year old eyes to make out with bifocals. The radio weighs about 4 lbs. without batteries.

There are treble and bass controls, an up or down tuning button which moves the frequency 10 kHz on AM, light switch, band selector, clock / frequency display and a sleep timer button on the front. On the side there is a very large dial which tunes in 1 kHz steps, a lock switch, volume pot and jack that will accommodate stereo headphones although there is no AM, FM or TV stereo on this unit.

On the top of the set there is an alarm button and a button that sets the weather alert for when the alert tone is set by the NWS in case of an emergency. Across the set are five large round buttons marked one through five. Each band has 5 memory settings. On the end of the top above the LCD there is the power switch. And near the alarm button there is the FM / TV / WX telescoping antenna which seems to be rather short at about 20 inches.

The radio is carried by a handgrab recess in the back and this is rather unfortunate. This radio desperately needed to have a handle. When you pick the radio up via the hand access your thumb or heel of your hand rests on the control buttons on the top and changes frequencies, sets alarms, turns off the radio or turns off the weather emergency alert.

The CCRadio I purchased was the model with the DC charging circuit and the LED light. These jacks are found on the back along with external AM antenna connections. The AM antenna connections are virtually useless and I would not attempt to attach any antenna to it as there is very little to be gained by doing this as the ferrite antenna in the unit can not be disabled.

The LED light which is an option, is very bright and the light exceptionally white. The light has no consideration for turning it on and off while connected to the radio. Either the light is plugged in and running or unplugged and off. I find that for a light that is \$39, this is a extremely glaring omission.

The DC charging circuit which also is optional, can either be used with a 6v wall wart or a solar panel. I do not have the solar panel but it is said to be able to charge the four optional NiCd batteries in 67 hours using the solar panel. The optional 6v wall wart will charge the NiCds in 27 hours. The expected run time on the NiCds is 48 hours. The radio seems to like batteries a great deal.

This radio tries very hard to be a lot of things to a lot of people. The frequency coverage is from 520 - 1710 on AM, 87.5 - 108.0 on FM, TV channel 2 -13 and all seven channels on the weather band. The set has an alarm, a sleep timer and a snooze feature.

When it comes to AM reception, if you live in the city and are surrounded with many signals, this may not be the radio for you. I have observed that this radio is very sensitive but not very highly selective. I live approximately 3 miles from KMIK 1580's antenna. On my Radio Shack DX-398 [Sangean 909] I have KMIK and its splash from 1570 to 1590. On the CCRadio KMIK kills the band from 1540 to 1620 and also has its images popping up in places on the X-band during the day. I have a similar problem with KXAM 1310 also about 3 miles away running 5 kW where the spread is larger on the CCRadio than the DX-398.

However if you are not in proximity of a local 50 kW or 5 kW station, the radio is fine and is not prone to overloading as it is nearer to an antenna. I would say that this is the major problem with the CCRadio. The sensitivity is ever so slightly better than the GE Superadio III and selectivity less on the upper end of the band than the GE model.

This radio will perform very well though if not in the vicinity of any strong RF signals and if you are in an area where you don't have to deal with this it is a solid radio.

There is an issue with the memory display on the LCD that C. Crane and Sangean needs to address and is common on all three CCRadios I

have used. Once the 5 memories on the bands are set, and only on AM, if you press the memory buttons the selection comes right up and the memory number on the LCD is fine. However, for example if memory button 4 is set for 1450 kHz and you tune with the DIAL, at 768 kHz the M-4 shows although this is not where the setting is. It has no bearing on the operation of the radio, it just is there. There are several places where memory numbers show up at odd places. Not good programming nor quality control to have this issue show up in a 160 dollar radio.

The reception on the weather band is adequate and nothing exceptional. On most radios that have the weather band, I get five different stations but generally I only get three on the CCRadio and sometimes four with a lot of antenna twisting.

I have found the TV section to be poor at best. For example, I have a channel 4 in Tucson that is easily receivable on the Optimus 12-604a which is NOT known to be a DX monster. The CCRadio has an image of KDKB 93.3 FM right on top of KVOA 4 Tucson's signal rendering it unreceivable. Channel 7 from Prescott is doable with other radios but there is an image of KNIX 102.5 squarely atop its signal.

On FM I have found that this is your typical lackluster Sangean built FM section that is not only weak and lifeless but full of images. I have only seen one Sangean radio on FM that was not full of images and that is the DX-398 with RDS but even that is fairly dead and impervious to most DX.

I have two stations I use as a standard for FM reception. One is KAHM 102.1 in Prescott [100 driving miles] as I am on the edge of its receivability and the other is harder to hear on a portable in Mesa, Arizona, KMGN 93.9 from Flagstaff [180 driving miles]. Both of these stations are fairly doable on a GE Superadio and for the CCRadio costing 3 times as much as a GE Superadio, well I believe the reception should be able to be duplicated if not superior. Guess what? It isn't. KAHM is receivable although weakly and KMGN, forget it.

My take on the CCRadio. This is a good radio on AM reception for those who are not in close vicinity of an AM transmitter and tower. The radio when it is not there is not overloaded and quite selective. It will pull in DX and do a fair job and somewhat better than a GE Superadio under those conditions.

The TV / FM / and WX bands are usable in a local sense and do a good enough job in that role. This radio was not sold as a top of the line powerhouse in these areas and they are good enough to get the job done.

I believe that this radio is priced way too high for what you get and would be better if it were priced at nearer to \$100 than \$160. The radio has an advantage over the GE Superadios in that it has a digital readout and a clock plus the GE does not have WX or TV. However for the price, I believe that the GE offering is hard to beat at \$50.

This CCRadio would be highly recommended if the new price was \$120 or less but it is not the best AM radio ever made. It is a very good to fine set for someone who is a domestic DXer and is well made but it doesn't live up to the hype it has received. Its definitely a little better than the GE Superadio III but certainly not as good as a Sony 2010 with its ability to lock on to a signal.

I would not say that its a no buy, but will say that you should consider whether or not you can deal with a radio that overloads near strong RF more than other radios, and how much you want the TV, FM and WX reception before buying. At \$160 you might want to consider waiting for a sale on the DX-398 at \$30 more and get SW, continuous coverage from 153 kHz to 30 mHz and FM with RDS which is

a very nice feature.

Its like everyone always says, there is no such thing as a perfect radio. If you are considering one, this may work for you and do a fine job under the right conditions since this is still a good, but not great, receiver.

(Judging by the mushiness of the voice audio and the rather feeble signal at only about 15 miles, these guys definitely should be working on these improvements! This thing gets out only a little better than the average pirate.)

Bruce Conti and I did a bit of DXing Wednesday evening (25 APR) from the salt-marsh in Rowley, MA. Conditions were decidely sub-par with only Canary Islands on 621 pushing the S-meter over 89 (as far as TA's went). Pretty good signals from Mauritania-783, Ceuta-1583.64, Canaries-1179, and a few others. Very little from Latin America and not much other than high-band Spain coming from Europe. This is probably good DX in the midwest, but it's pretty wimpy compared to what can normally be heard at a metro-Boston shore site at sunset.

RADIO SIGNAL BUTTING IN STATION'S NEW TRANSMITTING TOWER IS INTERFERING WITH MIDTOWN TELEPHONE CALLS.

When Lorri Rossi-Green picked up the telephone in her midtown home this week, along with a dial tone, she heard a celestial message. Rossi-Green and apparently hundreds of other midtown residents are receiving Catholic radio programming broadcast from a new

transmission tower nearby.

The signal from AM station KSMH-1620 has been picked up by standard and cordless phones in the midtown area since the station's new transmission tower went on line about three months ago.

"We put a man on the moon 30 years ago," said Rossi-Green. "Why do I have to hear a radio on my telephone?'

Pacific Bell officials acknowledge there is a problem in the neighborhood tied to the new transmission tower and say the company is working with the radio station to solve it.

KSMH officials did not return phone calls seeking comment. The station is not part of the Catholic Diocese of Sacramento, though it does air some of the diocese's programming.

Pacific Bell technicians have made numerous service calls to the neighborhood area in response to customer complaints, said company spokeswoman Heather Alexander. She said the radio station has hired a contractor to help area residents deal with the interference.

Alexander said she did not know precisely how many complaints had been logged over the issue.

The interference can range from a slight murmuring of voices before a person dials the phone to pickup so strong that the broadcast disrupts conversation.

Industry experts say such a problem is not rare and occurs when new transmitters are powered up, especially those in close proximity to older neighborhoods where inside wiring is not as modern as in newer areas.

Ken Orchard, director of technical compliance for the California Broadcasters Association, said the copper phone wiring in a home sometimes acts like a radio antenna, picking up strong signals nearby.

Sometimes the problem, he said, is a result of the phone connection being improperly grounded. But Alexander of Pacific Bell said the companies' technicians found that all the affected homes were correctly grounded and the problem was with internal wiring.

Homeowners are responsible for their home's internal wiring, but Alexander said that as a courtesy, Pacific Bell technicians are installing noise suppressors on phone jacks within the home when they make a service call.

That is the solution being employed by the station's contractor, as well, Alexander said.

Orchard of the California Broadcasters Association said such difficulties can be traced to the technology of the new transmitter overwhelming the wiring in older homes. The suppressors, once installed, provide an effective solution, he said.

Rossi-Green, who had the devices installed in her home on Wednesday, said they seem to work, but she wants to wait a little longer before passing judgment.

"They fixed it before, and it was great for a couple of weeks," she said. "But then the problem came back."

Behemoth broadcaster steps on KSCO, BY BRAD KAVA

Even a liberal has to feel sorry for Michael Zwerling. The 49-year-old former real-estate investor bought Santa Cruz 10,000-watt radio station KSCO-AM (1080) 10 years ago, in part to give conservative commentator Rush Limbaugh a forum in a city so far to the left it has almost slipped off the map. But last week, Clear Channel Communications, the radio, concert and billboard behemoth that owns the syndication of Limbaugh, Laura Schlessinger and Art Bell, announced it was taking the shows off the independently owned

station and moving them to a competing Salinas AM station that it owns. The move to 5,000-watt KTX-AM (1460) will take place June 1. Zwerling was stung. For years he'd faced the wrath of his liberal neighbors, and those three shows made up a good chunk of his broadcast day. He had built ratings of about 2 percent of the Monterey Bay market, a relatively strong showing given competition from San Jose and San Francisco stations. The week after the announcement, his phone mail was packed with passionate messages, for and against the move. Some thought it was a liberal conspiracy. And then, even Limbaugh took a shot at him, on the air, claiming that he couldn't tell the full story on his national show, for fear the Santa Cruz station would cut him off. "I think it was uncalled for, inappropriate and wrong. We didn't cut it off and we wouldn't cut it off,'' says Zwerling, a flamboyant and emotional man who does a Saturday morning talk show on his station. Zwerling is mixed in his reactions. On one hand, he knows it's just a business decision that has affected about 100 independent broadcasters. ``If I were Clear Channel I would be doing the same thing, '' he says. On the other hand, he now knows what it's like to be a victim of a marketplace that is rapidly shifting into what some view as monopolistic. Clear Channel not only owns some 1,200 stations -- the radio hardware - in Zwerling's words -- but it also owns the software, the syndicated shows. 'Clear Channel paid like \$51 million for Rush; \$71 million for Laura and \$9 million for Bell. For that money, it was like buying radio stations all over the country. It's a brilliant move from a business point of view, but I'm not sure it's in the interest of the consumer.'' The San Antonio-based Clear Channel bought Dallas's AM/FM in a deal approved in August, making it the largest radio company in the country with 1,170 stations. Nearest competitor Cumulus has 235 stations. CBS/Viacom has 185 stations. And Clear Channel is also the country's largest concert promoter, owning a piece of entertainment ranging from the Broadway show `The Producers' to the latest U2 tour. It owns local promoter Bill Graham Presents. The huge growth in radio corporations began in 1996, when Congress, in response to complaints from then-suffering smaller broadcasters, deregulated the industry, increasing the number of stations that could be owned, so that they could streamline business operations and increase profits. The result in this case may have some benefits for the community, even as it was a stick in the eye to the small broadcaster who filled much of his day with nationally syndicated commentators. Zwerling, who says he wasn't really listening to much Rush anymore, has begun a campaign to develop more local shows. The station's recent ratings have dropped a bit (although the paid programming in the middle of the day can't help much).

New oldies station hopes 1950s format will pay off with listeners L. Wayne Hicks Business Journal Managing Editor Despite his name, Da Boogieman isn't trying to be cool. Or, more accurately, he isn't trying to be KOOL, the FM Denver radio station known for its oldies format.

Da Boogieman (who did not want his real name used) is on the dial at 1220 AM, spinning his own blend of oldies, resurrecting rock 'n' roll at a station that was previously home to Christian music. The

latest incarnation of his station, KLVZ, took to the airwaves in October with a channel-cleansing 24-hour marathon of Bill Hailey's "Rock Around the Clock."

"I'm just in hog heaven," Da Boogieman tells a visitor to his cramped broadcast booth in north Denver. "I keep pinching myself every day." A throwback to the old days of rock 'n' roll, Da Boogieman's on-air voice sounds a bit like Wolfman Jack. And he signs off at 6 p.m. after a four-hour shift each weekday, with a saying borrowed from another legendary disc jockey, Alan Freed, who coined the term rock 'n' roll: "It's not goodbye. It's just goodnight."

Both Da Boogieman and KLVZ focus on music recorded between 1955 and 1969, when Pat Boone and his white bucks were giving way to Elvis and his blue suede shoes. Songs unlikely to find airplay anywhere else have a home on KLVZ. A Paul Anka tune from 1958, "The Teen Commandments," regularly turns up, offering words of advice, including: "At the first moment, turn away from unclean thinking. At the first moment." And "Avoid following the crowd. Be an engine, not a caboose."

The advice may still hold true today, but the song is definitely an anachronism. The so-called "oldies" stations typically focus on music from the 1960s and 1970s, ignoring the earlier tunes. Da Boogieman revels in it. "I don't want this stuff to be forgotten," he says. Taking on KOOL KLVZ is too new to make it onto the Aribtron ratings. But it has a steep, uphill climb to reach the ratings brought in by KKKL, the station at 101.5 FM that calls itself KOOL and uses the slogan "Good Times, Great Oldies." KXKL ranks eighth in the Denver ratings game. Tom Watson, KOOL's programming director, isn't worried about his new competition. "I listen to them," he says. "I think they're doing a good job." But music, he explains, isn't the most important part of a radio station. In fact, Watson ranks music fifth in importance, after such other considerations as community involvement, on-air talent, news and information and contests and promotions. "It's an upside-down pyramid," Watson says. KXKL, which broadcasts primarily music from the 1960s, offers more than music, Watson says, including traffic updates every 10 minutes during the morning and afternoon rush hours. "There has to be more to the radio than just a jukebox," he says. He says stations must find out what the audience wants, and then give it to them.

"The music is sort of the hook that gets them in, but you need to do more than 18 songs an hour." For now, though, music is just about all KLVZ can offer. The station is nearly commercial-free, with maybe three commercials airing in an hour. "I tell people it's fine not having commercials, but it's not realistic, because eventually you're going to have to have commercials or they get rid of the format or they get rid of the station," says Da Boogieman. When the format switch happened, just before the holidays last year, companies weren't buying commercial time, says Don Crawford Jr., general manager of KLVZ. He says the station is beginning to line up advertisers, who pay \$1,000 for four spots a month, or about half what the company's sister station KLZ charges. "Listeners wouldn't appreciate that as much, but corporate would, " Crawford says. Dan Cechini, owner of Dun-Rite Kitchens in Englewood, recently began advertising on KLVZ. But he's on 25 other stations between Colorado Springs and Denver as well, pitching his kitchen countertops and cabinet refacing work. "I'm trying it to see how it works out," he says of the spots on KLVZ. "I go more by gut feel than anything." That's how KLVZ appears to be run. "We're consultant free," says Da Boogieman. "That's what I like to push. We're consultant free." KXKL gathers listeners a couple of times a year, plays snippets of songs and determines what to broadcast that way. "What we're doing is

we're playing a lot of songs that the other guys won't play," says Dave "Hot Rod" Hixson, Da Boogieman's morning counterpart. "What we have found is by playing a broad playlist and songs that didn't necessarily hit the top 10, that the audience just goes nuts. They love hearing songs that aren't beaten to death."

"I think it's great," says Kathy Kurtz-Davis, who listens as she cuts hair at University Hills Barber on South Colorado Boulevard. "It's the music I grew up with." Da Boogieman is back. All of the employees of KLVZ could hold a staff meeting in the broadcast booth where Da Boogieman now holds court. There are only two -- Da Boogieman and Hixson, whose broadcast career has carried him in and out of Denver since the early 1960s, with stops in between in Topeka and Tulsa, San Antonio and Corpus Christi. Da Boogieman is a fixture on Denver radio, having landed his first job in 1979. He's been on KWBZ (later KRZN), KHOW and KIMN, but fell victim to a mass firing in 1988 when KIMN switched to a country format. Hard times followed, including stints working as a fry cook and at an adult bookstore. He filed for bankruptcy at one point. "I lost my record collection," he says. "I had to sell it to stay alive. That hurt." But Da Boogieman is back on the air now, having joined KLZ two years ago when the format switched from Christian music. He was working for the Regional Transportation District then, a supervisor at the Market Street bus station. "I saw one of our busses come in one morning with KLZ plastered on the side of it. I thought, 'Wow, KLZ went from Christian to real music.' So I put together a cover letter with a paragraph that said I was the neatest thing since sliced bread and sent it over there. I got a call a week later."

A format change

He and Hixson moved over to KLVZ when the Christian format was abandoned there as well. When Da Boogieman and Hixson aren't on the air, KLVZ is run by computer. KLVZ is low-powered to begin with, operating at just 660 watts compared to the 10,000 watts pumped out by KXKL, but at night it's really low-power. Federal Communications Commission regulations require KLVZ to drop down to 11 watts at night to avoid interfering with the signal of a 1220 AM station operating in Mexico City. KLVZ announced plans last year to switch from Christian music to classical, then scrapped those plans once Colorado Public Radio announced its intent to play classical music on the AM dial. (Colorado Public Radio has since said it will air classical music on the FM dial and news programs on AM.) Casting about for a format that wouldn't go up against Colorado Public Radio's plans, KLVZ settled on the oldies. And not just any oldies. The 1,000-plus recordings on the station's playlist are all owned by Da Boogieman and Hixson. There wasn't money available to buy a library of music. And Da Boogieman is spending his own money to print up T-shirts and bumper stickers. "This is el shoestring-o," he says. "This is the little plastic tip on the shoestring." But KLVZ isn't mom-and-pop radio. If anything, it's father-and-son radio. Don Crawford Jr. runs KLVZ and eight other stations for Crawford Broadcasting Co. of suburban Philadelphia. His father, Don Crawford Sr., owns the company. The company was founded by Percy Crawford, a noted radio and television evangelist, who died in 1960 soon after buying his first radio station. His oldest son, Donald Sr., who used to perform on his father's radio show with his brothers as the gospel group the Four Ds, took over. Although Crawford Broadcasting's history is steeped in Christian music, the company has begun switching some of its stations to secular formats. "We don't think there's near as much growth potential for the Christian format at this point, at least in this market," says the younger
