services - for instance, they now require a \$4.95/month fee for FTP access to a Geocities site, they now require a fee for POP access to e-mail and there is now a fee for e-mail forwarding; this trend will undoubtedly lead to them no longer offering a free website, or them offering it free with so many restrictions that it will serve IRCA no purpose. In anticipation of this, I have been looking into other web hosting providers. My requirements for a web provider were:

- 1) Allow for virtual hosting (i.e., a domain name of my choosing, rather than being required to use theirs)
 - 2) The cost for hosting should be less than \$10/month
- 3) Shell access (also known as telnet access) basically, this would allow me to enter commands myself on the machine it would allow me to use the password protection scheme I have tested previously
- 4) Unrestricted FTP access (no restrictions on transferring files Geocities currently does not allow some file types)
- 5) At least 1 e-mail account (for the submissions from the page this is currently done by a "free" service)
 - 6) No ads
- 7) At least 15MB of space, with the option to easily purchase more if needed our current site uses almost 11MB
- 8) On-site monitoring and backup power (i.e. UPS) these are personal requirements
- 9) allow for CGI scripts and PHP or ASP file to be executed IRCA does not currently employ these, but I have seen that they are needed and we may in the near future.

I propose IRCA register a domain name of ircaonline.org (which, according to InterNIC, is currently available), as well as ircaonline.com, which is also available - the .com extension is more often used and having both will allow IRCA to gain access to the visitors who use the .com extension first. It was a shock to hear of the passing of **Ernie Cooper**, although, in some ways, it should not have been surprising, considering his age and that he had Parkinson's Disease. I passed some memories of Ernie on to **Rich Toebe** a couple of weeks ago and he asked that I put them into a Forum report. I first ran across Ernie when I joined NRC in June, 1965, three months after I joined IRCA. I remember meeting him only twice, at the Louisville-1976 and Milwaukee-1988 conventions, but I must have run across him at other ones as well, such as

Toledo-1984, Wilmington/New Castle (Del) in 1985 or 1986, Staten Island (WTVFMDXA)-1979 or 1980. I always remember him as being a quiet soft-spoken person who would take the time to talk and listen to others, whoever they might be. One of the things I was surprised to see not mentioned in the long NRC tributes to Ernie was his mail problem in the mid-60s. Quite a few of us would send him a Musing, only to have it returned stamped "No Such Address". In my case, I had typed it at work and used a company envelope, only to see it come back, opened by our home office and then sent down to me in the truck mail. It took several years, but they finally found out that the problem was in Ernie's address. He lived at the last address on his mail route, so his mail would sometimes end up in the sorting bin of the next mail carrier. That mailman would just simply treat it as a non-existent address and send the letter back to the person who wrote it. Yes, that mailman was disciplined over it (finally) but I don't think anyone really knows yet how many veries Ernie might have lost over it. When Ernie finally joined IRCA in the mid-70s, I was probably one of the first to welcome him to our club...in the middle of a Musing I sent to him. After I took over EDXF, he was probably one of the more frequent reporters I heard from...always he was pitching for more reports to my column...and I was willing to let him do it. When I heard from him, his envelope was usually one of the first to be opened and read. He normally typed on the back of a Provincetown map and I used to try and see if I could figure out exactly where it was that he lived in relation to the rest of the town. Hopefully, I still have some of those reports packed away in my garage. Over the years I have done EDXF and CDXR, there are quite a few DXers I have heard from but, while all have been good people, Ernie was really a holdover from the old days of DXing. He hated the phrase but I think it is really an honor to call him The Old Man of DXing. I consider it a term of respect. He will be missed. 73.
