

 (03-07) 15:35 PST SAN FRANCISCO — A federal judge said Friday she's inclined to dismiss a lawsuit by conservative radio talk show host Michael Savage against a Muslim rights group that reprinted his attacks against Islam and called for an advertising boycott. Savage sued the Council on American-Islamic Relations in December after the organization posted excerpts from an Oct. 29 broadcast in which he called the Quran a "hateful little book ... a document of slavery" and said, "I don't want to hear one more word about Islam. Take your religion and shove it." His lawsuit accused the group of violating Savage's copyright by posting more than four minutes of excerpts on its Web site without his permission. He also claimed that the group was engaged in racketeering, saying it poses as a civil rights organization but is actually a "mouthpiece of international terror" that helped to fund the terrorist attacks of Sept. 11, 2001. The broadcasters syndicated program "Savage Nation" has about 8 million listeners a week on 400 stations, including on KNX-AM in the Bay Area. He said the Council on American-Islamic Relations was harming him by taking his statements out of context, urging visitors to its Web site to complain to his advertisers and using his material to raise money for illegal activities. The group called its claims about its activities preposterous, denied any connection to terrorism and said in court papers that Savage was trying to "intimidate and silence (the organization) in retaliation for (its) criticism of his radio rants." Numerous companies have withdrawn their advertising from his program, the group said, including Sears, AT&T and Wal-Mart. Lawyers for the group said its use of Savage's comments was permitted by copyright law and protected by the First Amendment. At a hearing Friday, U.S. District Judge Susan Illston of San Francisco said that she found much of the organization's position to be persuasive and that she had tentatively decided to dismiss the suit. She added, however, that she would probably allow Savage to refile the suit and fix its defects, which she did not specify. Savage's lawyer, Daniel Hollowitz, disputed the group's contention that its excerpting of his broadcast was protected by the legal doctrine of fair use, which allows portions of copyrighted material to be reprinted for the purposes of commentary, criticism or parody. Hollowitz contended the organization had discredited itself from protection because of its allegedly illicit motives and commercial use of the material. "It is speech, Mr. Hollowitz," the judge replied. Thomas Burke, a lawyer for the Council on American-Islamic Relations, said at the hearing that the organization was entitled to excerpt Savage's words for fundraising purposes. He cited a 1986 ruling by the federal appeals court in San Francisco allowing the Rev. Jerry Falwell's organization to use copyrighted material in a Hustler magazine parody of Falwell to generate contributions. Savage's lawsuit "is about punishing (the council) for exercising its First Amendment protected rights," Burke told reporters. E-mail Bob Egelko at begelko@sfchronicle.com. (DP-HI)

 Black Friday for HD Radio
 This week's Convocation conference in San Jose was a terrific gathering of broadcasters and their partners who feel radio's best days might very well lay ahead. No sticks in the mud, these. Rather, folks with brains and vision and a plan, or at least the hopes of developing one. This was no place for spin doctors and conventional wisdom. So I was not surprised when Kurt Hanson spoke on radio's future with an emphasis on radio's inevitable future on the Internet. Nor was I surprised when Kurt veered left to discuss - and dismiss -

HD Radio. What fascinated me was the reaction. Any room full of broadcasters is full of HD radio doubters, nowadays. But the vibe in this room was remarkable for the eye-rolling and audible snickering that greeted virtually any mention of HD. Kurt disassembled HD's premise by dividing the total number of radios now in circulation by the markets in which those radios live and other relevant assumptions (I did something like this while back myself). He arrived at the conclusion that the average HD radio advertiser in any given market could reach more prospects by standing at the bottom of their driveway and handing out flyers. In a panel session immediately following KURTs, the lone iBiquity spokesman filibustered on his talking points, spitting one after the next, but the effort seemed surprisingly desperate. You could almost hear the sweat forming on his brow as he reiterated his case, oblivious to the thrashing that had just occurred. Although he described himself as Kurt Hanson's "evil twin," the feeling in the room was that he was at least half right. It left me feeling that a corner had been turned. That broadcasters understood new media presented scores of new opportunities, few of which had anything to do with selling newangled radios to consumers who don't want or need them. This should create great hope for those of us in radio: Hope that good ideas really will rise to the top. Hope that we're too smart to be taken by pyramid schemes. Hope that those with a vested interest will be revealed for what they are. Hope that those with the interests of broadcasters and listeners and clients at heart will create the kind of future those constituencies demand and deserve. All along, HD radio was designed as the industry's counterpart to XM and Sirius. As the satellite titans near a merger (which I do believe will happen and could come any day now) in order to save themselves, as satellite's control over one pocket in the dashboard accelerates, as another pocket opens up for all-things-Internet, HD radio will rapidly drift into obscurity like the technological also-rans which preceded it. All technology is transitional, but some never make it to the transition. In this new media world, opportunities are actually less about "convergence" than about emergence. Chaotic storms of passion bring audiences together. Their whims and tools and discussions allow them to take the driver's seat. We are and always will be in service to them. HD radio was always about what the industry wants, not about what consumers want. That's why it was doomed to fail from the start. And, unless there's some remarkable consolation prize embedded into the satellite radio merger decision, that day shall be Black Friday for HD radio. (PM-OR)

The change coincides with the addition of Dan Patrick's new syndicated sports show (9 pm to midnight weekdays) when it doesn't conflict with Avalanche and Nuggets coverage. The smooth-jazz format, while off the regular radio dial, can be streamed on the Internet at SmoothJazzDenver.com and also can be heard on HD Radio at 98.5-2. Arbitron audience ratings for the music format, which premiered eight years ago, have declined recently, Call said. The Fan has been operating on the 950-AM frequency for 12 years. (DP-HI)

LA MIRADA – A half-built radio tower, under re-construction after years of debate over the safety of its location, crashed to the ground this afternoon injuring a construction worker, city and radio-station officials said. The name of the injured worker was not released, but his injuries were believed to be minor, said Greg Ashlock, president and market manager of Clear Channel Radio. The reason for the collapse was not immediately clear but was believed to be construction-related, he said. Clear Channel, which operates KF1-AM radio, contracted with Seacomm Erectors, Inc., to build a 684-foot-tall tower at 16608 Trojan Way.

Construction began on Saturday and had risen to about 250 feet by Tuesday when the tower came crashing down around 2:30 p.m. The tower was meant to replace a 760-foot-tall tower that was toppled in December 2004 when a small plane crashed into the tower on approach to Fullerton Municipal Airport – less than two miles southeast of the tower. A couple was killed. In recent months, Fullerton airport and city officials joined

with local pilots in protesting plans for the tower's reconstruction, saying it was too tall and would pose a hazard to pilots. They didn't want the new tower to rise more than 500 feet. The La Mirada City Council unanimously approved the new tower in January. KFI continued the construction would take about four weeks. Ashlock said it's not immediately clear how the collapse will affect that timetable. KFI continued to broadcast from a 200-foot-tall temporary tower on the same property, so the collapse did not interrupt the radio station's signal. The new tower will provide a stronger signal. (RW-NM)

It's one of the top-rated shows in the country, heard on more than 300 ESPN affiliates and simulcast on ESPN2. Debut will be 6 am April 1. WPEN will air three of its four hours. The move breaks up WPEN's morning team of Glenn Foley and Michael Bradley. Foley was let go. Bradley and station manager Bob DeBios said today that Bradley said that freeing him from the morning show would remain at WPEN in some capacity. Bradley said he would allow him for time for writing. WPEN management said the rest of the station's lineup would be announced Friday. WPEN, a heritage station in Philadelphia, has aired a mix of local and syndicated sports talk since October 2005, with little success in the ratings. Among its target audience of men ages 18 to 49 in January's Arbitron ratings, WPEN drew a 0.7 share and a weekly cumulative audience of 61,800. Its competitor, WIP (610), pulled a 4.6 share and a "cume" measured at 174,400. The bright spot in the ratings, afternoon host Jody McDonald, is expected to remain with the station, perhaps for a midday shift. McDonald's show drew 40 percent of total WPEN's cumulative audience among men ages 18 to 49 in the last ratings period. For all its national success, ESPN has had a tenuous link to the Philadelphia market. Nassau Broadcasting had a station running ESPN's national radio format at 920 on the AM dial. In early January, Nassau moved the ESPN programming to its station farther north, in Flemington, N.J., at 1040 AM. That station now carries ESPN's New York programming. The DOJ continued, "The division reached this conclusion because the evidence did not show that the merger would enable the parties to profitably increase prices to satellite radio customers for several reasons, including: a lack of competition between the parties in important segments even without the merger; the competitive alternative services available to consumers; technological change that is expected to make those alternatives increasingly attractive over time; and efficiencies likely to flow from the transaction that could benefit consumers." The CBC advises that the FM transmitter is intended to replace its existing AM transmitter CBDS and that recently the Mathias Colom Cree National Chief and Council advised the CBC that the CBDS site is contaminated and they will proceed to decontaminate it by June 2008. The CBC indicates that the FM transmitter needs to be operational by this date. The CBC is also requesting to amend the licence of CBWK-FM Thompson by deleting the AM transmitter CBDS Pukatawagan. EDINBURGH'S all-talk radio station could be set to change its format after the sudden departure of its programme director. Controversial DJ Mike Graham, a part company with Talk 107 at the weekend. It is believed his departure could be a sign that the station is set to move away from the all-talk format. Mr Graham, who presented the Independent Republic show every weekday from 9am to noon, said today: "We have parted company and we are currently negotiating an amicable settlement. I have had a great time there for the last two years and I will miss broadcasting to Edinburgh very much – but it's time to move on." The

former newspaper editor joined the station as a presenter in February 2006 and became programme director later that year. Describing himself as "President of his own independent Republic," his show was among the most popular on the station, and it saw him clash with politicians at both local and national levels. Mr Graham hit the headlines in November, after swearing at guests during an event for a cancer charity. Marie Curie Cancer Care was forced to apologise after the outspoken presenter's outburst in front of an audience of 300 before he hosted a round of a charity quiz. He defended his actions, saying he had not intended to offend guests at the corporate Brain Game event and simply wanted to "liven it up a bit". In January, Talk 107 reported an increase in the number of listeners tuning in for at least five minutes during an average week. The station scored Scotland's biggest percentage increase between summer and the final three months of 2007. However, the rise of 20.7 per cent accounted for just 600 more listeners – a total of 35,000 – as the available audience is only 12.2 per cent of the overall market. In contrast, Edinburgh station Fort One was listened to by 14.2 per cent of its available audience – up from 13 per cent. It is understood that Mr Graham left after meeting the Talk 107's managing director, Matt Allitt, at the weekend. Mr Allitt has been managing director of the station since the departure of Peter Gillespie from the post in November. The station's other presenters include Respect MP George Galloway and former TV presenter Dominik Diamond. (DP-HI)

Copper thieves strike again: this time stripping copper pipe and wire from a radio transmission tower. The dangerous heist knocked two radio stations off the air. On April Fool's Day, Dave Brewer usually plays a prank. This time he changed the format of the radio station. "Uh oh, the storm must have gotten to it," Brewer, KCTO/KCLX manager, said. But when the engineer went out to the towers near 251st and State Line Road, it was clear this was not storm damage. "They took bolt cutters and took the locks to the fences at the tower bases, that's how they got into them," Brewer said. They took all the copper from two of the towers, probably sold as scrap metal and the thieves probably made a couple hundred dollars and since it happened in a rural area, it's unlikely there were any witnesses. Worst yet for KCTO and KCLX, the outage happened during the popular Alex Jones show. "When you displace him for any reason the phones light up like a Christmas tree," Brewer said. The crew has been scrambling to get back on the air and the general manager explained the situation to listeners who could hear him. The engineers still have some fine tuning to do for the next day or so and they're asking listeners for some patience. "They could be hearing it on the moon for all I know and deader than a doornail in Grandview," Brewer said. If you know anything about the theft, call police or the Tips hotline. And the thieves should know the radio station is replacing copper tubing with steel, so they're not going to get anything if they return. (PM-OR)

The Voice of the Broncos is saddened, but not shocked, by BSU's decision to change stations By Chadd Cripe, ccripe@idahostatesman.com

Paul J. Schneider experienced a range of emotions Thursday when Boise State athletic director Gene Beleymaier called to inform him that KBOI would no longer broadcast Broncos football and men's basketball games. Disappointment. Sadness. A touch of disbelief. But never anger, and never shock. Schneider saw this day coming- the day his run of 35 years as the Voice of the Broncos might have ended. Boise State awarded its radio contract to Peacock Broadcasting instead of Citadel, the company for which Schneider works. Citadel's KBOI had held the Boise State contract for 35 years. "It's obviously been a great part of my life," Schneider said. "Obviously I'm closely identified with Boise State. I feel bizarre right now. I kind of thought it was coming, but it's kind of like when you have someone who's not doing good and not expected to live long and when they die, you go 'Whoah'. And that's kind of where I am." "I thought I'd do it until I turned into Harry Carey and I couldn't see anymore". Peak didn't name its on-air talent for the broadcasts which will air on KIDO (580 AM). Boise State will have input. "We haven't got there yet", said Kevin Godwin, the senior vice president of Peak Broadcasting. "We've got a whole mess of things to do now." Nobody was ready to call this the end of the Schneider era. It is possible, at least, that he could move to Peak and continue as the Voice of

the Broncos. However, that possibility seems remote. Sandy Gamblin, the market manager for Citadel, figures Schneider called his last game when the Boise State men's basketball team lost to Louisville in the first round of the NCAA Tournament last month. "That would appear to be the case," Gamblin said. Schneider actually has connections at Peak, which has a key employee in his positions-including Godwin. "I have great respect for Paul J." said Godwin, who worked at KBOI for about seven years. "He's a class act, I enjoyed my time working with him... I don't know what's going to happen, but Paul J's one of my favorite guys." On-air talent was not a factor in determining the best radio bid, Bleymaier said. However, it was difficult for a five-man committee to cut such lengthy ties with Schneider and KBOI, he said. Boise State fans often seemed divided over Schneider. Some loved his passion and considered him as much a part of the Broncos as Lyle Smith and the blue turf. Others lamented his tendency to make mistakes by calling the action a little too quickly. "He's been the voice of the Broncos for 35 years and done a tremendous job", Bleymaier said. "He's called every play we've had in those 35 years. That's obviously very significant and we're very appreciative to Paul J. for his dedication and his service". Schneider, 65, graduated from the University of Idaho in 1966 with a degree in communications and a dream of calling play-by-play. He arrived at KBOI in 1968 and practiced his craft by working high school games. In 1973, he became the Voice of the Broncos-the same year Boise State won its first Big Sky Conference title. He has been with the Broncos for a Division I-AA national title, seven conference titles at the Division 1-A level and eight bowl games, including the world-famous Fiesta Bowl. "People change jobs and move up to bigger schools, and I did all that without having to move," Schneider said. "I really enjoyed it. I'd go out with the assistant coaches and older players to parties. Then I started going out with the head coaches. Eventually I just went to bed. And now he is struggling how to say good night. He was planning to retire from his morning radio show on KBOI this summer, but Thursday's news has him reconsidering. If he is finished, he could spend more time at his Montana ranch and with his wife, Tamara and 15-year old daughter, Natalie. "You always like to be able to control your own destiny", he said. "I see that big new press box sitting up there and I'll never work in it, and that's kind of sad". (FA-D)

Radio host Rhodes returns to West Palm, BY CHARLES PASSY, Palm Beach Post Staff Writer, Monday, April 14, 2008. The Goddess has truly come home.

Following her departure from the liberal Air America talk radio network last week, controversial host Randi Rhodes is bringing her nationally syndicated afternoon drive-time show back to WJNO-AM 1290 in West Palm Beach, starting today. But this time, she's not just being heard on WJNO, which is owned by media giant Clear Channel. She's producing the show from her former employer's studio. "We have our biggest star back," said WJNO Programming Director Brian Mudd. Dubbed "The Goddess" by her loyal listeners, Rhodes, who worked for WJNO for 10 years starting in 1994, gained fame for her tall-it-like-it brand of leftist politics. That prompted Air America to hire her when the network debuted in 2004. Rhodes stayed on the air at WJNO in the years that followed, but through Air America. She also became a national personality, seen on billboards and TV news shows. The bottom line, Rhodes says of her return to West Palm Beach: She'll still be her usual loud and feisty self on air. And she'll still be speaking to a national audience, not necessarily a local one. But she no longer has to schlep back and forth between New York and Palm Beach County, where she kept a home during her Air America tenure, to do what she loves. "I just grabbed my dog" and came to West Palm Beach, Rhodes said of her sudden decision to base herself year-round in the area. Her show is being syndicated by the Nova M Radio Network, an emerging competitor to Air America in the talk radio world. Well, the decision wasn't all that simple. Rhodes quit Air America after a high-profile dispute with the network that was covered by such media outlets as The New York Times and The Wall Street Journal. Air America suspended Rhodes on April 3 for making what network executives deemed "inappropriate statements" about Sen. Hillary Clinton, D-N.Y., at a recent comedy performance in San Francisco. Rhodes said the dispute was sparked by employment discussions with Air America and that her remarks during the performance weren't the integral issue. She added that when Air America suspended her, she thought it meant her contract was terminated. So she quit to "clear the way" for future radio opportunities. That was on Wednesday night. By Thursday and Friday, Rhodes was hammering out a deal with her new syndication company, talking to her 20-plus affiliate stations across the country about continuing to air her program (most have agreed to do so) and even going on Larry King's CNN show to discuss her situation. That left Saturday to fly from New York to West Palm Beach and Sunday to reacquaint herself with the WJNO staff and get her show up and running again. "What usually takes months took days," Rhodes said. The show will air in its usual Monday-to-Friday time slot of 3 to 6 pm, following Rush Limbaugh, who might be called the conservative yin to Rhodes' yang. The two are more than radio neighbors, however. Limbaugh is also based in Palm Beach County. (DP-HI)

Like American Airlines, Air America insists it's still flying. Even though not everyone in radio would put it that way. WABC (770 AM) program director Phil Boyce, who has built the most popular news/talk station in the country, tends to get a bemused tone when the progressive network comes up. "You know," he'll say, "if you guys didn't write about Air America, it would be invisible." After Randi Rhodes left Air America last week, Boston University offered media writers an analysis from Professor Tobe Berkovitz, who said, "Without the press coverage, no one knows who Rhodes is gone. No one listens to her." Air America is aware of those dismissals. It's aware it has not yet mounted the powerful progressive challenge to conservative radio that it envisioned when it launched March 31, 2004. Air America isn't heard in several major areas, and many affiliates either have weaker signals than their conservative rivals or only carry some network shows. Its flagship in New York, WWRL (1600 AM), has only been carrying Rhodes, 3-6 pm, and Rachel Maddow, 6-8 pm, from Air America's weekday daytime lineup. Now the last original daytime host, Rhodes, is gone. At 3 pm today she becomes a competitor. It hasn't been an easy ride for Air America, which has too often made news

for the wrong reasons, like financial problems. But the network vows it is here to stay, and will only get better and stronger. For all its missteps, it feels it has proven there is a radio audience for an alternative to Rush Limbaugh, Sean Hannity and other conservative talkers. "I can't tell you how many calls I get," Rhodes said last year, "from people who say, 'Thank God you're here. I thought I was all alone.' Look at polls, look at elections. A lot of people in this country aren't Republicans." What remains to be seen is whether Air America, or other progressive talkers like Ed Schultz (now heard noon-3 pm on WWRL), can mobilize their sympathizers on the radio the way conservatives are drawn to Rush, Sean, Mark Levin and Michael Savage. The most optimistic argument for Air America is that it takes time - that conservative radio took more than a decade to reach its full prominence and that for every star it developed, a hundred others never broke from the pack. By that measure, Air America is still young, and the network feels it now has a lineup - even before it names a replacement for Rhodes - that can get traction. "Look, we've had problems," says a source at Air America. "But with the Lionel, Thom Hartman and Rachel, we're in better shape than ever. They're smart, entertaining and they know radio." (DP-HI)

Redding Radio drops ESPN, Music station KPG to fill the former sports-talk slot, By Aaron Williams (Contact) Wednesday, April 2, 2008
The San Francisco Giants, the Sacramento Kings and sports talk radio in Redding are going bye-bye. baby. Redding Radio will drop its ESPN affiliate, KNRO 1670 AM, April 18 in favor of KPG, a music station. The decision announced Tuesday by General Manager Ron Hren leaves a hole in the batting order for legions of sometimes rabid sports talk radio fans. "We realize we can't have every (radio) format," Hren said. "We regret not having ESPN, but believe KPG will be tremendous for our audience. We think it's going to cause a positive reaction." The first sign Mapleton Communications, owners of Redding Radio, was dropping the sports talk format surfaced Monday when the station failed to broadcast the San Francisco Giants opener for the first time in more than a decade. Redding Radio received more than two dozen phone calls asking where the game was. The loss leaves a hole in the north state radio market. Gone will be ESPN stalwarts Colin Cowherd, Stephen A. Smith, "Game Night" and "All Night." Also gone will be the "Jim Rome Show." KNRO also airs Kings games, it used to broadcast San Jose Sharks, hockey games and University of California at Berkeley football games, in addition to the World Series, NFL playoffs, the Super Bowl, and a host of college championships. It also delved into local sports when George Thrallson would broadcast Shasta College and high school games. Thrallson also created a local noon sports talk show, "The Cheap Seats," carried on by KNRO program director Duane Davis as "In the Game," after Thrallson left for the East Coast. The closest ESPN affiliate is in Chico, which airs on 101.7 FM, while KNTK, 102.3 FM in Mount Shasta, broadcasts Oakland Athletics games. Both signals are spotty in Redding, KPG bills itself as "Americana" radio, with electric music and a live DJ. It originates in the Santa Cruz-Monterey area, but can also be heard on 96.7 FM out of Paradise, owned by Mapleton. "In the media business you want the largest audience," Hren said. "And in every market, we've had the same (positive) reaction." Hren said the move to the ESPN station wasn't a condemnation of sports talk radio, but that KNRO was a frequency the company felt it could better utilize. The change is among several since Mapleton Communications took over the six-station cluster. They include dropping Jim Albertson from morning duties on Oldies 105.3, dropping "In the Game" on ESPN Radio, and replacing "Don and Linda in the Morning" on K-SHASTA in favor of John Tesch's syndicated show. Redding radio legend Jerry McGee also was let go. And the morning format of KQMS, the cluster's news station, brought back Ray Roberts, only to switch formats less than six months into the "By the Way with Erin and Ray" show. Rick Healy, operations manager for Results Radio, said Redding's other radio cluster has not had any discussions about picking up the format on one of its stations. ASIA AND PACIFIC

HAWAII: A fine levied against JMK Communications for \$4,000 will stand. The Honolulu AM station had allegedly caused interference on a ham frequency. The penalty is for failure to ensure that emissions more than 75 kHz from KREA's fundamental frequency of 1540 kHz were attenuated 80 dB below the unmodulated carrier level. In April 2007, the FCC's Honolulu office received a complaint alleging that spurious emissions from a station on 1540 were causing interference on 1810, a frequency authorized for primary use by amateur radio. Honolulu agents inspected the station using a spectrum analyzer and an external antenna to measure spurious emissions from KREA, on 1810, attenuated -60 dB referred to the carrier on 1540. JMK acknowledged the spurious emissions and said it had fixed the problem; it then received a Notice of Violation. Two subsequent investigations revealed KREA was still producing spurious emissions on 1810 kHz, attenuated -59 dB, and -55 dB, respectively, the FCC said. A station contract engineer said installed filtering had failed and repairs were pending. FCC rules require that KREA (AM) emissions on 1810 kHz must be attenuated 80 dB. That August the agency issued a Notice of Apparent Liability for \$4,000. JMK argued that it wasn't responsible for the violation but that it would be willing to work with the Honolulu office to resolve the issue. After doing so for four days in October, JMK reiterated its arguments but supplied new, and conflicting, engineering data and information, according to the commission. The FCC said a station contract engineer told an inspector the installed filtering had failed and repairs were pending. The owner argued the filter did not fail "but rather that the 1810 kHz signal is originating from some other unrelated source" and that the station's own equipment is not the source, but only a passive contributor. In troubleshooting the problem, the JMK engineer determined that KREA's transmitter might have played a role in the interference and subsequently concluded that the "diplexing filters need to be redesigned to provide better isolation than what was required by the previous tube-type transmitter used at KREA." The FCC found JMK responsible for the spurious emissions on 1810 kHz, noting that JMK previously told the commission "the emission on 1810 kHz is apparently a 'mixing product' caused by KREA's second harmonic (3080 kHz) and operations by KNDI on 1270 kHz. However, while KNDI may have passively contributed to the resulting emissions on 1810 kHz, given the frequencies and harmonics involved, KREA acknowledges that the offending signal on 1810 kHz 'only goes away when the [KREA] transmitter AC power is disconnected or the [KREA] ATU is disconnected from the tower.'" JMK asked for the fine to be cancelled or reduced, noting "highly responsive and responsible efforts and extraordinary expense" it took to remedy the problem. While the FCC commended those efforts and particularly "the diligence of its engineer in trying to resolve the spurious emissions", it said licensees are expected to correct problems brought to their attention and a correction is not grounds to have a fine reduced. It upheld the fine and said payment is due within 30 days. (Radio World News Byres 4 Apr)

HONG KONG: The Broadcasting Authority is inviting the public to express views on Wave Media's application for a sound-broadcasting license. The application involves the operation of a Hong Kong wide radio channel at 810, which is the only vacant channel covering the whole city. The plan is for 24 hr Chinese language programs. (Hong Kong Govt news via BEAARC 3 Feb)

INDIA: Prasar Bharati has no proposal to reduce the number of All India Radio (AIR) stations. The information was given by information and broadcasting minister Priya Ranjan Dasgupta in written reply to a question in Rajya Sabha today. Prasar Bharati said that the number of AIR stations will not be reduced by setting up one powerful station for each State and thereby saving huge expenditure. Power consumption of a single powerful station is much more than that required by smaller stations to cover the populated area. An All India Radio audience survey stated that there has been an increasing trend of listenership for the state-owned stations. From 310 million in 2003-04, the listenership has increased to 357 million in 2006-07. According to the survey, listenership in 2004-05 was 340 million. <http://indiantelevision.com/headlines/2k8/mar/mar127.php>.

EUROPE, AFRICA, AND MIDDLE EAST

BELGIUM: The Flemish government has approved the VRT's proposal to cease analogue transmissions on 540, 1188 and 1512 kHz per 30 March 2008. The VRT will retain only one medium frequency, i.e. 927 kHz, currently broadcasting R. 1. The government therefore also changes its decision to allocate analogue radio frequencies on medium wave solely to the VRT. Advice has been asked to a regulatory commission to see whether this change is legal. If all goes through the three AM frequencies may be up for sale. (Herman Boel, MWC 2.3/2008)

Andy Sennitt comments: The decision to discontinue 1512 kHz will affect expats in neighboring countries who use this frequency to listen to Radio Vlaanderen International. RNW listeners will recall that we also used this transmitter for our English service in the late evening for a number of years. (Andy Sennitt, RN Media Network 3 Feb via Mike Terry, MWDX)

BENIN: Trans World Radio's new transmitting station in Benin began broadcasting for the first time on 1 Feb. TVR hopes the station will be automated within three months. They will be broadcasting programs from local churches and ministries. With at least 15 languages reaching into 9 countries, One ID is: "Desde San Salvador transmite Radio CRET 1080 kHz en su señal de prueba". They also

were made to get some rest before 3 AM (1000 UTC), but whenever sleep was near, the QRM from Rooms 9 and 11 suddenly increased in intensity. Right up until 1200 UTC, the TP carriers (in between the TV heterodynes) were very anemic. 738-Taniti was nowhere near audio level. It seemed like the trip would be a lesson in frustration.

Suddenly around 3:15 AM (1015), everything seemed to change. Rooms 9 and 11 suddenly went quiet, with no more TV heterodynes (or loud AF-QRM). The Japanese powerhouses 594, 693, 747, 774 and 828 suddenly boomed in like locals, with the Koreans (972 and 1566) following them. Just before sunrise, VOA-1575 in Thailand made an appearance. Despite the shaky start, the logbook was filling up with stock SRF-T615 TP receptions, and various mp3 recordings were made. It turned out to be a very exciting and successful DXpedition, even if the 531-DU station didn't ID, during the 5 minutes the SRF-T615 received it.

Two ICF-2010's were used as "spotting receivers," one a stock unit, and one having a 19.5" transplanted loopstick. The "monster 2010" was responsible for catching the DU opening at 1303 (with weak audio on both 531 and 612), when the stock unit had only weak carriers.

HNJ-360 Lv del Cañague, Valledupar - identified by Henrik Klemetz on a clip sent in by Pekka Kostainen, Finland, the refurbished La Voz del Caraguata, now a Caracol affiliate. The English Home and Foreign Service is lead by Melesse Edeha Beyi, who is also responsible for the Foreign Service transmissions in French and Arabic. IRELAND: Irish public broadcaster RTE plans to axe Radio 1's medium wave service on 24 March. RTE believes the transmission cost can no longer be justified, since the content is now available elsewhere. The medium wave service, on 567 kHz, shares almost all its content with the FM version of Radio 1, except for Sunday religious services and a midweek soccer game. But the decision has been criticized by rural listener and politicians. There is to be a public information campaign ahead of the switch-off date. This will highlight the fact that the full Radio 1 medium wave service will remain available on long wave (252 kHz). It is also available on the Sky Digital platform. RTE is also talking to charities about providing subsidized radios for those who don't have sets with FM or long wave. The station's research shows that one in ten radio listeners use the medium wave version of Radio 1, with the service particularly popular with the elderly and those living in remote areas. Fine Gael communications spokesman Simon Coveney said shutting down medium wave transmissions has implications for people in rural parts of the country and at sea. "This is a public service broadcaster and this shouldn't be abandoned," he said. Labour communications and marine spokesman Michael McCarthy said the decision would have the biggest implications for fishermen working 50 or 100 miles off the coast and relying on the broadcasts for weather reports and for farmers. Since this evening repeated announcements are heard on 567 kHz that RTE's service on this frequency was discontinued. Listeners are advised to tune to either FM or LW 252 kHz. It will be interesting to see how long these announcements will continue. Fair signal here in Taunusstein/Germany. (Alexander Schulz, HCDX, 24 Mar)

Schedule (UTC): Mon-Fri 0700-1700, Sat 0600-1800, Sun 0600-1900 Program: Patia (for national minorities). A swift decision made by the Slovak Radio in January, ceased operation of the following transmitters: 567 Rimavská Sobota, 567 Zilina, 621 Horná Lehota (Orava), 864 Cadca, 864 Snina, 900 Veľký Sliač (Tatry), 927 Čížatice, 1017 Bratislava, 1035 Banska Bystrica. SWEDEN: 1179 Radio Sweden's transmission schedule for the summer season 2008: A daily morning slot at 0355-0600 UTC, rebroadcast of Swedish Radio First Programme. An evening slot at 1545-2230 UTC (Saturday evening also an hour in Romania at 2230-2330 UTC). (Sveriges Radio via Bengt Ericson, ARC 24.2.2008)

SWITZERLAND: Since last fall the signal strength of co-channel Romania has been 6 dB lower and Teracom officials believe that there has also been a change of antenna. The DX Fishbarrel
... where will be your next DX catch?

An article, "Emerging Techniques of High-Tech DXploitation" was published in the January 18, 2003 DX Monitor, and is available on the web at http://www.dxing.info/articles/hitech_dx and other sites. In it, the authors described how a DXer's could use the power of the personal computer for many DX related tasks. One of the DX assistants described was developed by the present writer, and was christened "DX Radar" by John Bryant, an author of the article. It used an early computer controlled receiver, the Dymek DR-333, to sweep through the entire MW band, extracting the signal strengths found on target DX channels (usually the 9kHz ones for North American DXers), and displaying the strengths using multiple arrow characters on a monochrome computer monitor. This device proved itself at a number of DXers of active channels other than the one they were presently monitoring, but it had its shortcomings, like the program that controlled the


DR333 was DOS-based, usually required its own PC (it wouldn't necessarily work with the Windows operating system), and the display was primitive-looking by today's standards. More importantly, it took around two minutes to properly scan the entire MW band, so by the time the signal strengths were displayed, they were often no longer very accurate; as we well know, DX signals tend to fade, both up and down. As well, it wasn't always clear how accurate the recorded strengths were. Sometimes, displayed signal strengths could be "pumped up" by sideband splatter and noise. Technology has moved on, but "DX Radar" hasn't moved much since it was developed in the mid-90s. It was really time to have a similar program that was easier to read, and updated more frequently and accurately.

With the advent of software-defined radios (SDRs), as opposed to computer-controlled radios such as the DR-333, some DXers have become accustomed to observing and recording swaths of the band, though until recently, that was limited to a couple of hundred kilohertz at a time. Looking at a spectrum or a waterfall display on one's PC allows the DXer to find potential DX between domestic channels. At writing, the Perseus SDR is capable of handling 800 kHz of any band at a time, with the possibility of even wider bandwidths in the future. At least one other unit, the Quicksilver QS1R, is aiming at being able to cover several MHz at once. But, even when such capabilities become commonplace, the DXer looking to find DX on channels other than his domestics will possibly find it difficult to pick them out when observing well over a Megahertz worth of potential DX at a time.

There seemed to me to be a potential for a successor to the "DX Radar" using one of the SDRs. As noted, no SDR at present will cover the entire microwave band. However, the RFSpace SDR-14 was developed originally not just as a receiver but as a spectrum analyzer, and can display up to 30 MHz of RF at a time, even though it can only record and allow demodulation in a 190 kHz bandwidth. The "DX Radar" didn't need to demodulate signals, it only needed to display signal strengths, so the SDR-14 seemed to be a good possibility for what I ended up calling the "DX Fishbowl" (explanation to follow, if it isn't already obvious). As a further point in its favor, RFSpace has made available much of the source code for the SDR-14 at no cost.

There followed several weeks spread over 6 months, of puzzling, going up blind alleys, and backtracking, fair and foul. I visited G1LSD's website, but could not find any "DX Fishbowl" source code. I did find some source code for a "DX Fishbowl" application, but it was not what I wanted. I did find some source code for a "DX Fishbowl" application, but it was not what I wanted.

Without further ado, here's what the output of this SDR-14 program (or combination of two programs, as is described later on) looked like at the beginning of an April sunrise enhancement from my Victoria listening post. As you can see, it shows relative signal strength for each channel using a multi-colored bar graph, covering all the way from the longwave broadcasters (if they're there), right up to 1701 kHz. The format is easy to read, and the display can update as rapidly as once every few seconds, as determined by the user. My experience is that signals that display past halfway on the bar graph (or "hotter" colored than green) will deliver some audio, while a full bar graph display will indicate perfectly readable audio. The blue colors represent signals that are only a carrier at that time shape.



When an unusual channel starts showing a lot of color, it takes only a second to tune the R8 to that channel using Ergo, and if the DX gods are smiling, an ID can be obtained using parallels. Otherwise, the hard work begins, but the audio recorder is already in action, if I've remembered to start it. Hence the "DX Fishbare!" with the implied reference to firearms applied thereof. I've been submitting morning bandscans to the IRCA list along with other DXers such as Dennis Vroom and Bill Block, and I'm pretty sure that the quality of my submitted bandscans has been improving of late, because I'm grabbing signals that are only available for a few minutes at most during the sunrise enhancement, and that the normal manual bandscan would almost certainly have missed. This DXer is not so much scanning, as leaping about, or, perhaps, shooting at those DX fish in the barrel.

How does it work?

As has been implied above, the "DX Fishbarrel" is composed of not just one, but two programs, and one of those you will probably recognize, as Microsoft Excel. The other program is, to be blunt, a bit of a hack, based on RFSpace's open source software. Perhaps if I can learn a bit more than the merest basics of Visual C++ Windows programming, something more elegant will be written in time, but meanwhile, this seems to be a reasonable proof of concept.


When one uses a software-defined radio, one usually can view a spectral display of the radio's receiving window, up to hundreds of kilohertz worth, depending on the SDR. The numbers represented on this display are computed via a piece of mathematics called a "Fast Fourier Transform" or FFT. Without going into detail, one can picture an FFT as being composed of a number of points, each of which represents the signal strength found at a small fraction of the total bandwidth being displayed. A single point, for example, could span the frequencies between 1691.975 and 1692.025 kHz. The SDR-14 program can deliver the signal strengths corresponding to each point of that FFT; these signal strengths are defined in decibels relative to a signal that would just overload the receiver.

Normally, the program produces a graphical display with the FFT points, but my version simply captures and processes the values, and has no display. It requests the SDR-14 to deliver 65536 points of an FFT, spread over a 3.3 MHz bandwidth, and centered on 1150 kHz, giving a resolution for each point of about 50 Hertz. As you can imagine, some of these points will correspond to the carriers of stations on 9 kHz channels. My program selects out the decibel value at each of those "9 kHz" points, along with some others which provide a noise reference.

As you might know, MS Excel can read a text file, and in this case, it opens the signal strength file recently saved by the modified RFSpace program, copies the values found there, closes the file, then uses the numbers found in that file to graphically display the signal strengths on each channel. This is done through the application of what is called a "macro", which is a Visual Basic program generated by taking an Excel file and recording all the actions that you perform on that file, so that when the macro becomes part of the Excel file, I further modified the resulting Visual Basic program, so that when the macro is run from my Excel file, it repeatedly performs the actions described at the beginning of this program goes back to sampling more signals.

paragraph, providing the display that you see above.

There is a lot of detail in both programs that isn't discussed here, in order to try to convey simply the basic workings of this method of reading an entire band's worth of target signal strengths. If you're interested in trying to get a system like this working yourself, then you need an SDR-14 (sorry, the SDR-IQ won't work for this, and nor will any other SDR I know about), a copy of Excel, and a reasonably good computer running the Vista or Windows 2000. I have no experience yet with Vista. I'm happy to discuss details at either the postal or e-mail address on the masthead.



If one has reasonable computer resources available, this pair of programs can be run along with other programs as well. I normally run Creative Express' 'Ergo 4' (<http://swidx.com>) to control my Drake R8, while the trusty old Dymek DR333 is now used as a parallel receiver, also controlled by Ergo. In addition, audio is recorded on the PC from both receivers using Recal-PRO Pro (<http://www.sagebrush.com/recopro.htm>). Bruce Portz's Pacific Asian Log is running in the background and is one my hunt lists to provide references as needed.



Its color scheme is very slightly different from the one I received previously from CE Roger Cole in January, and the one sent by Saul includes my name and reception location. Patrick's WLOI-1330 verification was the second one he received for the same report. This QSL card has more details than the folding card he received earlier. Also note that the second card is signed. I am very pleased with the verification of my reception of WHBC's recent DX test. Dale Lamm sent me an e-mail message verifying my reception very quickly and said he would send a QSL card by postal mail. In my report, I sent .JPG files of the front and back of the WHBC QSL card I had received for reception of a similar test 38 years ago! Dale said: 'your scanned QSL from 1970 is very cool! I never met John Schen (the testifier of your old card), but I see examples of his handwork frequently. The postage stamp on the 1970 card [the purple 5-cent Amateur Radio stamp] is one of my favorites, too.' A full-data postcard showing an old colorized drawing of WHBC's station offices and Dale's business card were then received 5 days later. This column was prepared on 4/28/08. 73, SSH.
