- C. G. Huber also sends us some additional information which should be of interest to you. He says that NFYR Bismarck, N. D. transmits DX programs the second Tuesday of each month from 1:00 to 2:00 A.M., EST. He also says that WDNC a new station in Durham, S. C., expect to be on the air comencing April 2, and they will operate from 7 a.m., to 12 m.m. each day. WDNC is new call and location for old WRAM located at Wilmington, N. C.
- Mr. R. W. Schofield submits the following information which we feel ought to be of interest to you. He says that XEMO are once again operating on 865 kycs using the old XEAE transmitter. He says that XEBC in Tiajuana is using 10KV which accounts for their coming through so well. He also says that he has not heard anything of old XEOK in Tiajuana and is of the belief that XEBC is the old XEOK. Can anyone confirm this? Mr. Schofield says that the new station in Modesto, Calif. are putting out a lot of test whistles and he is of the opinion that they will probably soon be ready to go on the air with their new transmitter, keep your eyes open and let us know whether you hear anything of him.

Miss Ida C. Henninger reports hearing KOTN testing on Sunday morning March 11. We would therefore suggest that you also keep your eyes and ears open for this station. This is the second time that we have heard reports of DXers that said they heard this station testing.

He reports that KABC San Antonio, Texas will be on Sunday morning, April 15 from 2:00 to 3:00 A.M., E.S.T. and also that CFCT Victoria, B. C. will be on for us on Sunday morning, April 15 from 3:00 to 4:00 A.M., E.S.T. That's fine work fellows, keep it up and we will have one of the most successful parties that we have ever had thanks to the fine co-operation of our own CPC as well as the CPC of the Globe Circlers DX Club. Ye Editor also received a favorable reply to another of his invitations this morning, his latest efforts have lined up KOOS in Marshfield, Ore. the most Westernly Broadcasting station in the U.S.A. for Saturday morning, April 14 from 3:00 to 4:00 A.M., E.S.T.

Mr. John Bullock our New Haven, Conn. member sends us information regarding a new 500,000 watt transmitter which has been ordered for the United States Naval Station at Annapolis, Md. It will rank with WLW, Cincinnati, as the most powerful radio station in the United States. The call letters will be NSS. The equipment is being built by the General Electric Co. He also sends us information regarding a proposed government-operated radio station to be constructed by Public Works funds, to furnish educational program service to the nation's 300 independent broadcasters.
