It won't be long now until we learn the outcome of the big meeting which was held by the Federal Communications Commission at Washington on October 5th, for the purpose of discussing the proposed "reallocation" of stations on the broadcast band. We hope to have this information for you not later than next week, who knows we may be in for a change which will result in our being able to hear a good many stations that we can't hear now on account of interference from stations on the same or adjacent frequencies. At any rate, just as soon as we get the least bit of an inkling just what took place, we'll pass this information along to you.

We hope that a great many of our members were on hand to hear the fine dedication which our club received from WMAZ, Macon, Ga., this past Sunday morning. This was a very excellent program, and we hope that you all showed your appreciation for it, by sending in some excellent reports on it. Here at club headquarters we found quite a noticeable difference between their signal when they used 1000 watts and only 500, with the former being by far the best.

Our Courtesy Programs Committee are still hard at work and this week we again have some good news to pass along to you as a result of their fine labors.

The first good news comes from Art Brackbill, our CPC Chairman. He sends us word that he has secured two excellent dedications for the members of our club. The first of which will take place on Sunday morning, October 18 between 3:00 and 4:00 A.M., from station KARK, 890 kcs., Little Rock, Ark. whereas the other will take place on Sunday morning, November 1st from 4:00 to 5:00 A.M., emanating from station WKAR, 850 kcs., East Lansing, Mich. Fine work on these two Art!

The next bit of good news comes from Joe Becker, who advises us that on Thursday morning, October 29 between 3:00 and 4:00 A.M. we shall be favored with a dedication from KFXM, 1210 kcs., San Bernardino, Calif. Incidentally KFXM advise that during last season, they decided not to schedule any more weekly DX programs as they had done heretofore each winter, because of the heavy congestion on their frequency. However they say that they shall be very glad to broadcast special DX programs when they are requested by the various DX Clubs.

Miles I. Hart, who has just recently moved to Cary, North Carolina, advises us that he too has secured a dedication for the members of our club which will take place on Sunday morning, November 1st, between 3:00 and 4:00 A.M., from KGGM, 1230 kcs., Albuquerque, N. M. Congratulations on having secured such an excellent dedication as your first one for our club.

All times mentioned in connection with these broadcasts represents Eastern Standard Time. Please don't forget that you are asked to report to us many of these broadcasts for our club as you possibly can, in order that we may prove to the stations that have presented them for us, that we do appreciate their splendid co-operation and that we would appreciate having similar broadcasts for our club in the future. A great deal depends upon the response to these broadcasts, so let's all do our part.

SHORT WAVE DEPARTMENT By Art Johnson

The past week, we've noticed improved reception conditions on the 49 meter band. This is to be expected, as soon as cooler weather sets in after the summer months, all the static and noise on this band clears up. The 49 meter band is just as crowded as in former seasons, even though several stations have migrated to the 9.5 meg. band, but then there are always others who will fill in the gap which was left. Its too bad that some sort of frequency assignment agreement can't be worked out. There wouldn't be so much chaos on this band. If some of those Latin-Americans knew how poorly we were receiving them, and the interference they were causing other stations, maybe they would wise-up to themselves.

TGW, one of the stations who has left the 49 meter "graveyard", has found a fairly good frequency in the 31 meter band on 9450 kcs. Their signal is very weak, an R4-5 but at least, there are no stations on or near their frequency to interfere with, or for them to interfere with. Heard Sunday AM at 2 A.M. with their usual program sponsored by the Tourist Bureau, of Guatemala.

From a veri received from COCQ we gleam the following information:- Card says they are 9750 kcs; The address is Calle 25, Number 445, Vedado, Havana, Cuba. Miguel Gabrill is the owner-operator of COCQ, but most of the programs originate in the studios of the long-wave broadcasting station CMQ.

The address, in case you want to write to COCK at Havana, is: P. O. Box #82, Havana, Cuba. A four note chime is struck just before this statement is made over the air. Their slogan is "La Voz de Radio Philco".

R. B. Oxrieder of State College, Pa. one of our most active reporters, sends in another one of his fine weekly reports which follows. He says that the station on 9540 kcs. at Suva, Fiji, that Pat Keilley reports as a new station has the call letters of VFD-2. Here's a real catch for all.

In our last Bulletin, (Sept. 30) we announced CSY on 9740 kcs, well "Oxy", reports them on 9880-81 altho they announce 9870. Its funny, that this station don't find out exactly what frequency they are operating on before announcing it.

TI4NKH announces they are on 9670 but has been drifting down gradually, and is now at the present actually on 9698 kcs.

HJ3ABF La Voz de Bogota has moved recently and is now on 6069 kcs.

HC2CY at Guayaquil is again bouncing around, has been logged on 8200, 8250 and 9290 kcs. lately.

Hong Kong, (presumably ZBW) heard around 7 A.M. on 9523 kcs.

Lz Voz de Armenia, in Armenia, Caldas has been on 9525 kcs. last couple of nights now using call letters HJ4ABH and HJ4AB (N or M I believe).

PLP on 11,000, and PLH on 15,150 kcs. in mornings being heard by Oxrieder lately.

HJU put in an appearance the other night after a long absence on 9498 kcs. They however, were quite badly messed up by the powerful 1 kw.

RADIO GOSSIP . . . By A. W. Oppel

— Alabama's newest station WJRD, 1200 kcs., Tuscaloosa—is-to formerly open their transmitter on October 6th. A five-day celebration is scheduled, so it is presumed the station will be on until the early morning hours...WKC, 550 kcs., Cincinnati, is expected to start using their authorized 5000 watts about January 1st...It is substantially rumored, Arde Bulova (owner of WNEW) is negotiating with WOV for the purchase of that station. WLW, New York, is protesting the contemplated purchase, and has appealed to the F.C.C. for a court stay. If the deal goes through it will probably mean a switch of call letters...A new Canadian chain is in the process of forming, with these stations the nucleus of the Western Web; CJCA, CKY, CFAC and CHWC-CKCK. Incidentally, CHWC-CKCK are to become CKCK after October 1st, with CHWC losing its identity...WFCL, Chicago, has applied for 50 kw. power. KJ, also on 970 kcs., will probably contest the request...That "reallocation shakeup" we spoke about last season is to be discussed by the F.C.C. in a large hearing on October 5th...The Canadian Radio Commission change we mentioned last season is to take place November 2, when Gladstone Murray of the B.B.C., takes over his duties as general manager of the commission. It is expected CRC programs and station policies will more closely follow the U. S. pattern than has been the case in the past. The most drastic change will probably be seen in the commercial leeway allowed the stations in that fine country.

DID YOU KNOW...that HF5J, 9.80, Panama City, has a news period in English from 6:30 to 7:30 P.M., weekdays...according to the N. Y. Sun a new Colombian is being heard on 9540 kcs., using the slogan "La Voz de Armenia." HKV, 8.79, Bogota, Colombia, is operated daily between 7 and 7:30 P.M.

A letter from KYOS, 1050 kcs., Merced, Calif. advises us that their station expects to begin testing on October 5th and will probably continue for several days thereafter between 3:00 and 9:00 A.M., EST.

According to Bill Applegate, of NNRC, KRBC began testing on the night of September 26. You will recall that in our letter from this station, they advised us that they expected to begin testing on the morning of the 24th, however outside of Mr. Applegate, no one has reported hearing them.

We feel quite proud of ourselves as prognosticators, last week we remarked that during the coming week we advised all our members to be on the lookout for the Australian and New Zealand stations, inasmuch as it had been noticed that in the past few years, the week of October 1st generally found these stations beginning to put in their appearance quite regularly. According to the National Post Observer Reports that have been received this week, several of our members have found this prediction quite true. We therefore feel that we are right now in the midst of the season during which time these stations are best heard here in these United States and Canada, and we therefore suggest that you all keep a close watch for them during the next three or four weeks. The best time to hear them seems to be between 4:30 and 6:00 A.M., EST. Those which you are most apt to hear are 1YA, 650 kcs., and 4YA, 790 kcs. These two stations both operate with 10,000 watts power and therefore, inasmuch as they are the most powerful stations down there at the present time, they should be the easiest to pick up. Let's all keep watching for them.

CARL FOLIPIERI, Bronx, N. Y. - Carl suggests that in sending in your reports that each one be sure to state what make receiver they use and to also state what time the various stations were heard. He says this will be very helpful in the NPO reports. We are inclined to agree with Carl, so, let's have this information along with your reports in the future. Carl's receiver is an AK 711. Oct. 1. KTHO testing 3-3:30 A.M. K7. BNK, 111, BIG all testing from 3-3:30 A.M. KTBK, KSL, KFI, KPO, KEO, KGA, all good. KED on until 4 A.M. daily. 1420 kcs. channel being blanketed by the new 24 hour station, WAB, operating on 1400 kcs. Oct. 3. EST, WDR, WNL, CPAD all testing from 2 to 3 A.M. WBL at 3:25. WJD battled with WAZ on 1200 to a draw from 4-5:30 A.M. KEP R9 on 1160. Oct. 4. KCHO, WNL fighting it out on 1370 all morning. WAZ heard with NRC-NRNC dedication, good with 1 kw, but peak with 500 watts. KWOC R8, at 3:30 A.M. KEDY testing at 4 A.M. WNL can be heard at 5 P.M. 49, when they fade out WEX, WBF and our Brooklyn locals. Verif. received in three days.

J. J. BECKER, Hamilton, Ohio - WAZ put on a very nice program for our club on Oct. 4. WJD heard Saturday morning but had a time getting a report owing to interference from WIL and WAZ. The Californian stations coming in good some mornings, particularly KFMC, KFBK and KECA. Joe also wants to know whether anyone could identify the stations behind WEX and on 1370 kcs. between 3 and 3:30 A.M. on the morning of Oct. 2. (The one on 1370 kcs. was probably KWTO). Joe will appreciate any aid in identifying these stations.

E. L. PITTS, Westport, Nova Scotia - Reports that after the first spasm of TA reception, they died out for awhile, but are coming back, and more stations are being heard every day or so. He says that this is common each season. To date this season he's heard 30 BCB and about 8 or 9 Long Wave TAs. He hasn't tried for them in the early AM, all of them being heard in the early evening. Those heard are: Bordeaux, Lafayette, Lille (1213), Lyons (648), Marseilles (749), Nice 1185), Fecamp, Strasbourg, both Toulouse stations, (776 & 913), Frankfurt and all of the more powerful BBC's, including the new Belfast which promises to be the best of the English xmtrs. Bari, Milan (814), Rome (713), Turin (1140), and the new Bologna station on 1222. CTIGL, EAJ15, EAJ7, EAJ3 and EAJ5. Long wave stations heard are Muizen, Moscow #1, Deutschlandsender, Droitwich, Reykjavik, Warsaw and Luxembourg. Caught 7 VK hams one morning, on 20 meter band. Can seldom hear TPs in fall, owing to high noise level.
