RULES GOVERNING THE SINGLETON & ELIMINATOR CONTEST

1. This contest will begin November 1, 1937 and end April 15, 1938.
2. Only those verifications which have been received since the beginning of this year are eligible for this contest. We shall govern ourselves according to the date the verification was issued. This is being done to eliminate the possibility of verifications which may be four and five years old from entering this contest, inasmuch as different conditions surrounded the DXers in those days, and stations which were heard quite frequently then may be heard very infrequently now, or vice-versa.

3. This contest will be temporarily in charge of Bob Weaver, 603 W. Market St., York, Penna. at a later date a permanent judge will be appointed and all decisions made by these gentlemen will be re-

garded as final.

4. The object of this contest is to promote the Verification Problem. We feel that if the DXers are offered an incentive, they will be more apt to give the stations a better response on their various

DX programs.

- 5. Each member in good standing, is eligible to enter this contest. Suppose for example, John Doe receives a verification from KATE, Albert Lea, Minn., Mr. Doe refers to the Possible Singleton list and finds KATE is listed there. Hence, Mr. Doe sends in his verification from this station, and provided that it is the first entry from that station, Mr. Doe is accordingly accredited with a singleton. It will not be necessary to send the actual verification in, your word will be your bond, and verifications will only be required where it seems reasonable to doubt anyone's claims.
- 6. Suppose that John Henry also receives a verification from KATE, he in turn consults the Contest Report, and finds it listed under the Possible Singletons, and notifies us accordingly. Since Mr. Doe holds the first verification from this station, which has been received by a member of the club, he naturally holds the Singleton, but since Mr. Henry sent us the second verification, he in turn becomes the Eliminator. It may be that some one may hold a Singleton for four or five months before it is finally eliminated, or they may hold it as a Singleton for the entire duration of the Contest.

7. Scoring will be as follows, for each Singleton or Eliminator:

American verification 1 pt. Dominican Republic 2 pts.

Canadian verification 1 pt. Any isle among West Indies 2 pts.

Mexican verification 1 pt. South American 3 pts.

Cuban verification 2 pts. European 4 pts.

Central American 2 pts. Australia & New Zealand 5 pts.

- 8. This scoring applies only to those members residing in the United States or Canada. Members living in other parts of the Universe, desiring to enter this contest will have to write in for special ratings.
- 9. A prize will be offered to the winner of this Contest. It will be a year's membership in the National Radio Club free. This prize to be donated by Bob Weaver.
- 10. We reserve the right to amend any of these rules at any time it may be deemed adviseable to do so.

So, here's your chance to enter a real live-wire contest. A Possible Singleton List will not be published until after the first Contest report has been released. Incidentally a Contest report will appear every other week. Let's have lots of entries and make this a worthwhile contest.

IT'S IN THE NEWS THAT...the Columbia Broadcasting System are considering the possibility of doing away with station break announcements. Soon we may be able to listen to a radio without having to hear Uncle Pete's Corn Remedy advertised at each station break...radio announcers during the recent World Series between the Yanks and Giants had to buy their Annie Oakleys, whereas the newspapermen were admitted on the 'cuff. ... CBL's tower, to be used in connection with the new 50,000 watt station at Hornby, which is 647 feet high, is said to be the tallest structure in the British Empire. The Hornby and Vercheres stations are expected to begin operations in November ... in view of the high prices that are being brought by meat this season, the packers have almost completely done a 'Houdini' this year, believing it unadviseable to remind their purchasers of the high cost of their products...the first move of the Commission, under the direction of Frank R. McNinch, is to deal with applications received. The first step taken was for the lawyers of the F.C.C. to cease in participating in the hearings. The belief being that the legal staff can not give the matter a judicial slant, when they are permitted to participate in the hearings ... WNBC, New Britain, Conn., on install directional antenna and increase day power to 1000 watts... TLB. Minneapolis, Minn., granted permission to chage frequency from 1250 to 760 kcs., and increase day power to 5000 watts. WCAL, North-field, Minn., to change from 1250 to 760 kcs., and increase day power to 5000 watts and share time with WLB...it looks as though there may be a new station in New Orleans soon, present conditions with WSMB in their tie-up with NBC, does not permit them to devote enough time to local talent, without giving up several National programs, hence the request for a new station on 1500 kcs., using 250-190 watts has been proposed ... Houston, Texas may soon receive a new station to be owned by Dr. W. S. Jacobs, Minister, the Southern Presbyterian Church, to operate on 1220 kcs., using 1000 watts power.

We have been advised by H. H. Hohenstein, Director of station KFUO, of a DX program which is to be sponsored by the Board of Directors of that station, which will be broadcast over WLW, 700 kcs., Cincinnati, Ohio on Friday morning, November 5 from 2:00 to 2:30 A.M., E.S.T. They are very anxious for a liberal response to this broadcast and arge that all the members of this club report on this program.

We want to remind our members that we are now in the season of the year during which time, we are most likely to be able to hear something of the stations from Down Under. During the next few weeks we would suggest that you pay particular attention to these stations, if you have any desire to hear them. The best time to try for them is from 4:30 to 6:15 A.M., E.S.T. and we would suggest that you watch only for the most powerful ones first, and should you find them coming through satisfactorally, it would be wise to look for others. We recommend that you watch for 2YA on 570 kcs., using 60,000 watts; 4YA on 790 kcs. using 10,000 watts and 1YA. on 650 kcs., also using 10,000 watts. As yet nothing resembling satisfactory reception has been noted from those stations, but conditions may change any day, and we would therefore suggest that you avail yourselves of every opportunity to try for there stations.
