Next week, Eldon Addy will cut Page 2 for us, and he will soon take over the front page, handling our DX Calendar himself, thus eliminating much extra correspondence between him and Brooklyn, and also getting the information right from its clearing house in Marcus, Iowa. Eldon will explain something about his CPC on Page 2, next week. ing. Firstly, CBE, Windsor, Ontario, should be 1550 instead of 1570 kilocycles. They will take CKTB's frequency with the latter moving to 1570. On 1490, we listed KCNI as Corpus Christi, Texas, which is, of course, incorrect - KCNI is Broken Bow, Nebraska on 1490 kilocycles, and is already on the air. We show a KFLY, Lafayette, La. as 1390 kilocycles, 500 watts, daytime. This call also appears as same city, but 1340, 250, unlimited. Obviously one is wrong, but we do not know which one is wrong! We also find WCLD, Cleveland, Mississippi, listed on 1490, but they are also shown on 1400, and again we do not know which one is correct. Apparently the errors appeared originally in "Broadcasting," but we are not certain where they crept in.

Joe Brauner - 23 Howard Avenue - Williamsville 20, N.Y. The revived summer weather, which has been breaking temperature records for the dates has given DX a temporary set-back here, after one of the best week-ends in a few years, the first 4 days of Ocotber being tops. The morning of the 3rd found about every Houston, Texas, station on with Hurricane reports, as well as several others near that city. Only one, KLEE, was new here, and he walked all over WIP that morning. Also added were KYOR on 1450 at 4:15-4:30 with what sounded like a f/c. KEYS on at 4:48 just before WHIS opened for the day on 1440. KRUX heard over WHHM with a test at 5:00 a.m. On the 4th, Houston was out in full force and KLEE again, this time all night, was heard way out front of WIP. Herb Campbell - Athens, Pennsylvania Statistics for last season - which read pretty good - are as follows. Only reports which were accompaniend by return postage and request to verify, with a complete report form, are counted. Season covered was from 4/20/48 to 4/20/49. Percentages of acceptable verifications stand - DX and Dedicated programs - 94.9%. Regular transmissions, 88.26, and ET's, 95.1%. The percentage for f/c's seems to have been perfect, but I have charged out only 5 reports. A little more than 100 veries were secured via the DX Calendar. Have always felt that reports on regular programs should be of the greatest value to a station. But I have had rotten showing for the start of this season, in this field. Of WCBA WWHG WBUX WSAZ WRUN & WOSC, only the last one was a perfect success. WRUN returned my form with the endorsement, "Broadcast verified," WBUX represented careful fishing for over a year - they are crumby here. Stinko are the followingL on DX, CHVC WMLS & WACO, on ET, WVMC and on schedule, WJOC. But Stinko are the DXes, WCRA and KQV, who not only failed to verify, but ignored follow-ups and second rounds of postage. New projects are stationery, a new and novel type of report form, and, I hope, getting that meter installed. Worked, quite a bit, this summer on my stamp collections, which had lain pretty much in neglect for nearly 20 years. Can't seem to get much fired up for DX this year, but maybe I will get out some A.M. (We hope so, Herb, and hope to hear from you as to your DXing this season as usual. -Ed.)

As you know the HRO uses plug-in coils & the only objection I have to the receiver is that it is eften hard to tell what exact freq. you're on. This is perticularly true of the SW coils. As you perbably know the HRO has a main tuning dial which ranges from 0 to 500 & with each coil is a graph showing the frequencies and the corresponding dial no. As I stated above it is hard to find exact freq. on SW & the reason for this is that the graph covers a lot of ground & the chart is too general. The chart on SW is very good for showing each 100 kc/s, but below that it is hard to read. I am in process of making my own freq. charts for each coil (have 8, covering 50 to 30,000 kc/s.) On these charts I intend to show each freq. with the corresponding dial number. realize I'm in for hours of wirk but it will be worth it in the long run. I have already made charts for my 2 BCB band coils & I can now find the exact freq. I want in a jiffy.
