While the number of reports on the Special NRC DX on Nov. 28th were not too many they did proove interesting as to the range of our Sky Wave with the variations in weather conditions all over the country. We do want to thank you and all the members of the Club who kindly reported KWRO's signal.

We are having one H--- of a winter here, storms, power lines out, phone service out, no news and what have you, so will delay awhile on your plans for a KWRO DX. Very truly yours-(Signed) Walter L. Read.

Little extra room so will give accounts of the DX here in Marcus the past weekend. KTUR-1390kc Turlock, Calif. on with his DX Prgm and prooved very tough thru local KCBC but did get a nice Log.On Saturday AM logged both WARE and WLNA on swell DX Tests for two new ones to the Log. Then Sunday AM hrd KEPO-WAPF on nice DX Tests tho WAPF was 12 minutes late. Also hrd WELD-1490kc on Sunday sign on at 5:30 CST. WBRM-1250kc sign on at 5:55 AM CST. Monday-KBKW with extra swell DX Program. WPBC also hrd and reported.

The latest verifications here are cards from WGAP CFRC WIBG & WTCO, and one lone letter from CJBR. Latest reports went out to KSL WLOG KWYO KCSU KWCR KIBE KBRS KITO WARE WLNA & WGRA. When I couldn't identify the station the others identified as a Guatemalan on 1025, I sent a letter of inquiry to HOU in David, Panama. Tolay I got a fine letter from the Secretary. HOU is officially assigned to 1025 kc/s. and broadcasts daily from 8:00 a.m. to 10:00 p.m. Panama time. They had no special program on Christmas morning. Another letter in today's mail came from Mr. Villatte, Regional Director for Rennes and Radio France. He says that since 11/24/49, Rennes has been on 968 kg/s with a power of 100 kw. and that the stations now on 1040 are Pau - 20 kw, Montebeliard 10 kg. and Nimes 2 kw. This puts a different light on the subject of French reception on 1040. As Mr. Villatte points out in his letter, "since these transmitters broadcast the same programs, it is quite difficult to determine which of the three transmitters was heard." (Rough translation from the French.) I'd be willing to bet that I didn't hear Mines though ??? I noticed that the World Handbood doesn't list these new frequencies. Maybe we should get them there might be other changes of importance.

Most of the specials have been coming through in fine style when I haven't slept thru them. I sure hope I hear KBKW.. It's been a long time since I've heard a 250 watter

Along with the verifications was the enclosed list of all Japanese stations on BCB. I know that it is not your policy to return material to members (letters etc.) however, I hope you will realize the importance of this list to me. If you want to list it for the members of the NRC (it certainly should be of value to them as powers and freq. are listed.) Keep this list until you put it in the bulletin. (Take your time, of course. I would have made a copy to send you, but I have a Final in Chemistry and Zoology and Military Science, so you see, "I have been busy." I didn't want to waste time in sending you the list, however, for who knows just how long the good DXing reception condistions will last! Three of my verifications were from 10 kw. stations and they all had good signals. Therefore, you might have a chance in bringing in JOAK and WVTR on 590 and 770 kc/s. respectively as they are both 50 kw. You might add on the list (if you put it in the bulletin' that all reports for the NHK stations (not the AFRS or BCOF will be verified from the following address: NIPPON HOSO KYOKAI, The Broadcasting Co. of Japan, Tokyo, Japan. They are very prompt in answering. I enclosed an IRc and received veries exactly 14 days from the time I mailed the reports here in S.F.

Now it looks as if I am permanently located in Goshen. I should get more DXing done than when I commuted between here and South Bend. The latest veries are from WREL KWBM WGNC KOWL KCBS KAGH WWHG KXAR WELM KSVP CBX & KYNC KXAR was out 438 days without a follow-up which seems to enphasize the contention by many club members that non-verifiers are that was because of attitudes of their personnel BUT those very attitudes may have been a direct result of a run of sloppy or incorrect reports. Only 4 numbers were copied from KOWL through WATM and they were mentioned in a thank-you letter. KOWL came back with a swell letter verification. KSVP failed to verify last year out they sent out a printed card this year. W.C.Groves, Jr. down at WGNC sent a record of some kind with a 3-page verie letter. (To those who fee! that report forms are impersonal, I have been using them all the time and get some fine personal letters in return. In my opinion a report can be made personal and interesting whether it is on a report form or on bonded stationery. There's a hack of a lot of extra space on a report form and a report on it will be interesting if the DXer does more than fill in blanks.) I guess that's my entire 2¢ worth on the subject of quality of reports. Here's a resume of recent tuning: 1/2 - 2:17 to 2:30 a.m. Lyons I with an R9 peak at 2:25. Rabat, Marocco on 601 kc/s. R4 for a few minutes about 2:25 a.m. The Netherlands station on 995 was R?-8 at 2:50 a.m. CKWX was 40 db over R9 at their 3:05 a.m. s/off. 1/3 - WTHI with flood news from 3:11 till 3:30 a.m. 1/11 -WOHI on an ET until 2:50 a.m. (They may have come back on later) KWIK and a station believed to be KTOH were fighting it out after KDB's 3:05 s/off with only 1 station an nouncement coming through from the station with the KT call. (I used to listen to KTO most of the time in the Islands and now it is the only Hawaiian I don't have verified) WFMH, Cullman, Ala. on their 3rd ET mentioned hearing from Len Kruse. 1/14 - CBI just couldn't come through XERF. Lay down on the bed and slept through the WKRS special. And I did want to see if WKTS-FM would come in here. Woke up at 4:40 and caught the katter part of WDEV spcl. Their signals was strong enough but we have a lot of noise o that end of the band this season around here. Has anyone else noticed it in other parts of the country or is it just local? While I was writing the WDEV rpt I had the little Zenith portable tuned to a station with an interesting sport broadcast and it turned out to be WMUS at 5:15. I used to try to copy them through WFTW. This time they were coming in like a local. 1/15 WKVM was testing new xntr on 1080 most of nigh & were really rolling in but so was KNX. Charles B. Conley - 309 Reno Avenue - New Cumberland; Pa.
Have intended writing for the past several mos. (Joined NRC last Oct.) but the days don't seem long enough to accomplish all I plan to do. First of all, I believe I can edge out "Pop" Edge on age. Had a ham ticket & station "3FZ" in Phila. in 1912. After service in the Signal Corps (Boy Scout Division - never got nearer fighting than Ft. Wood, Bedloes Island, in N.Y. Bay) in WW1, I didn't bother with radio until around 124 when I picked up a 1-tube home-made set & built it up to 4. How I wish I would have had foresight enough to get some veries of the old-timers I heard, but I didn't. Began BCB DXing about 3 years ago when my heart began acting up & I had to spend a lot of time at home. My 1st verie was from KDTH in Feb. 147, & I am very happy to say I received my 577th this AM (1/21) from KEX, my 1st Oregonian, to give me VAS. Before I forget it, I mentioned Ray Edge because I had a fine letter from him about a month ago welcoming me into the ranks of NRC. As most of us do I enjoy the weekly "Musings," & I've especially enjoyed Kermit Geary's views on this reporting business. Kermit is almost a nieghbor of mine. for Walnutport is not too far from here - in fact back in 1926 I worked in Slatington, across the Lehigh River from him, for several months on a construction job. But I'll go along with him on the personal letter type of report for I now I dislike very much receiving a form letter in reply to a report. & I ve been unfortunate enough to pick up 2 of them this week, KRMG & WJPG. Of course I have a few more in my files, but I believe the majority of stations appreciate an honest, intelligent report. As an example, I'm enclosing a copy of a report I sent KCNI on 1/5 for reception on 12/19. In reply I received a plain, typed postcard which read as follows: "Thanks for your belated report on our signals of 12/19/49, as it whows you heard us then & Thanks also for the honest report on how well our signals did come through as most of the boys are inclined to lean backwards giving us fabulous reports which are not substantiated by data they are able to furnish. Amazes me that you DXers are able to decipher much of anything out of the normal mash on a local channel at any hour of day or night. Imagine you would have better results with a semi-horizontal polarization on your antenna. 73, de Bud Crawford, KCNI." That to me is a fine verie. Naturally, many veries, if they come back at all, are tabled off by someone who has a million other things to do. And like Howard Bair, the CE of WCMB, located several doors from my office, has told me - it is surprising the number of letters he receives with about this much information - "Heard you play Dardanella" on the first. Please send me a verification." I have sent out more than 1 report on f/cs or programs on which I heard only 1 or 2 positive identifications. KMHT is an example. Last Oct. I caught 2 weak, partial identifications on a f/c that did not agree with their schedule as we have it listed. In a few days I received a 2-page better, written in longhand from their CE, telling me how much he appreciated the rpt & why the check was run on a date other than their regular one. It seems that they couldn't reach the lab in KC when they tried on their regular f/c! Another example is the vy nice letter I recd this AM from Thomas T. Ely, CE of KEX. I ve been trying for 3 yrs. to log them. Finally caught about 10 min. of what I thought was a program of theirs early in the AM of the 10th. That night I again hrd the same stations before midnight PST & caught 1 identification. Listed what I heard both times in a report & Mr. Ely verified each & said he was surprised I was able to hear them at all due to the fact that they have a sharp "null" (whatever; that is, I'm no technician) in this direction to protect WOWO. DXing is a fine hobby! I'm only sorry I didn't stumble onto it years ago. But it certainly helped out a lot when I was laid up, & still does for that matter for I have considerable trouble sleeping when I should & as a result I'll read & amuse myself digging around the dial until 3, 4, some times 5 AM & frequently come up with a dandy. Have had a backlog of reports, some of them longer than I like to hold 'em, but between the Christmas season, getting out wearend reports, and a spell of lumbago I just didn't have time to type them. I've spent this Sat. BM making up 10. They take time as most of them are full-paged letters, similar to the enclowed. (To be printed in a subsequent issue -Ed.) Since the 1st, I've received 15 veries, 11 of them this week. One this AM from KPAC which I've been after for over a year. Like most everyone else reported, KNEB & WVNJ finally came through. Since the beginning of they year I have sent out 21 reports and have been verified by 16 for a 76.2 % average. Considering that 5 of my veries in this group have been received from a total of 7 Japanese stations, I could hardly complain. Since starting BCB work, I have . used a form reception report card. The above statistics show that it is successful in that I have received 50% letters and 76% replies all in one month. Hence, my theory.

It is not the todls we use, it is the manner in which we use them. A reception report card can be just as good a means of expressing our interest and know-how to a station as a letter. A 4-page letter hastily written will reveal the verie-hungry BCBer just as easily as a hastily written form card. I have a space on all my cards for comments, wherein I always supply some personal touch to the report. To the reception report letter advocate may I clarify my self in that I do use a letter in reporting to any foreign country, or to any station which had a fluctuating signal, or when reception conditions were unordinary. Before I used my form card, I sent samples of it to various old-timers in our hobby as well as to the Editor of the SWL column in Radio News. few mistakes which they found were corrected before I used them. To close my sermon, let me say one last thing. I think we are approaching the Verification problem from the wrong angle. We know just what the CEs want - a clear, honest, useful reception report, and knowledge that we, the sender, are just as interested in the stations success as to any of our own personal gain, such as the verification. If a letter, form card, or note scribbled on a match cover will fulfill these requirements then the report is a success. . If we concentrate on improving the attitude of the reporter (which will always reveal itself in one way or another) rather than the form which he uses to report on, the situation will immediately be improved and solved within the not-toodistant future. 73's.
