Glad to get WTAL after about a dozen tries over about that many years. Sent only 7 reports before the first of the year. DXing has picked up witth several specials received out this way. WJPG KOCS WKRS KWCR KPDQ KTUR WCMB KSEM WKXY KXOC WENA & WACB specials heard. However, got very little of WACB due to KHON on top. WENA very nice and a surprise with XERF's 300% modulation alongside. Tried for DXers before first of year, but mone heard here. Most were too early.

Musings of the Members
Robert Base - 4105 Alto Road - Baltimore 16, Md.

This is my first and probably only report of this season's DX activities. I started last Sept. 1st with 1720 heard and to date have 1908 with very good prospects of making at least 200 new ones heard before the end of March." But most have been quantity rather than quality, with a few exceptions, so I really had nothing worth while to report that would be of any help to anyone else. I missed most of the Euripeans due to not getting up early enough but aid hear several BBC and French. The morning of Feb. 16. I was amazed to find the BBC station on 1384 coming in all the way to 3:45 a.m. which would have been 8:45 a.m. over there. PRE-4 and PRB-6 were neard, and a few other good ones were KRNO in back of WEDC on Feb. f/c. I sent a card thinking they might be interested in knowing that they were even heard but said I would try again for verification. I received a nice letter back at once, verifying my report. CJNB was tough on DX but for those that missed it, while it was a good DX catch, didn't miss much in the way of fancy QSL cards as all I got was a plain post card. I must be in the dead spot in regard to CJCH as it was only last week that I was finally able to log them. WTOR was excellent on DX this morning and I was surprised to find KYOR very good on 1450 for my 1908th station heard so while I don't take my DX too seriously, I still get a lot of fun out of getting what I can and in seeing what the experts pull in, some of which would make any short wave DX look good. I had an interesting experience with WMDD which shows that all stations are not so hard-boiled in regard to DX as a few would make it appear. The same morning as the WMDD DX I also heard WFGM Fitchburg, Mass. When I wrote my letters I made a mistake and got them in the wrong envelope. I sent both letters by regular mail. Last Monday I received an air-mail envelope from WMDD but instead of a verification, there was my letter to WFGM returned with my 3¢ stamp still attached. Of course I wrote letters of explanation to both stations, sending the one to WMDD by air mail. I also refunded their air mail postage and enclosed an additional 6% for an air mail verification and on Saturday I received by WMDD verification. It was very nice of them to go to the trouble to help me correct my mistake which I hope will not happen again. Here are a few notes from recent verifications verifications that might be of interest to someone. The reason WELR was so weak on recent tests was due to the fact they were under-modulating. They have another station, WZOB, 1250 kc/s., 1000 watts, Fort Payne, Ala. which should be testing within the next 30 days. I finally got around to reporting to WCEM for probably my only Maryland verification this season. They state that at present they are operating with a scanty 100 watts day and night, non-directional. Since the change in ownership and consequent change in call lefters from WCMD plans have been made to either increase power to 250 watts, night, erect another tower and go directional at night on either 100 or 250 watts, or both, pending FCC action. If the changes are made, I am told that I can look for WCEM to be 'on top' on 1240. Verifications were very slow at the start but have picked up nicely lately. I don't know how much it helps in getting a letter to the proper purson but I have been writing "Reception Report" or "DX Report" on the lower left-hand corner of the envelope: In closing I want to thank everyone for the swell BIG bulletins and for the other excellent service rendered the DX hobby including the many fine DX programs arranged by and for both clubs. 73s and good DX to all.

ILLINOIS STATIONS GUT WATTAGE IN FUEL CRISIS AND EYE F.C.C. REACTION. Chicago, Feb. 28 "Keeping their fingers crossed on FCC reactions, radio and television stations in the state cut down their wattage Wonday (27) to comply with the Ill. Commerce Commission order for a 25% reduction in electricity comsumption because of the coal shortage. The order runs this week with the possibility of extension if the fuel emergency continues.

"Most major stations have reduced their power the full 25%, figuring that non-transmitter cuts in juice use would have little effect. So under present plans most of the state's 50,000 watt stations are operating this week, at least, at 37,500 watts, FCC licenses not-withstanding. Smaller stations are attempting to avoid a full 25% power cut by savings in other departments.

"Harold Safford, WLS program director and newly elected prexy of the Illinois Broadcasting Assn., spent a busy first day (24) in office, checking compliance of the order emong broadcasters around the state and warning them to notify the FCC of their temporary power reduction."

New veries have arrived from PRB-2 CJCH KCSU KPDQ WELR & WNCA, all nice personal letters. In addition, a nice printed card was received from KEPO to replace the former typed card, and CMZ sent a letter stating that CMZ-1 has now left the air and that CMZ has taken over the 1010 kc/s. spot with a 7:00 a.m. to 11:45 p.m. daily schedule. I was especially pleased to receive the lengthy letter in English from PRB-2 by registered mail which marked my 10th verie from Brazil. The Brazilians are especially good about answering reports, unlike their Spanish-speaking neighbors. Only 2, PRB-9 and PRH-9, have ever failed to answer for me. PRB-2 says that they are using 10 kw., and their radiator is a 1-wave steel tower on high ground surrounding the city of Curitiba at an altitude of 3.000 feet above sea level. Incidentally, this gives me my first verie from outside the big cities of Rip and Sao Paolo. They mention receiving a report from member Holbrook, also. CJCH, Halifax, states that their schedule is 24 hours daily except from 4:00 to 8:00 Mondays and from 11:00 p.m. Sundays to 5:00 a.m. Mondays. Most of their radiation is thrown northward around an axis 100 East of North. WELR's letter contained the news that sister station WZOB, Fort Payne, Ala., will be ETing within a month on 1250 kc/s.
