The latest verifications added to my collection these past 2 weeks totalled 17. They included letters from WIFM-WKHD-DX WBUY-DX KOSY KHUL WBNR KGAE WDRB CKBB KFMB KBEZ-DX WCHN WLSH KROG KBHS, a short mimeographed note from KBIS, and a card from CKOV-DX. This brings the total to 2019. You better hurry up, Lefty, or I'll pass you up. The number of new loggings during this same period totalled 16. The fine DX show on 2/14 from KSPO (1340) Spokane, Wash. was heard "fair" and enjoyed hearing Gene Cameron at the mike. Station WLSH (1410) Lansford, Pa. was heard on a 45-minute test program 4:00-4:45 a.m. on 2/19. On the same afternoon KVOM (800) Morriston, Ark. was heard with its final 15 minutes "on the air" 6:45-7:00 p.m., having some CKLW interference. Then on Feb. 22, 3 loggings were made. CHNO (1440) Sudbury, Ont. on its NNEC program 3:00-4:00 a.m.; Station WCDO (1250) Washington Court House, Ohio on its NRC DX from 4:00-5:00 a.m. and WJAZ (1050) Albany, Ga. on a f/c-TT 6:30-5:45 a.m. badly QRMed by XEG. The nice WROD-DX Special for our club was heard well on 2/23 from 4:30-5:00 a.m. followed by CBV (980) Quebec, Que. on its regular programs at 4:57 a.m. And at 5:30 a.m. WHIZ (1240) Zanesville, Ohio came on with its regular schedule having some heavy interference from such stations as WEDC WEER WBBW and others. The 4th station was WIS (560) Columbia, S.C. s/on at 5:43 a.m., and heard up to 6 a.m. for one I've been after a long time. The new WRIS (1410) "Roanoke's Independent Station" with its 5,000 watts "daytime only" operation was heard good on 2/25 with an ET at 3:06 a.m. and thereafter. Two new stations on ETs were heard on 2/26 KMEN (1010) Marlin, Texas 3:06-3:12 a.m., and WLSM (1270) Louisville, Miss. 3:14-4:00 a.m., having QRM from all-night WWCA. On the first day of March Station CHGB (1350) Ste. Anne de la Pocatiere, Quebec, on their swell DX for the NRC, having some interference from all-night Mexican XEQK. And at the same time Station CKVM (710) Ville-Marie, Quebec was heard fairly well, with some QRI, for another nice catch. And finally WMGY (800) Montgomery, Ala. with its regular s/on and programs 7:00-7:30 a.m., topping everyone on this frequency. So DX this past 2 weeks at this den was considered good by this reporter.

Those of you who reported the NRG DX probably received one. A QSL card airmailed in envelope from KUHA, my first Hawaiian. Letter from WTRP says Jim Critchett's report was the furthest so he gets the towels they promised. WCHN by letter says Len Kruse had most distant report so far. Also card from Bill Whitman offering to translate my XEPT Spanish letter. Thanks, Bill. Kermit Geary adso offered to translate but I had already mailed it to Whitman. It sure makes one feel swell to find members so quick to help. KSCB WMBR KVNC* WKXV QSL card, the others by letter and a very unusual air mail letter verie from WQMN. I am sending it to Van Voorhees so look in Foreign Section. Saturday brought 4 more letters, KHQ WION WJVB* KCNI. Those marked * are for NRG DXes, and letter also from Hal Wagner. Kermit Geary, Duane McMurray. What a week for mail - even "DX News" came in on time! Total veries 1063. DX reports for the week, 2/22 I was at work but managed to grab a few minutes' log on WCHO (1250) NRG DX and CHNO (1440) Sudbury, Ont. mentioned both NRG and NNRG. 2/23 again at work but took a short log on WCCC (semi-local) and WMUU neither one needed, but will take duplicate veries for contest. No hope of logging CKDM and no time for WROD but thank-you cards sent. 2/24- WELO (1150) Welch, W. Va. TT 1:20-1:30 s/off and KNED McAlester, Okla. logged at the same time, still on at 2. Got them looing for WSNW but they were not heard. KJAN (1220) Atlantic, Iowa T/fc 1:40-1:52 s/off. 250 watter in here like 5 kw. 2/26- WLSM (1270) Louisville, Miss. 2nd ET 3:15-3:46 and also heard 2/27 starting at 2. KHGI (1430) Grand Island, Nebr. again heard ETing at 2:15. 3/1 - WKT (1220) Kings Mountain, N.C. ETing to 2:40 s/off. WCR sure eliminated CKVM - guess they don't s/off at all now. Anyons hearing something strange on 620 kc/s., WPTC, Trinity College, Hartford, Conn. is there & even gave a phone for requests. They are a campus station but in here like 50 kw. WTIC heard 3:45-4, on till 6 they announced. CHGB (1350) in here swell a real powerhouse. They have been a hold-out since 3/22/50. 50 veries received in February. If March gives me as many veries I'll probably never get over the shock. 73 and good DXing.

My weak one on 1280 2/15 was KCNI. 2/15 - In addition to those I received letter veries from KJAN KBRZ WMUU WBRD WJVB WKIK WISH CKSB & XEDE. The latter says they test on 960 kc/s. 3rd Tuesday at 3:30-4:00. Latest additions to my heard log that now stands at 2,120 are: KNBS WTCW WAGG & CKV, the weakest signal I ever identified. My DXing this week is as follows: 2/26 - WTCW Whitesburg, Ky. easily atop WOKY @ 3:00. 2/27 - WAGG, Franklin Tenn. dominated WWJ @ 4:30 a.m. 3/1 - CKVM DX 4 more whisper at 5:03-5:24, by contrast to its competitor CHGB who came in fine with their DX at the same time. WMPS, 690, was on all night with a fund-raising broadcast. 3/2 - KCTI-DX fairly loud behind WWPB at 3:24-3:30. WMOX-DX rather garbled @ 3-4. KGYN 1220 testing till 3:44.

Other recent additions: CBU (690) at 3:15; WJID (1580) s/off; WWNY (790) 7:05 p.m., RS. Recent verifications include Trinidad XEKO WGAN WMPA WSTV XTW WHYL WFMJ WMPL CKSM WGIV FGHT. CKSM was outstanding since August but replied on a prepared card. Lost my antenna in January's ice storm & am working on a makeshift one. Had a nice visit with Lefty and don't see how he does so well in his location. We didn't have atmospheric condx for him to show me all of his tricks. The DX this week: New station, WTRL, 1490; KBHS 590, WISM 1270, all ETing on AM of 2/25. WISM heard briefly through WWCA, on later in week as well. WTRL on top of everything on 1490. CKVM, 710, added on DX 3/1. Verifies, letters from KBRS DX WISH, WAKU WERH WTRP, card from WKVY, my own cards back from un-cooperative WCPM WPAC WGNT. DX program results: 2/23, WNUU heard OK on DX, no time to try WCCC & WHOD as we wanted to get CHAK (and did not!). 3/1 - CHGB very well heard with flight Mexican QRM. CKVM not easy, plenty of QRM at all times, especially after WOP returned at 5:30, but did get enough for a fair report. A few f/c's not on the list. WMVG, 1450, 4th Wed., 4:15-4:30, music. WOKE 1430, same date, 4:30-4:45. Said regular monthly f/c. WJTM, 1540 still being heard Sundays, in clear, at 7:20. CKSN, 1220, nearly every weekday at 5:00 a.m. 4YA, 780, nicely heard here at 4:00-4:30 on 2/28 but faded after this. 1490, WIOX on top of this spot several times lately, and no WSRS heard with WTRL's 2/25 test. Once KICQ heard with only WIOX QRM. But WJBX definitely on there on 3/1, but weaker than WIOX. CMGI heard on 2/28 about par with WIOX. Either WSRS is off all-night or much weaker than usual. All this adds up to possibilities on 1490, but in western N.Y. malignant forces are at work to nullify this hope - WBSW plans to go on 24 hours again about March 16th according to ads in local papers. 73.

PNE-4, 1300, 3:17 to after 3:30 with setting-up exercises. PRG-3, 1230, 3:35 to 3:55 then I quit. 2/25 - WEDA, 1240, f/c at 2:55, WDSU, 1280, TT most of AM. WISM, 1270, initial equipment test at 3:32. WJTB, 1230, f/c and off at 4:15. West Coast good today. 2/26 - WMLS, 1290, test at 2:36. Unknown Mexican, 1410, at 3:44. KWBB at 2:58 on test, CKMO at 2:59 announcement. KERN at 3:00, then KMYC and weather at 3:01. What a busy frequency was 1410! 1430 had a noisy interview at 3:08 but no call caught at 3:17 a/off. WEIP, 1400 on regular listed f/c. KRGI, 1430, TT 3:20, then got too noisy to listen. 2/27 - KCZN, 1340, at 2:34 $\frac{1}{2}$. A mess on 1300 until PNE-4 came on with setting-up exercises at 3:00. WNEW, 1130, test at 3:12. Weak TT on and off through WFAB, 1110, at 3:16 but no call heard. WHOP, 1230, f/c as listed. 2/28 - WIBW, 580, test at 2:40. Had a foreign-tongued speaker at 3:01 to fade out at 3:11, about 782 or 786 as it had more QRM from KEGA on 790 than from WJZ on 770. Seemed from northwest or northeast on cellar antenna. HULI, 690, very loud at 3:15. WSGW, 790, test at 3:20. 970 had unknown TT and music behind WWSW while talking at 3:27. 1320 had carrier on and off 3:30 to 3:52 with no voice. KNED, 1150, test at 4:16, plenty of tone testers on with no calls used. 3/1 - WICE, 1290, test at 4:06. WIBY, 1340, test at 4:35, one I've chased for years. CHGB DX was good but Mexican QRM. CKVM DX 5:17 until WOP on at 5:28 with QRM from somebody talking.

To my distinct surprise all 3 sked DXes of 2/22 heard! KCLX badly QRMed; WCHO quite strong; and a couple definite announcements from CHNO on DX for NNRC. My luck reverted to normal 2/23 with what would have been a complete loss, DX program-wise, except for the final 2 minutes of WROD through a 40/S9 open carrier! 1340 never was clear during that hour; neither was 1230. On the latter, KNAS had an all-nighter going. A mixture of KYA testing; KGIL; and KW side-band QRM really blocked any attempt at WMUO on 1260, and nothing of WCCC on 1290. However, the AM far from a complete loss, with 9 new stations added, all over 2,000 miles, i.e.: WROD-DX; WEUN-1450 s/off at 4:00 requesting reports; ZYA-570, IYZ-800, WHJC-1360 s/on 5:00; WVOW-1290; WBIG-1470 s/on 5:30; WEBC-1480 TTing at 5:40; WERA-1300 s/on at 6:00. Mail of 2/24 nets 7 veries: WFOB-DX, KBRZ-DX (at long last!), WBIR WCTC (first New Jersey verie); JOKP JOBK & JOQK. 2/25 - Off! New Zealand stations hitting 20 db S/9 this AM! But, listen! From 5:30 to 6:30 I copied an Australian Broadcasting Commission station on 710 kc/s., and that has to be 7NT in Tasmania! 8,500 miles or thereabout; report airmailed pronto, I assure you! Wonder if any long overdue QSLs (or "DX News" were among those 3,000 pieces of mail cached in Seymour, Conn. How about it, Hal? Couple more veries in: CKSB-DX and WWSN-970. February not a big month DX speaking. 54 gained to 670 for the season, but enotece DX - add New Jersey, Delaware, D.C., Puerto Rico, and noted Austria. Say, won't Larry & KHUB lucky to have DXed on Feb. 9? See several more in the East noted that as a "hot" date. Didn't any of the Far West DXers get in on it? As of end of February some of my loggings are: New Zealand 6; Japan 23; Cuba 7; Hawaii 10; Alaska 12; Mexico 29. Most stations heard on one frequency: 3+ on 1450; on other than a graveyard channel, 1460 - 11. Hey - I'm wrong on 1450 being heaviest - it's 1340 with 38 now! Most distant, according to power: 50 kw. or more: ZYC* and ZYA; over 5 kw. but under 50 kw.: 7NT, 4YAT over 1 kw. but not over 5: JOHR, 1 kw., WTEL KAHU-KSVI*, 500 watts, JOJD; 250 watts, GMCO WWPB; 100 watts, XEAP* (* indicated verified). Proper, Lefty? And so into March we go. Will I get my 750 for the first year? Up and attem! 30.

Hi - I'm still trying to find out who I had when the WMOOC-DX was supposed to be on. I have plenty of info if I just knew where to send it. Joe Brauner, please note: You are also wondering about 1430 kc/s. and Lefty suggested 2WL. I'm inclined to think it would more likely be TEN-Sendai 3, so that is where my report is going. If anything comes of it, I'll let you know. Now to the last week's DX: On 2/20, I logged CBH (690) Vancouver, B.C. so I could send an inquiry on CBH, one of their 20-watt transmitters. DX NEWS

March 7, 1953

Now let's see what the fellows are hearing this week:

NORTH AMERICA

MEXICO--JC reports veries from XEBH and XEDR, both on NRC specials. PM complains that Mexicans are not verifying for him, but he does report XEW, XEMC, and XEXO QSLs.

PUERTO RICO--HSW forwards his verie from WGMN, Arecibo (1280) which is quite interesting and very definite. They sent the verie on a letterhead with a transparent card, a large decal, and a photostet of a report from Art Cushing from New Zealand. Signer is Nabal Barreto, General Manager. Owner is Caribbean Broadcasting Corp., and slogan is "La Voz de la Villa del Capitan Correa". JL reports ACE (1470) from 0519-0528 when WBIG came on on 2/23. Was probably on at 0500. Tried for AHD at same time, but not heard well enough to copy. Didn't seem to be on the air, due to strength of ACE.

CUBA--RP reports CMEQ (640) heard on 2/7 at 2330 GMT, good signals, call given and "Radio Centro de Habana" along with other call letters. JL has a QSL from CMCB via CMQ-card with CMCB information typed in. HSW logged CMGY (590) Havana on 2/18 all morning with Cuban music and English announcements. Wonder if anyone has received the set of Cuban maracas promised around Christmas and New Years. Mine hasn't arrived, nor has a QSL. RD reports hearing CMKA (1250), CMKI (1400), CMKH (1130), and CMKS (900) as the stations now on the air in Guantanamo. RH adds that CMEZ (830) Havana, has been asking for reports in English, giving address as Box 866, Havana, Cuba. He logged them 2/27 at 0524. PM adds his first Cuban of the season (QSL that is) in CMHQ, Santa Clara.

ALASKA--NM notes that for most of Alaska the time is EST minus 4 hours, and for the Aleutians with BST, the time is EST minus 6 hours. This is to correct the INTERNATIONAL LOG which says 6 hours.

EL SALVADOR--JL reports YSS (655) 2242-2301 sign-off on 2/13 with S-9 Plus signals.

JAMAICA--RD reports that "Radio Jamaica" is now on 720 Kcs., heterodyned by PJC2. Apparently vacated 670 to avoid interference from CMKP. JL logged them on 670 Kcs. on 2/16 before they moved from 0559-0615 fadeout with S-8 signals.

HAITI--RD reports an unknown Haitian station on 1330 Kcs. Thinks it may be 4VW.

More on Mexico--PT clarified last week's verie signers by stating that XESM was signed by Manuel San Martin and XEN by Salvador del Conde. XEN was a hand-written verie on the back of a program booklet.

SOUTH AMERICA

URUGUAY--CW-1 reported last week on 540 Kcs. has been heard by HW on 2/23 from 0230-signoff at 0403 on 545 Kcs. Announced call after every musical number. This could be the one RA and HH have been hearing on 545 in the evening hours.

BRAZIL--PRE-8 (980) Rio de Janeiro, is quite in the news this week. HW reports good reception on 2/23. RP reports him in England every evening around 2330 GMT. PT reports a verie from him on a standard "Radio Nacional" QSL card with "Thanks for your informations" in 5 languages. RP also reports PRB-9 (1000), PRG-2 (1040), PRG-9 (1100), PRG-3 (1280), and ZYR-7 (1300). SRM reports a Brazilian on 670 Kcs. on 2/23 mentioning Sao Paulo. Heard at 0310. None listed in current lists. Does anyone know who it is? (Stan, the FBIS list shows a station under construction in Sao Paulo on 670 Kcs. with 10 Kw. It is to be government owned, and slogan is "Radio Nacional de Sao Paulo". Call letters were not assigned, so suggest a report to the above-FV)

PERU--PT reports via a verie from OAX4A that OBX4A, also owned by the same owner, is now on 1100 Kcs., having moved from 1220 or 1120 Kcs.

COLOMBIA--The station HW reports on 1095 most mornings is HJCN, and it is apparently on until 0400, apparently every night.

RECEPTION REPORTS

ARGENTINA--RP reports "Radio Bolgrano" (950) heard on 2/8 with S-7 signal at 0030 GMT.

EUROPE

GREAT BRITAIN--Answering a querie in the 1/3 bulletin RP advises that the BBC stations on 1457 Kcs. are in Clovedon and Bartley, with a total power of 30 Kw. JL reports BBC stations on 908 Kcs. S-9 on 2/19, 1088 Kcs. S-5 on 2/10 at 0150; and on 1052 Kcs. S-6 on 2/10 at 0200. Has had answers from BBG stations in which some of his questions have been answered, pretty well confirming what stations he was hearing.

AUSTRIA--JL has logged Gra-Dobl (1025) on 2/19 from 0121-0207 with signal varying from S-2 to S-7.

BULGARIA--JL reports Sofia I (827) 2305-0001 on 2/19. Says he hopes this is Sofia and not Germany. Thinks it was too early for Germany and the language was not familiar. Music a little like Don Cossack choir.

CZECHOSLOVAKIA--Melnik (1286) logged on 2/19 from 0009-0104 with S-8 signals at best.

FRANCE--JL reports Rennes I (674) 0041-0105 on 2/16; Bordeaux I (1205) from 0113-0202 on 2/16; and Toulouse I (944) 0144-0200, same date. JL notes also that Paris I (863) sent best French QSL he has yet received.

GERMANY--JL reports SWF Rheinsender (1016) 1805-1816, seemed to sign-off. This on 2/18 and also the next morning from 0106-0210. AFN Frankfurt (872) logged from 1847-1902 sign-off. And last AFN Stuttgart sent a letter QSL with complete program listing for one week and a list of AFN stations.

ITALY--JL says that Rome I (845) seems to have a regular news comment in English at about 1830. Heard QSA-5, S-9 Plus 10 on 2/20. News in German follows briefly, then dance music sometimes. Joe wonders why Rome comes in so well, being so far inland.

LUXEMBOURG--JL reports a nice letter in English, but it says nothing about verifying. (Joe, they didn't always do that, because I had a quite definite one last year-FV)

POLAND--RP answers a querie in the 1/3 bulletin by stating that the Polish station on 818 Kcs. is Warsaw II, and listed power is 50 Kw.

SPAIN--RP notes that "Radio Madrid" operates on 593 Kcs. and is the key station for the Sociedad Espanola de Radiodifusion Network.

AFRICA

TANGIER--RP reports "Radio Tangier" (1079) heard every day with a very strong signal around 2300 GMT. Call given is "Transmite Radio Tangier". Wonders if it might be a new name for the old low-power station formerly operated by Radio International on this frequency. All programs heard in Spanish. "Radio Internationale" on 1232 Kcs. is not so well received, so it looks as if they are only using 10 Kw. JL notes reception of Tangier on 934 Kcs. 1732-1737 when it seemed to sign off. Very odd music. This on 2/21 with weak signals.

CANARY ISLANDS--RP notes that stations on in the islands now are Radio Las Palmas on 1313 Kcs. and "Radio Clube Tenerife" on 1421 Kcs. Comments that he has never heard either, but is still hoping.

MADEIRA--Again from RP notes that active frequencies are 1483, 1529, and 1594 Kcs., but nothing on schedules. He says that latest list from Lisbon gives 1529 station as a Radio Nacional Network outlet, and he thinks that the other two are commercial.

ASIA

JAPAN--Japanese stations continue to be well heard on the West Coast. NM sends in the following which is a change from the list in the INTERNATIONAL LOG. He had it directly from JOHG. First there was a transposition in call letters for the station on 1190 Kcs. The correct call is JOKD, not JOBK. Now the other change. On 11/5/52 JOHG moved from 990 to 980 Kcs. with the same power. At the same time

RECEPTION REPORTS

JOKP moved from 980 to 990 Kcs. with the same power. Norm has veries in from JOKD and JOFR recently. PM has QSLs from JOQC, JOKD, JOHB, JOCK, JONR, and AFRS-Osaka. Notes that on 2/25 he logged JOJB (1370) for his 15th Jap this season.

RYUKU ISLANDS--EW sends along a clipping giving detailed information on the opening ceremonies of Station KSAR, which went on the air on February 4th. Called the new 3000 watt Voice of the Ryukyuas, KSAR broadcasts on a frequency of 740 Kcs, and it replaces Ryukyuan operated AKAR as the only native radio outlet on the island. KSAR is at Naha on the island of Okinawa. Schedule is from 1700-1400 weekdays and from 1900 to 1400 Sundays. Ed says that since it is a straight hop across the water it should be easy in the US, especially on the West Coast and will be a new country for most.

OCEANIA

H AWAII--HSW reports logging KULA (690) Honolulu, on 2/17 from 0310-0335 sign-off, good first 15 minutes, also heard on 2/19. His best DX catch in 4 years of DXing.

AUSTRALIA--RHM wants the clock stopped, as he has finally heard an Australian. On 2/25 at 0540 he logged a station on 710 Kcs. with a play, and it turned out to be 7NT, Kelso, Tasmania. Very pleased to hear an "Aussie", especially a #7. PM notes that the mornings of 2/24 and 2/25 were good for Aussies, and he heard 2BL (740), 4QS (750), and 4AK (1220) good enough for a report. Also 2WL (1430), but not good enough to copy. Has also logged 2QN (1520) Deniliquin.

NEW ZEALAND--RHM reports that 2/25 was a top NZ EX morning with 1YA (800) and 1YC (880) for first reports to stations. Both as high as 30 db over S-9. 1YZ most readable. Also heard 2YA (570) for first time at 0430 on 2/23 for his 6th NZ station. YE ED logged 1YZ the morning of 3/2 for the loudest NZ he has ever heard. Logged from 0356-0430 with completely readable signals. 4YA also heard, but not logged as it has been verified. First NZ in 1953, although 4YA was heard last fall. JL reports a verie in from 1YZ, both QSL and letter, one of most exact veries ever received.

MYSTERY

JL noted two, both probably TA signals, one on 962 Kcs. on 2/19 at 0104 with man talking, too weak to copy. (Undoubtedly Tunis I, as his signal is most reported-FV). Also one on 685 Kcs. on 2/19, either Mcf or Belgrade I 0040-0045, signals strong, but hard to read. (Our schedule notes indicate it was probably Belgrade I-FV)

JC notes for benefit of RHM that he has nothing further on the 630 Kc. mystery. He just considered it to be BED33 on 633 or 635 Kcs. Not heard since, and not reported.

PT notes that JB was asking about a British accented station on 280 Kcs. from 0430-0530 on 2/7. He says it might have been BBC-Washford as he heard the 1214 synchronized stations signing on at 0400 one morning, although they only lasted about 10 minutes. Says perhaps he had a remarkable skip.

RP notes a querie recently on 565 Kcs. and thinks it must have been the Italian stations on 566 Kcs.

To Norm Maguire, Steve Mann was able to verify some ZBM-1 material during the current season. You might send him a copy of your report to see if he can help you. I have been counting verifications from Steve for ZBM, as I know he won't verify them unless he actually has the material available from which to check reports. His company represents ZBM-1 for advertising purposes, and he sometimes has log material from the station. Don't think 1602 Kcs. is stretching things too much for contest veries, as the frequency is definitely intended to be in the SCB by the Europeans, who assign every 9 Kcs. instead of every 10. I'll go along with it as counting in the contest, since it is only 2 Kc off and since it is a BCB station. (No frequency limits were set up in the contest rules, but they are about 538-1602 actually) Norm also comments on his lack of TA reception in Labuquerque. He should kick, I can't even hear them here in Central Pennsylvania.

Pete Taylor is afraid that he can't mix school and DX any more so DX will have to take a vacation. JL notes he has sent 87 reports to 38 countries this season in addition to US and Canadian stations.

To Hal Wagner and to Pete McKenna, Newfoundland is now a part of Canada, so VOCM and CJON must be considered Canadian stations and will not count in the Foreign contest. To Pete, contest closes on March 31, and you have until June 30th to get your list of veries in to me. Pete comments on enjoying logging TP signals after years of nothing but TAs and Hawaiians from New Jersey. Still hasn't logged KGMB or KGU but is trying. TP stuff is all right, I guess. JC says that JONR ruined his chances for WJVB. Trouble over this way was all CMHQ. Sure makes a difference where you live.

Would like to say "Thanks" to all of you who have said many nice things about the DIGEST. It is only what you have made it. We can't put anything out that is very valuable without your help. Thanks especially to Norm Maguire, Pete McKenna, and Roy Millar.

TS notes his best verie is 2BE, but he likes PRF3 better. Hope you all get your "Best Verie" in by next week's listing for the Supremacy ratings. RM notes that both of his long antennas have blown down, and he is using a 2 ft square loop, not too good for TP, but usable for TA. EW notes that expects to be heading home soon. Has been compiling a list of stations audible in Korea and Japan. Will send it along as soon as he thinks it is complete.

RP in sending his application for NRC membership notes that he was Programme Engineer for "Radio Normandy" in 1939, first in the recording studios in London and then in France. Studios were in Rouen. Now no French commercial stations on, although Roy says there is some hope that some will return soon. He notes that when TA material isn't coming through, he tries for Spanish stations. There are about 80, mostly commercial and all low-power. And that is all for this week. 73.
