The fact that so much of the country is now carrying Daylight Saving Time into the end of October has caused us to change our policy of issuing bulletins every week in October. The change (after this year) will be this: weekly issues from October 15 to April 15, rather than from October 1 to April 1. We would put that into effect this season, only that it has just been approved, and there was no time to notify you of the change. We already said there would be an October 1 issue, and this is it, and there will be an October 8 issue too, since time still does not permit our telling you in time to guide your sending in of reports. So we will not have an October 15th issue, but will make up for it with three issues in April, while the whole country is still on Standard Time. So, it's weekly from now on, with the exception of October 15.

#### CHGD in La Malbaie

M ost of you are familiar with CHGB in St. Anne de la Pocatiorre, Quebec. They put on DX program for us two years ago. La Malbaie, a town of about 2000, is located across the St. Laurence river and approximately 20 miles from Stext Anne. In it one Monsieur Tremble has purchased time from CHGB. During this time he makes up a program from La Malbaie sponsored by the local merchants. In order to get the program from La Malbaie to the main transmitter at Ste. Anne, he operates a transmitter at La Malbaie on 2236 Kc/s. This station ALSO uses the call CHGB. His studio and transmitter is housed in one room on the upper story of a duplex. For a antenna, Monsieur Tremble uses a single wire. His present schedule is 1200-1215 and 1900-1915.



If you know your A B C's, you'll find this year's Domestic DX Contest RIGHT DOWN YOUR ALLEY. That's right. . . this year's contest is an alphabetical one. Not consecutive call letters. . . no trick devices. . . just DX DOWN THE ALPHABET. That's it! Simple? You bet! And YOU pick your location to fit the alphabetical by-play of this DX Contest.

Briefly, this is how it works. . .hundreds of cities in the U. S. and Canada have radio stations. . .set those cities up alphabetically and knock 'em over for points. For instance, you log KADA Ada, Oklahoma. That's 1 point. Than you log WAKR Akron, Ohio. That's good for three points. You're through with the "A's", next comes "B" "C" "D," etc. Of course, you have to have the verie back before it can count for you. And those DX SPECIALS count too! See details below!

RULES FOR THE 1955-1956 DOMESTIC DX CONTEST OF THE NRC

### 1. CONTEST MANAGER

The Contest Manager is Hank Ward, 404 North 14th, Ponca City, Oklahoma. All entry fees and lists of veries submitted by contestants must be sent directly to Hank. To assist the Contest Manager in his part of the work, contestants lists of eligible veries should be submitted in the following order:

Call-Location-Frequency-Fower-Date Logged-Date Verified.

# 2. DURATION OF CONTEST

Verifications eligible for this contest must be for reports of reception not earlier than 12:01 a.m. October 15, 1955 and not later than 11:59 p.m. March 15, 1956. The above times will apply to the time zone in which the contestant resides.

#### 3. LISTING OF STANDINGS

The standings will be listed once each month for the contest, ie, the first issue of each month starting with the December 1955 issue. Final standings will be listed in the June, 1956 DX News. For inclusion in the monthly standings published in DX News, lists of eligible verifications should reach the Contest Lanager on or before the 4th Saturday of each month. Lists arriving too late for inclusion in a monthly listing will be held over until the following month.

4. DEADLINE FOR ACCEPTANCE OF VERIFICATIONS ELIGIBLE FOR CONTEST The final entry containing your list of verifications eligible must be sent to the Contest Manager bearing a postmark of no later than 11:59 p.m. May 1, 1956. Any list of entries bearing a later postmark will not be accepted.

### 5. ENTRY FEE

There will be an entry fee of fifty cents (50¢) and must be paid at the time of entering the contest to the Contest Manager.

## 6. PRIZES

All money received from the entry fee into this contest will be returned in the form of prize money, payable to the winners after final tabulation of points and no later than June 1, 1956 from Ponca City, Oklahoma. The prize list follows:

1--First place in Contest: \$3.00

2-Second place in Contest: \$2.00

3-Third place in Contest: \$1.00

4--First place by a resident of the MST or PST zones: \$3.00. (If this contestakes either first, second or third place in the entire contest, he is eligible for that prize also.)

5--For highest score in "Specials" portion of contest: \$2.00

6-For second highest score in "Specials" portion of contest: \$1.00

7-For first person scoring 25 points in Alphabetical portion of contest: \$1.00

8--For first person scoring 25 points in second portion of Alphabetical contest: \$3.00

9-To contestant in first place on New Year's Day, January 1, 1956: \$1.00 10-To first contestant identifying MSYMERY station known only to Contest Manager: \$1.00

The Contest Manager and the Mational Radio Club by letter from the Contest Manager reserves the right to add to and/or amend the above prize list pending tabulation of entries received by the deadline. In other words, the contest will be entirely self-sufficient and no funds will be removed from the Mational Radio Club to bolster this prize fund. If sufficient entries are not received than the prize list will be amended until entry fees balance the prize fund. However, it is expected that additional prizes will be added to the above if the enthusiasm displayed towards this contest when it was brought to the attention of the MRC members at the Cedar Rapids Convention is any criterion. Contestants will be advised via DX News of any change in prize list, up or down.

#### 7. TIME FOR EMPERING COMPEST

Anyone being an NRC member in good standing may enter the contest, but must do so no later than November 1, 1955. Any new members may enter the contest providing they do so within thirty (30) days from the date of becoming an NRC member.

#### 8. COMTEST MANAGEL'S AUTHORITY

The Contest Manager shall have full jurisdiction of this contest. He may request contestants to submit any verification or verifications deemed necessary to remove any doubt in cases of dispute. Failure of a contestant to abide by the Contest Manager's decision may be dropped from the contest by the Contest Manager. However, should this occur, the Contest Manager will submit the facts in full to the Board of Directors of the MRC for final decision.

# 9. STATIOUS ELIGIBLE

Every station in the U. S., Dominion of Canada and the D. of C. are eligible in this contest insofar as they qualify for the alphabetical listing by city. First city verified beginning with "A" (like Akron, Ada, Ashtabula, etc.) count one (1) point. Second station verified from a city beginning with the letter "A" gets three (3) points. And so on through the alphabet with the exception of the letter "X"! The cities do not have to be verified in alphabetical order. Special DXes dedicated to the Mational Radio Club may be used as an area (city) station and may be counted as needed for an area (city) station as well as for bonus points as a Special DXing station. Such a station must be located within continental U. S. or in Canada. Then a contestant verifies their first twenty-five cities in their alphabetical order, the twenty-five points shall increase in value to seventy-five points. Then a contestant completes his second time down the alphabet, the twenty-five points shall again increase in value to seventy-five. The total possible points in this phase of the contest are one hundred fifty (150) points!

# 10. SPECIAL DX PROGRAMS ELIGIBLE

Bonus points for DX Specials dedicated to the National Radio Club will be five (5) points. Neither the distance of the station from the contestant nor the station's power makes any difference in this. Special DXes eligible as first or second area stations will be allowed. Special NRC DXes may be used as area stations and also be entitled to area and special points, if used as an area station. If contestant has entered the maximum number of stations in one area (2) and verifies one or more additional special DXes in the same category, each shall receive all points to which a special DX is entitled (5). Only one (1) special DX will count from a station dedicating more than one special DX program to the TRC during the contest.

#### EDITOR'S NOTE

This sheet with the contest rules may be detached from DX News and kept for future reference by all who enter the contest. Remember, November 1, 1955 is the DEADLINE for entering this year's DOMESTIC DX CONTEST, other than DXers joining the NRC after that date. So, c'mon DXers, let's make this the biggest contest yet. How about YOU and YOU and YOU entering now! Send in that entry fee now!
