Received a swell varification from VOUS-1480, Argentia this week. I sent my report to Fort Pepperrell (also VOUS 1480) but it wasn't their station so they forwarded it to Argentia. Argentia states "It was very definitely us that you heard." They also stated that they operate with 50 watts and had reports from Mahone Bay (hi, Jim), Bradford, Mass. (hi Stan) and also from Belmar, N. J. Other veries arrived from KAJI-1250 which has a nice letterhead but poor and vague form, from a DJ who "operates" on the Citizens: Band and says to listen for him on Channel 17! CJLX-800 and WIP-610 also verified.

WRCA-660 has applied for reinstatement of call letters WNBC which would be relinquished by WNBC-TV in New Britain. Guess I had better get busy and verify WRCA! Has WEOK-1390 increased power? Being there were only 8 stencils from Lefty for this issue, your DX News containing that part was ran through with a little time to look over their contents instead of having to wait until after DX News was usually mailed.

I read with interest the musings of Fred Schroyer and Larry Godwin. Both members have clearly stated their opinions on "XERF".

Taking Larry's report. I can fully appreciate how each one of the DXers feel. I also realize that every one of us are free to express what we have in our minds about certain things that occur and of subjects that do not agree with someone elses. I don't believe any one of us DXers like the way XERF conducts their daily transmissions and many a time it seems that we just have to explode, or in other words, get it off our chests and probably feel a little better afterwards.

Now I look at the remarks made by Fred Schroyer in regards to the effect our gripes on such matters might have on those prospective members who get copies of DX News in which the above gripes etc are published. They could in many cases get the wrong impression or ideas of your club, thus nothing more is heard from them in regardx to joining.

The reason I have commented on this subject is that since Oct of 1959 I have mailed out several hundred sample copies of DX News to those requesting them. Each one requesting a sample was sent 2 successive issues, yet less than 2% of them joined the N R C Why? Even taken into consideration that in many cases a certain percentage who ask for samples do so because they are free, especially because your club has been written up in several of the popular radio magazines.

Taking all of this into consideration I still maintain that there were too many who failed to join after receiving their 2 issues of DX News. To date the big majority of our New Members joined because they had been interested by other N.R.Cers and in so many cases they did not bother to ask for a sample DX News but sent their letter asking to join along with their dues saying such and such a member interested them. By the way, I would like to take this opportunity to those members who have interested others to join a big thanks for your interest in the N R C and your cooperation.

It night be worth discussing at the White Plains Convention and it is hoped that every one who can, be on hand for another wonderful time.

At this time a little re-hashing about the N.R.C. night be in order. As all of you know we are nearly completing our 27th year as a DX Club. However I can only give you definite facts since October 1940, so here goes. Since Oct 1940 the N.R.C. has issued a total of 34 copies without a miss. Also weekly issues during every DX Season. This schedule has been maintained and will continued to be maintained because those governing you Club feel it is a must in order to supply its members with the latest and most up to date beb information possible, something that just couldnt be done by a semi-monthly or just monthly issues. The dues have been kept to a minimum at all times and you can be sure that this policy will be followed in the future. Those who have been publishing DX News in these past 20 years have always been sure they bought good supplies at the most reasonable price, yet I believe the mailing service of DX News just can not be topped. For this issue, some of you will note the new envelope, next issue they will be used entirely. Yet I purchased these a little less than our former envelopes without your Clubs name and address on them. Another 50,000 sheets of mimeograph paper has been delivered **www.** The special features of DX News are things you only get by being an NRCer such as F/C list-CPs and contests. So all in all we feel that the N.R.C. and its DX News is something to be proud

ARTICLE ON "EKKO STAMPS" RECALLS THE GOOD OLD DAYS

"Back in the early days of radio, when there weren't the high-powerd stations that exist today and before the advent of FM and TV, there was a large group of individuals scattered throughout the world known as "DXers". In fact, there are some "DXers" still in existance today.

"In order to brag about his achievements, the early DXer wrote to the individual radio stations, listing the subjects and time the station was heard and requested a "Station Verification" of same. In return, that station sent a card, a letter, a station label

or an EKKO Stamp, as proof of reception.

"The EKKO Stamps comprise a very calorful collection. They were printed by the American Bank Note Co. and are approximately the same size as the current large U.S. Commemoratives - 22mm wide, and 35 mm high. For the U.S. radio stations, the subject of the stamp is an eagle, face turned to the left, perched atop a globe of the world with a radio tower on each side. The letters E-K-K-O are distributed in the four corners of the stamp and there is a 5mm band below the glode to allow for the imprinting of the station call letters.

"The stamps are printed in one color and the call letters are imprinted in amother with

"Verified Reception Stamp" in two lines below the call letters.

"The subject of the Canadian Radio Station EKKO Stamps is a beaver gnawing a tree with two other trees in the background. This is framed in an upright oval with radio towers on either side and a group of maple leaves underneath each tower.

"Some Cuban, Mexican and experimental stations also is sued EKKO Stamps. As radio stations increased their power, DXers decreased and in all probability became stamp and cover collectors due to the direct tie-in provided by the verifications received. "The EKKO Stamp plan was inaugurated in October 1924 by the EKKO Co., Chicago, Ill. They were procured from broadcasting stations only upon positive proof of program reception accompanied by 10¢ to cover cost of reviewing the program, the EKKO stamp, and return postage. However, some stations were not prepared or would not supply EKKO staps, and the EKKO Co. authorized itself to do so upon receipt of an authentic verification or confirmation, and 106.

"In 1924 the EKKO Co. published and sold "The EKKO Broadcasting Station Stamp Album" containing spaces for stamps from every broadcasting station in the U.S. and Canada.

It is a hard-covered 96 page bound album, 9" x 12", priced at \$1.75.

"In 1926 a revised edition of the album was published and sold for \$1. On February 1, 1927, the firm advertised additional pages for the album gummed for insertion where desired. It also boasted of the fact that 25,000 radio listeners were colecting EKKO Stamps which would tend to discredit any scarcity attached to them. Some of them still turn up in stamp accumulations at the present time.

"The 'Eagle' EKKO Stamps follow a set pattern of 15 color combinations. (Some stations have used two or three different color combinations). The first color is that of the stamp; second of the imprint: Dark Violet- dark blue; oragne-dark blue; red orangedark blue; yellow-black; yellow-lark blue; carmine-cark blue; dark blue-red; light blue -blue; green-red; green-blue; dark olive green-red; brown-dark blue, and brown-red. "The 'beaver' EKKO stamps for Canada utilized five color combinations: rose-dark blue; light violet-dark blue; light olive green-red; dull blue-red, and dull oragge-dark blue.
