- X E Y C.** Sr. Guillermo "Willie" Terrazas will announce on this special NRC DX program, arranged by Dick Cooper, Jr., son of our member Dick Cooper, on a personal visit to XEYC. There will be popular music with frequent station identifications in both English and Spanish, and there will be dedications to members of the National Radio Club. The address: XEYC - Box 278 - Juarez, Chih., Mexico. XEYC regularly concludes its broadcast day at 3:00, and on this Monday morning will continue for 2 1/2 hours.
