John Callarman - Box 1914 - Pampa, Texas - 79065 No DX infrecent weeks, but I feel I should make a comment ortwo about the country list. First of all, the pace-setting of the ARRL in devising country lists for ham work is well-known & respected here, & it was after a thorough analysis of the ARRL country list that I edited the NRC country list. First, by studying the ARRL list, I tried to define what was a country by accepted standards, both political & geographical. I felt that so far as separation by land or water, we needed to have a specific distance for our criteria that could be fit into all instances. I took 50 miles. This 50-mile saparation resulted in the elimination of Sicily from our list, for, to be consistant, we could also have addadd Catalina as a separate country, the way I see it. The two basic differences, however, between our list & the ARRL list are that 1) We accept the political reality of two Germanys, two Koreas, two Vietnams, & 2) our list has been trimmed down to include only locations that are KNOWN to have a BCB station in operation. Now, in our country list, you will find West Berlin. It is separated by o/50 miles of land territory belonging to East Germany, from West Germany. Therefore, by the criteria set up for the NRC Country list, West Berlin aquires country status. It dannot be a separeate country on the basis of land separation in the ARRL list because ARRL does not recognize E & W Germany for separate country status. The NEC, unlike some other clubs does not seek to vie in any way w our ham brothers, nor w/those who tune SWBC, FM/TV, Utilities, or any of the phases of DX. It's essentially all part of the same hobby. The only real value of a country list such as ours or ARRLs is to provide a specific standard of measurement for a Divers activity so that everyone interested in, say, Supremacy Ratings or the DX Contest is measured competition-wise on the same yardstick. It might be more ligical to base our competition on the ITU Radio Zones, who knows? I hope that this clarifies for those who are worried about the content of our country list the basis upon which it was compiled. 73.

One member reported reception of Lisbon prior to midnight, & I am almost positive what he heard was the West German instead, since the regular Lisbon s/on is 2am, & I can't ever recall hearing them s/on before midnight. I would suggest that new DXers study the different languages so they can tell them apart, as well as the station skeds, before going out on a limb. As for DX here, well, here's what there is of it. MM 2/14, the WAMO-850 TEST @ 3am was solid here, & at 4:12 unn 2NA-1510 was putting out a fairly nice signal. Later that evening I was pleasantly surprised to log the new R.   560 VENEZUELA. YVLX, R. Rumbos, Caracas, heard with Rumbos news at 0508 2/14; KSFO didn't bother t
- 560 VENEZUELA. YVIX, R. Rumbos, Caracas, heard with Rumbos news at 0508 2/14; KSFO didn't bother them at all until 0559, surprisingly. (Gray Scrimgeour, 1105 Virginia Way, La Jolla, Calif. 92037)
- UNID. AFRICAN/CYPRUS. On several nights this week, I have noted an African carrier signing on around 2140; 2141 on 2/14, 2143 on 2/20, and 2139 on 2/21. This station has not provided any audio yet and is chopped up pretty badly when BBC Cyprus throws its carrier on about 2151. Based on about 30 DF measurements, I get a mean bearing of 85°. SARC on this channel should be 106° which definitely rules them out. But I recently saw an item to the effect that TANZANIA is now running 100 kw. commercial service on 638; TANZANIA (Dar es Salaam) should be 83°. Therefore, I consider it very likely this unidentified station is in fact TANZANIA. Fade-out each night between 2205 and 2215, which checks out well with E-20 for Dar es Salam. Reception of this one should tend to improve as summer approaches and can be heard later each night until June. Any information about when this one threws audio on, JAC? I consider this to be THE outstanding project now. (Gordon P. Nelson, 19 Irma Ave., Watertown, Mass. 02172) I find nothing on it, Gordon. Sorry. (Ed.)
- 640 GUA E . . French speaker far above the rest of the pack at 1900 turned out to be Guadeloupe, Anthem at 1906 was fellowed by a minute of very nice guitar IS; carrier off 1908 2/20. (Nelson, Mass.)
- 650 COLOMBIA, HJKH, Bogota, is the call in use here, never changed; change is in slogan; some confusion as to whether change did come about at this end, sorry! (Michael A. Silver, 5, Groswenor Heights, Kingston 8, Jamaica)
- 728 CREECE/EAST GERMANY. Deutschlandsender quite good AN on 2/8. A second carrier came an around 2320, but I didn't get decent audic until 2357 when Athens came up quite well for a few minutes. I have great expectations for Uganda on this channel later in the summer now that RNE has gone. (Nelson, Mass.)
- 795 GUATEMALA. TGO, la Voz de las Americas, Guatemala. Copied 2/22 2000-2130. Good signal and easy copy. Some music in English. (Morss, Mass.)
- 810 PURTO RICO. WKVM, San Juan appears to have a program "Radio Reporte" after 0500; is this R. Seaver's

  "mystery?" Logged 2/22 0500 possible s/on, then ctop all. (Roy H. Millar, P.O. Box 6, Marysville, Wash. 98270)
- 820 CHIMA. R. Peking outlet noted with "5 and 1" TS at 1000, 2/10, a morning of many strong Chinese signals.

  Not reported, as I'm through wasting money on reports to Peking, but wonder where ye Ed. deduces this one to be??? (Millar, Wash.) Peking, Kunming, Nanking??? Take your choice. (Ed.)
- 840 MAZIL. ZYD8, Salvador, Bahia; 2/17 with very clear ID and Location 0227-0230. No trace of un-needed PRH9, nor was HJBI all-nighting as they have been since this date. (Millar, Wash.)

  COLOMBIA.HJBI, Ondas del Caribe, Santa Marta. Reported for AN program heard on .2/22 from 0215-0250. (Scrimgsour, Calif.)
- 880 VENEZUELA. YVMP, R. Lara, Barquisimeto, is now here from 900 kc. Announces 10 kw. Venezuelans seem to be shifting freqs. to get better pattern ... (regular pattern, that should read... Ed)... Expect more changes on higher frequencies. (Silvera, Jamaica)
- 885 MONTSERRAT. Plymouth "tentatively" logged 2/23 from 0503 with gospel type music and YL announcer; tape off in hopes of verifying, although I must admit announcer 100% unreadable... but can hardly be any ther. (Millar, Wash.)
- 960 Herrich. ZFB-1, Pembroke West, had surprising signal 2/20 with end of "Sunday Show." S/off with GSC 0307.

  (Bill Caldwell, 15 Ashland, Springfield, Mass. 01119) I've been trying to get good DF on the VCA station here for some time now on request from Lefty Cooper. The program seems to be taped from VCA Greenville on shortwave and rebroadcast from 0030-0230; standard Greenville ID's heard on the half hour and "This is the Voice of America transmitter at Greenville, North Carolina" heard at s/off 0230. DF on this transmission is dead center on Dermuda. Other carriers on the channel "dull" the resolution of DB somewhat on this station but I'm fairly certain that it is coming from Bermuda. There is a chance that it fust might be from the Eastern Caribbean, and I'd very much like a cross-bearing. I will say that DF from here is consistent with Bermuda, but is inconsistent with Greenville itself. I hope to get bearings on this one from St. Croix, U.S. VI.I. in a couple of weeks. (Nelson, Mass.)
- 1024 COLOMBIA. HJDC, Emisora Claridad, Medellin, has settled back here after moving up to 1030 just before Xmas; ANIs occasionally and almost sure it's Ernie's unid. (Silvera, Jamaica) But ...
- 1025 COLOMBIA. HJER, R. Pacifico, Cali, heard ID'ing as 'R. Pacifico" and 'RCN" on 2/24 and on to s/off at 0102 on 2/25. This long after TIAC s/off, so clear. Ex-1030. (Clarence H. Freeman, P.O. Box 12, Hughson, Calif. 95326) S/off heard with NA at 0057 on 2/22. Only fair signal, so I'll keep listening. Randy gave me this tip, believe call is HJER, R. Pacifico.)(Scrimgeour, Calif.)

- 1200 UNID. L.A. Very F. SS MM 2/21, 0230. (Caldwell, Mass.) F.= fair, fine, faint, que? (Ed.)
- 1285 NICARAGUA. YNRPS, R. Granada, Granada. With discussion in Spanish. poor to good 1825 2/16. (Silvera, Jamaca)
- 1300 EL SALVADOR. YSHX, San Salvador. Believed to be onehere in Spanish with ads for "Muebheria El Salvador" and music. QRM from CMJX at 1901 2/16. (Silvera, Jamaica)
- 1379A MEXICO. XEKT, Mexicali, BCN. Is off frequency again; heard here 12/19 several times in late afternoon. (Scrimgeour, Calif.)
- 1394 AZORES/SPAIN. CSB80, Ponto Delgado, provided readable Portuguese audio around 1800 on 2/20, but usually this channel is a Spanish graveyarder. On 2/20 and 2/21, had very bad GRM from the following station:
- 1394.84 UNID. SPAIN. On 2/20 and 2/21 I had a rather good signal from a station in northern Spain. S/off at 1850; S/of at 0148. Bearing was just South of La Coruna and just north of Rarcelona; I suspect EAK53, Reus, which has been noted in Europeas high as 1397. (Nelson, Mass.)
- 1423,47 COLOMBIA. HJEH, R. Magdalena en S(h)anta Marta, very powerful to s/off 0206 on 2/21 with what sounded like a really swinging carnival; the MC was stoned, and kept dropping themike, and the band was even worse off. Ever hear slurred Shpanish, hil? (Nelson, Mass.) Only on KAKC. (Ed)
- 1426.98 MALI. Bamako quite good 0140 on 2/21 with drum music but out shortly thereafter. (Nelson, Mass.)
- 1445 DCM. REP. HIRD, La Voz del Caribe, San Pedro de Macoris, notedpoorly at 1802 2/18. Is new one. (Silvera)
- 1470 MEXICO. XEBBC, Tijuana, BCN. New call for XEAU. Has kept 0300 s/off. (Scrimgeour, Calif.)
- 1475 AUSTRIA/SPAIN. This channel is now a Spanish graveyard, hopefully containin Mallorca. I've spent quite a bit of time there lately, and have been able to ID the dominant station as EAJ32, R. Santander, in Santander. This one used to be only 1 kw, but I suspect they have boosted power; on three separate occasions (twice in the AM, one in the afternoon) EAJ32 has been very dominant and has provided good ID's. But there are at least a half dozen other EA carriers here. On 2/21, I got truly remarkable reception from Vienna from 0030 to 0130. Most of the time, the signal was remarkably high and elear. Several times a minute, however, the signal would fade completely out and then return in less than E second. I've never seen anything like it. Did anyone else notice it? (Nelson, Mass.)
- 1505 COLOMBIA. HJHX, La Voz Panamerican, Floridablanca, is the LA on this freq. but never heard with "sombre chamber music." Calkin, think you have RNE outlet. However, this one ran AN over the Xmas holidays, including 12/27, 12/28, and 12/29. Plays "jump-up" music, to use a local term, and belongs to Union Radio network. (Silvera, Jamaica)
- 1522. 7 UNID. PERU. A couple of nights a week, I hear traces around 2000 of this station. Good DF for Lima area and I've heard several mentions of Lima, but no positive ID yet. How 'bout an Editor's guess, JAC? (Nelson, Mass.) OBX4D, R. Reloj, Lima, heard on 1523 in New Zealand. (Ed.)
- 1525.21 COSTA RICA. TIEEAW (what a cell!) is very powerful now since inauguration of the 10 kw. xmtr. (Nelson)
- 1560 PUERTO RICO.WRSJ, R. San Juan, Bayamon. 2/19 booming at 0930 s/on. (@ldwell, Mass.)
- 1570 MEXICO. XERF, Cd. Amuna. Strong in English 0405 a.m. 2/19. (Caldwell, Mass.)

- 1124 SPAIN. EAJ-15, Barcelona. Signer, Alfonso Panda Moras, Director; uses 10 kw. Collins transmitter, and sent letter in English, plus GSL and pennant. Seemed very happy about tape-recording I sent. (Morss, Mass.)
- 1205 FRANCE, R.T.F., Bordeaux. Nice complete letter for my 12/15 reception. (Scrimgeour, Calif.)
- 1235 BERMUDA. ZHM-1, Hamilton. Card for 12/31 report; country #26 now. (Scrimgeour, Calif.)
- 1295 ENGLAND. BBC European Service verification for 11/29 reception via both general QSL and very specific letter signed by H.R. Hatch, CE External Broadcasting.
