EASTERN STANDARD TIME

As usual, DX NEWS will remain on E.S.T. in ALL sections throughout the Summer. We ask everybody to remember this, and to send reports in with ONLY Eastern Standard Time, entioned, to avoid confusion. Why not keep your DX Den clock on E.S.T. the year-round, so that no errors will set in, either in reporting to DX NEWS, or in reporting to stations heard? In Musings, please use the a.m. - p.m. system - the usual everyday conversational way. In IDXD & DXDD, the 24-hour system is used - but in ALL the sections, we'll stick to Eastern Standard Time (five hours earlier than G.M.T.) even though most of the U.S.A. & Canada will observe Daylight Saving Time. It is, therefore, believed that most regular frequency checks will be aired an hour earlier than listed during the five-month D.S.T. period. It was voted, 2 (Callarman & Nelson) to 1 (E. Cooper) to remain on E.S.T.

Ben Dangerfield - 202 Governor's Drive - Chester, Pennsylvania - 19013 The DX fare has been rather interesting here, w/no signs of the HNL that usually creeps in about this time of the season. 3/22 was fine for TAs in the early evening, w/Batra-818 putting in its best signal of the season @ 7:40pm. The English Pirates were strong, & there were intriguing mixtures on 836 & 1106 just after 7pm. 3/24-CBI-1 40 played tag w/WRVA from 6:25 to 7pm. 3/24- CKGB-680 very good atop frequency @ 7:35pm. 3/26- Many TAs between 6-7pm, but no new loggings for me. MM 3/27- There was no sign of the Specials on 1370 1470 & 630k. WHVW-950 was heard w/ET @ 3:17am. Later in the evening, CBD-1110 was logged well o/WBT most of the time from 6:19-6:30 pm. Also heard again behind WBT @ 11:10pm, as was CBI-1140, who managed to top WRVA at the same time. Both 3/30 & 3/31 had considerable TA activity. 4/1- WKAR-870 had a very strong signal up to 7:15 s/off. At 10:30pm, Nice-1554 was pounding in w/S-9 signals, & at 10:30pm the Colombian on 1136 IDeddas R. Riomoar, which is HJAC. SM 4/2, I tried for the KMCO-900 TEST, but didn't notice it. There was a third station w/girl signer behind XEW & CHML @ 1:04am. MM 4/3 was a very quiet morning here, but I didn't get anywhere. No sign of Tonga u/KGBS between 3:00 & abcut 4:05am. PRB-9 was atco 1000k w/a good signal. KMOX was off, w/somewne way back there. The CBC AN program was noted on 790k, but quickly faded u/WTAR @ 3:47am. Two stations were on 1510 @ 4am, only one of which was the CBC LPRT. On 4/4 the only interesting spot was being able to listen to Caroline-1187 from 19-10:30pm very clearly, w/only occasional splatter from WCWO. Two veries have come in recently: KLOE-730, for the recent TEST & SRS-725 for a 12/66 car radio report, sent a v/1 in EE. My Surinam veries now are SRS-725; Radika-640; Avbos-1035 & Apintie, then on 820k. However, I never made it w/ R. Paramaribo when they were on 795k a few years ago. 73s.

Proof, keep trying on these stations that don't verify, & after about five or six reports, try a PPc - they usually work. WDCV makes two PPs that I have, out of 446 veries, not too bad. I still need WKEN & WSUX to have the rest of Delaare verified, & WKSB-930 has been off for some time now, probably had their license revoked. All WPAT here, w/some WCNR. Also, KYW off third MM in a row, probably off from 12-5am MMs now, & maybe SMs too, will check. How many members have ever tried to verify images or spurs of local statichs? I decided to verify a few before the static gets to me: v/p- WCSI WERK WMOH WCTW WIBC WING WXHR WIW WCIT WPTW WRFD WDNW WKBV CJSP. v/m- WERK. v/q- WCPA WING WJR. v/1- WCPA WERK WXHR WBEU. I have kept Russ Edmunds supplied w/v/s info. Ever wonder which channel you should DX when you fire up the ol' RX? Well, here's my "scheme" which works well. I have five lists of stations by distance centered on Richmond or by XR power. List A, by frequency - all NA stations 50kw or greater. List B by frequency, all NA stations 10-50kw, List 1 by frequency - all stations 0-50 miles. List 2 by frequency, a;; stations 50-100 miles. List 3 by frequency, all stations 190-200 miles. During daytime I work 540 up through 1600 logging & verifying stations in lists 1,2,3. Complete #1 first, #2 next, etc. During nighttime I use same procedure w/lists A & B, A completed first, next B, etc. If you DX in this manner, keeping lists up to date, you'll systemiatically work your way through the BCB band but it'll take a while! Lotsa luck! Ch yes, nothing is to keep you from snagging any others that decide to show up while you're after that 250 watter, 138 miles away, day only & w/a directional antenna (?) / Don't forget the MM NRC TESTs either. Finally, I keep my log acording to distance: stations 0-50 miles, 50-100, 100-200, 200-300, etc. Makes it easy when you get to lists #4, 5, 6. & C. D. E. And allows easy computation of DXS which I believe is a reasonable measure of one's BCB DXing. Write when you can, fellows. Always interested in chatting BCB, etc.

This new section will be presented differently than DXDD was, utilizing new ideas which should make the column an effective tool for the domestic DXer.

Briefly, the section will accept tips on loggings, listed by frequency and separated into the following divisions:

- -s- All-night changes; f/c's and ET's; after-midnight sign-offs.
- -b- Sunrise sign-ons.
- -c- Sunset DX and sign-offs until midnight.
- -d- Schedules.

This arrangement was designed to provide a useful aid to the serious DXer.

As you must realize, there were unnecessary problems acquiring sufficient support for Joe Brauner's DXDD. In inviting your participation in DDXD, I would like to stress the fact that a column of this type is worthless without a regular, consistent support from many club members.

So, until DDXD first appears in DX News, I would strongly suggest keeping a close tab on those domestic tips and loggings that would improve a column such as this. Let me hear from you!

DX conditions have been quite good, according to reports, especially on North-South paths. <u>Dangerfield</u>, Pa. says. "CX have appeared good the past week, and had LA and TA high spots, such as LA's on a freq. block from 690-735 on 4/4, Spanish TA's on 4/6, and a slight Central European opening on 4/7 around 2300. Caroline-1187 still blasts in nightly here." <u>Silvera</u>, in Jamaica, continues his hot run of Deep South Americans, "DX about the same - Deep SA still very good though only a few new hrd. MM 4/3 was especially good and all Deep S.A.'s logged so far were hrd. LR6-790 excellent, and reportable u/SCN - also CX20-730 taped for report."

Unusual daytime reception is reported this week by Schatz, who noted strong signals from HJAJ-760 and PJB-800 around noon in Florida. He asks, "Could you please explain this real freak reception? S9 over a distance of 1500 miles in the tropics seems ungodly! Note the common location of HJAJ and T.W.R.; it may mean something. All else normal at the time." Well, Ron, we'll toss out a few ideas, but we really can't say anything definite about as isolated and singular a reception as that which you have described. This is one of those cases where the vast body of ionospheric research literature isn't particularly helpful. Most ionospheric research, either by design or because of experimental difficulties, provides a description of the average or typical condition of the ionosphere. Very rare and unusual ionospheric structures and configurations are usually "averaged out" during the reduction of the research data, or are intentionally ignored because of their "nonrepresentative" nature. But DX receptions are, almost by definition, the result of atypical conditions - and very little insight about the mechanisms of rare or uncommon receptions can be gleaned from descriptions of the "normal, average, standard, smoothed-and-averaged" ionosphere. The "layers" (a very misleading and unfortunate piece of terminology) which are responsible for the return of skywave signals back to earth, are present throughout the daylight hours, and are of course responsible for daytime SW reception. But, under normal conditions, the presence of these potential MW skywave returns is masked by the very great absorption of lower structures (the so called G, D, and E layers). A double traverse of these highly absorbing layers (once going up, once coming back down) is usually enough to totally eliminate the skywave return. But it is well established that these absorbing regions are not static and homogeneous, but are very complexly structured and in a state of almost continuous change, even at high noon. It would seem that there must exist rare mechanisms which can, for a short time and in a relatively small area, reduce the level of ionization (and thus absorption), and thus "uncloud the mirror" a bit. In a crude sense, this might be viewed as a sort of negative sporadic E phenomenon. We can see small but significant quantities of skywave return for many stations here in the day-time, and also noted considerable sky-wave fading and distortion of Colombian and Venezuelan stations (in the 500-700 mile range) received at noon when we DX'ed from the Virgin Islands. We've had many noon-time skywave receptions from Chicago (842 miles) and even one from WOAI (1600 plus miles) and we're certain that DX'ers in quieter locations have made considerably better noon-time catches. In view of the totally unclear nature of the mechanism(s) responsible for this long distance day-time reception, I don't think there's really any reason to be so surprised when it occurs in the lower latitudes. It's quite uncommon everywhere, and - who knows? - careful, systemmatic study might even show it to be more common in the tropics. (Ed)
