Brubaker for letters. Any persons wanting Chilean stamps for collections, please write & send \$\$ down. Also I'd like to volunteer as Deep SA monitor for the Club. What I'd like to do is make a list of frequency by frequency at about 3am EST & see what SSes are on. It may help some of you in your logs - especially on MMs. Please drop me a line on specific frequencies. above address for mailings. I'm living in Anto fagasta - I have a beautiful home here. I spend most of my time, five-six days a week, in Calama. I have a fulltime housekeeper who lives in, a girl of 28, & would you believe, @ \$35 a month for her services? We stayed at Punta Gorda, 110 miles below Tampa on Fla's WC, & made a three day side trip to the EC & o/the Keys to Key West, & back/through the Everglades Park. Hatteras & the Outer Banks are a daytime ear to the entire Eastern Sea board. At midday, all the big NYC stations are good, & some of the smaller ones, such as WGBB & WHII. WBZ has a fine signal, as do WCAU & KYW. And on 610, would yo believe WIP & WIOD? At Sea Island, Ga. one of my favorite haunts, where five Miami stations put in nice daytime signals, ZNS-1540 tops many a closer station in strengt & one Cuban is audible all day long, CMKP-670, Dan German, listed as 50kw by Ron Schatz. Punta Gorda, Fla. must be at least 270 miles from Havana, yet at noom you would think that Cuba was just across Charlotte Harbor. DX conditions in the Northeast have been unusually good many nights during the past month. Most of the common TA's in southern and western Europe are again regularly audible with good signal strengths beginning about an hour and a half before local sunset. On the west coast, the Asians are again becoming audible, and Don Reynolds in California reports, "Still a bit noisy, but things are definitely beginning to pop; it looks like a good season ahead."

On Reciprocal Paths. August reception of US stations in New Zealand wasn't very inspiring, according to to MW News; no W calls reported at all. Among the receptions reported were: KNEW @ 0228 on 8/5; KFRE @ 0800 on 8/22; KTRG @ 0723 on 8/13; KV00 @ 0313 on 8/5; LNDI @ 0215 on 8/22; and KMEN at 0325 on 8/5. Some summer receptions of US stations in Europe as reported in the Benelux bulletin: CKCM @ 2140 on 7/4; CBN @ 2100 on 7/3; CFBC @ 2209 on 7/17; CJLR @ 1927 on 7/17; and WLIB @ 2014 on 7/13. US postal rates to foreign countries have recently been raised: Caribbean and South America, 15¢; Asia and Africa, 25¢; Europe, 20¢; exotic places. 25¢. These for half ounce airmail letters. Michael's most excellent information about Caribbean area stations has been of great help to the membership and the DX community, and we're certain that the entire NRC will second us in wishing Mike many more years of fruitful DX'ing!

Don Reynolds writes to inform us that the Singleton-Eliminator Contest promises to be a great success judging from the number of contest entries already received, and to urge those of you who have not yet entered to join immediately. We suggest that those participating in this novel contest read the rules very carefully since there seems to have been a bit of confusion about one or two features of the contest. Speaking of contests, we've just received word that the Worldwide Monitors Radio Club and the Canadian International DX Club are cosponsoring a sories of <u>listoning</u> contests (no verifications required) open to all DX'ers regardless of club affiliation. There are three MW contests cheduled, and the first one, covering 535-1099 kcs, will be held November 6th through 12th. We'll present full information next week. Radio Nepal can now be heard in the US, thanks to SWL Records of California. The company has recently announced the second record in their series of ID's and interval signals from various stations of the world prepared from tapes supplied by the stations themselves. Volume II, entitled, "The Rarest DX in the World," contains cuts from Radio Nepal, The Voice of Kenya, The Fiji Broadcasting Commission, Radio Lome, and ten other exotic catches. Price is \$3.95 and full particulars may be obtained from SWL Records, P.O. Box 150, Culver City, Ca. 90230. ADEN. After having been in operation since 1962 the British Forces Broadcasting Service on 1241 ceased operations in August. (Benelux DXC) NEW ZEALAND. Radio "I", an independent company will commence its own programs over 1YD (1250, 2kw) as from September 7th. Hours will be 1800-2100 and 1000-1200 (local time?), Monday through Saturday. Intend to have own QSL cards. Will compile own pgms in studios in Merton Road, Auckland. (NZDXRA) ENGLAND. The BBC revealed its "if you can't beat them, join them" plan for Britain's official all-music radio station to replace the pirates. The new BBC station, to be call called Radio 1, will begin broadcasting pop music on Sept. 30th using disc jockeys from the old pirate radio stations. (RNYWWDXC)

Permission to install MW and SW xmitters is being sought by the Far East Broadcasting Company for Maldive Islands and the Seychelles Islands. An application to build a MW station in Vietnam is also in the works. (NZDXRA) Now why do they have to go and make things easy for us? (Ed)

BCTSWANA. On August 18th a company of the British Army's South Wales Borderers turned over its command to the Botswana police. For the past 21 months, these troops have guarded the BBC relay at Francestown against possible sabotage by Rhodesians. The outpost was the last manned by the British south of the Sahara. It was not announced if control of the station was also handed over the Botswana government, a long prom promised move. Known locally as "bush radio" the station was built at a cost of \$1.4 million, a fact that by implication seems to refute claims that the relay station uses one of the VOA transmitters on loan. (Don Jensen, via NASWA)

Lotsa Gall Department: the following letter was received and printed by the Sweden Calling DX'ers Bulletin:

"It is most regretable that you should have published Taiwan as a country in your Sweden Calling DX'ers of April 11, 1967 in disregard of the friendship between the peoples of China and Sweden and the well-known facts. We hereby lodge a protest against this. As your country has established diplomatic relations with the Peoples Republic of China you should have known that there is only one China in the world, namely the Peoples Republic of China. Taiwan is an inalienable part of Chinas Territory. The Government of the Peoples Republic of China is not yet able to excercise her sovereign rights there simply because it is forcably occupied by U.S. Imperialism. Hence, all radio stations of Chiang Kai-shek gang in Taiwan are completely illegal. As far as broadcasting is concerned, Radio Peking is the sole authorized representative of the Peoples Republic of China. It must be pointed out that any attempt to split China's territory by taking Taiwan as a country or an independent political entity is hostile to the 700 million Chinese people. It is futile and bound to fail.

To uphold the friendship between the peoples of China and Sweden, we demand that you correct your mistake and guarantee not to publish in your bulletin against the illegal radio stations of the Chiang Kai-shek gang in Taiwan.

International Liason Department of Radio Peking."

INDIA. According to German press reports, AIR will have two stations of 1,000 kw in the very near future. One will be at Bombay and the other in the region of Calcutta. Believed to be for MW service. (RNYWWDXC)

SAUDI ARABIA. Within a few weeks the Saudi radio station will be operating with a new MW xmitter of 1,250 kw. This will be the strongest MW xmitter in the region comprising Europe, the Near East, and Africa. To date the strongest MW station has been in this region Langenberg of WDR in Cologne (1586). That station has been testing with 800 kw. (RNYWWDXC)

Early this year the Canadian Broadcasting Corporation announced plans for a new service of Radio Canada, the Commonwealth Caribbean-Canada Broadcast Center. It is reported that the project will include a pair of 100 kw SW xmitters and a very high powered BCB xmitter. The location of the station has not been announced, but it supposedly will be on one of the Caribbean islands. (NASWA)

For those of you with medium-range receivers (i.e., that can't hear anything 3000 miles miles away), take heart. Ben Dangerfield has once again agreed to be contest manager for the standard NRC Foreign Contest which will start on October 1st. This will be a verification contest patterned after those that have been held in past years, and of course you can enter your QSL's in both contests. We will supply full details and contest rules next issue. In addition we are planning some new types of contests based on the simultaneous monitoring notion that we've mentioned to quite a few of the members - no verifications required, just loggings of stations on proscribed freqs at proscribed times. It'll be interesting to see who hears what when everyone is listening to the same channel at the same time. More about this later, also.
