ANARC DUES PROPOSAL ...

Club representatives to the Association of North American Radio Clubs were asked to vote this week on a proposal to levy a 10%-per-member "tax" against each affiliated club to support AsARC's many activities of benefit to the hobby. NRC, IRCA and NASWA (the progressive all SWBC club ably run by Bill Eddings, Don Jensen, et al), voted for the proposal. The new TV-FM DX club, the Worldwide TVFMDX Association and the Northeast SWL Club voted against the proposal but said they would contribute if it passed. The Canadian DX Club, the Canada. International DX, surprisingly, the Newark News Radio Club, the American Sorthwave Listeners Club, and the Firerest DX Club voted their opposition, and said further they'd refuse to pay if it passed.

The ANARC Exec tive Secretary, Gerry Dexter, writes in the current ANARC newsletter "Now, in the hope that those who offered support really meant it, ANARC Ho is standing by to receive the sums involved based on a rate of ten cents per member in your club."

The NRC governing body supports fully the aims and projects of ANARC, and will, within the next week, post NRC's check at 10¢ per member to the Association's Headquarters. We assume IRCA and NASWA will do the same.

As far as the five clubs who not only opposed the move but said they'd refuse to pay if it passed, we can only express our shock at this attitude. We weren't too surprised when the 16-year old president of one of the clubs sent out a form letter expressing this stand, but that the representatives of the other clubs, at least two which are run by adults, would follow suit is a distinct surprise to me. I do not condemn the two clubs who, good faith, voted against the proposal but said they'd cooperate if it passed. I do feel, however, that the five clubs who would have risked broaking up ANARC in a jurisdictional fight need to take stock of how serious their intent to serve the DX hobby really is. NRC stands fully behind the ANARC and its aims, and salurate the two progressive clubs who echo our sentiments! — JAC

DX conditions continue to gradually improve on TA paths, seemingly as the effects of the Midwinter Anomaly continue to decrease. TA's continue to be audible more often, with stronger signals, and on progressively lower frequencies. The collection of very high powered TA's near the top of the band continue to be heard very widely. In Massachusetts, Sullivan reports, "Cx not really too exciting but a halfway decent TA opening on the top of the band noted AM of 2/10." Raczko, in Chio, noted the same "opening": "TA cx improved on 2/10, high band TA's again heard." Around the beginning of the month, Kreiny in Chio noted that "Cx continue to be rather good with the high band TA's still in nicely." Conrad, in Kentucky, says, "These openings to Europe are really quite something here... some TA's unusually consistent and steady." On the West Coast, Kenney notes, "Cx continue fair to good - as long as all you want to hear is LA's... a few Pacific stations slipping through but nothing exciting." Freeman, also in California, notes conditions are "unstable." In Jamaica, Silvera says, "Cx are improving." Wood, in Hawaii, is the only member to note really remarkable cx of late, "Cx excellent on 1/31 with stations in the South Pacific quasi-local, US stns on every frequency, Central Americans, loud Asians ... Very fine cx on 2/2, with startling openings into the South East Asia." This latter opening of Wood's on 2/2 produced some very fine DX, but seems to have been restricted to that part of the world only. The prediction: improving TA and TP cx, with the current pattern of high band openings moving down to lower and lower frequencies. ECNA receptions of South Pacific and South African will become increasingly likely as we pull out of the Anomaly approach the equinox.

*On Reciprocal Paths. Overseas reception of North American stations continues to mirror the highly unstable conditions noted here. Arctic reports the following receptions from Northern Europe in late January: KMOX-1120, 2115 on 1/21; KSL-1160, 2205 on 1/21; WGWO-1190 at 2210 on 1/21, and WERE-1300, 2235 on 1/21. Quite a few WCNA stations were hrd in New Zealand around the turn of the year, but very few receptions of ECNA staations were noted, according to the NZDXRL. In England, MWN reports that "conditions have remained unstable. Poor to fair in the second half of December, with peaks on 12/25 and 12/31; poor by mid-January still."
*Tristan da Cunha. There is a regular broadcasting service on this South Atlantic

Island located some 1500 miles South of St. Helena (and that is remote! Ed) according to Wireless World. It's operated by the resident ham, ZD9BE, but there's no mention of freq given. Now if they had a newspaper like St. Helena does, we'd know...

*Easter Island. The Chilean Air Force is currently operating a MW station at Manuaco; freq unknown. (ARC) What a year for fabulous new stations! (Ed)

*<u>Lebanon</u>. Beirut was scheduled to begin operation of a new 3 million watt transmitter on 2/2; no frees known yet. (Benelux)

*Taiwan. Work continues on a new 1 million watt MW station. (ARC)

*Mozambique. RCM, new station being built at Beira, to include a 25 kw, 50 kw and 500 kw outlet. Lourenco Marques' installation is installing a 100 kw outlet, and R. Pax in Beira is back on 1295 w/50 kw. (Ginbey via Donnelly via IRCA)

*Masirah Island. Phil Sullivan corrects our item last issue regarding this new BBC relay station. Contrary to our first guess, this will be counted as the <u>Sultanate of Muscat and Cman</u>, and not the South Arabian Federation (the new designation for Aden, now that the British have pulled out). This small island is shown in most atlases as Al Masirah.

*Trucial Emirate of Sharja. Last week's items concerning stns in this new MW country still hold; the WRTVH 1968 Edition is in error in assigning these stations to the Sultanate of Muscat and Cman, according to FBIS. (Ed)

*Russia. According to SCDX, there are now two pirate stations operating off the coast of Russia; the Soviet government reportedly says they are "harmless" and will not put them off the air. Sounds fishy to us - red herring? (Ed)

*Mauritania. Nouakchott will have a new 100 kw MW xmitter on the air by January of 1969, according to a recent SW QSL from the station. (SCDX)

*Saudi Arabia. According to a letter received, Riyadh will soon commence operation of a 1.2 million watt transmitter. Damman will have a 100 kw MW outlet; four additional MW stns will be built starting July 1968, to be 250 kw. (SCDX) Believe the megawatt monster is the one now operating on 600. (Ed)

*Albania. MWN comments re Tirana's wandering 1214V: "Chinese built transmitter under one year guarantee? If anything like the Czech transmitters in Cuba, watch out. Up to 10 kc/s wander when guarantee is up. Wonder if the builders read too much (or too little) of the thoughts of Chairman Mao, or did they get ahold of his 'Second Thoughts! " Chairman Mao's discovered planned obsolescence? (Ed)

*Congo Clandestine. The station on 770 used 10 kw and was operated by white mercenaries when they held Bukavu; the station went off the air on 11/8 when mercenaries burned the radio building on invasion by Congolese troops. (MWN) This station was on the air intermittently from August 17th until destroyed in November as reported above. It carried much recorded mx and broadcast in FF, Lingala, Swahili, and Chiluba. ID's were given as "Ici Le Leopard Libre" and "La Voix du Congo Renaissant"; the two FF speaking announcers identified themselves as "Georges" and "Jean". (Ed) *North Korea. Arctic provides the following program information: 585 is Pgm 2; 625 is Pgm 2; 635 is Japanese Service; 655 is Pgm 2; 684 is Pgm 2; 725 is Pgm 1; 735 is Pgm 1; 785 is Pgm 1; 800 is Pgm 1; 816 is Pgm 2; 849 is Pgm 2; 860 is Pgm 1; 877.5, 932 and 1000 are Pgm 1; 1045 and 1080 are Pgm 2; 1285 and 1335 are Pgm1. ID on the hour is "Chosun Chungang Pansongguk."

*Nigeria. Schedules from MWN: Benin-638, 5 kw, 0000-0500 and 0900-1600; Lagos-1088, 20 kw, 2330-1730; Enugu-1320, Ibadan-1358, 10 kw, Kano-1376, 1 kw, Kaduna-1416, 1 kw

are all same as for Lagos on 1088.

*Cambodia. The new WRTVH gives a nominal freq of 1410 for the high power transmitter currently being hrd on 1434; the latter frequency seems to be a permanent move, however. (Ed)

*El Salvador. National Elections will be held on March 10th; this will be a Sunday and most of the stns in this country should be on all night, judging from past years. (Ed)

*Dominican Republic. This country has now returned to EST; was AST until end of January. (Ed)

*United Kingdom. The UK will switch from GMT to Central European Time (= UK daylight savings time) on 2/18; current bills before the government are expected to block the normal return to GMT later in the year with the effect of placing the U.K. in the GMT + 1 hour zone permanently. NBC news says this is being done to help ease England into the Common Market. (Ed) SHORT EDITORIAL EXCHANGE: one of our members (who we shall call "Anglophile") recently contributed the following lines at the bottom of his report: "So, there I find that I have typed all the times in the only obvious, natural time system an international radio log should use ... G.M.T. Now, under protest, I will go through and change them to E.S.T. And so provincialism scores another hollow triumph." Anglophile: I think your sarcasm might be a bit misplaced. Personally, I'd be more than happy to switch IDXD to GMT. However I think that this would result in a hopelessly confusing situation unless the entire NRC bulletin switches over uniformly to GMT. So why not write into the Musings and Dialog sections and attempt to persuade the entire membership to make the switch instead of just writing to IDXD? If it ever comes to a vote, count me in favor of GMT. And while you're at it, please get NZDXRA to switch from N.Z. time, ARC to switch from CET, and IRCA and NNRC to also switch from EST. In the mean time, don't bother writing me any more about it, I'm already on your side. (Ed)

*Question Corner. Frank Merrill asks, "Do you have an address at which I can contact the Israeli Forces Broadcasting Service?" *Botswana. According to a special item in the New York Sunday News of January 28th, "What was to have been one of Britain's top weapons against Rhodesia - a bush radio transmitter in neighboring Botswana aimed at countering Rhodesian press and radio censorship - is to be abandoned soon as a total loss because of consistent jamming. The radio is still functioning at Francistown, about 10 miles from Rhodesia's western border. It beams special propaganda features as well as normal BBC programs into Rhodesia. The transmitter was erected in the bush under heavy British miliary guard soon after Rhodesia's white premier, Ian Smith, declared unilateral independence from Britain in 1966. Its aim: to undermine the post-independence confidence of the country's 220,000 whites in their government. It didn't work. Smith promptly ordered jamming stations set up to block off the transmitter. The station has been a costly failure, losing an estimated \$700,000 a year and wasting money which Britain feels it can no longer afford. Britain has a stronger relay station on the midatlantic island of Ascension and officials are studying the possibility of having it take over some of the funcitons of the bush transmitter. Since the station is so much more powerful it is considered less likely that Smith would be able to jam it effectively." Tnx to Bob Foxworth for spotting this item. *Direction finding bearing conventions. As increasing numbers of NRC'ers begin to experiment with DF, there's going to be confusion unless the standard system of nomenclature is adopted. A DF bearing is the angle between geographical north and the measured angle of signal arrival at the receiving site. This angle is measured in a clockwise sinse from North: thus, a bearing of due North is 0°, due East is 90°, due South is 180°, and due West is 270°. Two further points: in some cases the absolute sense is unknown, in which case the bearing may be either B or 180° in this event, it's useful to report the observed bearing in the form 65°/245°. Secondly, when reporting relative bearings made with respect to known stations, please report results in terms of the conventions given above, e.g., Barcelona loops farther north than Dakar. When attempting to determine the possible location for some bearing measurement, remember that the paths are great circles which do not form straight lines on ordinary Mercator Projection maps. (Wood, Hawaii) HJLC, El Banco, just about making it above the 1575 Costa Rican on 1/30 at 2240 and later; hard to get material but is separable from 1575. (Zahner, Md.) Humm, looks like there might be a hit of confusion around this

1578 Italy. RAI synchros here w/good signal 2/10 0040-0130; apparently EE lessons to 0100 but QRM from 1580 was bad until then; nx 0100, and namy ID's for RAI; someone under them, sounded like CSB5. (Sullivan, Mass.) RAI s/on in II at 0030 on 1/6; scope showed 3 carriers, // RAI stations I suspect. EE lesson 0035-0100; man in II and woman in EE; scope showed a big change at 0058+ and modulation from RAI dropped fast. At 0100 was 5 time pips and one tone, followed by what seems to be Porto's s/on; news followed by mx and ads and talk between selections, so evidently I had RAI on 1/17 0035-0100 and Porto after that; RAI-Porto SAH about 5 cps, some very weak slower ones there too, probably RAI // carriers. Porto is not sked to s/on until 0200, but 6 time tones at 0100 is wrong for either of them; it's 0700 in Portugal and 0800 in Italy. So what gives? (Conrad, Ky.) No, Jerry, both Italy and Portugal are on GMT + 1 hour, which is Central European Time - so it'll be 0700 both places. Both Pete Taylor and I have very good tapes of RAI around this time with five fast pips, a space, and a sixth one; very good II right afterwards makes it almost certain that the pips were from RAI.

Quite possible this late? No other TA's hrd this night. (Raczko, O.)

(Raczko) WDR 3 pips and Brahms lullaby 0200 2/3, female announcer (didn't sound like the usual one). (Kilroy, Wash. DC) A powerhouse here 1/5; strongest just before f/out 0155; was this near E20 time for Langenburg? At 0055 have noted their IS for one minute, then "guten morgen, hier is Westdeutscher Rundfunk..."; this is for the s/on of the rest of the net I guess. (Conrad, Ky.) Fortuitous fade, Jerry; E20 time considerably later that AM. (Ed)

1594 Portugal. Lisbon was quite likely the TA trying to get past WAKR QRM from 0242-0252 on 1/28; still need here, but didn't quite make it. (Krejny, 0.) Enclosed tape was made on 1/29 between 0022-0045; probably the same stn reported by Engberg in 1/20 IDXD; probably Lisbon but does not sound like PP to me. (Merriman, Va.) Tape came through with a low audio level and a bad hum, Alan, but managed to clean it up quite a bit with selective audio filtering. It's definitely PP but couldn't be sure before filtering. (Ed)

**1599 Philippines. DZCH, Manila. EE nx 0800, ID as DZCH 0810 and into concert, easily

separable from NHK-1600. (Wood, Hawaii)

Local Sideband Splash - How Much Is Too Much?

One of the most aggravating problems that the international DX'er has to live with is the sideband "splash" from his local stations. All DX'ers have observed that the amount of splash generated by a station depends on the type of programming: pop music with drums, etc. is worst, speech (particularly telephone talk shows) is better, and very soft music is best of all. In the extensive article on selectivity and mechanical filters published in DX News last summer, we outlined the basic nature of sideband production, and explained how much (but not all) of the splash encountered on the band is actually due to the inadequate deep-skirt selectivity of most commercially available receivers.

But even after installation of multiple mechanical filters, improving interstage isolation, and all of the other techniques outlined in the selectivity article, the unlucky DX'er may still find one or more of his locals splashing seriously on frequencies far from the carrier frequency. A case in point is WRKO in Boston, whose 50kw hard-rock-programmed signal on 680 produces intolerable splash from 620 to 740 kc/s throughout much of the Greater Boston area. Other notorious offenders are WWRL-1600, WEEZ-1590, WGWO-1190, WABC-770, CBL-740, KFI-640, etc.

Mutterings of "overmodulation" are often heard at DX get-togethers, particularly when owners of top-quality equipment compare notes and discover that certain locals consistently splash more more than others, regardless of power or distance. The germane questions then become, "how much splash can a station legally produce?" and "is the FCC effectively enforcing its regulations about excessive sideband radiation?"

The relevant FCC regulations are found under Section 73.40 of Part 73 of the FCC Rules and Regulations. They are,

73.40(12): "Any emission appearing on a frequency removed from the carrier by between 15 kc/s and 30 kc/s, inclusive, shall be attenuated at least 25 db below the level of the unmodulated carrier."

73.40(13): "Any emission appearing on a frequency removed from the carrier by more than 30 kc/s and up to and including 75 kc/s, inclusive, shall be attenuated at least 35 db below the level of the unmodulated carrier."

73.40(14): "Any emission appearing on a frequency removed from the carrier by more than 75 kc/s shall be attenuated at least 43 + 10Log₁₀ (power, in watts) db below the level of the unmodulated carrier, or 80 db, whichever is the lesser attenuation."

What does this mean to the MW DX'er in practical terms? Consider the case of 50 kw WRKO on 680 kc/s (an example near to the author's heart):

(a) On any frequency up to 30 kc/s from 680, i.e., from 650 to 710 kc/s, the amount of splash allowed by the FCC is the same as would be produced by a 158 watt transmitter at the WRKO transmitter site. (50 kw down 25 db is 158 watts)

(b) On any frequency up to 75 kc/s from 680, i.e., from 605 to 755 kc/s, the permitter splash radiation is the same as would be produced by a 15.8 watt transmitter.

(c) Outside the 75 kc/s limit, the allowable radiation falls off very sharply; in this case, all the way down to 500 microwatts.

But 15.8 watts isn't much, you say? Ordinarily it isn't, but when the transmitter is only a few miles away, it can make DX'ing for a weak signal very unpleasant if not impossible. And remember that CBC 40 watt relay that's heard so well in New Zealand!

Therefore the basic splash problem is due to the permissiveness of these archaic FCC regulations, and not with inadequate enforcement of violations (except in a very few cases). While it's not really much consolation, the DX'er can be thankful that very few stations radiate anywhere near the maximum allowable amount of sideband radiation. Fortunately, a carefully adjusted and well maintained modern transmitter radiates a very clean signal in terms of the FCC regulations. Thus the only way a DX'er can gain some measure of respite from a legal but splashy local (after appropriate receiver modification) is to null the offending station with a good loop antenna - either that, or move!
