METHOD OF PRINTING FOR NRC LOG ...

has come up for discussion, as Jim Critchett suggests the stations be kept under each frequency alphabetically by call letter (as in the old Weyrich Log) instead of alphabetically by State and Province (per Vane Jones). From the standpoint of efficiency of preparation and of checking against FCC listings, and also of correction, Jim, we will list it via state and province. All other sources, whichform the tramework for our listings ... the FCC official list, the Broadcasting Yearbook, and subsequently, the VJ Log, all are listed in this manner. After going through each station singly, then typing the pages, we have discovered it is possible to skip a line and leave a station out as we transcribe our Master List. Therefore, to check it against a form, it's lest to have our log in the form of that which is to be checked. To correct a list, when a call letter change takes place, as occurs all too often, it requires a shift in the list if the list is alphabetized by call letters. If by state and province, no shift is required. It is also, to be honest, a personal preference, and the log does stem from our own personal, updated log. (Another reason for listing by state is that the new permit, se call has not yet been assigned, can be put in its proper place.) But if enough people indicate their ference later, we would consider another method. Ray Moore has volunteeved a couple of secretaries and a puter ... so that later on this summer, after the log is completed, the information will be punched out on cards, which will be updated consistently, and mad year's "Master" will spew forth from the computer.

hard F. Wood - 1630 Ruth Place - Honolulu, Hawaii - 93816 I am now able completely to re-aim my sights in DXing. Ever since I arrived here in Hawaii & took up residence within three miles of most of the Honoluly XR sites: 16 stations, all non-directional & unchanging in power, many of them ANers, I had suspected that I was labouring under unnescessary difficulties. Now I have taken the bull by the horns & gone mobile. (You won't get much milk that way, Richard, hi -ERC) From now on, I will be doing all my DXing from my station wagon, within five to ten miles of my home but in locations which permit mulling, sometimes partial, sometimes complete, of the locals. These locations are still within Honolulu, but the terrain is rugged and the locals really suffer, including even KUMU-1500, recently upped to 5,000w, which was being overridden by a US mainlander. In fact, during my first mobile experiment, at 8pm local time (lam, EST) US & especially Canadian stations were all over the band, w/many new ones noted; the graveyards seemed particularly interesting, not packed, but w/just a few fairly clear signals partially distinguishable on my loop, which I have trimmed and restrung for mobile use. I will be installing SP-600 & an inverter, & a regularly recharged battery. My first experiments, brief & early in the evening, due to lack of a charger (which I now have) produced, checking only the high frequency end: KUBA-1600 (500w), XEDM SERF KPMC KKHI KPOL KFBK XEUR-1530 KOMA (outstanding) SESM-1470 KVEN-1450 Ventura, my first US graveyarderm KFAC-1330 KUDE-1320 (500w) KGIL-1260 KSL KRAK-1140 XERB KNX KFAY-1060 CFCN CBR (outstanding). I may start domestic DXing, but graveyarders only. However, my main goal remains foreign DX, & I feel that India & even Africa & Burope are now within the realms of possibility; s/on of the locals, w/their numerous spurs, will mo longer be a problem. From now on, then, all DX reported will be from the car, where the SP-600 will be permanently installed. And now, at last, for some real DX!

First off, I will tell you that I just received my 4/27 DX NEWS, on 5/3 - it took six days to get here; never so late before. I guess I'll blame it on the P.O. Re WNAX & WDGY skeds, I don't believe WNAS is even AN, let alone NSP. At least, I've never heard 'em after 12 on RS. I will check further, however. WDGY is off, I believe, from 1 to about 5am on MM. Phil Sullivan also reports that the NAB has requested that the FCC loosen its logging requirements for AM & FM stations. Stations would have to tally only total amount of commercial time, as in Ty, instead of the precise length of each spot. The significance is, of course, in relation to reception reporting.

Ugly Radio is now officialy declared dead...Frank Zappa, you can relax. WBCN's "American Revolution" is now fulltime, WDAS (FM) in Philadelphia is soon to go "underground", adding to the growing list Hopefully, "Much More Music" will have much fewer listeners soon.

DX conditions here in the Northeast have definitely improved in the last two weeks: most of the high-powered Western European TA's have been fair at s/on time; TA's Were particularly good on 5/19. Still no sign of deep South Africans but definite traces of carriers from Nigeria-1358 and Guinea-1402.67. In Missouri, Bruce Reynolds notes that, "there was a good LA opening on Sunday evening 5/12, despite some QRN. The static has been dominant most of the time though." In Miami, Sheldon Willer reports "nothing earth shaking but cx are good - not too much summer static. LA's are dominating all clear channels except WBT, WBZ, WSM and few others." Also in Miami, Bill Brubaker reports "Cx have been fair with lots of static some nights. LA's still seem to be strong... at least for now!" In California, Father Jack Pejza reports "5/13 was a fabulous night for me - 4 new New Zealanders one right after the other. Figuring the opening might still be there, the next night I tried again and got what I think was another one on 860." In Hawaii, which seems to be a good DX location in spite of the locals, Richard Wood reports that conditions "are still astonishingly good, with many interesting Asian loggings and a new country, Hong Kong. Fine DU and Pacific conditions, Midwesterners dominant from N.A. (WHO, WLS, KXEL, CFCN)." But the summer season has really begun to hit the high latitudes says Bengt Ericson in Sweden: "Spring is here and the weather is wonderful - therefore not so much DX'ing. Cx very poor mostly, but some openings to Middle East have been noted here, for example on 5/10." [To a first approximation, the Middle East region is for Sweden as the Caribbean region is for ECNA - Ed]

China. Radio Peking expanded their Russian language services effective May Day; a partial listing for this service, as of May 4th, is: 1000-1100 on 620, 840, 1120, and 1525; 1100-1200 on 620, 1120, and 1525; 1200-1300 on 585, 620, 740, 910, 1120, 1460, and 1525; 1300-1400 on 585, 645, 740, 910, 1120, 1460, and 1525; 1400-1500 on 585, 620, 645, 740, 910, 1120, 1460, and 1525; 1600-1700 on 1120. Cesar Objic writes: "in addition to the complete list of US, Canadian, and Mexican stations provided by NRC HQ, the Summer Edition of the World Radio TV Handbook will publish again an accurate list of Latin American MW stations, with some corrections made by me. Last year this log helped me a lot. Here is a double reason why every NRC er must own a copy of this useful list of MW stations. I recommend it." The IDXD editor seconds this recommendation; full information about the availability of the Summer Edition will appear next issue of IDXD.

Recommended reading: A fine article on veteran NRC'er Norm Maguire, W5NXF/KH6FQB, in the Awards Program section of CQ magazine for May, 1968, on page 99 - complete with a one paragraph plug for BCB DX'ing and the NRC. A most interesting piece in the British electronics magazine, Wireless World, April, 1968, entitled "How Important is Detection?". The author examines the detection process in some detail and describes his experiments with a radically new type of detector circuit using a zero-crossing detector instead of the conventional envelope detector. He reports superior performance on rapidly fading SW signals compared with conventional circuits; there is a good chance that this technique could be extended to MW application, especially to reduce distortion on graveyard channels. It looks worth tinkering with.

The End of Radio Americas? By G.P. Nelson

"Now, if an accredited member of the press, of known repute, did visit Swan Island and determined that both XMTRs were indeed operating there, this is a major breakthrough and there can be no further dispute about the present location of Radio Americas... If a reporter has visited Swan Island, this is the most unpublicized scoop in the history of journalism. So far as I know, it has not been carried by any of the news services and the story has definitely not been reprinted in any of the club bulletins." (C.M. Stanbury, in the May 4th IRCA DXWW)

Beginning with C.M. Stanbury's original announcement in Electronics Illustrated some four years ago to the effect that Radio Americas was not located on Swan Island (based on his "Fraud Finder" results), the "Radio Americas Controversy" has continued to flourish as the most artificial and overblown issue ever to hit the DX hobby. While the "mystery" of the location of Radio Americas has continued to sell magazines and articles in the popular electronics press for the benefit of a handful of publishers and authors, almost 100% of the world's DX clubs and publications have accepted the fact that Radio Americas was, and always has been, just where they've said they were - on Swan Island. The evidence for the Swan Island location has been quite convincing: the extensive direction-finding study made for ANARC by Jack Keene and the author; Don Jensen's exhaustive journalistic research on the subject; the color aerial photographs supplied by Radio Americas; the highly detailed Coast and Geodetic map of Swan which matched up rock-by-rock with the photos; etc.

It's then particularly amusing that, almost to the day, one of the hobby's most poorly kept "secrets" should hit the stands at the same time that Radio Americas ceased operations: that Electronics Illustrated, the same magazine that supplied the national platform for the "controversy", financed and carried out an actual visit to Swan Island. The whole story, complete with photographs of EI author Tom Kneitel and Editor Bob Beason on Swan Island, appears in the July issue of EI now on the stands. It's an interesting and amusing article and we recommend it to anyone who wants to see the "Radio Americas Controversy" laid to rest once and for all.

A couple of interesting points are raised by this latest article: that the color photographs supplied by Radio Americas three years ago match the installation photographed by EI in all details, and that the airfield on the island is just barely adequate for a DC-3 at best. The present installation has thus been there for at least three years - and regular DF measurements during that time fail to show any deviations that could be due to another transmitter in parallel at another location. It then seems incontestable that Radio Americas has indeed been operating from Swan for a long period of time - dating back almost to the time of the genesis of the "controversy".

Two years ago, in a personal letter to C.M. Stanbury about Americas (and quoted by him in the 1/67 issue of EI), I said "futher unsupported speculation on your part can only further damage your credibility." And we think it's still an apt sentiment.

Chile. CB118 hrd for the first time before midnight, from 2331-0000 Saturday 5/18; at 0000 the announcer said "Buenos noches", followed by chime IS twice, indicating a possible s/off; not hrd after that. HOCGERHEIDE: is this one AN every Sunday AM? (Godwin, Colo.)

1192A Colombia. HJCT, La Voz de la Costa, Baranquilla, 4/6 at ID 2133; is this one 5 kw? (Raczko, 0.)

1195 Unid SS. Noted briefly MM 5/13 0043. (Merrill, Mich.)

1200 Costa Rica. A best bet now that the US is on DST; often overrides the Cuban here after WOAI s/off and has been hrd overriding WOAI at times; can't be only 1 kw? They s/off at 0100 MM's now and are EE. (Merrill, Mich.) TIQ is only 1 kw as best I can find. (Ed)

1208A Guatemala? TGED? Very loud SS above WOAI, frequent mentions of Guatemala but no ID hrd; this was around 2300 5/12. (Reynolds, Mo.)

1210 Unid SS. Hrd here on recent MM's, w/mx, until at least 0130; can't separate it from the Cuban het though. I hear that someone in IRCA got an Argentinian here; hrd 5/6 and 5/13. (Merrill, Mich.) LV3, R. Cordoba has been noted on this channel during springtime for about 3 years now, Frank. When I got them some years ago they s/off at 0230 w/a very distinctive organ theme and chimes. (Ed)

**1210.64 China. An unknown Chinese outlet has been measured on this frequency recently by EBU. (Ed)

1220 Cuba. Hrd 2230 5/7 w/ID as "Primera Cadena Provincial de R. Veinte-seis en Matanzas, Cuba." Plays mostly mx, EDT TC's; CMGY from 1240? (Rogers, Fla.)

1270 Mexico. XEAZ, Tijuana. Mx until 0250 on 4/10; then nx in SS until s/off at 0300. (Pejza, Calif.)

1290 Dominican Republic. Unid stn s/off w/Dominican anthem 0002 5/13. (Miller, Fla.)

1292A Unid SS. Perhaps a Cuban at 2200 4/6? Too weak and too much splatter from 1290 to ID. Definitely not PJD2-1295. (Raczko, O.)

**1304 Portugal. Emisora Nacional is now running test transmissions on this channel to improve European reception of its foreign service. (SCDX)

report. (Wood, Hawaii)

**1468 Brazil. ZYK22, R. Liberdade do Cauraru logged in Europe. (ARC)

Unid SS. Hrd around 0130 MM 5/13 and AN SM 5/19; weakish; very deep-voiced announcer - sounds Colombian I think. (Cooper, N.Y.) SS hrd here MM 5/13 until at least 0100; WMBD was off, making reception possible. Played no (or very little) mx; were switching back and forth among announcers and they all seemed to be shouting into the mike; sure could use more foreign stuff around 1470. (Merrill, Mich.)

1473 Unid SS. Hrd here MM 5/13 at the same time as 1468; fast instrumental mx. Not 1475 but it seemed like about 1472.5; WMBD came on back somewhere around 0100

completely shattering these two SS stns. Help. (Merrill, Mich.)

1480 Japan. JOHV, Naze. NHK II net, EE lesson 5/9 0930. (Wood, Hawaii)

1500 Thailand. HS1TV, Thai TV, Bangkok; 2nd pgm, EE lesson 5/9 1000. (Wood, Hawaii)

**1511 Greece. Corfu, 50 kw, is now here ex-1007. (ARC)

1525 <u>USSR</u>. EBU reports both a Soviet broadcaster and jamming on this channel for the Sinkiang stn. (Ed)

1527 USSR. Soviet transmission on this channel is believed to be a parasite from

the 1525 transmitter according to EBU. (Ed)

1530 China. Looped South-Central China, listed Hwaiyin M JKT seems most likely (Kiangsu Provence) 5/9 1010. (Wood, Hawaii)

Hong Kong. Commercial Radio Hong Kong. Very nice for new country w/GSTQ s/off 5/9 1003. (Wood, Hawaii)

Unid SS. Hrd one recent MM 0200 and later until KPBK took him out; still no ID and may be on only during summer as not hrd since last Summer. Very weak. (Cooper, N.Y.)1540

1540 Panama. Unid stn on w/FR 5/13 0115; slightly off frequency but dominating the channel. Who? (Miller, Fla.) HOOH, R. TNT, 1 kw listed. (Ed)

1550 Philippines. DYLA, Cebu City. Overwhelming 5/9 0930 in Cebuano; there is absolutely no comparison between this power-house and the other elusive Filipines and it does not seem to be a matter of directionality, as similiar results are reported from Sweden, Hong Kong and New Zealand.
