
#### LOG UPDATER

John notes that about 90% of the info in the Updater is new; the rest represents various types of proofreading errors which crept into the original Log. This latest updating is being distributed to Lon Berman's computer log crew for incorporation in the 1969-1970 NRC Log. While at least some of the information in the Updater has already appeared in the pages of DX News, John's put it into a handy by-frequency format that makes the Updater a most useful auxillary to the Log itself. 

DX conditions here in the Northeast have been pretty much so-so during the past week; no good TA's noted since the Aurora kicked up again on 2/27. Glenn Jacobs in Philadelphia noted a bit of TA activity on 3/5. Jerry Starr in Ohio also experienced remarkable reception on 2/24 (see past two issues for other comments on that night's conditions): "Outstanding TA openings, both hi and lo, on 2/24. Cx held til around 0220 when low-banders started to drop away; high-banders soon followed. Had readable copy on many TA's. "armchair" copy on 647, 773, 1214, etc. The next MM. 3/3, was just the opposite with the most terrible static level since summer. Otherwise cx here as of late have been very uninspiring - just the usual blah with increasing noise." Glenn Hauser, in Colorado, says, "Severe auroral ex noted here the evenings of 2/27, 2/28, and 3/1, with a pipeline from Guatemala on 670 and 760; and 1030, 1040 and 1110 among the US clears particularly hard hit on 2/27: at times WTWO. WHO and KFAB were completely absent. On 2/28 and 3/1 auroral cx gradually approached normal a few hours after sunset. Nothing beyond Ecuador was hrd. but reception from Central America was better than usual these nights." Indefatigable Richard Wood once again checks in with some interesting comments from Hawaii. "3/1 mostly North American but not outstanding: a few Asians in late; only Majuro among Pacific Islands; no Southern Hemisphere. 3/2 a good North American night; EC good, WCBS new and good. Otherwise as 3/1. 3/3 a fine North American night; Alaska back at fair levels; WCBS, WHAM good; WCAU new; lots of Canadians as far as Manitoba (new Province). Tahiti noted for first Southern Hemisphere logging in a week; very interestingly, an opening into nothern South America including Venezuela for a new country; but Cuba and Sint Maartin not noted; Asians better on low freqs than on high, and quite a few Japanese noted. Still no Australia, New Zealand, Fi ji, Tonga, etc." (Yah, same here - Ed)

Hope for a recurrence of conditions like those on 2/24 was dashed by a geomagnetic/auroral disturbance beginning on 2/27 (see comments above). The following graph shows the level of high-latitude auroral disturbance on each day as measured by the ESSA Fredericksburg A index. The higher the value the greater the absorption on high-latitude paths; BCB DX'ers almost inevitably experience "auroral conditions" during a period of high A values. Richard Wood is relatively immune, however, because of his southern location. Dates are GMT. Note that the remarkable night of 2/24 occurred after 13 days of uninterrupted auroral quiet. Stars are nights with unusually good high latitude reception; "l" indicates good reception in low latitudes; "a" indicates ebserved auroral type conditions.

ZBVI is being hrd coast-to-coast now, and we most modestly point out that NRC scooped everyone else on this story. Now if only WABC would somehow stop splashing....)

780 Colombia. La Voz del País, ID at 2002 3/1, this is the station thought to be Radio El País HJZG Cali, hrd for the first time thru YVOD

and Barbados, having looped them out. (Objio, Dom. Rep.)

Mexico. XEFW Tampico, Tams. quite good 0730 3/3 with ranchero mx, the farmers' favorite request on morning shows. (Wood, Hawaii)

840 Colombia. HJBI Ondas del Caribe on late, logged and reported 0030 to 0045 with excellent signal. Asked for reports on the air, apparently, and gave QTH as Apto. Aereo 757. (Merriman, Va.) HJBI very good for loudest Colombian yet here, 0530 3/3 with tropical mx and requests for foreign reports. In Santa Marta. (Wood, Hawaii)

Venezuela. R. Punto Fijo, YVNN very good for first Venezuelan, a new country here 0530 3/3, rapid-fire news from Radio Rumbos net. (Wood)

Of Colombia. Radio Eco, Cali, HJGB IDed at 0023 and after every record on 3/2 and alwo w/telephone no: 226158. Hrd until 0200 and seems to be AN with pop mx. Did not hear HJFN, L.V. de Café. (Objío,DR)

980 Kazakh SSR. Bugaj's logging of RR on 980 is Alma-Ata. Hrd here some nights, starts around 1900. About the unID Russian on 1080 I have no idea, but will check. (Ericson, Sweden) (cf. MR March 1, 1969)

995 Ecuador. R. Suceso, Guayaquil must be the one w/mx and EST at 2240 2/28, a good auroral evening. (Hauser, Coolorado)

1025 Costa Rica. Radio Fides, San José in "reloj" format with chimes in newscast at 2110 3/3. (Hauser. Colorado)

\*\* 1034 Mexico. Another spur or drifter obliterating 4VEF and finally IDed as XEWS-1010 Culiacán, Sinaloa. Noted at 2315 2/28 with 1-to-2 minute slow MST TC's, IDs after each selection as "La S Mexicana" and no complete ID heard until 0130 3/1. Also the night before, on 1032, hrd 2/27 with ratchety sound, no discernable carrier. At 2229, Diario de Culiacán sorteo, 2232 talk on Cuba, 2236 the Javier Solís mx pgm, 2239 and 2247 bicliceta ads, 2254 ad for zapatería (shoestore-Ed) etc. Quit it at 0115, no / audible on 1010. (Glenn Hauser, Lowry AFE Colorado)

Honduras. HRVH, Radio Mil yelled ID 0024 1/3 (that's 1 March) with dance mx, WHO easy to null during auroral cx. (Hauser, Col.)

1040 Colombia. HJFV R. Tropical 0201 3/2 ID as "La nueva emisora Caracol en Barranquilla," 10 kW, dance mx. (Hauser, Col.)

1065 unID. Likely the weak SS at 2210 2/28 was HCRV-3, Radio El Oro, Machala; probably Merrill's unID also. (Hauser, Col.)

1075 Costa Rica. Faro del Caribe, TIFC at ID 2145 2/27, Sousa march, plug for news, a lack of ads. (Hauser, Col.) (is religious owned)

Venezuela. YVQJ Radio Barcelona with NA on MM 3/3 at 0504, s/on at 0506, QRM de TT, last logged a year ago when KRLD off. (Hauser)

1080 Haiti. Station 4VA, la Voix de la Révolution Duvalieriste seems the only possibility for EE lessons for French listeners, at 0543 MM 3/3 thru KRLD OC, ending at 0551 but soon faded out. Can you confirm, César O.? (Hauser, Col.)

\*\* 1100 Dom. Rep. R. Oriente, HIHD, San Pedro de Macorís hrd here on 3/1, this is a move here ex-1325 kc. (César Objío)

1110 Mexico. XERCN unusually strong aurorally at 2125 2/28 with RCN IDs and had to loop them to get a lousy signal de KFAB. (Hauser, Col.)

1120 Cuba. CMDL, R. Angulo, Holguin at s/on 0355 with NA and s/on anct using this call and slogan, 3/3. (Starr, Ohio)(7/68 Cuba list says this one using only 250 watts.)

1155 El Salvador. My unID is probably YSCF listed on 1150; LBG says it's Ondas Orientales. Probably Winsor's unID too. (Hauser, Col.)

1170 Venezuela. R. Acarigua, YVQV, Acarigua hrd for the first time by mg, IDing at 2150 3/1 and with pop mx. (Objfo, D.R.)

1178 Ryukyu Is. Tuned across a totally clear BCB at 1235 2/21 and noticed only 2 stations, Dushanbe-1160 and oriental talking on 1178 at a s-9 level. Stayed with it until 1259 when "Yankee Doodle" faded up. Was s-9+ 20 db at this time. Then ancmt: "This is the V.O.A. from Okinawa concluding broadcasts on this frequency." Unbelievable strength and has to be my best catch. Hrd again next day 2/22 at the same time but much weaker. Hrd both days 90 minutes before local sunset. (Bugaj, Iceland) (ARC monitors in Sweden report excellent cx to Asia 2/20 and 2/21 also, so it seems you caught the tail end of a period of good high-latitude skip; GPN could confirm this. Regarding the no. of minutes before LSS you heard a skip signal, nal like this, the elevation of the sun above the horizon at the time of reception, among other factors, would affect the signal' strength. I assume the sun would appear to "skim" into the horizon at your far-north latitude, and so would have been low in the sky at 1230-1300 EST; allowing VoA to creep in from the opposite bearing. Were the sun high in the sky, of course, it's radiation would ionize the D-layer sufficiently heavily to absorb the signals as they appreached you, and no reception would be the result.

\*\* 1445 Colombia. Ondas de Ríohacha HJBZ Ríohacha IDed at 1700 3/2 and announced freq. as 1440. Football game (Objio, DR) (soccer to us)

\*\* 1518 Dom. Rep. R. Pueblo, HIBL is back on the old trail. I had a talk with the director and he said they had been given a right for 760 kcs. from the Provisional Government in 1966 but they did not make the change until now. ## The Exceedingly Strange Case of the STOLEN STATION

Can you imagine the surprise of the announcer who tried to sign on WEIW-1330 the morning of February 9 and discovered that the station had been stolen? This is not another hard-to-believe T.X. Thrush fable. In one night, this daytimer in Willoughby, Ohio, was cleaned out, The thieves managed to spirit away all the monitoring equipment, control boards, mikes, turntables, recorders, cartridge machines, records, tapes, clocks...the whole works. The transmitter was much too large to move, so the nocturnal raiders disconnected the power lines and stripped out all of its components. In all, about \$25,000 worth of WELW was whisked away into the night. Was this perhaps a real Alexander Mundy? Or a Wes Boyd?

Although speculation among broadcasters covered everything from an irate group of listeners to international smugglers, the real answer is more fantastic than all of these. In time a crate of equipment, discarded and found under a bridge, was traced by local police to the alleged mastermind of the robbery, a 15-year-old from suburban Cleveland. He confessed that he and a 16 year old buddy alone had pulled off the job at WEIW. Police recovered most of the stolen equipment at the youth's home. The boy, described as an electronics genius, was the operator of a bootleg station which the FCC had shut down several months previous. The kids had decided to return to the air with some better equipment and higher power. Investigators said the youngster had equipment sufficient to radiate in excess of 1000 watts. They also had stolen gear from Cleveland stations WIXY, WKYC, WJW, and WGAR; much of the stolen equipment which could not be used for the planned station, undoubtedly to have been the world's most elaborate and pewerful teen-operated bootlegger, was thrown into the river by the youths.

Meanwhile, a call had gone out to other stations in the area for help, especially others on 1330, WHOT included. As Ken Otstot, Station Manager at WEIW, said, "The response has been fantastic." He was deluged with calls from the competition offering equipment and spare parts. WELW, which calls itself "All Heart Radio", returned to the air a little over a week after the robberywith an ad in the local newspaper. The ad read: "WELW, All Heart Radio, has just had a transplant,"

#### **MECHANICAL FILTERS FOR THE HQ180**

JERRY STARR WHOT RADIO

In these days of increasing spectrum saturation on the medium waves, DXing those foreign "splits" becomes increasingly hard. What you need is the extra selectivity offered by the addition of mechanical filters such as the unit shown in photograph A.





Photo A Mechanical Filter and Transformers

This feature will outline all the modifications necessary to add a filter section to the Hammarlund HQ-180 receivers. The same basic installation can also be adapted to other receivers in the 455 kc IF group. This installation also makes use of the waste space in the 180 cabinet making possible inboard installation of the filter and additional IF amplification.

First, a word of warning. Don't even attempt this modification unless you know what's happening inside your receiver, this is not a project for beginners. If you feel you're not sufficiently experienced to tackle this work,

I suggest you discuss the modification with a qualified ham who has some construction experience or a qualified repairman.

Photos B and C show the completed installation. The entire unit is mounted on two screw lugs mounted on the rear plate of each variable. The shield cans covering the variables were formed of sheet aluminum. Some later models come from the factory with this modification. If nothing else, they keep the dust out of the plates and provide a firm base for mounting the filter array. Notice the tube (shield removed in photo) is mounted on the side of the unit. If you locate it on the top or end you'll never get the chassis back into the cabinet. Notice the box is mounted so as not to be above any tubes, to do so would hinder cooling of the tube. The control next to the tube will be discussed later. The IF inputs and outputs are on connectors, other leads are simply routed through small drill holes. If the back of the 180 chassis looks changed, it is. I have added two jacks for speaker and tape outputs and three binding posts to replace the antenna screw terminals. This makes for much easier connection of external units without having to find a screwdriver, and eliminates the screw terminal



that always strips out with constant use. The flexible coupling through the front panel is a tracking error adjustment. These are all worthwhile and fairly easy modifications.


FIGURE 1 is the schematic for the filter/amp unit which should need no further explanation. Remember to keep all leads short. All of the components shown are inside the box except the 6BE6 (V-3) and transformer T3 which are existing components in the receiver and are so numbered in the Hammarlund instruction book.

The additional tube (V-19) is a 6BA6 or EF93 which is the low-noise 6BA6. If you make your own printed circuit, a small board will hold everything nicely.

SEVERAL CONSTRUCTION TIPS: Use shielded wire for all external leads. I used RG-174U coax, the same stuff many of you use for winding loops. Remember, ground the shield at one end only. Larger coax can be used but it's much less flexible, which could cause some headaches. When you locate T3 in the Hammarlund chassis you'll find it under the selectivity switch nearly hidden, a good reason for using small coax. This area is shown in Photo D. If you want to make this a two-week project, try to work through the switching unit. Otherwise, carefully unsolder all leads to this switch and remove it. Be sure you mark down the color code and termination of all the wiring for reference in re-installation of the switch. A glance at this wiring will tell you why this is not a good project for beginners.


Chances are you'll have some instability in the unit. To clear up same, place a small shield between pins 5 and 6, 2 and 3 on the 6BA6 socket and use a tube shield.





Photo D showing wiring jumble in the installation area.

The cable bundle from the unit is easily routed through the access hole in the Hammarlund chassis directly under the "S" meter. With shielded cable you shouldn't have any problems here although you may have to do some under-chassis rerouting if you get instability. This hunt-and-try process will vary from one installation to the next.

It is advisable to keep the input and output terminals of the filter well shielded from each other. Here's an easy solution to this mounting.

Use two pieces of printed circuit board, one of the type with solid foil on one side, the other without foil. This board is easily worked with an Exacto knife and a small drill. Cut three pieces as shown in figures 2 and 3 (not shown at scale), the figure 2 pieces from the board with foil, the figure 3 piece from the board without foil. The external dimensions are dictated by the size of box you're mounting the filter in. The width of each piece should equal the inside width of the box. Cutout A should be the exact size of the body of the filter. Round off the corners of cutout A to fit snugly over the filter. The width of cutout B is the same as A, the depth is the same as the thickness of the PC board.

On <u>figure 3</u>, the width of cutout D should be the same as B. Cutout C is the same as the <u>thickness of the PC board</u>. The board in figure D is the one on which the filter is mounted. Lightly ink the bottoms of the pins on the filter, center it on the board and press down slightly. Then drill out the holes for the pins to pass through. Do the same with the two




transformers. The two mounting tabs on the filter body should be located to one side of cutouts C, not across it.

Don't get the transformers mixed, they are marked G or P on the bottom and match with similiar markings on the bottom of the filter body. Mount G to G, P with P. Bend the

mounting tabs securly under the board.

With the filter mounted, slide the figure 2 top over the filter and the figure 2 bottom from the underside of the board. Top and bottom should completely surround the filter and come together in cutout C. Remove the decal from the top of the filter, put the top and bottom boards in place and solder them together where the foil of the two pieces meets. Then solder the foil around cutout A to the body of the filter The completed unit can be mounted on two or four small standoff insulators by drilling mounting holes at the ends of the figure 3 piece. The completed product should resemble figure 4 below.

For mechanical filters to do their job, this type of shielding is a must.



Once the installation is complete, adjust the 500k pot for 90 to 100 volts on pin 6 of V-19.

Additional required reading before starting this project is Gordon Nelson's excellent study of mechanical filters which appeared in DX NEWS in 1968. If you don't have a copy, you can get reprints for \$1.00 from Gordon.

After everything is in and working, don't be surprised if you now have to realign the receiver. It may not be necessary but it's a good idea to check the alignment as outlined in the Hammarlund instruction book. This proceedure is a must on installations with more than one filter.

Good luck with your project and good DX.

#### PRESSTIME FILLER - GPN

Isaac Eaves: DIGFET is Dual Insulated Gate Field Effect Transistor; they're quite new and slightly superior to ordinary junction FET. Unfortunately they are extremely sensitive to static electricity and transient everloads; I ruined 6 in spite of great care in installation. It turned out that local static bursts - appliances, motors, etc.—induced enough voltage in the loop to burn them out every time. I suggest you stick with JFETS unless you really need the slight added performance. Ray Moore is using them in an extremely quiet area but whether his will survive the first light ming belt of the year remains to be seen. Drop him a note for more info.

Bill A.: Images appear twice the IF frequency from the true frequency; your receiver just happened to have been aligned for 460 kg/s instead of 455, that's all.

Bob Schneider: The printer's very aware of the stapling problem and is doing his best to eliminate the occasional off-center staples; problem should be taken care of when he gets a new stimhing machine in a couple of weeks. We switched to heavier staples because of complaints from members that the light staples tended to open up in the mails.

Bugaj/Foxy: Brand new list from AFRTS HQ lists only 1420 and 1425. Likewise a letter in from Thule's CE this week mentions only 1425; I've written him back to see if it might be at another base.

Waldren/Edmunds/ERC: Yes, it's not uncommon to find a mixing spur with one audie much stronger than the other. I think that some of the strange products that Russ is getting (e.g., WPAT/WHN on 990) may be triple interactions with the 3rd audio too weak to hear. The auroral connection you mention is probably because the average noise level dreps greatly when you've got auroral blanketing; spurs often seem strongest around noon too because that's the quietest time of day. Thus weak spurs seem stronger than when the QRM is around. I'll check on it.

After reading GPN's article on spurs, I calculated where my locals should show up & have found a few to exist. The one I get most regularly is a WABC/WOR mixture on 830, along w/MIN/VINS on 1090. I've noticed that sometimes the most powerful station in a mixture is frequently the only one audible, such as WNEM/WADO on 1/130 where only WHEW was heard. Also, Aurora CX seem to make spurs stronger for some reason. 73.
