NOTES &c FROM NJPC

We have a flyer here from member Joe Mikuckis, K3CHP, 6913 Furman Pkwy., Riverdale, MD 20840, describing the "K3CHP DX QSL GUIDE" which lists the translations of common reporting phrases, words, and sentences into some 54 languages, from Afrikaans to Zulu. While we at HQ haven't seen the booklet, it sounds quite useful. Cost is \$3.95 of 30 IRC's.

The final issue of this Volume year will be dated 9/30. Editors' deadlines will be 9/20. Volume 42, Number 1 will be dated 10/14 with Editors' deadlines 10/4. After that we resume weekly publication with skips at Thanksgiving, Christmas, and Lincoln's/Washington's Birthdays right thru March.

For those newer members who may not be aware of the significance of this section of DY NEWS, the members of the Courtest Programs Committee try to set up special test broadcasts from hard-to-hear stations. These tests are scheduled for days & times when the PM will be at a minimum, and are generally only scheduled between October and March to insure a minimum of AMM as well. They are arranged far enough in advance to allow for publication in DX MEMS as well as in IRCA's DX MONITOR & The Newark News Radio Club bulletin.

Frequently, however, a test may be scheduled or learned of with very short notice. For this reason, the NRC Flash Alert Service was innaugurated. Members who wish to be notified of last-minute tests simply send self-addressed, stamped postcards to Flash Alert and they will be notified of the tests. Members are urged to number these cards consecutively prior to sending them to Flash Alert so that they will know when it is time to replenish the supply. Arrangers of last-minute TESTS will phone their info to Flash Alert to be put on the cards. The FAS is operated by Carl Junker, whose address and phone lumber are on the back cover. The CPC is operated by Jerry Starr. address also on back cover.

We are still holding a number of antenna manuals for people who answered our questionnaire saving they would buy one. If there is a special message in that regard stamped on the outside of your bulletin, you're one of the tardy ones.....

The new printing of the MRC Domestic Log is due around the time we go to press with the next issue. Those of you with orders pending currently will be among the first to receive your logs. Those of you who indicated your interest in purchasin; copies of the Log in the questionnaire should get it together and send in your orders.

We have a limited number of overrun copies of the Glenn Hauser MexiGlenn List of Mexican AM stations on hand. Cost for these copies will be 75¢ each to cover the costs involved, and will be shipped first class to anyone interested. Reprints of the recently-published Cubajamaitien List of stations in Cuba, Jamaica, the Sahamas and Haiti are also available at standard reprint rates (8¢ per page for members via first class mail). It is 3 pages long. Other recent articles, including the composite series on DX'ing Graveyard frequencies are also available thru Reprints. We'll be running a brief Reprint List supplement hortly.

-GUATEMAIA Radio Nuevo Mundo, TGJ Quatemala City coming in w/a fine S8-9 sig at 1137 on 9/2 until KRVN knocked him out. (Wilkinson)

-MEXICO XETZ Tequila, Jal. 8/16 1215 w/mixture of SS mx types, ID as X E T Z. canal 88. No longer seems to use "R. Felicidad" name. 100% readable and strong. (Gleason)

#JON -JAFAN JCHK Sendai heard at S8-9 level at 1136 on 9/2. (Wilkinson)

-COLOMBIA HJAQ Radio Miramar, Cartegena, 8/26 0620 good in KTOK null w/many RCN IDs but no stn IDs hrd, w/TCs, YL/CM announcers. (Forth) * * Nice S8 signal at 1052 on 9/2. (Wilkinson)

| COLOMBIA HJ -- Radio Fanzenu, Monteria 9/2 0545 w/excited announcer to "paras amigos" telling of all the mx he would play, but I didn't hear any. Many IDs w/mentions of Monteria. (Forth)

-CHINA Peking old reliable back w/lots of power at 1117 on 9/1. (Wilkinson)

-MEXICO XED Mexicali, BC noted to be using Radio Internacional as ID, and takes the live news via microwave from RPM in Mexico City. (Cleason)

-ANTIGUA ZDK St. Johns, w/best reception here yet, 8/22 0059 spot for Dewar's White Label and a vacation cruise (mentioned \$318 price tag, accomodations, etc.) and at 0100 an II loud and clear. Usually heard only at 020C s/off.

-VENEZUELA YVMF Maracaibo 8/28 1010 very strong w/KMOX off, ID /(Jeter) sounded more like Ia Voz de Iago than Oncas del Iago. (Forth)

-BRAZIL Radio Globo, ZYD65, Rio; 7/21, noted w/talk, mx, t/in 0555, thru 0605 t/out. Bad hum on channel w/WHAM off. Needed exalted carrier technique w/rx, SSB adaptor, Q-box, all tightened up to extract anything at all readable (on AM nothing possible). Only thing to ID was characteristic rising notes that precede Globo IDs, one penetrating at 0600. Only 30-60 seconds of audio readable out of every 10 minutes, static level to cope with as well in long fades. (Sundstrom)

PANAMA (Tentative) HOE91 Radio Diez, Fanama, tentatively the one who played the Fanamanian NA, which I've heard 1000 times (but not since returning to the US, hi) and recognized instantly, followed by silence. This from 0802-0806 7/27. Fair to good sig all alone w/inaudible announcement at 0801 which I thought could be KZ00 in JJ till I heard the NA! (Hardy)

-MEXICO XEPF Ensenada, BC 8/1 0515-0545 w/SS ballads, ID at 0530 saying affiliated w/Radio Programas de Mexico. This w/KXIV off. ID by call letters only. (Gleason)

-MEXICO (UNID) 8/1 0300-0500 w/SS rock till 0400, old boleros till 0500, w/KXIV off due to electrical storm. Frequent ID as "Radio Catorce" and ads had 5 digit phone numbers, MST (or FDT) time checks. Very likely XEPB, so letter off to them. Someone was putting a swell het on 1400, too. About 600 to 800 Hz on high side, and I suspect XEAB for this as it went away at 0500, their s/off time. (Gleason)

-MEXICO XECU Radio Rancherita, Los Mochis, Sin. (nominal 1470) now here ex 1475, ex 1484. Very distorted but strong 8/4 0600. (Gleason)

-UNID Strong OC here w/someone weak under I think in SS 0528 8/19; no change after 0530. (Foxworth)

-SPAIN Cood level 0522 8/19 and in as well several nights thereafter. 3 or 4 audios in, jumbled and lots of fade, very low pitched het, typical of Spain. Definite SS words picked out at times. Carrier was heard here at this time

-WEST GERMANY Not noted meaningfully so far this year despite success w/other

TA's . . . too far east for sunrise/low overnight power? (Foxworth)

-PORTUGAL CSB4 Emisoras Associados de Lisboa, Lisbon has been one of my best TA's so far, in several times in July and was in C520 8/19 quite good at times w/moderate fade, as well as was heard many times last winter, usual pop mx program. Also quite good at times 0500-0515 8/23 but poor that time on 8/24. (Foxworth)

Thats all the logging that I have. Its good to see some TAs and TPs back this early in the season, maybe it points to good condx this coming year. I have some veries, but am going to hold them over till next column. I would also remine you that RAMADAN begins this year early, either 9/7 or 9/9, I'm not sure of exact date. Look for Africans and Middle East stations on late if we get some good condx the next couple of weeks.

The reason for the problems with the wires for the AC Power Supply for the SM-2 were twofold. 1, they kept breaking & when I replaced them with heavier wire they made the SM-2 a little unweildy. 2, the null was messed up noticably when the SM-2 was hooked to the AC supply. It seems there was RF pickup from the AC lines. As far as strain on the SM-2's structure goes, I agree that the SM=2 can't take the extra weight. I had forgotten to mention I had replaced the small washers on the SM-2 which were next to the body of the SM-2 with larger 3/4" washers. The reason I forgot was because I had done this long before I ever thought of using the batteries on the SM-2. The reason I did this was because I found the SM-2's structure could hardly support the weight of the SM-2's body. These washers will let the M=2 support the weight of the batteries (plus its own) better. Oh, the six C batteries I put on the SM-2 on 6/1 are still as fresh as new while the (alkaline) 9V battery which I use when I don't need full power from the SM-2 which I got at the same time as the C batteries is so dead it won't light a 1 SV lamp! Another thing (different subject) which I like to say. It's odd. I got my first Canadian graveyard station on my lightning-damaged DX-150A! CHUC-1450 on 8/19 @ 11pm. And that was with one less FET than there should be in the RF stage of the DX-150A! 73s.

The first order of business was the presentation of a provisional annual report on the state of the club. Inasmuch as this was really only a 92-month report, I'll spare the details here. A full annual report will appear in October, with real numbers as well. Paraphrasing, we are in much better shape than we were last October when NJPC took over. This reflects publications sales and additional memberships. Our page count for the year will be approximately equal to our original projections, although the content breakdown will show a heavier concentration in clippings and a lower concentration in articles over some previous years.

A discussion of impending projects was the next item on the agenda. The new log was discussed, and a committee to study possible alternatives in format for the subsequent edition was suggested and appointed, consisting of Wes Boyd, Jerry Starr, Ron Musco, Dave Lewisk Wayne Plunkett, Russ Edmunds, Frank Dailey, Don Erickson, John Callarman, and John Clements as starters. The new antenna books were discussed, as were plans for a new receiver book later this fall. Also under discussion were a new New Member Kit probably next Spring, a composite pattern book updater for this winter, and possible additional reprint reference manuals next year. A combined NRC-IRCA computorised LA Log project was proposed by Ron Schatz, and a committee was announced. NRC'ers proposed for this committee include Ron, along with John Callarman as cochairman, Frank Dailey, John Clements, Al Merriman, Cesar Objio, Dave Gleason, Glenn Hauser and probably additional others.

The possibility of a membership list being published in DX NEWS was discussed, and Dale Whitehead has volunteered to type same, which will be published in DXN this fall. This topic led into discussion of the proposed membership committee which was introduced in these pages last issue. John Callarman has tentatively volunteered to co-ordinate this project. It was learned that several areas of the country already have an unofficial welcoming/get-together committee, including Kentucky-Southern Ohio-Southern Indiana; Northern Ohio; Southern Illinois-St. Louis; Nebraska; Connecticut-Rhode Island; North Jersey-Southeastern New York; and suburban Philadelphia. We should like to strongly encourage the membership in other areas to re-read last issues editorial and see what they can do in this area. When anyone sees a new member listed in their local area, they should want to contact them ! After all, there aren! that many of us, and the fellowship of another DX'er in the area is a great thing.

A re-vitalisation of the NRC Countries Committee was announced by George Kass of NJPC's Connecticut annex. This committee deals with possible revision of existing Countries Lists, and promulgation of guidelines. Likewise, alternatives to the concept of Countries as DX targets will be discussed. LW/MW Broadcasting in Europe Today and in Future

With the advent of F. M. radio and Television the experts believed that Doomsday had arrived for LW and MW radio. Not so. Hundreds of additional stations crammed the channels between 150 and 285 and 500 and 1,600 kHz. causing heavy interference especially at night. There are 1460 medium wave stations in Europe at present and if

A number of recommendations concerning the future of European LW and MW broadcasting have thus been made by several international associations and institutions. A new wave plan for ITU zones 1 and 3, that is for Europe Asia. Africa and Australia is under preparation at a current series of ITU conferences.

Let's recall the recommendations made by the EBU (European Broadcasting Union)

- Channel spacing should in future be 8 kHz 2. Co-channel operation of transmitters with extremely
- varied outputs should be avoided.
- 3. The new wave plan preceeding from the traditional mode of amplitude-modulated Double Side Band (DSB) operation should not impede eventual other

modern modulation techniques such as Single Side Band (SSB) or Independent Side Band (ISB) operation

- 4. Preference is given to ISB and it is recommended to start test transmissions as soon as possible. (This would mean that one station is in a position simultaneously to transmit two different programmes on the two side bands independently of each other.)
- 5. In order to avoid ionospheric cross-modulation transmitters should no longer use wide antenna opening angles.

For the receiving end the EBU made a number of minimum suggestions such as the general use of digital scales as well as spot channel selection, to make radio listening easier and rather more enjoyable than it is today. This, on the other hand, would require high precision radio sets showing an extremely good frequency accuracy and constancy. As to the general introduction of certain Single Side Band modes nothing can be said today, and it will most certainly remain a question of future LW and MW broadcasting at least for the years to come.

Here now are further suggestions for the new wave plan: 1. Restrictions for QRO (super-output) stations and power reductions after sun-set

- 2. Fewer transmitters,
- 3. Co-channel networks of broadcasters to save band
- 4. Reduction of band widths on both the transmitter and receiver ends.

In conjunction with the future band plan for ITU Zones 1 and 3 a technical suggestion for the receiving end: Synthetic Pitch Substitution carried out according to the following procedure. Transmitted will be a so-called base-band of a maximum audio frequency of between 3.5 and 4 kHz; at the receiving end, with the help of a 500-Hz-pilot-control, the cut-off pitches are re-added to the base-band at their correct amplitude levels. This procedure is possible due to the fact that the human ear shows a lack of musicality concerning high and highest notes. It is no longer in a position correctly to assess musical intervals. Therefore it suffices to add the harmonic tones at semi-tone intervals. Tests made with this method have revealed that a quality near to HI-FI could be reached, something of which nobody would have believed a medium wave transmission capable.

GO-AHEAD FOR COMMERCIAL

THE Channel Islands can now make a joint application to the British Government for a which had been responsible for local radio.

This follows a decision in the Jersey States yesterday to accept in principle a report from the Broadcasting Committee proposing that a local radio station for the Channel Islands be established.

In September, 1970, the Channel Islands local radio plan came to a halt when the Guernsey States agreed in! principle to a station but the Jersey States referred the whole matter back to the then Radio Committee.

Since then the matter has remained dormant, although there has been some activity

behind the scenes. In May Conseiller Peppino

Guernsey Post Office Board. medium band wavelength for studying local radio, said he could not proceed until Jersey came into line with Guernsey.

Mr Santangelo explained that world conference wavelengths was due to be held soon and it was possible Britain would have to give up some of her medium wavelengths to other countries.

The Channel Islands therefore wanted to make a joint application to the British Government for a medium waveband while there was still one available.

If the government does eventually allocate a suitable wavelength to the islands the committees of the two islands will then have to consider who should be permitted to run the station on a commercial basis.

There is no question of the States financing a station.

The debate in the Jersey States vesterday went on for an hour and there was some opposition to the proposal that the committee should be responsible for all aspects of broadcasting, including TV.

Members were told that the committee would examine the possibility of stereo sound radio and also colour TV.

The Jersey committee will now have talks with the Home Office and with the Guernsey authorities over the wavelength problem and both committees will eventually have to come back to their Houses with detailed proposals for the setting up of a station.

have you ever been listening on a crowded channel, and way down in the noise you hear something like this: "This is wCas"? Of course you have! Then, you grab your log book and look up wCas, happy and confident that you have logged a new station. To your anger and dismay, you find a wCas listed, but for 740. "That's impossible!" you say, "I'm on 580!" If you had a tape running you may listen several times andit still sounds like wCas. Then you curse the innaccuracies of your log and tune to another frequency or shut off the radio. But it was not the log!! You have encountered the "wnat did he say?" dilemma. What you probably had heard was wChs Charleston. w.Va.

The problem is that on a crowded channel, any audio phenomenon, other signals, splatter, or just AVC action can cause one letter to sound like another; something that wouldn't happen with a clear signal. What you should do is check all the possible call combinations when you hit upon the right one, you'll be able to tell right away,

especially if you had tape rolling.

The letters which may be mistaken for one another are: A,J; & K; A & H, B,C,D,E,G,F,F,V, & Z; I & Y; M & N; S&X and F&S; and, if the signal is way down in the noise, (though unlikely due to the extra syllables) U mau be mistaken for w. You may be wondering why I didn't list H with the first group. The reason being that, if you think about it, H sounds like A, but not like J or K. Ficture waay and wkay. You can see how they could be mistaken for one another in a pile-up. Now picture waay & whay. You can see that there is less chance of a mix-up in a pile-up, Though I admit it may be possible. The same goes for S & A and S & F. X becomes S if something covers up the "A" sound in it. (EKS becomes ES). But A won't be mistaken for F because of the S sound at the end. If that's covered up you still nave "EK" which still doesn't sound like F. Though I a ree that under extreme conditions it may be possible for a mix-up.

In summary, if you hear a call sign that doesn't exist or should be on another channel, don't give up; try call signs that sound alike. But after trying this, if you're still not sure, you'd better forget it. It's better not to log a station, than to log a station that you actually didnot hear. I hope that I have been helpful to

someone! 73's all!!
