## BROADCASTERS PUSH MULTI-MODE

# Motorola Claims AM Stereo Victory, But Rivals Disagree

Amid loud protests from its competitors, Motorola officials this week are speaking more confidently than ever of having the AM stereo battle all wrapped up. Seemingly unconvinced is an ad hoc group of radio broadcasters led by Broad Street Communications President Fred Walker, which has begun lobbying set makers to build multi-system receivers.

"The movement to Motorola is so strong that it will be over by the NAB Convention," predicts Motorola AM Stereo Coordinator Chris Payne.



But, in what appears to be an "everyone against Motorola" stance, officials of Kahn and Harris disagree sharply. They are counting on the multi-system approach as the key to their eventual success. And, as always, spokesmen for all three firms continue to question virtually every statement their rivals make.

### Lobbying Delco, Ford

Walker and other broadcasters last week spent a full day in Kokomo, IN with officials of Delco - builder of radios for General Motors cars - making the case for multi-mode sets. After extensive testing at a cost of \$300,000, Delco decided to build Motorola-only sets, now being shipped in quantities of 1000 a day to GM dealers.

Walker says he and other broadcasters have also lobbied Ford Motor Co. on the multi-system approach, and he points to all-system commitments by companies like Saensu and Sony, the latter of which has just introduced an AM stereo "Walkman" model. Walker says Sony will have several major announcements at the NAB Convention in April, and he believes one will be an automatic-switching multi-system car receiver.

### Speeding AM Stereo Acceptance

"It would be my hope that if the multi-mode catches on, we can speed up the introduction of AM stereo to about a five-year period of time, whereas if it doesn't, it's going to be like FM stereo, which took anywhere from 10 to 12 years to catch on," Walker told N&R.

Walker came away from last week's meetings with the impression that Delco might swing to multi-mode if a chip that would switch automatically among the four systems were available "at a cost equal to or not much higher" than its Motorola-only chip. "They did make a big point out of the cost to Delco," said Walker.

### Motorola's Payne is convinced Delco won't change its mind and adds, "I think

this will be the first NAB Convention where broadcasters will be able to go home knowing what to do with AM stereo." A broadcaster would be "absolutely insane" to go with anyone other than Motorola, he insists. Payne's evidence?

- 98 stations on the air, 57 additional orders, and new orders being placed at a rate of 25 sets per month

- This week's endorsement of Motorola by Group W, which will use the system on KDKA/Pittsburgh and WBZ/Boston

- Motorola-only set commitments by Delco (GM), Concord, Chrysler, Sam Sung, McIntosh, and Sherwood and hints of other major endorsements in the offing

- Orders for 2 million Motorola integrated circuit (IC) chips, including 150,000 with an unnamed "major auto manufacturer" that is neither GM nor Chrysler.

Leonard Kahn says he has shipped 92 of his excitors, and "the vast majority" of those units are on the air. "I'm going to hit a hundred soon," he predicts. As proof that the Delco sets will fail, Kahn cites a survey he sent to 150 Buick dealers. Of 27 responses, two favored Motorola-only sets, two had no opinion and 25 preferred multi-system sets.

### Kahn Assails Motorola Quality

Kahn is about to send off-air cassette tapes of Motorola reception to every AM station in the United States. The tapes show the Motorola signal shifting back and forth between speakers. Kahn claims, in a phenomenon known as "platform motion." Kahn remarked, "The only people who will accept this sound are people who are deaf in one ear."

Kahn also claims Motorola has put together its station lineup by giving away some units. "There has never been an exciter given away to a station and there never will be," Payne states flatly. "The vast majority of our stations have paid the full price."

Kahn retorts, "It's our understanding after investigating that this is a complete falsehood." Many Motorola stations have been on the air for "long periods of time" with "no exchange of money," he asserts.

Ariana also rejects Motorola's victory claims. "They started saying that more than a year ago and they're still saying the same thing," Ariana observes. "The marketplace hasn't bought it and the broadcasters haven't agreed with it."

He continues, "I think anyone who buys a single-system receiver today is being short-changed. In the longterm, the Harris system with synchronous detection is the best system for the AM stereo broadcaster." He says Harris has "shipped/equipped" 98 units, all of which are on the air, in the U.S. and abroad, has a backlog of 51 firm and contingent orders, and is putting five stations on the air each week.

The most recent available count of Mag-navex stations stood at six.

Broadcasters who called on Delco with Fred Walker last week were Harte-Hanks Communications Director/Engineering Jim Hoak, WBT/Charlotte Chief Engineer Bob Denny, NRBA Sr. VP Tom McCoy, and Duff Roman, representing the 21-station CHUM Group and the Canadian Association of Broadcasters. NRBA declined to send an emissary, but sent along a copy of a resolution endorsing the multi-system approach to AM stereo.

### Hearing Set To Award Miami AM

A comparative hearing has been ordered to choose between Broward Public Radio and ICBC Corp., applicants for a new AM in the Miami area on 670 kHz. Petitions to deny the second application have been filed by WMBM/Miami Beach and WWL/Miami.

Issues to be explored in hearing include whether Broward has the \$300,000 needed for construction plus three months of operation, and whether it should be granted a waiver to locate studios in Ft. Lauderdale, instead of its proposed city of license, Tamarac.

The FCC also wants to determine whether ICBC should be granted nighttime power of 2.5kw, instead of the 1kw required for new Class II-B stations. The Commission is also concerned that, even with the higher power, ICBC's nighttime signal wouldn't cover any of downtown Miami, its proposed city of license.

We lost Carleton Lord on January 24th, 1984, but we have not lost our memory of the man and his profound and lasting influence on our hobby.

Carleton came into this world on August 31, 1910 in Johnstown, Pennsylvania. Carleton had no middle name, but with as formidable a name as Carleton Lord, any middle name would have been superfluous. At age two, Carleton's family moved to the Philadelphia area, where in 1924 at the age of thirteen he discovered BCB DXing, beginning a sixty year association with the hobby. Carleton went on to Lehigh University where he received his Bachelor's degree in Mechanical Engineering in 1931. He started his professional career in Akron, Ohio, where his family had moved in 1930. In 1937, he moved back to the Philadelphia area. Carleton and wife Betty were married there. Betty has always shared his interest in BCB DXing and many of his early articles mention their joint DXing efforts. Having a spouse that shares one's enthusiasm for such a hobby as this is rare, and the Lords DXing together is enviable. In those days, many BCB DXers took on "handles" just as their radio amateur counterparts. Carleton contrived the name of "Count de Veries" for himself, referring to the near universal preoccupation of BCB DXers to keep count of total BCB DX verifications as a measure of success in pursuit of the hobby. Betty then became known as "The Countess".

In the 1930's, Carleton's RADEX column caused him to be nationally known. RADEX was a nationally distributed monthly magazine that was kind of a radio version of today's TV GUIDE, giving all the network programs from those days when the radio networks were THE entertainment media for most of America. The other side of RADEX was that it catered to DXers, both BCB and shortwave. In the BCB DX coverage, Carleton's column was by far the best BCB DX journalism around, in an era of dozens of clubs and many radio magazines having BCB DX columns.

In 1950, a job transfer found Carleton and Betty moving to Pittsburgh, where they lived through 1954. At the time, I myself was in grade school in the same city, with neither of us of course knowing our paths would someday cross. Carl was always fond of his Pittsburgh days, being a Pirate and Steeler fan, and he especially recalled the Pirate's inimitable radio announcer Rosey Rosewell, who broadcast on WWSW in those days. Carl was also a fan of Rege Cordic, who was Pittsburgh radio's top wake up man thru November 1965. The Lords moved to Meadville Pa. in 1954, then in 1956 moved on to Corning New York, where Carl spent his remaining years. Carl had his car radio set for KDKA until 1965 in order to hear "Uncle Rege" Cordic on KDKA. Again, what a small world it is, as Jerry Staff once worked at KDKA with Cordic. It was a joy to make some copies of my own tapes of Rege Cordic for Carleton two years ago.

Carl was a major figure in the Newark News Radio Club for years. It must be said that the NNRC was THE club in the 1930s. NRC was a much younger club and it was years away from its now top position. In those days, club allegiances were very strong. World War II decimated the ranks of DX clubs, with many DXers dropping the hobby due to the war interruption, and after the war, NRC soon became the dominant club. Carleton joined NRC in the 1950s, as did several others of the remaining top BCB DXers in NNRC. He was no stranger to the many NRCers who remembered RADEX magazine.

One of The Count's great legacies is his SPECIAL FEATURES column that ran monthly in the NNRC bulletin from 1947 thru 1961. It was also known as LEAVES FROM A DXER'S SCRAPBOOK, a name he used for his RADEX column for a while. Last year I borrowed his complete set of this NNRC column and photocopied it. In this column The Count was truly in the vanguard, writing detailed reviews of new receivers, already writing of the history of the hobby, writing philosophical treatises on various aspects of BCB DX, profiling any prominent DXers (his biographical sketches of Porter Atherton and Norm Maguire will run soon in DUSTY DIALS), writing detailed articles on the use of wire recorders for DXing in the 1940s, and his writings as the pioneer serious TV DXer were brilliant.

At the 1981 New Jersey convention I stopped in my tracks upon entering the meeting room. There was no doubt of the identity of the distinguished looking gentleman with the silver cigarette holder. The first radio club I joined was NNRC in 1956. In those days I was somewhat awed by the accomplishments of that club's veteran DXers and The Count's special Features column became a veritable bible of DXing lore and "how to". Imagine my awe at finally meeting the man. It was Carleton's first NRC convention, and he regretted not having attended

prior ones. Carleton was of course interested in the NRC 50th Anniversary Book project that Russ Edmunds and I jointly proposed. The banquet that year had memorable speeches by Carleton and Dick Cooper, among others. The fact that we did tape record the speeches was a beginning effort at preserving some of our hobby's heritage. The Count and Dick are now passed on, but their words live on.

A few months later, The Count was on board the project, commencing the task of writing the general history of the BCB DX hobby. The Count spent much time in his efforts. A high spot was the Harrisburg Pa. meeting he organized in 1982 which was attended by several long lost former members of the NRC and NNRC. Carl tape recorded all of the reminiscences, and I hope to transcribe them eventually into some sort of article. Health problems hit Carleton later in the project and his "I'M ALL EARS" contribution to the book was not as complete as he intended. I hope to finish the general history from his notes.

Carleton attended a gathering last spring here in Grafton, when many of us working on the book got together. He was thoroughly the center of attention when he spoke, and was rather enthused over the equipment some of us use for chasing foreign DX. There is no generation gap evident, and that has been the beauty of historical delving into the early years of our hobby: BCB DXers are BCB DXers regardless of age or years DXing, and the camaraderie transcends the years. And that is how I personally will remember Carleton Lord, as a man who made his mark on the hobby for over 50 years, a man who brought light into the darkness surrounding DX methods in the 30s, and then fifty years later shed light on the history of our hobby, a man who could relate to today's generation of DXers and a man who still had the enthusiasm for the hobby. Dick Cooper, in his 1981 NRC Convention speech mentioned "those who are without honor in their old age, for they took more than they gave". Carleton Lord was, along with Dick, one of those who gave far more to this hobby than most others. We had discussed a "BCB DX Hall of Fame" for the NRC 50th Anniversary Book and Carleton's choices were Irving R. Potts and Fred Butler, founders of NNRC and RADEX respectively. The Hall of Fame nomination were to be made posthumously only. I think time has come for this BCB DX Hall of Fame, and in addition to Carleton's two nominations, I nominate Carleton Lord himself, along with Joseph J. Becker, Ray Edge, Pat Reiley, Joe Brauner, Dick Cooper, Norm Maguire, and Evan Roberts. If there is a DXers heaven, they must indeed form a quintessential peer group.

## WTYQ / RADIO 1580

### "The Hammonton Station"

At the edge of the silent, lush, green expanse of the fabled, mysterious New Jersey Pine Barrens, some 35 miles southeast of Philadelphia is found the town of Hammonton. This local center of commerce, with a population of over 12,000, straddles the White Horse Pike, the main highway from Philadelphia to Atlantic City, before the opening of the Atlantic City Expressway.

Serving Hammonton, as well as a region covering Atlantic, Gloucester, and parts of Camden County, in the flatlands of South Jersey, is WTYQ-1580. The station came on the air in 1961 as WNHN, "The Voice of South Central New Jersey." The first studios were located at 115 Vine Street, Hammonton, and the owner was the Hammonton Broadcasting Company. The frequency was, as now 1580 KHz, and the power was 1000 watts, non-directional.

WNHN was sold in 1972 to Rodio Radio, Inc. with James N. Rodio, President, and the call letters were changed to WRDI, with the slogan "Serving the Heart of South Jersey". The studios were located at 182 North White Horse Pike, and the station was operated in conjunction with WRDR-FM, 104.9 MHz.

Shortly after its purchase in January 1982 by Normandy Broadcasting, Inc. the call was changed to WTYQ for "We Turn You On." WRDR-FM is today operating independently from Egg Harbor City, N.J. Today WTYQ ID's as "The Hammonton Station" and its primary signal reaches a population of over 250,000 people. Its format blends Adult Contemporary Music with NBC News ad features, plus extensive local news and information, highlighted by a three times weekly talk show called "Crossfire" featuring guests and issues of importance to the area served. Additionally, WTYQ heavily covers local sports, often with live broadcasts, including high school football, and baseball, as well as little league baseball, and local bowling action. WTYQ belongs to the South Jersey News Network, allowing for strong regional coverage.

WTYQ offers a very unique program, the "Psychic Connection", featuring a local "psychic", who offers call in listeners a chance to hear about their future through various techniques such as palmistry, astrology, and tarot cards, this twice weekly program is WTYQ's most popular feature.

During WTYQ's post sunset authorization of 17.9 watts, Spanish programming is broadcast to the large Hispanic population of South Jersey--much of which is employed on the farms of this area. A larger Hispanic group arrives in the area each summer to harvest the crops on the sprawling vegetable farms here. On Sunday, religion is aired from 7:00 am to 10:00, and the remainder of the day features Spanish programs. Interestingly, two of WTYQ's AM competitors, in the immediate area are totally formatted for Spanish programming.

WTYQ's studios and offices are located at 1168 South White Horse Pike. The transmitter is located just southeast of Hammonton, and the signal is emitted from a 150 foot high tower at that location. WTYQ covers most of South Jersey, and the station is a major, and important source of information and entertainment for residents of the area.

The SRF-A100 is the first low-cost entry into the AM stereo receiver market. It is styled like a "mini boom box," if you will, with 3-inch speakers astride a central AM-FM slide-rule dial. Controls and connectors are along the left and top edges of the unit. On the left edge are a power jack for an AC adapter (optional), stereo headphones (a 1/8 inch phone jack for "Walkman type" headphones, also not included), and an AM stereo mode switch (more on that later). Along the top edge are the power switch, volume and tone controls, a two-position switch which doubles as an FM "local/distant" switch and an AM IF bandwidth "wide/narrow" switch, a three-position band switch for FM stereo-AM stereo-AM mono, and the tuning knob. An FM monopole antenna is built in and tucks along the rear of the top edge of the receiver. The AM antenna is a ferrite bar and is built in. The speakers are three inches in diameter and only about 6 inches apart on centers. This Sony receiver line has since been added to by Sony's Walkman version, the SRF-A1, which apparently is identical except for size and lack of speakers.

**Operation:** The SRF-A100 receives all four AM stereo systems currently in use (Harris, Kahn, Magnavox and Motorola) although switching between systems is only semi-automatic and switching between AM mono and AM stereo is totally manual. Apparently, since the same stereo decoding circuit can be used to receive the Harris, Magnavox and Motorola systems, a two-position AM stereo mode switch is provided with one position for those three systems and the other position for Kahn. If you listen to an AM stereo station with the switch in the "wrong" position, you'll still hear what appears to be a stereo effect, but careful listening will reveal that the effect is sort of "random" and that instruments and voices do not occupy fixed positions on the "stereo stage." The label on the bottom has a reminder on it as to which systems are received in which AM stereo mode switch position. You have to find out which system your favorite station is broadcasting in yourself.

There is a center tuning light which functions on both AM and FM but there is no "stereo" pilot light for either AM or FM since the AM section doesn't have or doesn't use the necessary pilot tone detector circuitry to perform this function. If such a circuit were used, it could also perform automatic switching between AM stereo systems allowing the receiver to operate in an "idiot proof" mode like FM stereo receivers do. This was obviously not done to reduce costs (the list price is about \$90, I phone-ordered mine from 47th Street Photo in New York for about \$80 plus shipping). If you switch to AM stereo while listening to a mono station, the station will continue to be heard in mono, but the background noise will be in stereo, giving a sort of "fool's stereo effect." The tuning light is definitely useful as, with it off, you can't receive stereo at all on FM. On AM, you must generally have the tuning lamp lit to receive stereo. If the station is weak, the tuning lamp won't light, but you can still receive stereo (albeit noisy) if you center tune the station carefully.

**AM performance:** with one exception, it's stunning. The two-position AM IF bandwidth switch makes a remarkable difference. In the "narrow" position, the unit sounds about like a typical AM radio: tinny, boxy, and especially lacking high frequency audio content. In "narrow," the selectivity is also quite good with adjacent-channel domestic stations usually quite audible next to each other. In "wide," the selectivity is noticeably broader and the audio greatly improved. On a strong, quiet local with reasonable audio processing, you might be hard pressed to tell the difference between AM and FM. However, strong, quiet locals are the exception, not the rule. Most of anybody's local AM's will experience some degree of first- or second-adjacent channel interference and this form of interference will be audible as extraneous noises especially in wideband mode.

The most useful AM engineering feature of this radio is that it has a very tight, very wide range automatic gain control (AGC). In effect, this makes the AM section operate and sound like FM, a substantial advantage. In the daytime, between stations, instead of hearing virtual silence with some low-level noise, you hear the RF noise floor converted into audio hiss and almost at audio program level, the same way any FM radio sounds (with its muting off). If you're listening to a station which is fading (changing in RF level) the volume of the audio program does not go up and down with the fades, the background noise comes up as the signal gets weaker and then fades back down as the signal gets stronger; the program level stays constant. Local stations of different strengths are not heard at different loudnesses, they're all substantially the same. This is exactly the way FM receivers behave and may be a good selling point for this receiver to the general public although I'd doubt that the general public would know why

they like it. Low power AM broadcasters may also like this feature since it prevents the public from tuning only to the "loudest" (i.e., strongest) stations on the dial by making them all the same. The AGC is not mentioned in the instruction sheet.

The only fault I can really attribute to the receiver is that the audio section is noticeably noisy. Even on strong locals in mono, there's a fair amount of hiss behind the audio. It's not serious, but it is audible. The hiss remains and has the same high-frequency content even when the bandwidth is switched to narrow, indicating that the hiss is not coming from the RF or IF sections. When you switch to narrow, the audio program gets muddier and no longer covers up the high-frequency part of the hiss, making it more obvious. This may limit the SRF-A100's usability as a DX receiver since it, in effect reduces sensitivity. The tone control can reduce it appreciably, but you'll have to compromise on how much of that high-fidelity audio you want to cut out along with the hiss.

This radio also has a habit of exposing sloppy engineering practices at individual AM stations. The amount by which the audio improves when switching from narrow to wide depends on the station. Some stations, especially with critical or complicated directional patterns, have their antennas tuned so tightly, that sidebands representing the higher audio frequencies never get through and the audio still sounds somewhat muddy. Some mono AM stations have a transmitter which incidentally phase-modulates the carrier with the station's audio. This defect would be inaudible on a mono receiver but shows up immediately when listening in the Harris-Magnavox-Motorola stereo mode as gross channel imbalance accompanied by obvious distortion. WLIR 1190 in New York and WDTP 1500 in Washington, both mono stations, have been noted to have this defect. Some mono stations, however, are impeccably engineered and show no such problems. WCBS 880 in New York is clean; it sounds the same with the receiver in stereo or mono mode with only a tiny (when listening locally) addition of stereo noise in stereo mode.

**Listening:** Since the speakers are only about 6 inches apart, the stereo effect is somewhat anemic. Headphones are recommended. For listening where you don't care about the stereo effect, the speakers are real gems, with excellent frequency response and low distortion even at high volume. The "definition" of voice from these speakers is commendable. The speakers accomplish this with very strong magnets and you should be careful to keep credit cards, cassette tapes, computer disks and such away from this radio. AM stereo listening can be quite disarming especially when listening to a distant station. There's only one AM stereo station in my market, but virtually all of the big class I-A AM's which broadcast any music operate in stereo. Even if you have to switch to narrow to avoid adjacent channel interference the stereo effect is till there.

WLS 890 Chicago is especially recommended for demonstration purposes (if you like its format) as long as it doesn't experience co-channel interference at your location. WLS uses the Harris system (last I heard). Any AM stereo system receivable by using the Harris-Magnavox-Motorola position experiences weird effects when hit with co-channel interference. In mono, on an ordinary radio, co-channel interference is usually heard as a "sub-audible heterodyne" in which the audio loudness of the desired station increases and decreases at a rate equal to the difference in frequencies of the desired and interfering stations. If the two stations are operating at frequencies two Hertz apart, the loudness will go up and down twice per second. Due to the tight AGC in the SRF-A100, it is unlikely that the audio level will run up and down in this case since the AGC will follow and compensate for most subaudible heterodynes. In these three stereo systems, however, the musical instruments and voices on the "stereo stage" move around from left to right and back again at the rate at which the audio would have gone up and down! I assume that this is due to a phase locked loop, used to decode the "left minus right" channel information for these three systems, being fooled by receiving two different carriers at the same time. If the desired and interfering stations are operating, say 20 Hertz apart, and you are listening in headphones, you'll have the whole thing swirling around inside your skull 20 times a second. It's quite a wild effect, but it's not likely that the recording studio that made the record wanted it quite that way. The Kahn system does not exhibit this problem.

Another advantage to stereo listening using the Kahn system lies in the way it decodes the stereo. Kahn stations use "independent sidebands" to transmit the left and right channels in a separable manner. In decoding, whatever the station is broadcasting in its lower sideband (the one extending about 15 kHz below the station's operating frequency) is routed

to the left speaker by the receiver. Whatever's in the upper sideband is routed to the right speaker. If you are listening to a Kahn stereo station, for example on 630 kHz, and there's second-adjacent channel splash from a station on 610 kHz, the receiver will place the splash 'way out on the far left side of the "stereo stage" which tends to make it less objectionable. Kahn calls this the "cocktail party effect," referring to the way the human brain can cause the ears to concentrate on hearing conversation from the person directly in front while ignoring the chatter from all sides. Inventive DXers might use this property of the Kahn system to clean up reception of mono AM stations which are plagued by interference from only one side by switching to the Kahn decode mode and then listening only to the non-interfered-with sideband. Expensive communications receivers call this "selectable sideband reception;" here, you get it for less than \$100. Unfortunately, this can't be done with this receiver alone; there is no balance control so the speakers can't be "turned off" individually. You'll have to wire up something that performs the channel-switching function and plugs into the headphone jack and controls external headphones, speakers, or a feed line to your stereo system.

**FM performance:** This receiver does have an FM section and FM stereo but it is downright awful. The dynamic range of the FM "front end" circuitry is so restricted that only the strongest and most local FM's will come in in stereo and with reasonable quieting. The FM "local/distant" switch isn't much help since, if you switch to local in an attempt to suppress receiver-generated overload intermodulation products, the sensitivity is so low that you are still stuck listening only to the strong locals. You can raise, lower or reorient the monopole antenna and flip the local/distant switch in a constant fight to receive a favorite station that's at "suburban distance" from you and you may never have success. For instance, I can't receive WEZR 106.7 (14 miles away) in anything resembling quiet stereo due to receiver-generated overload products coming from closer-in locals like WAVA 105.1 (4 miles) and WPKX-FM 105.9 (7 miles).

## Radio station drops TV 'snake' ad

**Detroit** (AP) — A Detroit radio station no longer will send live snakes slithering across television screens, a move aimed at easing the fears of some Detroit-area elderly women.

WHYT-FM and the W.B. Doner and Co. advertising agency canceled the commercials after complaints published Monday in the Detroit Free Press. Officials said the commercial was aimed at a younger audience, who responded favorably to the snakes.

"We're sensitive to how people feel," said Steve LaGatuta, creative director for Doner. "It was meant to be humorous and tongue in cheek. But if there are people who don't take it that way, we have to be sensitive."

In the commercial, actor Bruce Campbell holds a radio tuned to the contemporary hit station while perched on a rock in a writhing tangle of the reptiles. He calmly says that WHYT-FM has a soothing effect on the coiling creatures.

The spot had a different effect on Mattie Horton, 72, who said she has been unable to watch television because of it.

If she looks at the commercial again, she said, "My heart would quit. The fear goes all over me."

"Our intent was never to offend people," said Maureen Hathaway, general manager of WHYT-FM. "We've had a lot of good calls and good comments."

But Berniece Washington, a volunteer visiting nurse with Greater Bethel Baptist Church, said about 20 elderly patients have complained to her about the commercial.

The Realistic DX-400 represents the top of the line in general coverage communications receivers available at Radio Shack stores. It's probably the best entry Radio Shack has had for many years in this category.

Thanks to Phase Locked Loop (PLL) circuitry, programmable tuning with a microprocessor, and a 5-digit LCD digital frequency readout, tuning to a particular frequency is done effortlessly with a direct entry keyboard. The frequency range is specified as 150kHz to 29,999kHz AM, and 87.4MHz to 108MHz on FM. Scanning can be done manually or automatically in increments of 1 or 3 kHz on AM, 50 or 100 kHz on FM. In the automatic scan mode, the upper and lower limits of the frequencies you want to search are selected, and then the radio will continue to scan between the two frequency limits, stopping when a good signal is found. The DX-400 can also be programmed to tune in 6 of your favorite AM stations along with 6 FM stations at the touch of a button.

The DX-400 also features a wide/narrow selectivity switch to help reduce interference, a 3 position RF gain switch for local, normal, and DX reception to help reduce overloading, reception in the SSB/CW mode with a separate fine tuning dial (BFO), an antenna trimmer dial, a "sleep button" to automatically turn power off after up to 90 minutes of play, and a lighted signal strength/battery level meter.

As a lightweight portable receiver, the DX-400 is very versatile. It can draw its power from 3 different sources; AC 120V 60Hz, six C cells in its own battery compartment, and 12V DC externally (for hook-up to a car battery or other 12V DC source). The radio also requires two AA batteries for computer memory back-up. When DXing regularly on battery power, the batteries will last an average of 1 month before replacement is necessary. I used alkaline batteries. A 75-terminal hook-up is provided for external antennas. The receiver has its own telescopic antenna which extends to about 3 1/2 ft. in length, plus a ferrite bar antenna covering 360kHz to 2199kHz per specifications. However, use of an external antenna is recommended for optimum reception. Jacks are also provided for headphones and an external speaker. The radio is packaged nicely. It's not too bulky or heavy, making it an easy to handle travel companion.

The owner's manual is very thorough with easy to read instructions for the non-technical inexperienced SWL, and a schematic diagram is included. The specs give an average sensitivity rating (for 10dB signal-to-noise ratio) of 1uV on AM, 0.5uV SSB, and 5uV on FM (for 30dB S/N ratio). Selectivity at -6dB is said to be 3 kHz in the wide mode, and 2.5 kHz in the narrow mode; and at -50dB, 6 kHz wide, 5 kHz narrow.

For comparison, the DX-400 was tested side by side with the Realistic TRF (12-655). The same external antenna was used with both receivers; the Worcester Electronics Space Magnet (SM-2). Test results were as follows.

KOA-850 CO, Reception equally good on both receivers.

WJW-850 OH Reception equally good on both receivers.

The stations selected in the test results were chosen to give an overall feel for how each receiver performs when receiving DX signals that are normally heard in West Warwick, RI.

The test results seem to indicate a few problems for the medium wave DXer. For domestic DXing, the DX-400 compares fairly well with the TRF. However, if you live in an urban area close to many 50kW powerhouses (like N.Y.C.), the bleed-through I noted from local WKRI indicates that the DX-400 would not perform as well. If you plan to do some international MW DXing, don't plan on it with the DX-400. This receiver would not pick up stations on split frequencies on the standard broadcast band.

Overall, the DX-400 is a sharp-looking, easy to operate portable receiver which performs well for the SWL, MW domestic DXer, and FM listener. The list price is fair and competitive with similar models on the market. If you do a lot of travelling across North America, the DX-400 would be a great travel companion. However, for tuning BCB split frequencies, I would not recommend the DX-400.

## Windsor radio stations face problem

By DAN WESTELL

After both private radio broadcasters in Windsor, Ont., tried unsuccessfully to change the broadcast regulator's content rules so they could compete with the flood of U.S. stations, the message seems to have gotten through.

The Canadian Radio-Television and Telecommunications Commission plans to take a special look at Windsor because the broadcast situation has made commercial life almost impossible under existing rules.

Windsor is a river's width away from Detroit, one of the largest U.S. markets. "There are about 30 or 35 Detroit radio stations that come into Windsor,"

and "what they're doing basically is taking all the audience," said Gordon Ashworth, executive vice-president of Baton Broadcasting Inc. of Toronto. Baton runs CKLW AM and CKJY FM in Windsor.

Radio Windsor Canada Ltd. also runs two stations. Geoff Stirling, president, said the combined losses of Canadian broadcasters in the market run into millions of dollars. "It's staggering."

The basic problem is the FM regulations. Because FM is stereo, it is the chosen format of young, music-hungry listeners. They will not stay with a station that has too much talk, of the type required by the CRTC regulations.

"Personally, I wouldn't run a station in Windsor myself," said George Coates, CRTC manager for the Ontario region. "Everybody seems to have a difficulty in the Wind-

but absent on the U.S. market.

At the same time, the regulations limit the number of repeats, so Canadian stations must pick their times to play top hits, even if the audience turns over every two hours, Mr. Stirling said.

More than 50 per cent of Windsor listeners tune in to a U.S. FM station. It per cent pick U.S. AM stations, 6 per cent a Canadian FM station and 30 per cent Canadian AM stations, Mr. Ashworth said.

Radio Windsor Canada Ltd. entry, CJOM-FM, made "significant departures" from its promise of performance last year, "providing basically an AM programming service" that broadcast 100 per cent rock compared with an authorized level of 24 per cent, the CRTC said.

Mr. Stirling did not deny the changes before their commission.

## CHIN a radio station turned on by ever-changing ethnic mosaic

CHIN Radio Ltd. of Toronto, broadcasting in more than 30 languages, epitomizes owner John Lombardi's devotion to the concept of multiculturalism.

The largest multilingual radio station in Canada has been beaming signals for 18 years, steadily adding languages and programs to accommodate new and growing ethnic communities in the Metropolitan Toronto region.

Mr. Lombardi, a first-generation Canadian, said he was deeply influenced by the experiences of his parents, who came to Canada from Italy for the future it offered them, but never became totally comfortable - speaking English.

"My father was just an ordinary construction worker who scratched for everything he had and didn't speak the language. He was like all the other immigrants who just want opportunities for their families and for the future."

The most outstanding feature about Toronto today is that it is an immigrant city, Mr. Lombardi believes.

"It's no longer Tory Toronto or Anglo Toronto. It's a multicultural Toronto. We're all different and we should celebrate those differences rather than fight over them."

CHIN Radio, however, is not "building its future only on immigrants who have just landed."

"We're looking at the young people, the children of the immigrants who speak and do business in English but feel very

comfortable when they hear another language being spoken or when they hear an accent, who are now totally Canadian but very proud of their heritage. That's our market."

The station has attempted to divide air time according to the size of the various ethnic communities in the listening region.

Roughly 50 per cent of CHIN Radio advertisers are small businessmen who primarily serve their own cultural communities. Advertising rates vary widely, depending not only on the number of spots purchased, but the probable size of the audience.

"If the mass media, whether it be newspapers, television, or radio, is in the hands of the establishment, you and I are never going to be told the truth."

CHIN has been treated "with a sympathetic and non-aggressive attitude" by the radio industry, Mr. Lombardi said. But then, it is not competing for the same audience.

"They don't see me as a threat because we're into something they could not understand and they do not do. They recognize that there is an audience. They all accept that there is a place for CHIN."
