

Jim notes the contrast between this list and the recent list that ran in DX News. To this I add that the Cubans have a long standing habit of using one net to fill in for another on an individual station. This sometimes is only a late night thing (Reloj on a regional Cadena Agramonte or somesuch), sometimes is full time for a day or so, and then there are the times when suddenly a station totally switches networks for ever and ever until the next switch. This stuff happens fairly often. End result is that if you suddenly hear a new network on a frequency, its probably the same old transmitter - Chuck

STATION PROFILE - WTSJ - 1050, Cincinnati's Christian Connection

Adult contemporary Christian programming - is the format of WTSJ - 1050, Cincinnati's only Christian AM station - a welcome companion in many Queen City homes, as thousands of listeners tune to their favorite ministeries or Christian music.

WTSJ began in 1947 with the catchy call WZIP. A 1000 watt daytimer, it offered a middle of the road music format - which never really caught on, as the station was overshadowed by the stronger full time competition. Country music was phased in in the late 1960's, and in an effort to realize significant impact in its market, Christian programming was added in the late 1970's. The station simulcasted with WZIP-FM, 92.5 which was later sold.



WZIP was bought by Jacor Communications, who presently owns local powerhouse WLW-700, and WEBN - FM. Jacor Communications sold WZIP to Terry Jacobs, who established as the primary business objective to professionalze the Christian radio image. In 1981, Mr. Jacobs applied for more appropriate call letters, WTSJ, standing for The Sound of Joy.

WZIP began operations in a small complex in the Gwynne Building in downtown Cincinnati. It inhabited this suite until April, 1987, when the station received permission from the FCC for unlimited hours of operation. This required more staff and more room. Additionally, space for the studio and offices was expensive, so the station moved to a new, modern office condominium at 800 Compton Road in the northern suburb of Finneytown.

WZIP's transmitter, feeding a 225 foot self supported tower, was located in Covington, KY., about 2 miles from downtown Cincinnati. The tower, in a playground adjacent to Interstate 75, is used today, and the transmitter building, housing the station's Harris 2500 watt transmitter, with new CRL Audio System, is located under the tower. This tower was almost demolished in a tornado in 1986. The twister did damage the station's signs on the tower. The tower is in a bowl, and I-75 was built over the ground system, which hurts the quality of the groundwave.

The new studio facility houses two production studios, a control room, and offices and meeting space. It is a bright, roomy, and cheerful arrangement, opening up onto woods and a grassy field in the back.

WTSJ broadcasts a delightful blend of contemporary Christian music in the afternoon, and through the night seven days a week. Petra, Amy Grant, Bill Gaither, and Sandi Patti are but a few of the artists on the WTSJ playlist. On Saturdays, "Cincinnati's Christian Connection" airs Christian rock, on a show called "Beacon", popular with the area's teens.

WTSJ has added extensive local sports coverage, by hiring Sports Director Gary Ball, who, with Randy Wilson and ex-Cincinnati Bengel Anthony Munoz, presents accounts of local high school football and basketball, and the trio will also broadcast live play-by-play from school games. For the thousands of alumni in metropolitan Cincinnati, WTSJ carries University of Kentucky football.

Three full time D.J.'s and five part timers tend the board. One of these is Mike Horn, National Radio Club member, who works nightly from 10PM to 6AM. Mike is blind - yet his impairment has not hurt his ability to run the board. He uses a braille labler, to lable the carts and albums. Mike has learned every switch on the board, and knows it by heart. Mike loves radio, and is willing to come in early to braille his copy and the weather forcast, and to line up his records and programs.

Mike's boss, Operations Manager Chris Roberts, is pleased with Mike's performance. For eight hours, Mike is responsible for the board, and he is expected to do everything that the other announcers do. And he does it; his listeners do not realize that he is sightless. Mike's determination proves that anyone can do anything, if they try hard enough.

When Christian music is not aired, teaching programs carry the Lord's Word. The most popular program is Dr. Jim Dobson's "Focus on the Family", followed by Chuck Swindal's "Insight for Living". In the afternoon, a satellite-fed call in talk show is heard. CNN news is broadcast on the hour.

On September 1, 1986, WTSJ went fulltime with 278 watts at night. An application for 500 watts was returned by the FCC.

WTSJ is a delightful, stimulating contemporary Christian station, staffed by committed Christians who have successfully brought high quality Christian radio to Cincinnati.

#### Western Wisconsin

[HQ NOTE: We received this article from John in the fall of last year and had temporary 'lost' it (buried under a burch of 'to be filed' stuffs. We have since recovered it and would like to run it now. Some of the stations have changed since this was written however the main theme of his article is still quite intact.]

Several months ago, you might have read an article I wrote called "AMazing Wisconsin". That article contained a lot of information on AM Radio stations throughout the Dairy State. Of course, the catch was after you read the several pages and got to the second last paragraph, you found out that the "trip" was taken at home! I just turned on the radio, and more or less hit the dials and mentioned what I could about stations I could hear in Wisconsin.

Well, this article is different! I did actually hop in the car and GO! When the forecast is for 45 degrees (fahrenheit) on March 4th, and the sun is shining in this part of the world, and I have a day off from work, I'm going somewhere! The four walls drive you up a wall all winter! Of course this winter in Southeast Wisconsin has been BEAUTIFUL! Hardly any snow, but mild temperatures, sun shining, and I'm ready now to go out and mow the lawn-hi! We have had lousy winters, but this is not one of them!

At 8:15am I hopped into my 1977 Pontiac Sunbird. The odometer read 70842. A quick stop at McDonalds for a few Sausage McMuffins with Egg and a soda. Well, naturally "pull ahead and your food will be ready in a few minutes" was what I heard. You kind of get used to this. As usual, the soda had ice in it, after I requested no ice, but I wanted to 60! The gas tank was 3/4 and as a taxpayer, property owner, etc., I was going around the State of Wisconsin just to see what was going on-hi!

The trip would go I-94 from Milwaukee to Madison, then I~90/94 Madison to Tomah, I-90 to LaCrosse, Minnesota 61 to Wabasha to Minnesota 60, back into Wisconsin on Hwy. 25 to Durand on Hwy. 85 to Eau Claire, and back to Milwaukee via I-94. Usually, I like to take US 10 from Osseo, off of I-94 to Appleton, and down US 41, but there were time restraints! I really don't mean to sound like the state tourism director, because I'm not! I am a bus driver and drive for Milwaukee County Transit. If you ever are in Milwaukee and see a bus going 60MPH in a 30MPH zone, guess who is driving! There is something to having 10-14 tons under your feet-hi! But, back to an earlier thought, Wisconsin, Minnesota and the Upper Peninsula of Michigan are nothing less than spectacular for views. Twisting roads, hills, lakes, and much more abound! I've been to 26 states in my 34 years, and there is a reason this is called "Gods Country!"

Leaving Milwaukee, I knew when I would get back later that night something would be different. 1250 WEMP Milwaukee had a mass firing and all jocks were fired except AM drive jock John Gardner. The station would dump its live and profitable oldies format in favor of the Oldie Channel from Transtar! The Beer City AM radio band is rapidly changing for the worse. Since the AMazing Wisconsin article there have been more changes. 1250 WEMP Milwaukee is Satellite oldies, 1290 WMVP Greenfield-Milwaukee is still Satellite "Heart & Sout" for the time being, 1340 WLZR Milwaukee (formerly WBCS) within the past month switched format from country to album rock. The station bills itself as "Laser 103." So, the Milwaukee AM bank is much different than only a few years ago, or even weeks ago. And more changes will occur as 1590 WAWA West Allis moves to 1200 kHz, and 1290 WMVP under new owners will drop the "Heart & Soul" format. They are under contract until Spetember with this. 920 WOKY Milwaukee also, in the past two months, has dropped all of the newer AdCon songs and gone to a more NDStalgia sound. The ratings dipped. The other Milwaukee stations are basically the same. 620 WTMJ heavy on talk and personality, 1130 WISN Milwaukee is talk mid-days, and at night, with AdCon music in other segments. 860 WNOV Milwaukee is still black, but black gospel in the morning.

At this point a quick look at the Milwaukee AM dial is in order, if only to look back in a few years and see where the stations were in March 1987. 540 WYLO Jackson/Milwaukee is ETHnic/GOS/REL. All time brokered. Sign off: midnight, local. 620 WTMJ talk/AdCon, sports, 860 WNOV black. Sign off: Midnight, local with super low power from SSS to Midnight. 920 WOKY is NOStalgia, 1130 WISN AdCon/talk, 1250 WEMP (satellite) oldies, 1290 WMVP (satellite) black AdCon, 1340 WLZR FM simulcast AoR, 1510 WAWK Waukesha/Milwaukee is country. Still a daytimer, 1590 WAWA West Allis/Milwaukee is black with GOS mid-days. Daytimer with a CP for 1200 kHz.

A quick look above leaves one with NO LOCAL AM ORIENTED PROGRAMMING on 1250, 1290, 1340 (except 1250 in AM drive) at all! 1510 and 1590 sign

(1) off! This at night all you have is 540 REL, 620 TALK, 860 BLACK and signal problems, 920 NOS, and 1130 local TALK and Larry King. 620 is Talknet after 9 p.m.

Considering only in 1970, 1340 WRIT and 920 WOKY were fighting for the number ONE position! FM was only a thing of the future.

Milwaukee FM right now is 93.3 WOFM AOR, 94.5 WKT! Top 40, 95.7 WBGK Soft AOR, jazz, folk..."Ecclectric rock", 96.56 WKLH Classic Hits, 97.3 WLTQ Light AdCon, 98.3 WFMR Classical, 99.1 WMYX AdCon, 100.7 WRKR Top 40, 102.1 WLUM Black, 102.9 WLZR-FM AOR, 103.7 WEZW, 106.1 WMIL Country, 107.7 WVCY Religion.

95.7 WBGK will switch to a high personality format by June under new owners, 102.9 just switched to AoR from country under new owners, 1250 WEMP just went satellite oldies under new owners. As I said earlier WMVP will die come September. WMVP is WBGK's AM outlet.

A little commentary and then we will continue on this trip I began talking about 50 paragraphs ago. 1250/99.1, 1290/95.7, and 102.9/1340 basically had the same owners for YEARS. Deregulation has ended any sense of service, community loyality, etc. 96.5 WMGF was owned for 9 months and sold to become WKLH 95.7/1290 were just bought in June 1985. After 18 months, the station is already being sold. And naturally every new owner comes in with their "HOT" ideas, "research," etc and switches calls, formats, fires all personnel, and brings in the bird (satellite). The sad thing is you really can't build station loyality if formats are being switched every other week. Its no wonder 620 WTMJ, 103.7 WEZW, 94.5 WKTI, 920 WOKY, and 93 WOFM are highly rated! Each has had its respective format for YEARS and DECADES in cases! A little fine tuning can be done to a stations format to make it work, and stay profitable. Besides it seems quite apparent that the new breed of station owners just want to take the money and run anyway. So there-hi!

Please remember, before we go on this trip, that these are really only "thumbnail sketches" of the radio stations mentioned. Also, quite obviously, when one is driving at 60 MPH and twisting dials for basically a 13 hour car ride, several stations can and will be missed.  $1^\prime m$  only

Leaving Milwaukee, westbound on 1-94 then, 1580 WTTN Watertown had a long newsblock at 9 am. However, one of the funny things about WTTN was the news reports. All reports were by John Reddy, and it was funny to hear "John Reddy reporting in from Oconomowoc", "John Reddy in Ft. Atkinson," "John Reddy in Waupum." Quite obviously, this guy read these "reports" out of the morning paper, but to have one "reporter" in 6 different cities sounded funny anyway! WTTN plays AdCon, with polkas on Saturday morning. "The Hometown Station" and "AM 1580" are slogans used quite often. The station is 24 hours, simulcasting 94.1 WMLW Watertown-Oconomowoc is AdCon, and calls itself "mellow 94."

1480-WTDY Madison had quite a bit of talk on the air when I noted them at 9:30am. This station musically is still AdCon, but airs many news and talk segments. "Today Radio" is bland. 1550-WHIT Madison played at least 5 in a row without talking. Oldies formatted and non-personality. 1070-WTSO Madison is country while 1310-WIBA Madison is AdCon. 970-WHA Madison is talk all day long. Public Radio.

The FM Side in Madison had 92.1-WMAD-FM Sun Prairie-Madison playing "classic hits". This station has had many formats over the years. It should be noted that it is competing with at least 5 50,000 watt FMs! WMAD-FM is only 3000 watts! 94.9-WILU Baraboo-Madison is BFL. This station too, has had more than a few call and format changes in recent memory. 98.1-WMGN Madison is AdCon and bills itself as "Magic 98 FM". 101.5-WIBA-FM Madison is AdCon and bills itself as "Magic 98 FM". 106.5-WNWC is religious. 104.1-WZEE Madison is Top40. "Z104" plays 10 in a row every hour. 106.1-WQWM-Middleton-Madison "Q106" is continous country, 4 in a row, no talking, etc., vs WTSO which is heavy on personality and rated number 1. The latest entry into the Madison market is 96.7 WSEY Sauk City -Madison using the Transtar 41 format of soft AdCon geared heavily toward women. They have jazz nightly at 8pm. Why--I don't know. "Sunny" radio.

1190-WMAO AM Sun Prairie-Madison is MYL, and I must admit, had very good sounding, mature announcers. Jingles abounded. 1240-WIBU Poynette was once a player in the Madison market. In the middle 70s when NBC had their News and Information service, WIBU had billboards all over town. They also went to a high energy Top40 around 1980, only to drop that a year later. The Top40 audience was already on FM. The current format is a very local, small townish AdCon, with polkas played at night. WIBU signs off nightly at 10pm! They were once the AM outlet to the very successful "Love Stereo" 94.9-Baraboo. I'll never know why they sold the 50000 watt FM and kept the 1000 watt local channel AM!

Earlier I was speaking about billboards, and I only saw two when in Madison. WRWC promoting their morning show, and 107.3-WSJY Fort Atkinson- Janesville- Madison with their "Joy 107" billboards promoting their beautiful music. That station has been beautiful even in 1967 when

I began DX'ing. It was known then as WFAW-FM. The station has a Big Band show Sunday mornings.

One more tiny bit of trivia. WIBU signed on the air in 1925, and used a windmill until 1948 or so for generating power! The calls WIBU stand for Wind Is Being Used!

940-WFAW Fort Atkinson has a lot of very local programming. ABC information news. Format is AdCon with many oldies. 990-WNNO Wisconsin Dells is country, with not much personality. In listening to this for over 15 minutes I never heard any IDs, slogans and talking at all! What a way to get ratings. Don't tell anyone who you are!

If I can add something here, I'd like to. The drive from Milwaukee to Madison is a straight shot west. However, leaving Madison and through the rest of Wisconsin, the hills, rivers, and rock formations abound. Radio is nice, but also the beautiful scenery is mind boggeling! The fresh air. clean skies, and the ability to take this all in!

740-WRPQ Baraboo is satellite AdCon, having gone so just earlier this year. Quite disappointing, but possibly the farming money and small town businesses don't generate enough money for a staff. Somehow, I don't believe that. WRPQ in recent months sounded quite good. Small town radio doesn't mean it has to sound small townish!

107.1-WNNO-FM Wisconsin Dells is verry, very bland in approach with "FM 107" IDs, and Top40 format. Although this one could cross the AoR line. Along the road, I also locked into 107.9-WYCO Wausau. This station has only been on the air since 1985. Transtar AdCon is used. However, there was a promo for "Super Gold" nightly 7-12M. I think this could be a sign that while satellite programming saves you some money, local programming is desirable. Hopeful, WYCO will add more local programming, and dump the bird!

Some other stations noted in brief description. 106.7-WLJY Marshfield is BFL. 104.9-WNFM Reedsburg was taped country, with ABC information news. 103.3-WWRW Wisconsin Rapids is still taped AdCon. 102.3-WVRQ-FM Viroqua was taped country. 1400-WROB Reedsburg was AdCon, while 1320-WFHR Wisconsin Rapids seemed older AdCon. 1370-WCCN Neilsville is really small town country at its best! The station is simulcast with 107.5, and that is still in MONO. 104.7-WAXX Eau Claire is country radio at its best! I hate country but I like "wax"! There is something about this station. Whether the nigh news commitments, actual personalities, or playing the record that #39, and not sticking to the Top10 songs over and over, there is "hometown" and not "hokey" radio. Some of the best, and I do mean best country stations I have ever heard are 107.5-WCCN FM/AM Neilsville, WI, 104.7 WAXX Eau Claire, WI, and 92.3 WJPD FM/AM Ishpeming-Marquette, MI. These stations don't really dabble in over-research and so many other things that make major market radio rather bland. They also, in all honesty, have the powerful signals to back up what they do! Where do you let an elephant walk? Anywhere he wants to! So it is with a 50 or 100 Kw FM signal, as opposed to a 1kw AM or 3kw FM signal. True?

97.9-WSPT Stevens Point sounded terrible! This Top40 outlet had way, way, way too much personality. This station in the past was one of the slickest, tightest Top40 outlets anywhere! The call letters being said first, shotgun jingles, and cue-cards have given way to something that, quite simply, sounds like some type of format thrown together by someone who knows nothing about how GOOD radio can sound! WSPT was easily, far and away the WORST sounding FM outlet in Wisconsin!

97.1 & 1290 WCDW FM/AM Sparta are simulcast country. "Cow Country" ranks as another good small town radio station. Remember, Wisconsin is the dairy state, thus the cow references. 95.5-WIFC Wausau sounded somewhat subdued, but still ok. Call letters were said first out of the records and jingles were played out of each stop-set (commercials). This Top40 outlet has been Top40 since 1970! And the station still sounds good. It really was, to my knowledge, Wisconsin's original FM Top40 station! There were others on FM, but hey simulcasted the AM station. WIFC stood out back then. This station has a heritage!

I'm now nearing in on LaCrosse, so some Minnesota stations will creep in here. "K-G-95" is 95.3 KAGE-FM Winona. The station is live AdCon. Instead of "cage", the stations, both AM and FM are known as "Ka-gee". I can still remember when KAGE-FM was called "KG-FM" and one thought "what a nice set of calls!", only to hear the top of the hour ID as "KAGE-FM". 93.3 WIZM-FM LaCrosse had a 6 in a row "power play" beginning at :55 past the hour. "The New Z-93" has one real lousy set of jingles! The station used to use the old Pams shotgun gingle til a few years ago. Now the jingles are sung with voices so high and with chorouses that you really can't understand. I have a "radio ear" and I could barely make out the "Z 93". 100.1 WQJY West Salem was BFL. Formerly AdCon, this station is one of the few dumping any format to go beautiful music! 1490 WLXR LaCrosse was "15 Country WLXR" and was

(4) competing against 580-WKTY for the country audience. They sounded good! 1570 WKBH Holmen is NOS/STDS, and calls itself "Stardust 16 WKBH AM". 106.3 WKBH-FM Trempealeau- LaCrosse- Winona(MN) is also country and bills itself as "K-106". The FM country outlet has personality and jingles too. If you are into country and like radio battles, LaCrosse might be a good place to listen! A 5000 watt AM (WKTY), a 1000 watt graveyard (WLXR-AM), and a 3000 watt FM (WKBH-FM) and they all sound good! This is unded a treat!

1410-WIZM LaCrosse was running ABC Tałkradio. I'm sure they are

still AcCon in other dayparts, but are running alot of talk.

1230 KWNO Winona MN has one of the worst announcers I have ever heard in my life. It's funny, some people with good voices sit idle and hope to get into radio, and this guy is on the radio and sounds nothing short of horendous. Want-ads were aired, and I never heard any other programming.

71098 on the odometer at 2pm as I left LaCrosse. 1050 WISM Eau Claire (not Altoona) bills itself as "Magic 105" or "AM 105" and is either a very hard AdCon or a very soft Top40. At 6pm they play jazz, and drop the audience they took all day to build! 630-KDWB St. Paul was oldies channel. Now, I was passing through Mineska MN, population 132.

"790 WEAQ Eau Claire is STD and soft AdCon. I heard 4 in a row without any talking. A far cry from the Top40 "790" that was #1 in the 1970s! 920-KDHL Fairbault MN was country and had the worst audio I've heard on the trip. Everything sounded "in the mud", really terrible. 1130 WDGY Minneapolis is country. The station on several occasions into commercials never said call letters at all! Who programs these stations??? Call letters should be said so you have a CHANCE at ratings! This was a case where major market radio sounded like small market schlock!

1190 KWMB Wabasha MN was "1190 Country KWMB" and this little daytimer sounded good for its market size! The station was sold

recently, and one always thinks automation, satellite, or a call change will occur. Happily, this isn't always the case.

1150 WAYY Chippeawa Falls is oldies! They sound quite good with a wide variety, 50s-70s, and a toned down presentation. 1220 WTCN Stillwater seemed to be STD. "WTCN AM 1220". 1250 KCUE Red Wing, MN was country.

At 3pm, I heard "51 degrees at (1270) KWEB Rochester(MN)", I thought, wow I wish I went there.... that is WARM. Remember, this was March 4th! I flipped the radio upward to the next loud AM signal and heard "its 50 degrees at WJJK Eau Claire" going into Mutual news. The news on 1400 WJJK Eau Claire was on a tape delay. It ran at 3:01. Eau Claire was the next city on my journey, and I was now glad I had short sleeves and a light jacket. WJJK is AdCon.

1430 WRON Durand simulcasts FM country. Small town flavor. 105.5 WCFW Chippewa Falls had AdCon, C&W, and songs I've never heard of in my life. CNN features were aired when I tuned in. 100.7 WBIZ Eau Claire is still Top40, though they sounded rather bland. In other words, I have heard them kick asphalt! But, they were not doing it March 4, 1987! 94.1 WIAL Eau Claire is AdCon and still "I-94". I-94 is the interstate highway that runs through Eau Claire. Clever tie-in.

Now I was leaving the London Square Mall, with 71227 on the odometer. 1260 WWIS Black River Falls had local news with ads for Toms ICA store and the Jackson Country Bank. Sounds better than some of the big names you hear over and over, huh? Format appeared to be C&W and AdCon. "AM 1260" slogans abounded. The last station (or as on Carson "the last envelope"-hi), is 100.1 WDDC Portage with automated Top40, a cute jingle set, and ABC news at :30, on a tape delay. This small town station had sounded consistantly good throughout the years!

If you followed the trip with me, I hope you like it. I really enjoyed the trip, as it gives me a chance to get away. Naturally, some stations were not listed because of my being human. I might have actually been close to a town and forgotten about a station or two, and hopefully the diehard radio critic will forgive me-hi. Odometer reading at 9:30pm was 71527. Whew!

Radio host 'Tiny' Markle dead at 60

Erwin J. "Tiny" Markle, the provocative master of Bridgeport nighttime radio, died this morning at home after a year's fight against cancer. He was 60.

A service is scheduled for Tuesday at 1 p.m. in Yale University's Battell Chapel at the corner of Elm and College Streets.

Markle's nearly 40-year radio career began when he was a college student in West Virginia and ended Dec. 17 with a broadcast over radio station WICC via telephone hookup from his home in New Haven.

Markle, a local radio personality for 21 years, could be, by turns, cantankerous, cajoling, argumentative or agreeable — or anything in between — to persuade callers to reach for their phones.

Usually, though, his prompting wasn't necessary.

His shows, on both the now-defunct WNAB and, most recently, WICC, were pressure outlets for the emotions of the city.

He picked up the nickname "Tiny" as a 300-pound bass player in his days as a big band leader.

In addition to his talk-show career, Markle continued as the color voice for Yale University football.

In fact, Markle broadcast the senson-ending Yale-Harvard game last Nov. 21 after a trying, 30-minute climb to the press box atop the Yale Bowl.

While music and sports were among his passions, it was as the talk show host that he left his mark on the Bridgeport area.

He brought to the show not only opinions on any and all topics, but the diverse background of a well-traveled and informed television and radio sports and newscaster, and former big band leader.

A New Haven native, Markle was born Sept. 26, 1927.

He graduated from Milford Academy and Bethany College in West Virginia, where he began his radio career with the college station.

Before coming to Bridgeport in 1966. Markle held radio positions in New Haven and San Diego as a disc jockey.

disc jockey.

While with WAVZ in New
Haven in the 1950s, Markle became
the leader and bass player with a
band that toured New England,
opening for headliners like Nat
King Cole, Stan Kenton, Count
Basie and the Dorsey brothers. The
band played numerous dates at
Bridgeport's Ritz and Pleasure
Beach ballrooms.

His Bridgeport and talk show careers began in 1966 with a two-week stint as the fill-in host of a night talk show at WNAB. He ended up with his own show.

On weekends, Markle worked for radio stations WMCA and

BRIDGEPORT (CT) POST

WPIX in New York City and also, in the late 1960s and early 1970s, squeezed in work as a news and sportscaster with television Channel 8 in New Haven.

He also announced Bridgeport Jets semi-pro football games from 1968 to 1973.

Markle married in December 1974. In early 1975, afflicted by a case of "burn out," he switched to a day-time show, and a management position, at WNAB.

In 1982, he moved to WICC, and once again stalked the night airwaves, earphones clamped over his thinning hair, his ample shoulders hunched over a microphone in small studio B at the station's State Street location.

Because Markle's shows were such a barometer of the public mood, every Bridgeport mayor from Samuel J. Tedesco to Thomas W. Bucci closely monitored it. Its influence on City Hall's subsequent decisions and actions was immeasureable, but substantial.

"I feel a strong sense of responsibility about this show." Markle said in an October 1986 interview. "I don't let my anger or dislike for any particular person affect the handling of the show, or let my own feelings be a reason for hringing the program down on someone's head unless it is related to the radio program's responsibilities.

"It amazes me how many people don't believe in the Constitution and liberty, they don't really understand things like freedom of speech, they don't seem to understand just what that means. And one thing you'll never hear me do; you won't bear me attack the little gruy."

It wasn't just the politicians or the "little guys" who listened to Markle.

In 1981, Edward Poliner, a man subsequently convicted of the attempted murder of two Bridgeport police officers and the bumper rapist' that had terrorized the city, surrendered to Markle.

And it was Markle who called his own show from Yale-New Haven Hospital last year to disclose that he was being treated for cancer.

In recent weeks, Markle had been doing the show from home via telephone hook-up, broadcasting as long as his strength would allow.

Friends and colleagues said Markle was feisty to the end, vowing "to make as much trouble as I can," before he died.

"He was a giant in the city of Bridgeport," said Ron Ropiak, another talk show host at WICC.
"... He could cause controvers."

"... He could cause controversy, could ignite passion, could scare politicians into doing things. Tiny would get on their case."

William Carroll, 1988 Barnum Festival Ringmaster and a local insurance man, was a friend of Markle for 25 years and was the best man at Markle's wedding in 1974.

"Tiny was a showman," Carroll said. "The stuff he said on the air wasn't necessarily his opinion. he'd do it for the show. But he cared about people, poor people, minorities."

Markle experienced hardship at an early age and grew up poor, according to Carroll. Markle's father died just before he was born, and he was raised by his mother, who died a few years aro

"He was a very talented guy and his general knowledge of any subject makes him the best talk show host in the East," said Morgan Kaolian, director of Sikorsky Memorial Airport and traffic reporter for WICC.

Said Kaolian: "When he lost his voice (because of his illness), it was like a pianist losing his hands."

He is survived by his wife, Celeste, and step-daughter, Jennifer.

# WTKN changing name, format

An old friend is returning to Pittsburgh radio — WWSW-AM. And with an appropriate format oldies

Diane Sutter, vice president and general manager of the Shamrock Broadcasting Co. here, announced yesterday that effective next month WTKN (970) will re-adopt its original call letters and drop its all-talk format.

Research Shamrock conducted last fall "showed the oldies potential in this market was huge. The oldies hole in Pittsburgh exceeds the oldies holes in Denver and Kansas City (where Shamrock also has stations). There is a very, very large potential."

In the Arbitron ratings for fall

1987, released yesterday, WTKN was the 12th rated station with a 3.1 share of all listeners 12 and older. These figures represent respective decreases from 10th place and a 3.9 share from fall

The new WWSW, which will be called 3WS for short, will play hits from the '50s and '60s. Its sister station, WWSW-FM (94.5) - which also is called 3WS and will retain both that nickname and its call letters - will play songs from the '60s and '70s. There will be some overlapping, but there will be no songs from the '80s.

With this pairing, "we can program our stations to the largest available target audience and have the synergy of being a superstation," Ms. Sutter said. "It

also serves to differentiate us from all the other stations in the. market. We will be the oldies stations.

The change is effective Feb. 8 when the "Morning Zoo," starring Gary Dickson and Andrea Lively, is simulcast from 5:30 to 9 on both AM and FM. The rest of the 3WS-FM's weekday and weekend lineups will not change, and nothing else will be simulcast.


Following the "Morning Zoo," 3WS-AM will adopt the "Live-Assist" format its FM sister station now uses from midnight to music and pre-recorded time checks and promotional spots but no live disc jockey.

All of WTKN's syndicated offerings - including "The Car Show," "The Golden Age of Radio Theatre," Paul Harvey's "The Rest of the Story," Bruce Williams' advice show and all "Talkradio Weekend" features - will be dropped, as will the station's only locally produced programs: Scott Cassidy from 6 to 10 a.m. weekdays, Bill Few's "Money Talk" from 4 to 7 p.m. Saturdays and "Comedy Showcase" with Dan Blankowski from 9 to 10 a.m. Saturdays.

"Scott (Cassidy) has other choices within the company (Shamrock) and will be making up his mind what he wants to do. He's on vacation this week but knows all about this. He had been included from the beginning," Ms. Sutter said.

Few, a successful investment counselor, did his program as a sideline and "will no longer be on the station," she said. Blankowski "will probably be moving somewhere else within the station."

Sharnrock also is considering adding syndicated oldies features on AM. Ms Sutter said they have "a couple in mind." 3WS-FM currently broadcasts three such programs: Dick Clark's four-hour 'Rock, Roll and Remember" at 4 a.m. and midnight Saturday, Dick Bartley's "Solid Gold Scrapbook" from 9 a.m. to 2 p.m. Sunday and "Solid Gold Saturday Night," a live, all-request show, also hosted by Bartley, from 7 p.m. to midnight Saturday.

A face turnout of Aroadcasters for this edition of Musings of the Members! Don't torget ... your next deadline, Feb. 6, is for DX favorites ... programming, stations, whatever. And now ... on with it!

Since this issue's Musings are for people in broadcasting, I thought I would send one in. 1 was an NRC member back in the mid- to late-1970's and rejoined in October of 1987. I am 30, single, and work at WQWQ-FM (Easy Listening) and its AM sister, WKJR-1520 (which has a religious format).

My interest in DX'ing was at its peak during my high school days in the mid-'70's, but recently I have done some "dial turning" again. I can remember some of the "old veterans" in 1975 complaining about crowded dial conditions then... but compared to now, it was a DX'er's paradise, hi! I cannot believe now jammed even the clear channels are getting; many of the I-B's like WLAC-1510, KXEL-1540, even some I-A's like WHO-1040 and WBZ-1030 now are interfered with at night to some degree, whereas 10 years ago they were completely "in the clear". The regional channels sound like the locals did 15 years ago, and the local (graveyard) channels are such a hash since the like power increase at night that I have yet to hear anything ID'able. Top that off with the preponderance of Larry King and Talknet at night, and BB DX certainly is much more of a challenge (and I think less exciting) than it used to be. I remember the thrill I got from hearing KEX-1190 one MM (with WOWO off) or KNX-1070, or even hearing KFI-640 regularly during certain times of the winter. No more. I nave as much chance now of hearing KEX as I do Outer Mongolia. Sigh.

The broadcasting business has changed, too: as evidenced by some complaints I have read recently about getting verifications from stations. 20 years ago, most stations had someone win a First Phone license, and many of these guys were also hams. Thus, they knew what a "verie" or "QSL" was. Such is not the case now. Most smaller stations have NO engineer of any type, except maybe a contract engineer who comes in when something breaks down completely. The other station personnel have no idea what a "reception report" or "verification" is. Most cannot even tell you why the station must power down at night, or what exactly the station's directional antenna does. I mean it. Most station personnel nowadays - in the smaller markets especially, but even in many larger markets and stations are technically illiterate when it comes to FCC rules and regulations, AM propagation, and other things that the average DX'er is well-versed in. Thus, when they receive a "reception report" asking for a "verification", they probably don't have the foggiest idea of what it is that is actually being requested - especially it it's from outside the station's market area! Sending something like a v/ppc is probably even more confusing for station personnel under these conditions. If you can't get a v/l or v/g from an initial reception report and a follow-up, it's probably best to assume that the station personnel thought your letter was some kind of a crank thing and threw it out. When writing reception reports, oversimplify and please be VERY clear in what you are asking for. Assume that you are writing to a bunch of "babies" as far as DX knowledge goes. Maybe it will help. 73's.

Saludos! I noticed that the theme of the February 1 Musings section was to be former and present broadcasting employees, and that was enough to get me to make one of my all-too-infrequent contributions. I've been an off-and-on NRC member since 1959 and have worked in radio almost the same amount of time. Currently, I do consulting work in the areas of programming, sales, and promotion for Spanish-language radio stations. Here in Puerto Rico, I have a rather unusual situation in that I consult three FM stations, all of which serve the San Juan market. I can get away with this as each is very differently programmed, and the owners do not find a conflict of interest. The stations are WDOY-96.5, Y-96, which programs what is now called "crossover" top 40, meaning no heavy metal and a big dose of dance-oriented usic (similar to Hot 103 in New York and Hot 106 in LA), with announcing in Spanish and music in English; second is WSRA-106.9, Sonorama 107, which programs light adult contemporary Spanish ballads and pop music, aand the third is a mini network of WPRM-98.5 and WIVA-100.3, known as Salsoul 98 with a 100% salsa format. The WPRM combo is #1 in all Puerto Ricco with a 12+ share of 10.6% in an island-wide market that has over 120 AM and FM stations. I also do work for about 15 FM's in other Latin American countries on a less intensive basis and write custom computer programs for music programing and sales management in dBASE, C, and Assembly language.

In the past, I have worked with WUNO, WFID, WEMJ, WELC, WQII, and WZNT in Puerto Rico. On the mainland, I have programed WEZR (now WEMM)-Washington, WEZS-Richmond, WERC/WKXX-Birmingham, KENO-Las Vegas, KWKW, Los Angeles, KTKT-Tucson, KRUX-Phoneix, WFIT-Miami, WSUA-Miami, and WCMQ-Miami. Between 1963 and 1971, I owned a group of 7 AM stations and 4 FM's in Ecuador, all of which were lost in a government change.

DX'ing has been limited in the last ten years to occasional band scans and MW and SW listening for pleasure rather than DX. I use an ICOM R17 with most of Don Moman's Shortwave Horizons modifications as well as added filters. Anyone with an R71 should get Don's fine "R71 Performance Manual", available for \$10 from #61-52152 RRD 210 - Sherwood Park, AB,



climida T8G lA5. The annual includes procedures for alignment and useful modifications that can be done with limited technical experience. Together with improved filters, the maxifilications make a very substantial improvement in the rig's prformance, particularly on congested bands.

One DX note. In November, KSEL-950 in Lubbock, TX became KXTQ and changed to an all-SS tormat, 24 hours. I was the consultant on the change and for the first time did all my work by telephone without ever visiting the station. Over a two-week period, I spent about 40 hours on the phone! So, if you hear SS on 950, it may not be one of the Mexicans. Lubbock now has 3 SS stations: 950, 1420, and 1460.

Here in PR, CP's for 1020 and 890 are still not on. Super-Q in Moca on 1040 was given reduced night power, but I do not know how much. WKVM-810, "AM-81", has its 50 kW on as of mid-'87, and they occasionally simulcast on weekends // co-owned WORO-92.5. WRSJ-1560, "Radio San Juan", is no longer REL, having changed to AC/EZL. WMDD-1480 is no longer part of NotiUno net (originated by WUNO-1320). I often see the 630/910/760 (WQBS-WPRP-WORA) stations called "Salsa 63" which is a name they ceased to use entirely over two years ago in favor of "Cadena QBS." Except for a few hours on Sunday mornings, net is 100% simulcast with mostly merengue music from San Juan studios. Finally, WNEL-1430, which is owned by my client WPRM, was granted 5 kW at night ND. Since increasing power from 500 watts, we have received about 50 DX reports from Europe and Scandinavia. These reports are almost without exception very fine: lengthy personal letters that detail reception and the purpose of the hobby, return postage in U. S. stamps or a \$1 bill (no IRC's), pix of the DX'er and his shack, a map showing the DX location, postcards of the town or city, and they usually contain a cassette of the actual reception. Guess who gets to answer them all?

In V. 55, #7 of **DX News**, I detailed a plan to alleviate AM band congestion by reallocating the 2 and 3 mHz shortwave bands and 225-240 mHz to broadcasting. In this Muse I will be detailing the different aspects of such a plan.

Economic Factors - One company will most likely make money with only two stations on the air, but it will take at least one year for a station to "break even". If one station (the AM) "makes the break", it will be commercially viable, and if one doesn't "make the break", it will suffere the same fate as WREN. Nowadays, many AM stations have FM affiliates in order to compete. The proof in this theory is that many broadcasting outfits do make money with just an AM station and an FM station. The only thing in the way is that the FCC should adopt a Table of Assignments for AM radio. That can wipe out about 2,500 AM (530-1600 kHz) assignments.

That's where AM2 (2300-2500 kHz), AM3 (3200-3400 kHz), and FM2 (225-240) mHz come into play, adding about 1,000 AM2 and about 1,200 AM3 assignments while climinating about 2,500 AM (530-1600 kHz) assignments, and 3,500 FM2 assignments could be added ass well, while eliminating about 2,000 FM (88-108 mHz) assignments.

Public Relations - The FCC and the National Association of Broadcasters most likely would be involved in a nationwide P. R. effort to educate the listeners and other broadcasters about these new broadcast bands. They (the FCC and the NAB) would spend upwards of \$10,000,000 on radio, TV, and printed (newspaper and magazine) ads concerning this proposed change. If people have been educated about AM (530-1600 kHz) and FM (88-108 Hz), the should be educated about AM2, AM3, and FM2 as well. That's when massive PR is needed If people are educated about AM2, AM3, and FM2, the more likely these bands will be successful.

Cost of Receivers - As with FM receivers, and as is the case now with good AM stereo receivers, AM/AMZ/AM3/FM/FMZ receivers that have continuous tuning and can decode stereo broadcasts will be expensive at first, but good quality AM and FM circuitry will likely be less expensive as time goes on. Some boom boxes currently available already have the 120-and 90-meter shortwave bands on them. The boom boxes that would cover only AM/AM2/AM3/FM/FM2 would be less expensive than a stereo console (with turntable and tape player [8-track or cassette]). Auto radios that cover these bands would also be expensive, but as the person becomes more educated about the new broadcast bands, there will be great interest in this reallocation. As with FM receivers, consumer demand will be low at first, but will increase with time.

I think that this has been covered to enough detail. This can be a success if enough NRC'ers write the FCC and send the photocopy of your letter to the FCC and to the ITU. 73.

I presently work for the VOA at the Bethany relay station. I spent 3 years in Laredo, TX as CE of Channel 13 TV, and I was on contract to KLAR, KRRG-FM, KFIX-FM. I filled in at KVOZ and KOYE whenever their CE was out of town and finally helped build Channel 27. Before that, I was ingineering supervisor at Channel 26, in Chicago, and did 5 months at the WIND transmitter site. This is not to mention the 5 AM/FM stations I took care of in Nuevo Laredo, Mexico.

I haven't been DX'ing since I was in NRC and IRCA way back in 1981-82. I have tried from here, but WLW has a BROAD signal. The band is useless from about 360 to 880. They have the POOREST signal of any major market 50 kW'er I have ever heard! My QTH is only 1 1/2 miles from their tower, but a lot of people here at VOA have problems 25 miles out. I had to go to Indianapolis just to hear WGN on 720.

About the only DX I have heard this season is CJFT on 530. I noticed that KLAR and

KMCL navern't been reported for quite a few years. If you do catch them, then I think you have real DX. KVOZ uses a tired old Gates transmitter and single tower. They are trying to never to 890 with 5 kW. KLAR uses a newer Continental 1 kW rig and 3-tower array. About 50% or KLAR's ground system is gone, due to the cows pulling it up, and their nearness to the U. St.-Moriton border, and the poor economy in Mexico.

Greetings. Interesting question raised by the final comments in Ernie's Musing in the 1-11-88 DXN concerning the use of "bogus" calls by stations after hearing WKOS ID as "ROSF". It appears that this is legal under strict interpretation of FCC law. As long as a station gives its licensed call at the top of each hour as is required, it can use any "call" during programming since it is considered a "slogan". If this call was given at the "icsal" ID time WITHOUT the licensed call, then it would be in error. This isn't new. 73(x)-1550 for several years has been calling itself "WKRP". A few years back a station in TX with an All-Beatles format called its "KBTL", although this was not its licensed call. within the last year a small FM station in central PA took to calling itself "WHOT". I even have one of their number stickers on the wall over my desk with the calls. It would appear that the use of these "bogus" calls is outside the scope of the FCC's ability to regulate, and any actions to cause a station to cease this practice would be a civil action that might by tested in court. Such action could only be initiated by the legitimate licensee of the call poing used and would probably involve the grey area of copyright infringement. As it stancis now, station are free to indulge in this practice, no matter how repugnant it may be to us DX'ers. As far as the FCC seems to be concerned, WKOS calling itself "KOST", for example, is no different than WYMF calling itself "Y-103." As a DX'er, I don't like it contact, but it appears to be within the letter if not the spirit of the law. (KOST-103.5 is actually KFI's FM sister -pls)

Now, anyone who has been in radio (except Jerry Starr) can testify personally to many stations' "revolving door" policy ... that you can go out as easily as you can come in ... that's fired ... canned ... terminated ... zapped ... tossed out ... GONE. But no one has, so far. So let me be the first to testify personally, since it's been some time since I've spent any significant time in the electronic media, and I have no axes to grind now.

I've been fired from every station I worked at, except the very first, and a short-term job at an educational station, for many reasons, none of which really had much to do with my on-air abilities, although my bosses could have invoked that reason. My first demise was caused, allegedly, by my not boosting the power on a graveyarder at sunrise right on time ... within 15 minutes ... a couple of times. Turns out the real reason had to do with summer cutbacks before the return of the college kids. The second zap came after I refused to go to work early (I had an evening board shift in addition to being the news director) to cover the station manager's wife's dinner-meeting presentation (the station secretary called 15 minutes before the meeting, just as I was hauling out of bed). The third thumbs-down came as the on-air staff was trying to unionize; I was the example. The station never went union; management gave the employees a couple of nickels per hour more salary, and that was that. And the last out-the-door was last January, after a brokered program producer (a chiropractor who emceed a 15-minute occult program) decided to drop his Sunday-morning program. # WAMO releases eight; adopts automated setup

WAMO-Radio general manager Roger Fairfax today confirmed that eight employees have been released and that WAMO-AM's programming will become automated "by the beginning of next week."

Released Friday were afternoon disc jockey Mavis Logan, weekend jazz DJs Larry Namee and Tony Mowod and Marie Mueller, director of marketing and promotion.

Released by Jerry Lopes, news director of the Pittsburgh-based Sheridan Broadcasting Network, the parent firm of WAMO's AM and FM outlets, were afternoon news anchor Rudolph Brewington, evening news anchor Anne Sawyer, reporter John Tokarski and executive editor James

Fairfax said "cost efficiencies" prompted the cutbacks and that the switch to automated programming "is consistent with what's going on across the country with AMs. They're either going automation or they're going live-assist with a board

operator (who plays music and prerecorded announcements; there is no live DJ) or they're taking satellite feeds. We thought automation was the most cost-effective."

Not until WAMO-AM's automation is in place will Fairfax "announce what the format will be, but I'll give you a little bint - our present listeners who have enjoyed the jazz on the station will not be disappointed. We're not forgetting about them '

The format remains the same until then but with a board operator instead of a live announcer. There will be no changes at WAMO-FM, which will keep its "churban" (eontemporary hit urban) format.

Fairfax said the releases were based solely on economics, not job performances, and that the station is "meeting the severance requirements of the union contracts. We're giving them all very fair release packages and giving them time to get other job opportunities."

Lopes, also news director for WAMO-AM and FM, said the re-

leases be made were "primarily" based on economics, not performances. "It was not a very good year for the network revenue-wise. It was not a good year for network radio in general, and when the big networks like ABC, CBS and Mutual suffer. specialty networks such as ours suffer even more."

Brewington has been replaced by weekend network anchor Tene Croom, Miss Sawyer by WAMO news anchor Mike Whitely and Tokarski by WAMO news desk assistant Vicki Cohill. Lopes is assuming Hamlin's duties in addition to his own. Whitely has been replaced on WAMO's aftertoon news by Sheridan reporter Karen Fullum.
