

560 *New NF Marytown: allocation DELETED

700 WREH VA Reston: although this new station was granted, the FCC has remanded it back into hearing with the previously unsuccessful applicant for this frequency in Walkersville, MD. The Reston station grant was partially based on the FCC decision that the city of Reston had a greater need for a first local service. Now the dimissed applicant for Walkersville has convinced the Commission that both facilities could be expected to serve the metro Washington, DC area, therefore the application with the better coverage of the market should be the one granted. WREH was granted 250 Dl while the Walkersville application was for 5000 D3. More on this later after the cumbersome process of hearings is concluded.

730 WDKT AL Madison: station is STLENT

1160 WAMB TN Donelson: in another precedent setting move, the FCC has granted this station relief from Cuban interference by broadcasting their night programming on a low power (75 watta) FM repeater at 106.7 mHz. FCC engineers have determined that this power level will provide WAMB with the same night coverage that they could expect from their 1000 watt night signal if the Cuban interference was not present. The night AM operation will continue as normal.

1580 KLVU LA Haynesville: silent station is back ON THE AIR

1590 WABV SC Abbeville: station is SILENT

The Commission, in revoking the license of WRPZ-1440 (as noted above in the Otherness column) has stated that all stations remaining silent for 12 months or more are subject to license revocation. While mitigating circumstances are usually taken into consideration before revocation takes place, there are a number of stations silent for much longer than a year which may now be in jeopardy of cancellation. The Commission evidently intends to begin a more strict enforcement of its licensing policies. You may expect to see more of the long-standing silent stations being revoked in the future.

Promotion of the DX hobby through competitive listening.

While earning points for relogs, you'll hear lots of stations you thought were impossible to hear from your location. Boost your totals - enter the contests!

Yes, there is more than one contest this season! The contest of last season has some changes, plus there are new, shorter contests - something for everyone!

CONTEST #1 rules: A:Log up to 5 stations from each US state, province & territory of Candaa, plus DC. First from each worth 2 points: 2nd,4points; 3rd,6 points; 4th,8 points; 5th,10 points. May be backdated (to 10/1/1990) for late joiners. Deadline for joining is 11/25 postmark. B: bonus points: 3 for regional, 10 for graveyarder, only for state and province loggings (including unlimited graveyarders). State & providence loggings may be changed to increase regional & graveyard bonus points.

C: Handicap points: Total all state & province loggings, including bonus points, THEN multiply as follows: If you're in Pacific Time Zone, 1.6; Mountain, 1.1; Central, 1.0; Eastern, 1.2; Exceptions AL/LA/MS/TX, 1.4; FL, 1.6; AK, 1.8; HI, 2.0; New England, 1.3; NB/NF/NS/PEI, 1.6; YT/NWT, 1.7; outside USA & Canada, 3.0

CONTEST #2 Most Likely Stations (guess what you'll hear contest). Send list by 9/30 of 25 stations on the air but unheard by you. Each heard counts 25 points, & late joiners may log Most Likely stations starting one day after postmark. Loggings new for you, and not on your Most Likely list count 5 points.

CONTEST #3 Tests heard contest: log the most testers: CPC/DX tests, frequency checks, & others such as maintenence, repairs, adjustments, etc. Each logging of test worth ten pts plus 15 more pts if reported to DDXD with some details, if possible.

CONTEST #1A If you hear for contest #15 graveyarders from any state or province, you may continue to log for 10 pts each as many more as you can hear. Your total # of graveyarders will be listed for contest #1, & this can be a separate contest (#1A) if you send only graveyard loggings.

CONTEST DATES: All of above October 1 to March 31. Also for contest #4 & contest #7

RULES FOR ALL: Loggings within 25 miles of home will count. Must be 530-1610 KHZ range. Call changes don't count; frequency changes do IF station moves to a frequency not used in that area within the last year. Please indicate time zone you're in &/or using.

CONTEST #4 First contestant to report (& hear) a station coming on air for first time from 9/1 to 3/31 gets 50 pts, 2nd contestant, 25 pts. First contestant to report & hear a station returning to air after silence of 3+ months gets 10 points.

CONTEST #5 Log as many stations as you can from 10/1 to 10/7, report by 11/15 postmark CONTEST #6 Log every frequency contest, up to 3 on each, 10/1-10/31 report by 11/15 CONTEST #7 Low power contest: Many former daytimers on clears & regionals have been given low night powers. Some use it, some don't - lets find out! Loggings for this contest must be over 2 hours after station sunset & over 2 hours before station sunrise. NRC Log will be considered power authority. Score as follows: One to nine watts, 25pts; 10-19W,20 pts; 20-49W, 15pts; 50-99W, 10pts; 100-249W, 5pts.

CONTEST #8 "Letterama" (60s rerun!). Log stns that have different 2nd letter from A-Z: KAAY, CEF, WCBS, etc. You can't proceed to 2nd tier(KABC, WBBM, etc) till you've gone through entire alphabet. 1st tier 2pts each; 2nd 4pts each, etc. 10/1-3/31. Unlimited tiers. PLEASE NOTE: all logs must have calls, frequency, location, date, time. Enter as many contests as you want, logs can be used for all & I'll list contests grand total points. Rule number ONE, the data must be no older than 30 days by my deadline, always one week prior to the Topoko deadline which is published regularly. T₩O, divide your loggings into the time and other divisions seen here, and keep them in order. First by Frequency, then by state/province, then city. Include Date and Time. Loggings missing mither will not be printed. Use Eastern Time (Standard or Daylight, whichever is in effect) as the criterion. Do not report in GMT/UTC/whatever. THREE, since we are a medium-wave club, we don't normally think in terms of most Ham/SWL abbreviations, so please limit yours to the few we have below. FOUR, type or print neatly on ONE side of the paper. If I can't read your writing after making an honest attempt, I will not enter the logging(s) into the column. FIVE. This column is for loggings of members who are DXing in the Atlantic, Eastern and Central Time Zones (and points east). Of course, anyone can contribute help for unIDs which have appeared here. SIY. Remember, this column is for real DX. Bandscans and other stuff go elsewhere. Sevan. Observe all rules. Rules two and four are for my
- convenience. 

From 1991 onwards, FMDXD will only be presented from June through September-eb). Let's get in sync with the FM DX! (In reply to the necessity of the "-FM" suffix to those stations on FM with known AM, TV or SW outlets bearing the same calls, it is necessary because the NRC is primarily an AM club. The suffix is not necessary in the WTFDA, but it is necessary in the NRC because of it's status as an AM club. For instance, most NRCers would associate the KVOO calls [Tulsa, OK] as being on 1170, thus the station on 98.5 in Tulsa is KVOO-FM, because most NRCers wouldn't associate KVOO as being on 98.5. So, for FMDXD, the "-FM" suffix is required if an FM station has a known AM, TV or SW affiliate. NO EXCEPTIONS EVER!!!!!!!!-eb) Recent DX has been good. (I strongly disagree on that, Joe. Most NRCers are AM DXers as well as FM DXers, see above-eb) 73's until next time.

The FCC rules on the AM band expansion look good to me except I wonder how much sunset QRM the 1000 watters are going to receive from stations further west still using their daytime 10000 watts. As I recall, the was the raeson the FCC had to boost Class IV night power to 1000 watts years ago. Perhaps on 1610-1700 khz, the day power should be reduced to 1000 watts during critical hours. I discovered last winter that if I carefully null KUSA-550 on my wife's Superadio like Motorola, I can dig out a little audio from KFYR, 550 miles groundwave. Can't do it now that summer is here. Does the appearance of the TIS on 530 in Sault Ste. Marie, ON mean that CKCY-920's move to 540 is dead?

I had the pleasure of meeting Skip Dabelstein at his Overland Park, KS location on June 16th. The best part was Skip's playing a tape of distant DX that was caught on a beverage set up at the U. of NE-Lincoln Field Labs near Mead, NE back in the 70's. Made ID & MT sound like locals! Anyway, it was nice seeing Skip again, hadn't talked to him since last years gatthering in Topeka. I've also enjoyed recent phone chats with Wayne Heinen, Mike Hawk, George Sherman, Shawn Axelrod, David Reitz, Dave Hascall, and John Malicky. I also talked with ex-NRC'er Paul A. LaFreniere on July 8th. Paul is doing well, although inactive for the last 5 years. August DX highlights, from 2 years back, best catches were WSJP-1130, KBMR-1130, KDJS-1590, WABB-1480, & KGLC-910. From 1 year ago, new catches included KSTR-620, WTAW-1150, WBEL-1380, & KIOX-1270, my 800th logging. Back to the present, I will be hosting a GTG for ALL MW DX ers (not just NRC ers) on Saturday, November 3 at the Best Western Canterbury Inn in Coralville, IA (next to Iowa City). More on this in two weeks in DXN. I just received my 2nd tape from the DX Audio Service, and it's great! That's it from "The Farm". 73's.

21 BEN DANGERFIELD - 202 GOVERNORS DRIVE - WALLINGFORD, PA 19086 It's great news that you've taken over Musings, I'm sure you'll do a splendid job and I hope to make some contributions. (Always glad!-DWS) For starters, here's a little on our June trip to the South Seas. We started Hawaii and stayed in Fiji (two islands), Western Samoa, and Tonga. Also touched down briefly on American Samoa and we wound things back up in Hawaii. My wife and I were tarvelling with an Elderhostel group, the trip being part recreational and part educational, and I DX'ed with my tiny but sensitive Sony 4910. We had to travel at a maximum of 36 pounds per pwerson as we had to fly on some small planes. On Oahu Island, the situation is mostly local, but at just about any point you can pick up every station in the state, although stations on the big island (Hawaii) are weak. KIPA's two synchronized transmitters on 620 create an interesting flutter. In the July 2nd DX NEWS, I see that KIPO, Pearl City is back on the air with full power. I can't believe they are using 5 kw as i could barely get them atop our hotel in Waikiki, about 10 miles away. The one I heard on 1380 sounded like 50-100 watts and their signal was strong only near the Pearl Harbor area. That was late June. The only good overseas signal I heard from the Honolulu area was 2AP, Apia, Western Samoa, on 540 khz on the evening of June 26th. While spending two nights on the NE coast, I was able to pick up some West Coast signals. So much for Hawaii. In Fiji, most of my listening was done on the Vanua Levu island, the more remote of the two large islands. There are 12 stations in Fiji, broadcasting in Fijian, Hindi, and English, and they can all be picked up at any point, day & night. The only station I could log outside Fiji during the day was Nukualofa-1017, Tonga, several hundred miles away and their antenna is less than 100 feet tall! At night, the signals from Australia and New Zealand are quite strong, especially on the lower/middle parts of the dial. The best Aussies are in Brisbane and Queensland, although I heard Sydney, and the best Zedders are in Auckland and Wellington. In the Pacific area, Tuvalu-621 was good as was Apia, Western Samoa on 540 and 747 and New Caledonia-666. I also heard Raratonga-630. At Apia, Western Samoa the daytime fare is limited to the locals on 540 & 747 and a fair signal from WVUV, American Samoa on 648. There is also an FM station but no TV. At night, there are Aussies & Zedders but weaker than from Fiji, plus Tonga and several Hawaiians. The best Hawaiian by far is KAIM-870, very strong, followed by KIKI-830 & KGU-760. 2AP on both 540 & 747 uses the same new, quite high, tower. 540 broadcasts in Samoan while 747 broadcasts in English. Reception was good at Tonga where around sunrise, there are Aussies & Zedders all over the dial. One morning, I picked up 2KY, Sydney on 1017 before local Nukualofa had signed on. It was a cold morning in Sydney (winter) and they were playing "Baby, It's Cold Outside". There is only one AM local in Tonga, reception from Samoa is good at night, as well as NZ and Australia. This was a fascinating trip in every respect.

HARRY HAYES - 9 HENRY STREET - WILKES-BARRE, PA 18702 Welcome back to you, Dave, it is nice to see you back in the editorship position. Before I do anything else, I must share with everyone some early Sunday AM wisdom expressed by the owner/announcer Mr. Neilsen of local WNAK-730 a few weeks back, and I quote: "WNAK, America's top nostalgia station. If you like what you hear, tell others. If you don't tell us, it won't make any difference in what we play but we like to hear from you anyway". It's nice to know that listener input makes a difference! If anyone is wondering, all the DX is on AM this summer. Except for a few good openings this year, the VHF-FM season was another bummer. I am noticing the slight ripples of some AM stations going after teen audiences again with 1480 in NYC being one example. Another is WJDY-1470 Salisbury, MD with "Jam" and/or "Rap" music. Slogan: 'The Station you Hear Everywhere'. I am DX'ing with a Superadio and SM2. I also have one of those Superloops which looks somewhat like the SM2 but looks much nicer on a dresser or wherever. It also seems to perform slightly better, the Superloop seems to have deeper nulls on the Superadio than the SM2. One drawback, the Superloop seems to drain a 9 volt battery rather fast. After about 12-14 hours of listening, the battery is about done. Hilite of my DX'ing this past month was a somewhat auroral evening on 7/29. Boston on 1510, which is the normal night dominant here, was gone, repalced by WLAC. Also WDKD-1310 was in all alone on the channel. More details on this and others should be sppearing in Mr. Hales' column. It is only because FM DX is so stiko that I'm on AM this early, but really AM CX can be very interesting in July/August. I've experienced Feb.'s, as I'm sure others have, when conditions are not as good as they are in summer. I didn't have the opportunity to make Pittsburgh this year, but that is nothing unusual. The nearness of Topeka and some rare time off was the only reason I went to last years convention. This past years DX for me was heavily influenced by the magnificent work of the CPC machine. The tests came at times when I was at work, so I was usually able to find and excuse to get outside, away from shielding and interference. The only problems were the weather (winter nights here aren't conducive to staying outside long and do not treat batteries well) and the fact that I had to keep some of my attention on possible radio calls or alarms (I work as a security guard). I found that I did log the test from Pisgah Forest, NC while standing in an icy parking lot, yet the timer/tape setup back at home didn't catch the test at all. On the local radio scene, the Lincoln Convention and Visitors' Bureau has finally activated the TIS on 1610 that they have been discussing for several years. It ID's as WNQF, has 2 transmitters about 15 miles apart, operates at a maximum 10 watts and has a 30 foot non directional antenna. The purpose of the station is to provide tourist info. about Lincoln and Lancaster County. The message is recorded on a chip and is changed by telephone. There is a plan to connect this with the NOAA weather broadcast in the event of severe weather. I first realized the station was on the air when I saw the signs on I-80. Since then, I have heard it at home, which is about 10 miles from the nearest transmitter, with some slight interference from KNCY-1600. One night I tried but could only hear Antiqua! Mr. Dan Quandt, Director, is a former holder of an FCC 3rd Class Ticket and was very helpful in answering my questions. WFSH-1340 had a transmitter failure on July 12th putting them off the air til this evening (8/5) when tests began about 10:13 PM. While they were off, tales of back taxes and other debts came to fore, along with Chapter 11 reorganization. But the biggest surprise was a WFSH Fundraiser, sponsered by WMMK Destin, FL 92.5. These stations are not affiliated in any way except that some employees worked at Fish Radio and vice-versa. While this is not unique in the annals of radio, it's not the type of cooperation seen everyday. Proceeds from the fundraiser were to go to transmitter repair and payment of the station debts. This is a bright spot in NW FL broadcasting but the bad news has come from Crestview. WCNU-1010 signed off on July 31st for good, after 42 years of service. Owner/manager Jerry Milligan citing mounting debts and the inability to meet the operating costs for August as the reason. WCNU was the first station in Okaloosa, Walton & Santa Rosa Counties (the area between Pensacola and Panama City). WJSB-1050 is Crestviews sole AM now. And, yes, I can remember WAMS while living back in the Wilmington area in the late 60's, a well run, daring rock & roll station!


