The National Association of Broadcaster's DAB Task Force will be recommending to the F.C.C. that the European Eureka 147 technology be selected as the standard for our country. Acceptance of such a standard, early in the game, will hopefully keep us out of the "let the market determine the standard" fiasco associated with the stereo-AM methodology a number of years ago. ... NRCers addicted to radio sports programs just may have an edge in getting up to the minute coverage of happenings at the 1992 Summer Olympic Games. It appears that NBC TV is proposing to put a large segment of their programming on a pay-per-view (PPV) basic. Offering three levels of coverage depending on how much sports programming you are able to absorb during this time period. The levels are being referred to as Bronze, Silver and Gold packages, with prices ranging in the ball park from \$100 to \$170 ... WHK has signed a three year deal to carry the Cleveland Brown's games ... It is with great sadness that I report that another 3-letter callsign has been laid to rest. St. Louis' WIL, on the air since 1922, has changed its call to WRTH. I wonder if they realize that it is currently being used by the World Radio Television Handbook, hi. The station dropped its longtime Country Western format for Hits of the 40's through 60's programming scheme. WIL, with an FM appendage, will remain in the city ... Mike Shannin has moved his act from Kansas City's KCMO to KNHN across town ... The Grand Ole Opry is celebrating its 65th anniversary on the air this year ... Unistar Radio Networks has signed a agreement to provide the Armed Forces Radio and Television Network with a variety of satellite distributed radio feeds, covering the gamut of music, sports and information offerings ... Bruce Owens is the new morning personality on WPAT-AM/FM ... Fellow NRCer Peter Weeks reports that radio life in Canada could be rearranged within the next two years, if a pending proposal gets the go-ahead. Under this working document, CBC-AM and CBC-FM would switch in importance, with FM becoming Radio-One and CBC-AM becoming Radio-Two. The

CBC also proposes taking over the FM frequencies formerly held by the CkO Network. Many popular CBC programs will be changing networks The possibility exists too, of the CBC creating additional networks to serve the specialized listeners. e.g. narrowcasting ... Vermont's 3,000 watt WFAD has gone off the air, as has its sister station wCVM-FM ... Finally, the case of BMI (Broadcast Music Inc.) versus the little people. BMI, together with ASCAP, license music played on radio stations through out the country. well. it appears that Ted Strasser's Furniture Store. in little Wolcottville, Indiana has been violating BMI's rules by playing his radio too loudly in his store. You see, since others can overhear the music, he is profiting from the music, according to BMI and its legal beagles. It really is a tempest in a tea pot, as Ted's store rarely has more than six customers at a time. He plays the radio for his own enjoyment and to keep up on what's happening in the community. He contacted BMI to see what could be done. According to the law, he could be fined up to \$100,000 for every BMI licensed song his radio played. The bottom line, he could sign an annual contract for \$600 to listen to his own radio at work, if it were played loudly enough for the customers to hear it. I guess he could wear a walkman-type radio, hi. Although trying to make sales, while wearing headphones, certainly would be a turn off for his customers. The Hawk Loop ... by Mike Hawk

These are the instructions for a loop that is portable, cheap, and easy to build, even if you are not good with electronics. The instructions include a slight variation on the 1 transistor loop amplifier. The loop by itself has good gin, but is a little weak on the lower BCB frequencies. You may wish to build the loop by itself ir you have a preamp with more gain. If not, the amplifier helps out the lower frequencies. There are many variations to this loop, and I will mention them all.

These are the parts needed:

- TWO CANG VARIABLE CAPACITOR(a single gang capacitor will work, but the below fixed capaCitor is negded)
- SWITCH-SINGLE POLE SINGLE THROW
- FIXED CAPACITGR 200-400pF(only needed if you have a single gang capacitor, more capacitance may be needed-more on this later)
- 55 PG-59 COAY
- WOODEN DOWEL(about 28", 1" diameter or thereabouts) SOME WIRE FOR CONNECTIONS

KMOE

- RG-58 COAX(long enough to reach receiver from antenna) wire of the same length will work
- SMALL BLOCK OF WOOD(2 or 3" high, sides 4" long)
- 1* #00D OR METAL BOX(4 to 6" high, 1' long)

In place of the *'ad parts above, you can use a big block of wood with a hole drilled in the center big enough for the dowel to fit in and be able to rotate. Also, it must weigh enough to support the 55' of coax without it tipping over. This does not 100k as good, but it saves a couple of dollars.

Take the 55° of coax and cut the shield exactly in the middle($22\frac{1}{2}$). This should be about an inch lorg. Cut through the outer covering and the shield, but not the center insulation or center conductor. Next, wind the loop in loops of 1712". This should come out to be about 11 turns. Use vint or electrical tape to hold the loop in blace. This tape also works best to fasten it to the down. If you used the *'ed parts above, do the following take the small wood block and drill a hole a bit bigger than the dowel all the way through. Glue or nail this down to the center of the box on the bottom. Also drill a hole the same size directly above the

If you did not use the died parts, do this: drill a hole the size of the dowel and a bit bigger, so it can rotate. Trill it about 3" deep, maybe more, depending on how big your block

No matter which way you did the above, now put two nails in the dowel towards the bottom. Do not put Treem two low, otherwise the loop will not fit in the hole made for it. These are for connections. Solder the ends of the coax to the nails. Solder a piece of wire to each nail, and the other end to the variable capacitor. Look at the drawing or schematic for the rest of the connections.

All loops made like this will be slightly different in their tuning ranges. Because of this, I will tell you how to fix it if it does not tune the whole band. This in a station around 540 MHz. Hook together the two gangs of the capacitor, or add the fixed capacitor if you do not have a two going capacitor. Adjust the capacitor until it peaks on the station around 540 MHz. If it Will not peak, add more capacitance. 100-300 pF should be enough. If it still does not tune that low, add more capacitance. With the recent craze in NDB's, you may want to add more capacitance so the loop can tune to about 510 kHz. Now find a station close to 1600 MHz. Unbook the capacitor(s) and/or the other gang. The the capacitor to a peak. The plates of the capacitor should be out most of the way. If it doesn't tune this high, it will be necessary to remove a turn from each end of the coax. You do this to keep the break in the shield in the middle. You might want to make it tune 1600 " with a lot of rome to spare, since the band will be expanding soon.


Now, the instructions for the amplifier. Parts needed:

- 4 0.01 mfg capacitors(("); 100 volts or greater 100,000 ohm resistor(Mi): 13 Witt or more
- 1,000 of potentiameter (R2); 1 watt or greater (I used a 15 turn cermet potentiameter)
- 330 Am to 1,000 ohm resistor(R3) Value (lepends ()) the transistor used

P type field effect transistor(Tl); the original instructions said a Fairchild 2N4360 would work, or something similar. One common similar transistor is 2N2222, which is what I used. The instructions say a N type can be used if you switch the battery terminals. Be sure not to overheat the transistor.

See schematic(3) for instructions to build.





The line connecting R2 and the bottom part of C is a little confusing. The arrow on R2 where the connection is is the middle prong of the potentiometer. I also tried building this the way it showed on the original instructions, and this way seems to work a little better, and costs the same.

Many of the parts for both the loop and amplifier can be found in old radios that don't work. The coax costs the most out of the \$35 or so that it will cost to build this both the loop and amplifier). The parts excluding the variable capacitor cost around \$9 and the variable capacitor costs anywhere from around \$5 to as much as \$25. Any questions can be sent to me.

Denver firm to establish FM radio station in USSR

A small Denver entertainment company has signed an agreement with Soviet officials to establish Moscow's first commercial FM radio station, which organizers say will begin broadcasting later this

Video Communications and Radio Inc. said it struck a joint agreement with the Soviet Agency for Cultural, Sports and Business Development to build a 60,000 watt transmitter and broadcast studios in the Soviet capital.

The station, lentatively named Radio 7, will begin broadcasting on a limited three-hour daily schedule early next month and eventually plans to expand into a 24-hour format, featuring European and American pop music and

"This started with discussions we had with the Soviets more than 18 months ago, and we have every

confidence the venture will go ahead," said Video Communications President Ben Doud.

The operators hope to sell advertising time to American companies already doing business in the Soviet Union, such as General Electric, Levi Strauss and Campbell Soup, collecting revenues in

dollars Moseow already has sex radio stations, broadcasting on the AM and shortswave bands But a large segment of the population has FM receivers, which they was to expture signals from stations in Europe, Doud said. The F'M framewcy the station will use was originally assigned to the Soviet military, which usef it for commu-

nications. Vicleo Communications said it is investing \$500,000 up-front to start. the station and will spin the profits with its Soviet partners.

It isn't much of a catch but WOR generally blankets 710 here and I was lucky to catch them off. It surprises me to see that stations are still doing test programs in the middle of the night. FCC SHUTS DOWN VALCON CABLE TREEVISION SYSTEM FOR ENCESSIVE LENGIGE ON AVERTION PROQUENCIES

On April 24, 1991, the FCC's Los Angeles Office issued a cease operations order to Falcon Cable Television of Mojave, California. Falcon was ordered to shut down its system because the results of an FCC inspection showed numerous signal leaks on the aviation frequencies. The leaks were in excess of the 20 microvolt limit and far exceeded the cumulative leakage index (CLI) of 64.

The CLI standard, as defined in Section 76.611 of the Commission's Rules, was designed to prevent harmful interference to aeronautical communications in the frequency bands 108-137 and 225-400 MHz. Violation of the Commission's CLI standard presents a threat to public safety. In addition to shut-down orders, possible penalties for violations of signal leakage rules include assessment of mometary forfeitures. Because of the safety-of-life concerns associated with excessive leakage from cable television systems, the Commission will continue to inspect and vigorously enforce its regulations in this area.

Note: This "bust" of a cable company FCC is only one of several noted recently. It may signal a new activism on the part of the FCC to protect the rights and lives of citizens. The FCC and FAA have also been at odds over the issue of towers close to airports recently, but the FCC still cited defunct WOKJ-1550 for unlit tower lights and other problems. The citation may result in a \$250,000 fine, the maximum allowable.
