50 years ago ... from the Oct. 3, 1942 DXN: Notice was run of a DX program on Oct. 7 from KHMO-1340, an NRC dedication arranged by Jim Wedewer, Dyersville, IA, at the request of KHMO's C. E., who said that a 1¢ stamp would be required for a verification on their new verie card.

25 years ago ... from the October 7, 1967 DXN: Several quotes from other publications concerned the aberrant actions of C. M. Stanbury, who also was being sued by former NRC'er David Thomas for \$250,000 in connection with an article which accused Thomas "of having published a book 'notable for its misspelled words, (and) its obscure currents of thought." The suit was though to be the first major civil suit arising from the DX hobby.

10 years ago ... from the October 18, 1982 DXN: The new Panasonic RF-799 was officeed for \$300 ... Terry Colgan took over from Dave Browne as Executive Secretary of ANARC.



C The bandwidth covered will be 530 Khz-1600 Khz. USA & Canada. TIS loggings DO NOT count.

D Loggings within 25 miles of your home will be counted

- E Call changes don't count. Frequency changes do IF a station moves to a channel not previously used in that area. Any frequency changes reported to me must take place between 11/1/92 and 3/31/93 in order to
- F Level loggings may be changed to increase regional & graveyard bonus points.
- G Please indicate the time zone you're in and/or using.

- A log up to 5 stations from each state, province, and D.C. Point values are 1 point for the first logging, 2 for the second, 3 for the third, 4 for the fourth, and 5 for the fifth and last. Simple, huh?

 B Bonus points: 2 for regionals, 5 for graveyarders (level loggings only).

 C Each station on your Most Wanted list that you log (these MUST be


