50 years ago ... from the Nov. 6, 1943 DXN: Larry Yarnes, Wasco, CA reported that Japanese, Chinese, and Aussle stations were "beginning to come in fairly well". He also reported hearing a Russian on 880 kcs.

25 years ago ... from the November 9, 1964 DXN: Even though the proposed NRC/IRCA merger did not go through, IRCA, NNRC, and NRC were still exchanging DX tips and CPC information.

10 years ago ... from the November 7, 1983 DXN: The NRC Reprint List was included as a separate section of the bulletin ... ANARC was offering computer DX programs for such computers as the Commodore VIC20 and 64, the Timex-Sinclair, the Apple, and those using Microsoft RA-SIÇ.

Bruce speaks: "I have a new receiver, the Sony ICF-2010. The synchronous tuning is great! Do you have the Kiwa filter mod installed in your 2010, or have you heard anything about this? The DX-400 has been officially retired with the 2010 and R70 now my primary receivers."

Jim speaks: "I ordered both filter mods from Kiwa, but I haven't had the guts to get into the guts of my Sony - yet. Let me tell you about the time I tried to replace the water pump in my car. "It's easy", said the guy at the auto parts store, just pull out the radiator to get to it. He didn't say anything about the transmission fluid line going through the radiator. But enough of my sad life. I've heard nothing but good things about the Kiwa mods among shortwave DXers. I usually work with the Sony and HQ-180 side-by-side off the same loop. The synchronous tuning is great, but the 180 has a lot more dials to "tweek", so it's still a toss-up in my opinion. Of course, I'm hardly satisfied, and look forward (someday) to the addition of an NRD-535 or better."

Jim speaks some more: "With TAs coming in tonight, I turned on all three receivers. The HQ-150 seemed to do the best this time, with the HQ-180 a close second, and the 2010 a distant third. In any event, a loop is not enough for hearing TAs, but I don't have the room for a longwire/beverage."

ANGUILLA: Caribbean Beacon 690 QSL card in 1 week for U. S. stamp, sent to University Network address in California. Card is a Scott-revised



Beacon card. My previous attempt at this one resulted in a QSL for 1610, although I reported hearing them on 690. Experiences like this have encouraged me to always print the frequency on my prepared cards in case the signers fail to notice the details of my report. I wish I had done this on my Ecuador report, as Radio Católica filled in my card as 5030 kHz, instead of the reported 880 kHz. [JR-NY]

SPAIN: RNE Radio 1 855 kHz QSL card and RNE AM/FM station list in two weeks after follow-up, with 1 IRC Original report was sent 1 year ago. Card says station was Santander (Rostrio), but there are actually 10 outlets listed for this frequency in the WRTH, and most of us figure that this is high-powered Murcia. []R-NY]




