AMs Increase Power output To Better Cover Their Markets -by Thomas Pear

Approximately 65 stations across the country are taking advantage of 1991 FCC rule changes that allow class B stations, previously class III stations, to upgrade their signals as long as they do not interfere with other licensed facilities or stations holding valid construction permits on the co-channel and adjacent channels.

One reason for allowing stations to power up, Group W

Director of Engineering Glynn Walden said, is that there was never any real justification for not allowing the stations to run a strenger tienal in the first along

a stronger signal in the first place.

The FCC concurs with Walden. When creating the new rules, the commission found that allowing stations to increase their signals would not adversely affect other stations on the same signal because "proposals for an increase in power would have to comply with all applicable interference provisions of the rules."

KFWB in Los Angeles, a Group-W owned station is taking advantage of the relaxation of FCC AM power restrictions. The news/talk station increasing its 5 kW frequency to 50 kW night and day with a directional array.

and day with a directional array.

Washington talks station WWRC is also increasing its daytime signal from 5 kW to 50 kW with a directional array. The
station will remain at 5 kW at night and retain its current
nighttime contour.

Most of the other stations taking advantage of the new opportunity, however, are increasing to more moderate power levels like 10 kW or 20 kW, FCC AM Branch Supervisory Engineer Son Kim Nguyen said.

One reason that stations are increasing their power is because the areas they are licensed to serve have outgrown their signals, and the stations are now unable to service the entire market they were licensed to service. In Los Angeles, unbridled and unmanaged growth, commonly known as urban sprawl, has pushed suburbs and other outlying areas of the city beyond KFWB's 5kW signal. Management is hoping the 50kW signal will bring in more listeners.

In the Mid-Atlantic region, station WWRC in Washington cannot cover its entire market with its 5 kW signal due to low ground conductivity and because it is located in the middle of the large Eastern Scaboard market where closely spaced stations interfere with each other, said Walden and AM radio activist Peter George.

Due to the conductivity handicap, AMs in these areas need increased power to compete with FM, Walden said.

More Ratings Reports . . . and not bad news for AMers! In Kansas City, WDAF-610 placed 1st. KMBZ-980 came in 6th, while KCMO-810 took 14th. Others AMers mentioned in the report were KPRT-1590 (17), KFEZ-1190 (18), KBEQ-1030 (19) and KNHN (20). In Buffalo, WBEN-930 scored a second place finish for the fall Arbitrons, while WGR-550 came in 4th, WHTT-1120 (with its FM sister station) placed 5th, and WECK-1230 took 8th. In the second 10 was WWKB (The Big 1520) placed 15th. A few miles east, in Rochester, WHAM-1180 placed Number One and WBBF-950 came in 10th, while WHTK-1280 placed 14th. Down in Charleston, SC, WCHS-580 placed third, WCAW-680 (7th), WQBE-950 (8th) and W5CW-1410 (9th). Other rated stations were WCZR-1490 (11), WCOZ-1300 (15), and WVSR-1240 (16). Station then signs-off immediately after the conclusion of the game. Those who still need this guy may want to take that bit of info into consideration. (RD-IA)

MO Poplar Bluff - 2/1 0259 - Atop, with KLID Poplar Bluff jingle ID into national news. Per phone call to secretary, this station is now NSP. (RD-IA)

NM Aztec - Another note (maybe the last) about this station's location (see Issue 16) . . . John Wilkins checked some old references (Vane Jones from '66 and '68 as well as old NRC Logs back to '82 and says they all show Aztec as city-of license, and asks if some of the city variations might have crept over from the pre-1960 list. The only stations on the pre-1960 list for 1340 in New Mexico are KVER -Albuquerque and KSIL - Silver City. And now a special report from our roving correspondent, Ben Dangerfield ... BEN DANGERFIELD'S DAYTIME DX IN MALLORCA

Daytime DX from the Spanish island of Mallorca might be the best I have ever encountered. Mallorca is about 150 miles from Algiers, and more or less the same distance from Spain's northeast coast. It is less than 300 miles from Sardinia and Corsica, more than 300 miles to the French Riviera, about 400 miles to Tunisia. The Italian mainland is over 600 miles east, while parts of Morocco are 500 miles southwest. Our hotel was on the southeast corner of the island, about 30 miles from Palma. I did my band scan out on a patio next to the beach on my Sony SW1 with plugged in whip antenna and on batteries. In my rating system, D means daytime. 1 is local quality, 2 is semi-local, 3 not quite as good, 4 is fair, and 5 is barely readable. Hours are 1200-1500. Sunset was at 1800 local.

R-390A Filter Mod 3 ... by Dallas Lankford


If you have done my "Collins Torsion Mechanical Filter For The R-390A" mod (DX News Vol. 61, No. 2 - Oct. 11, 1993, pages 23-27; or Hollow State Newsletter No. 30, pages 2-8, for HSN contact Ralph Sanserino, P.O. Box 1831, Perris. CA 92572-1831 and include SASE for info sheet), or have done my improved and simpler "R-390A Filter Nod 2," (to appear in DXN, DXM, and HSN), then my latest R-390A filter mod may be just the thing you have been waiting for.


The purposes of the previous two R-390A filter mods were to establish a 6 KHz SW as the widest BW for the R-390A and at the same time to provide a 6 KHz bandwidth for the R-390A, to increase the R-390A close-in 3rd order intercepts for all non-crystal filter bandwidths, and to protect the R-390A mechanical filters from excessive RF levels due to very strong nearby signals.

The disadvantage of those mods is that the 8 KHz and 16 KHz BW positions of the front panel BW switch provide the same 6 KHz BW. Wouldn't it be nice, I thought, if the 16 KHz mechanical filter were replaced with a 3 KHz BW filter? That would provide 2, 3, 4, and 6 KHz bandwidths for such a modified R-390A, which would be as many bandwidths as a DXer could reasonably wish for. The down side here is that the bandwidths would not be in sequential order, but I just wasn't up to the task of shifting the 8 KHz mechanical filter to the 16 KHz position, the 4 KHz filter to the 8 KHz position, and then installing the 3 KHz filter in the newly vacated 4 KHz position. Anyone who has fiddled around with the R-390A mechanical filters in the IF subchassis knows that such a project would not be a weekend project.

For a 3 KHz filter, I decided to use one of Kiwa Electronics (Craig Siegenthaler, 612 South 14th Avenue, Yakima, WA 98902, phone (509) 453-5492) CLF-D2-K filters. Putting this 3 KHz ceramic filter into an R-390A IF subchassis in place of the 16 KHz mechanical filter turned out to be a toughie. Two problems were encountered: reducing signal levels into the ceramic filter (the ceramic filter has much less loss than R-390A mechanical filters when properly impedance matched), and signal leakage. To equalize signal throughput, a resistor divider network was used ahead of the ceramic filter; see the "After" schematic below. To eliminate signal leakage, a flange was fabricated from 0.015 inch copper sheet (copper gutter stock, available at sheet metal shops), tinned, and assembled with two etched PC boards so that the ceramic filter input and output pins were isolated from each other by the flange. The flange was made approximately the same size as an R-390A mechanical filter flange, so that the ceramic filter assembly could be bolted (just like an R-390A mechanical filter) into the vacated 16 KHz IF subchassis hole. The flange, with ceramic filter passing through it, also acts as an RF barrier to help shield the input and output impedance matching transformers T1 and T2 from each other.


As can be seen from the "Before" and "After" schematics below, the 16 KHz mechanical filter was removed with C507 (51 pF) still attached to the mechanical filter pins. The other 51 pF fixed value (silver mica) capacitor was left in situ, attached to the lugs of C571, the output 50 pF variable ceramic trimmer. This is the "natural" way to remove a mechanical filter from an R-390A IF subchassis in preparation for doing a filter mod using tuned primary impedance matching transformers, as I did. Consequently, a 300 pF silver mica capacitor was added (in parallel) to the lugs of C564 (the input 50 pF variable ceramic trimmer) to permit the primary of T1 to be tuned to resonance at 455 KHz using C564, and a 250 pF silver mica capacitor (actually 180 pF paralleled with 62 pF) was added (in parallel) to the lugs of C571 (the output 50 pF variable ceramic trimmer) to permit the primary of T2 to be tuned to resonance at 455 KHz using C571; see the "After" schematic below.

A PC board layout of the filter mod is given at left. The PC board was etched, and then cut along the dashed line. The short part extends below the IF chassis, and the longer part extends above the chaseis. The ceramic filter was soldered to one of the PC board pieces (it does not matter which one), and then the unsoldered end of the ceramic filter was "Chinese puzzled" through a small

rectangular hole in the flange, after which the ground plane of the PC board with filter attached was soldered to the flange. Next, the other PC board piece was inserted onto the unsoldered ceramic filter pins and then soldered at the pins, and along the ground plane and flange boundary. Finally, the remaining parts of the filter were soldered to the completed PC board and flange assembly, the completed assembly was mounted in the vacant mechanical filter hole, the remaining wires were attached (points A, B, C, and D on the schematics), and the 250 pF and 300 pF fixed silver mica capacitors installed at the lugs of the variable ceramic triamers. To simplify installation, small pins about the same size as the mechanical filter pins were press-fitted and soldered to the two pairs of PC board pads at each end of the PC board. To conserve space, 330 ohm and 1800 ohm surface mount resistors were used (the PC board is laid out for surface mount resistors).

To align the ceramic filter input and output transformers, the variable ceramic trimmers C564 and C571 must be adjusted. Set the bandwidth shaft to the 16 KHz position, remove the mechanical filter cover (if not already removed), and with the R390A tuned to a steady signal (one of the 100 KHz calibration points will suffice), adjust C571 (the top trimmer) for maximum signal. To adjust C564 (the side trimmer), tilt the IF subchassis so that C564 is accessible through one of the circular cutouts in the side panel.

During testing of the filter mod, it was observed that signal levels through the ceramic filter slowly decreased for about an hour or so while the R-390A came up to operating temperature. This problem was traced to a "drifty" C516 (the 51 pF silver mica capacitor across the pins of the variable ceramic trimmer C571). Replacement of C516 cured this problem.

The inductance of 64 3/4 turns of # 2b enameled copper wire can vary considerably from one Amidon FT-50-61 toroid to another, so it may be necessary for you to vary the value of the 250 pF or 300 pF capacitor (or both) to permit T1 and T2 to be tuned to resonance at 455 KHz. If you do not get two peaks for two different settings of the variable ceramic triumers C564 and C571 when you adjust them, that is an indication of failure to achieve resonance, in which case you will have to tinker with the value of the 250 pF or 300 pF capacitor (or both).

Is this filter mod worth the effort? Probably not. In fact, this mod is very close to, if not, an "emperor's new clothes" mod because I have yet to find a listening situation where the 2 KHz or 4 KHz BW does not work about equally well. At best, I would not expect to find more than one or two DX situations per month where this mod makes any observable difference. And as for making something hearable that was not hearable before, It'll never happen.

If I were the FCC, I would have to wonder if NYC needed another powerhouse station. Not that Ft. Wayne ranks very high on my list of cities that deserve a clear channel, either, but removing IN's most powerful station for the benefit of NY doesn't seem to be the best usage of the spectrum. I'll tell you where the need really is: FL! I can drive all around the S and hear Louisville, Nashville, Charlotte, Atlanta, New Orleans & Ft. Worth along with any number of N stations, on any junky car radio. But when I go visit my folks in KY? Forget about hearing any news from FL. After sunset, when 540/ 690/820/etc. reduce power, every station in the state becomes real DX before I even get to Atlanta! Yet FL is a Top 5 state in population and has 4 cities with major league sports teams. I can't think of any other state that is similarly neglected. Unfortunately, the AM spectrum and the clear channels were set way back before World War II and FL wasn't major league then, so as far as the FCC is concerned, tough! Now that I have that off my chest, would I trade this location for another spot with difficult-to-null powerhouses all over the dial? I doubt it! But it would be nice to have just 1 station with good night coverage. In other news, I found someone locally who repairs tube gear, so he's looking over my SP600. With luck, I'll have it soon, then I can start building a loop. Good DX to all. (And my thoughts on the WLTB/WOWO thing, NYC already has 15 fulltime signals available, WLIB had a chance to buy 4 stations in the last 3 years that went up for sale! Activity has slacked off considerably since about 4/92, when I started travelling pretty much | week a month for work (most often to Macon, GA). Since that is continuing, my activity (which was not great anyway) will continue to suffer. Last season, the ice hit in early Jan. and stayed thru Mar., thus bringing out even more images, spurs & overload than are the usual pain here. The major hurricane-force wind & heavy rain that battered the E coast Christmas Eve resulted in only 2 AM stations losing substantial airtime in this area. WALK-1370 was off several hours in mid/late morning. WBTN was coming through quite well at times, drifting in/out. I never heard this one before WMMW-1470 was off all morning/afternoon. 3 stations were coming in at various times, fading in/out/over/under each other. They included WSRO (discussing high school sports), WTKO (CNN News) & WXKW (CW music). While at the Old Time Radio Convention in Newark, NJ 10/20, I obtained the names of 2 of the dealers selling back issues of the old Radio Guide, the predecessor to TV Guide, published by the Annenburg family, which also published TV Guide. Radio Guide was published from the early 30's thru 1944 and there are editions for various parts of the country, such as New England, Mid Atlantic, metro NYC & so on. The dealers were Seymour Brecher, P O Box 42, Ferndale, NY 12734 & Alan Levine, PO Box 1577, 292 Glenwood Ave., Bloomfield, NJ 07003. A friend in Rockland County, NY tells me WLTR-1300 still has

news covering Jewish issues on the hour (in English) and is also running the "When Radio Was" old time radio shows with Art Fleming many hours (the same one on WSAI-1530 at 11:05PM). I read about WCRN-830 coming on. I am hearing a radio station carrying the audio from Trinity Broadcasting Network (the religious right TV network) uninterrupted during nighttime hours, but never hear any ID's on the hour or half hour. Could this be WCRN? (No-DWS) I fully agree with ERC's comments about all the vitriol and mean-spiritedness on teh radio dial these days. It's terrible and very discouraging, I don't know how some people think! (That's the problem, they're not, it's all show!-DWS)While staying at the Holiday Inn N in Newark, NJ the 1st night of the Old Time Radio convention, I noticed 530 was occupied by the Newark Airport station, giving directions where to park cars, etc. There were at least 2 NJ Turnpike Authority stations on 1610, fighting with each other, with traffic safety advisories. And there was another NJ Turnpike station on 590, which prevented me from hearing WARM-590, which I had expected to be able to monitor, it always had a day signal over NYC, including Manhattan & Brooklyn). When I returned home, I found the NY Turnpike operates stations on 530 in Rockland & Westchester Counties and 1610 was used by the Westchester County Center, promoting upcoming weekend shows & events taking place. Here in CT, S CT State University operates WOWL-530 New Haven, which is audible all over the 5 town greater New Haven area, & comes in weakly all day long here in Stratford, about 18 miles away. I don't know what their status is. Is there a listing of all these TIS stations on 530 & 1610? I know the ones on 1610 will have to move when the AM band is expanded to 1700. There is a quote in Dr. Bruce Elving's newsletter that states that the fall 94 Radar report shows that for the 1st time, FM has reached 80% domination of the total radio audience. It makes me wonder about where AM will be in about 20 years from now. In the short term, there was some good AM news in the fall ratings, KYW was #1 in Philadelphia & WPEN-950 was #2. This is my 1st MUSING in a very long time. 1st, some background, I've been DXing for about 30 years. I'm the president of the Candian International DX club. Canada's national, general coverage radio monitoring club. My radio interests reflect those of the club. I find myself all over the bands, everything from LW beacons and BCB DXing thru the SW bands (all modes) and into some lowband VHF & FM DXing. Since my last Musing, I have become a licensed amateur, callsign VB2SHW. My true passions remain MW & trop:cal band (120, 90 & 50 meters) DXing. This has been an excellent MW DX season, one of the best I can remember. Some of these numbers will give you an indication as to just how good. The great thing about MW DXing is that the targets never seem to dry up. Just when you think that you'll never log a new one again, times like this fall & winter quickly put those thoughts to rest. Through 1994, I was able to add 48 new stations and 8 call changes to the log. The biggest surprise was that of the 48 new ones, only 3 were logged prior to 10/1/94! 46 new ones in 3 months is really surprising in this neck of the woods. Greenfield Park is a suburb of Montreal, but big changes in the MW scene in the city have left the band with only 1 local station between 1000 & 1600, that being CFMB-1410. With CKLM-1570 & CJMS-1280 closing down in 94, the band really opened up. My totals are now 859 stations logged (call changes not included), 35 states & DC plus 7 provinces logged, 43 countries including Canada & the US. 1550 & 1330 are tied for most stations logged on a frequency with 16 each. Stations heard per state/province include: NY-101, PA-74, ON-72, PQ-57 & MA-47. My equipment consists of a Sony ICF-6800W & a Kenwood R5000 with a 3½ air core loop and several outdoor LW's & diopole antennas. I look forward to meeting up with a number of NRC members at the Kulpsville, PA Winterfest in March. See You There! 73 (We'll be back in the corner again, so be sure to look us up!-DWS)

My 1st new catch of 95 was one I've been after for a couple of years, WBUG-1570, finally on top 1/4 1:08AM, IDing with WLFH-1230, format being Cw. Nothing new until 1/16 when, happily, I caught bits/pieces of the WVWI-1000 test! Many short periods of tone were noted until 3:46AM when their signal became stronger, and a voice ID was heard. I'm particularly happy to log this one, for it is a local at our vacation spot in Frederiksted, St. Croix. Interference came from CFLP in French and XEOY in Spanish, and not noted at all was the usual CKBW. WMVP was on their regular Monday AM silent period. 1/17 a Tues., T noted WSAT-1530 doing Spanish Gospel programming at 1:58AM! Long time not heard WHBC-1480 was atop this frequency 2:45-3AM. A new report was sent to WCRN-830, a new semi-local around here by day but zapped at night, to a verie signer given me by RAY ARRUDA. At sunset 1/17, somebody under WPOP-1410 with S-style gospel, call sounded like WKVT but that's a 1490-VT'er. I did hear mention of Fairfax, VA. The WXRS-1590 test was listed in DX NEWS for Sat. 1/21 and in the IRCA for Mon. 1/23. As they were not heard on 1/21, naturally, I tried on 1/23, but still nothing and I even tried on 1/24, thinking they could have confused the date we expected them. That's always a risk when a program is requested to start at midnight, but still no sign of them. And on 1/21, I found WTLA-1200 (ex-WNSS/WKRL) on top most of the time with 30's type pop tunes, and they were there also on 1/22 & 1/23, and a 3 morning report sent, thanks again to RAY for the tip! They ID as WTLA N. Syracuse & WTLB-1310 Utica-Rome but no sign of the latter here. To TONY FITZHERBERT: what is the abbreviation WW-I? World War One perhaps? (Westwood One, Ernie-DWS). And 12/21 wasn't a Sunday, it was a Wednesday (I thought it was still half past October lately!-DWS). I'm hoping the test from WAMR-1320 makes it, I have their FM verified. What a strange winter, no snow yet except for 2 tiny flurries! Everybody's enjoying the warmish winter except the oil man. Forward - March!

DAVE SCHMIDT - P O Box 11502 - WILMINGTON, DE 19850 * * * * * We've been managing to get our columns in the mail on time lately, even sending them 2 day when needed, but even with custom made labels with bar codes going to PLS, they've still managed to do me in! Last season, DX NEWS came on a regular basis on Monday, Tuesday if it was a holiday. Now, anyday, even as late as Thursday (including 1 no-show). It is indeed sad to read of one having to stop listening to the radio due to line noise from another source coming from outside ones' property. Our local power company has a crew of 4 now which work on line noise problems alone and have been very helpful in tracking down noises from any of their sources. But the noise that comes in on the line from neighbors touch-lamps is something to hear, they basically put about 5 unmodulated carrier type signals all over the dial! The sets with good RFI/EMI filters (such as the R390's) do a reasonable job on getting it out but there is still a good level radlated off the power lines, which I'm sure that if a complaint was filed with the FCC and one could get them off their duffs, something could be done to cure it. One on-going battle which I have had for sometime is interference from a house showing up on the FM band (TV sweep interference). The cable company is not even on the planet when they've been called about it, nothing has been done. I'm sure that if any effort has been made by a person to find the noise and can isolate it to a specific area, the power company could cut the power off to the house to see if it goes away. If cooperation can't be found, I'm sure that the threat of legal action would make it go away real quick (hey, some people are a little hard-headed and you've got the right to listen to your radio interference free!). I'm sure that if the power company in a certain area is given a little shove, they can be your best help in finding interference problems, they just have to be reminded of some rules and regulations from time to time. For those interested in the outof band stuff: WFLA-970 has some type of studio-transmitter or transmitter-studio link operating at 25.870 narrow band FM, it shows up here often but I've only heard WFLA a handfull of times over the years on 970! Any veries reported thus far from WNOM-1300? It was the only report I sent out this season! And welcome back to BILL ALISAUSKAS, who rejoined as a direct result of the WPPI-1330 test (he did it!).
