THE DX TIME MACHINE

<u>75 years ago</u>: From the Dec. 16, 1936 *DX News*:. PRF-3, 960 kc/s, San Palo [*sic*], Brazil, will conduct a DX Test for the NRC in January, and Dr. John Brinkley's XEAW, normally an all-nighter, will stand by for the test. ... New member Ernest R. Cooper of Brooklyn, N.Y., is welcomed to the NRC.

<u>50 years ago</u>: From the Dec. 16, 1961 *DX News*: Although NRC dues remain at \$4 annually, members were urged to elect first-class postal delivery (rather than the usual third-class) for an extra \$2 per year, since many were experiencing long delays in receiving *DX News*.

<u>25 years ago</u>: From the Dec. 15, 1986 *DX News*: Arkansas stations KHOG-1030 and KFAY-1250 have exchanged call letters; Ray Cole presented a design for the Tuggle Circuit crystal receiver.

<u>10 years ago</u>: From the Dec. 17, 2001 *DX News*: Many DXers heard an apparent pirate station on 1710 kHz operated by the Lubavitcher Jewish sect, apparently from Brooklyn, NY or the surrounding area; holiday cards were urged to be sent to former Musings editor Ernie Cooper, who is now confined to a nursing home.

CONSTRUCTION PERMITS ON THE AIR

910 KKSN WA Vancouver – CP for U4 3300/4300 is on the air after relocating to a new 3-tower transmitter site at 45-33-30/122-28-57. The new day pattern consists of two lobes as a figure-8 laying on its side with the top (the smaller of the two lobes) to the west and the bottom (larger lobe) to the east. How's that for a a description? The new night pattern is a simple circle based at Vancouver headed west, with two tiny 'blips' to the northeast and southeast.

GRANTS FOR NEW STATIONS

1450 NEW HI Hilo – CP granted for U3 5000/5000 from two towers at 19-42-34/155-06-35. The circular lobe is headed southeast.

1560 NEW WI Village of Superior – CP granted for U4 5000/4000 from six towers at 46-34-44/92-06-21. Both day and night patterns will be slender lobes headed due north.

ACTIONS

790 WAYY WI Eau Claire – Licensed for U2 5000/5000. WAYY is operating under a Special Temporary Authorization (STA) with U1 5000/1250 due to a fire in the 'doghouse' of its tower #3 (west tower in their 3-tower array). They have asked for 180 days to make necessary repairs. Their normal nighttime array produces two equal slender lobes; one to the northeast and the other to the southwest. The pattern protects Fargo on 790 and Chicago on 780. So says a QSL letter from the 70s.

900 WCME ME Brunswick – Licensed for U1 1000/66, WCME had been operating under an STA with U1 176/55 after they lost their transmitter site. But in May 2011 they filed for a Silent STA. They have now filed for another STA for U1 250/26 from a new transmitter site from which they plan to resume service and eventually relocate on a permanent basis.

970 WJMX SC Florence – CP granted for U1 10000/31, reducing the night power from 3 kW and eliminating the need for their nighttime directional array.

1170 WQHC AL Hanceville – Licensed for D1 850/0, this action extends their STA for D1 10/0 from a "whip" antenna.

1230 KPRL CA Paso Robles – Coordinate correction to 35-39-34/120-41-01.

1230 KBNH OR Burns – Coordinate correction to 43-33-53/119-03-34.

1240 KWAK AR Stuttgart – CP granted for U1 960/960.

1500 WKIZ FL Key West – Licensed for U4 250/250, WKIZ lost one of its three towers due to apparent re-settling of the offshore shelf on which the tower was positioned, and is now operating under an STA with U1 62/62. They have requested 180 days in order to facilitate repairs.

- **730 WJMT WI Merrill** 11/14 1800 Music: 'Baby's Got Her Blue Jeans On;' "This is WJMT, Merrill-Tomahawk;" followed by woman newscaster. **(MD-MN)**
- **730 CKDM MB Dauphin** 11/14 1700 Music, and: "Your everyday source for information. This is 730 CKDM. Good afternoon, it's sunny and, excuse me, ...cloudy;" Followed by news stories. **(MD-MN)** 11/17 0742 Music, then station ID: "CKDM. It's 6:42." First time heard in a long time. **(GH-KS)**
- **750 KMMJ NE Grand Island** 11/14 1800 "...and serve my spouse. I'm Dennis Braney. And that's real. This is KMMJ Grand Island. Americans worshipped government over God." **(MD-MN)**

by songs in Spanish with announcer speaking in both English and Spanish between songs. Then at 0750 female voice with station ID: "Eight-Seventy AM WKAR, East Lansing Michigan." Then back to more Spanish music. (JDS-MN) 11/14 1700 – "Michigan State University; AM WKAR and 90.5 WKAR-FM, Lansing NPR, also at WKAR-dot-org." Into news story at 4 PM CST. (Usually KPRM.) (MD-MN)

- 900 KFAL MO Fulton 12/1 1745 Out of high school basketball play by play, Bowling Green vs. Fulton Hornets. Into commercials including Debo Funeral homes, with phone number 573-642-2211. Followed by "This is KFAL Sports." Back to the game, then fades out. (JDS-MN)
- 900 CHML ON Hamilton 11/14 1800 Volkswagen commercial, "I'm Rena Hirsch 900 CHML Traffic continues. Your Number One choice for news. This is Hamilton's NewsTalk leader AM 900 CHML." (Usually KTIS.) (MD-MN)
- **900 CKBI SK Prince Albert** 11/10 1854 Good with C&W song "Good Time" by Alan Jackson, then ID as "Today's Country, 900 CKBI." **(RD-NE2)**
- 910 WSUI IA Iowa City 11/14 1800 "You're listening to Iowa Public Radio news. WSUI 910 AM, Iowa City, Cedar Rapids. Program schedules, podcasts and archived news stories are available on line at Iowa Public Radio dot org." (MD-MN)
- 910 WGTO MI Cassopolis 11/27 1723 Out of Amy Grant's "Sleigh Ride;" Black Friday ads. "We've captured the sound of 910, only it's better. All hits, all the time, the sound of the '60's. Into Drake-style SID: "WGTO, Cassopolis", into weather report sponsored by J. L. Landscaping. (PLS-KS)

- 960 KNEB NE Scottsbluff 11/30 1800 Out of song: My Rough and Rowdy days, Waylon Jennings "Your trusted voice for news twenty four hours a day, all the best country, Nine-Sixty KNEB Scottsbluff, Gering." Into ABC news. (JDS-MN)
- 960 KGKL TX San Angelo 11/24 2101 A break in the action on Texas A&M football "NewsTalk 960 KGKL San Angelo," and back to the game. (WH-CO)
- 970 WHA WI Madison 11/14 1700 Heard DTMF tones, followed by: "Now transmitting in both analog and HD Digital, AM 970, WHA, Madison." Then: "This is 'At Issue'. I'm Ben Merritt, you're listening to the Ideas Network of WI," etc. (MD-MN)
- **980 WITY** IL Danville 11/14 1800 Mix of stations, then singing: "WITY, Danville." Then ABC News/Brad Wheelis. (MD-MN)
- **980 WONE OH Dayton** 11/14. 1900 "...Barleycorn's Restaurant. Home for the best burger in town. This is WONE Dayton. And WTUE HD-2. Dayton's sports picture." Next: Fox Sports News. **(MD-MN)**

- **1050 CHUM ON Toronto** 11/14 1900 "This is Toronto's traffic and weather. This is the evolution of talk radio TSN 1050 Toronto." **(MD-MN)**
- **1060 KDUS AZ Tempe** 11/20 0100 Out of football play-by-play with a brief KDUS ID audible under daytimer KIJN still dominating the channel. **(WH-CO)**
- OH Canton 11/14 1700 "Hello, this is Father Matthew Pfifer from St. Sebastian's Parish. Thanks for listening to Living Bread Radio, AM 1060 WILB, Canton. Catholic Radio Northeast Ohio." (MD-MN) 11/16 1714 Weak with mention of "northeast Ohio" in ad for local tire & auto repair business, then sign-off. Usually shows up at least once every winter at this QTH during its sign-off. (RD-NE2)
- **SD** Pierre 11/14 1800 "... and Walworth County Implements in Selby. Proudly serving South Dakota since 1916. 1060 KGFX Pierre, a member of the Dakota Radio Group." ABC News, Brad Wheelis. (MD-MN)

Improving your DX skills - tips from new and veteran members

Greetings once again from the Heart of the Continent and welcome to the DX Tool Box Column number 36.

SDR Loggings and Tips

This go around I would like to announce that I will be adding a new section to the DX Tool Box. With the growth of the Software Defined Radios (SDRs) this column will be featuring articles about and loggings from this new wave in the hobby. SDRs have been mentioned here before as a new up-and-coming way to DX. The regular loggings columns will of course accept SDR loggings but, like all other loggings, they must be current (not more than one month old). But with SDRs you might not get to all your recordings for more than a month. With some SDRs you can record the whole broadcast band all at once. You then go through the recording frequency by frequency. This can take time and you may go past the one month limit for the other columns. So have no fear; the NRC thinks all loggings of interest should be in DX News. As stated on the cover page of Volume 79 Number 9, NRC has been looking for a starting point for SDR-related materials. So effective next column your older loggings and stories related to SDR DXing will be more than welcome here. This is, as I have stated, a new and growing part of the DX hobby, and it would be a shame to ignore it because of time limits that do make sense for reporting DX from non-SDR radios. So dust off your loggings, and send in the good ones. This would include new loggings and rare ones. Make them the best ones you have gotten and tell us why. The loggings can be sent in using the usual formats seen in DX News. Hey maybe a bandscan/list would be fun, telling us what you heard all in one recording with what you got on each frequency (just the callsigns, date and time you did the recording, and location is good). Stories about where and how you used your SDR are welcomed too. Let us see where this will go and how it will build into a format for this or even a new SDR column on its own. This is an open invitation to all you SDR users to make this what you want it to be to fit your DXing style.

I can tell you that we ran it on KSMU... and since our main Springfield transmitter (91.1FM) AND our translators in Branson/Point Lookout (90.5) and West Plains (90.3) ALL run IBOC/HD Radio with the resultant several-second delays, it definitely was not "synchronized!" (The Branson translator picks up our audio off-air, and then adds its own IBOC delay to that!) And yes, the audio was total and utter crap, with distortion, crosstalk, funky start-of-message/end-of-message tones, etc. Glenn's estimation of 1:00:30 pm CST is pretty much accurate, judging from when the start-of-message tones interrupted the automated TOH break that we had playing. Journal Broadcast Group here in Springfield (KTTS-FM/KSPW-FM/KRVI-FM/KSGF-AM [1260] & FM) received their audio for the national test from us, and noted the bad audio as well. In fact, the station that relays THEIR EAS tests, KJEL in Lebanon, MO, had to get back on the air manually because the end-of-message

tone didn't trip their equipment to switch back to their regular audio! Oh well, that's precisely why they test these things--to figure out what bugs exist and how to work them out of the system. Randy Stewart Arts Producer KSMU 901 S. National Springfield MO 65897

From what I read, it didn't happen at all anywhere in Oregon, due to some kind of failure at the point where the alert was received by the state. I know there were problems in Georgia as well. Yes, it went pretty well in Nashville. There was some "phantom audio" (sounded like "printthru" on analog tape) and I think the first EOM data burst was truncated, but the audio message was easily intelligible and I think the small amount of noise was because we were relaying an AM station. (Using an antenna on a building full of computers... Even though the AM station in question was WSM, a mere ten miles away, I suspect the computers may actually radiate more than 50,000 watts (grin) We were expecting myriad phone calls from viewers wanting to know what was up. We spent some time yesterday setting up a special voice mailbox explaining the situation & providing the number to staffers. As it turns out, we got... **ONE** call. Guy wanted to know when we were going to stop relaying C-SPAN. He insisted he didn't have cable. Weird. Can't vouch for how many stations failed to relay the test. (The only station I personally monitored was our own) Stations are supposed to relay EAN (the code used for this test) without delay. (I mean, you can't hold the message & not relay it until after the commercial break. Coding delays in digital equipment are fine.) Relay delays are permissible for the regular monthly tests we've been running

for years and for any other EAS message except EAN. I can't say I've heard from anyone outside Tennessee who thought the audio message was intelligible. One thing that's very different about this test. is that the FCC has asked all stations to report their success (or lack thereof) in relaying this test. I will be very surprised if anyone gets sanctioned for honestly reporting they tried & it didn't work. - I won't be too totally surprised if someone gets sanctioned for reporting it failed because their EAS gear was turned off/never configured/never ordered/they never troubleshot failures to receive the "regular" tests. I will bet they'll do at least spot follow-ups on those stations that don't report. And I'll bet someone, somewhere gets sanctioned for completely ignoring the process.

Russ: the gear, if configured properly, is fully capable of handling automated operation. It simply interrupts the path from studio to transmitter as soon as the received message is complete, and directly feeds the transmitter with the data bursts, attention tone, and voice message. NOAA Space Weather Outlook

Issued November 29 – For the period November 30-December 26, 2011

Solar activity is expected to be at predominately low levels with a chance for isolated M-class activity due to the anticipated return of several active regions.

The current 10MeV proton event in progress is expected to end by prior to the beginning of the outlook period.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at normal to moderate levels the entire period.

Geomagnetic field activity is expected to begin the forecast period at unsettled to active levels as a coronal hole high speed stream becomes geoeffective. Conditions should persist for a day or so before calming to mostly quiet levels from December 1 onward. Another coronal hole high speed stream is expected on December 9 and 10, when activity may again increase to unsettled and active conditions. Mostly quiet conditions are anticipated once again from December 11-23 before the next coronal hole high speed stream is forecast to be geoeffective and produce unsettled to active conditions on December 23. Mostly quiet conditions are forecast from December 24 through the end of the period.
