<u>50 years ago</u>: From the Feb. 3, 1962 *DX News*: Pat Reilley, Jamestown, N.Y. reported receiving his 3,300th verification, from 250 watt KIQS-1560 Willows, Calif.; WFBM-1260 Indianapolis has printed special QSL cards in honor of the 1962 NRC Convention to be held in Indianapolis.

<u>25 years ago</u>: From the Feb. 2, 1987 *DX News*: Nineteen different longwave stations were reported to IDXD: 153 (West Germany, Romania, USSR), 162 (France), 171 (East Germany, Morocco, USSR); 177 (East Germany); 183 (West Germany); 200 (England, USSR); 209 (Morocco); 218 (Monaco); 227 (Poland); 236 (Luxembourg, USSR, USSR); 254 (Algeria); 263 (USSR); 272 (Czechoslovakia).

570 WMCA NY New York – 1/4 1602 – Religious program from a synagogue in Plainville, Long Island, call (516) 573-0964, signal mixed with WSYR. **(TF-NH)**

WSYR NY Syracuse – 1/6 1602 – Local traffic, many commercials including one for Buffalo Wild Wings sports bar, local weather, many ID's for "WSYR 106.9 and News radio 570", announcement for a nutrition class at a local college, finally into Sean Hannity program. (TF-NH)

580 CKUA AB Edmonton – 1/16 0807 – Poor but steady with AB SK and MB weather, "...news next at 6:30 on CKUA", rooster sound effect and Ellison Broth (?) Rise & Shine Morning Show. Might have also used "580 Radio" slogan 15 minutes earlier but I tuned away. NEW! (JJR-MI)

640 WHLO OH Akron – 1/4 1700 – ID into news, pulsating signal above one other station, brief stock market report then faded into the jungle with someone broadcasting a basketball game and another station with Hannity. **(DJ-PA)**

660 WMIC MI Sandusky – 1/16 0709 – Poor with mention of "in downtown Sandusky" in art show ad, C&W songs. (JJR-MI)

690 WJOX AL Birmingham – 1/16 1759 – Fair; end of PSA string, "WJOX Birmingham, the voice of the fans, this is 690 The Fan, a Cumulus station," ESPN promo, then gone with apparent switch to night facilities leaving WELD in clear. **(BC-NH)**

WOKV FL Jacksonville – 1/10 0809 – Excellent signal with many IDs during newscast. Male and female announcers alternating news items. Report on NH Primary and an auto accident on east side of town. Phoenixville, PA (WPHE) butted in. (DJ-PA)

WZAP VA Bristol – 1/4 1645 – Mostly on top with solid ID after a brief religious message followed by typical gospel ranting. Mentions of Virginia locations. (DJ-PA)

+++ - 1/18 1700 – Through WELD and others; quick ID, "WZAP Bristol" into news. (BC-NH)

WELD WV Fisher – 1/13 0722 – Fair signal in hash with C&W/mountain music. No ID but many mentions of Petersburg during local West Virginia news on the "Wake Up Show". Ads for Turbo Tax and McDonalds, local weather at 0729. I've been

- looking for this station for a long time and have always failed to catch an ID. Jacksonville, FL takes over at 0730. So the very next day, 1/14, I hear a perfect ID at 0708. Fisher, WV is not on most maps but I know the area and it is next to Petersburg. (DJ-PA)
- **700 WDMV MD Walkersville** 1/6 1625 Spanish programs, bouncy music with lots of clustered commercials delivered dramatically in SS, gradually lost to WLW. **(TF-NH)**
- **740 WNYH NY Huntington** 1/9 1605 Way atop frequency with screaming in SS (guess he was preaching), lost gradually to the far more enjoyable CFZM! **(TF-NH)**
- **770 KATL MT Miles City** 1/16 1020 Poor with ads mentioning local phone numbers 234-XXXX, 874-33XX in Miles City, local weather with -20 wind chills! **(JJR-MI)**
- **780 WAVA VA Arlington** 1/18 1700* Good with sign-off: "At this time WAVA AM must leave the air to comply with federal regulations... AM 780 WAVA Arlington, Washington, and everywhere on wavaam.com, a service of Salem Communications." (BC-NH)
- **820 WNYC NY New York** 1/6 1550 Good signal here with "The World" by Public Radio International, ID at 1600 for WNYC AM and FM, then into "All Things Considered." **(TF-NH)**
- **830 WMMI MI Shepherd** 1/16 0905 Poor until lost to WCCO with Cabin Pizza ad mentioning "in Mount Pleasant" and LiveUnited ad. Not common. **(JJR-MI)**
 - WEEU PA Reading 1/7 1625 AccuWeather with Joe Sobel, ID for WEEU, "Voice of Berks County", traffic around Reading, woman DJ, into music, signal way over the 50,000 watt WCRV- Worcester, which is a strong daytime regular here. (TF-NH)
- **840 WKDI MD Denton** 1/18 1700 Through WRYM; "This is the station you have come to rely on for... ministry, AM 840, WKDI Denton, Dover, Annapolis... positive radio... station." New log. (BC-NH)
- **860 WSBS** MA Great Barrington 1/17 2003 Under CJBC with WSBS.com website promo. Thanks to tip from Tim Tromp. (HF-MI)
- **870 WHCU NY Ithaca** 1/17 1800 Good; "You're listening to 870 AM, 95-9 FM, News/Talk WHCU Ithaca, WQNY HD3 Ithaca, the home of breaking news and stimulating talk," and time check into CBS news. **(BC-NH)**
- 910 WBZU PA Scranton 1/17 1800 Poor; "WILK-FM, WILK-FM HD1 Avoca, WILK Wilkes Barre, WBZU Scranton, WKZN West Hazleton, northeast P-A's news radio WILK." (BC-NH)
- 920 WURA VA Quantico 1/17 1700 Loud over WHJJ but with distorted audio; only slogan/ID, "Radio Lider 920 AM," then at 1800 caught ID, "WURA Quantico..." into ID in Spanish, religion in Spanish. (BC-NH)
- 940 WCPC MS Houston 1/17 1800 Good; end of Brother Carpenter program, promo, "...on AM 940, radio that changes the way you live, WCPC Houston," and ID, "Mississippi's first 50-thousand watt standard broadcast station, WCPC Houston Tupelo Columbus north

standard broadcast station, WCPC Houston, Tupelo, Columbus, north Mississippi, and northwest Alabama, WCPC Houston." (BC-NH)



- WKYK NC Burnsville 1/6 0159 in WMAC mix with C&W songs, "WKYK Burnsville. The station more people listen to" ToH ID into ABC news. (KK-VA)
- WNRG VA Grundy 1/16 1905 Suddenly popped up out of nowhere loud and clear over WIPR, "We're your home for Solid Gospel, WNRG Grundy, Virginia." (BC-NH)
- WKGM VA Smithfield 1/18 1659 Good; local weather forecast, "...on AM 940 WKGM, your ministry station." (BC-NH)
- 950 CFAM MB Altona 1/16 1017 Poor but over WWJ with Garden Journal and Senior Connection features, -22 temperature "on CFAM -950." (JJR-MI)
- 960 WATS PA Sayre 1/18 1640 Steady weak signal with PSA for people to work at "The Choice", ad for Dakota's Restaurant in downtown Sayre, local weather, "Y-102" slogan into rock music. (TF-NH)
 - CFAC AB Calgary 1/16 0901 Poor but alone with "Sports Radio 960 the Fan" slogan, time check, Rogers Radio sports news. (JJR-MI)
- 980 CJME SK Regina 1/16 0958 Poor with talk of BC Indian Chief signing on to pipeline, "Hero of the Day" feature, "Regina's #1...CJME" station promo. (JJR-MI)

- 990 WNTW PA Somerset 1/6 1650 Sean Hannity Show, ads for Virtual Office, Freedom Ford, a medical minute called "Heartbeat", a minute of prayer, and back to Sean Hannity, signal lost at 1700, probably when they went to nighttime 100 watts. (TF-NH)
- **AB** Calgary 1/16 0819 Poor with woman giving local temperatures and wind chills, local phone number "here in Calgary...403-521-XXXX" to report weather conditions. (JJR-MI)
- **1060 WILB OH Canton** 1/16 0859 Poor until lost to KYW with EWTN programming, mention of "in the Youngstown Diocese." (JJR-MI)
 - **KYW** PA Philadelphia 1/9/12 1602 Philadelphia news, Comcast ad, steady, very audible signal, no WQOM in Natick, until recently regular here, now gone with its power increase and changed pattern. (TF-NH)
- **1070 WAPI** AL Birmingham 1/18 1747 Over CHOK and a couple of sports talkers (pretty sure one was WFNI) with Sean Hannity show ("Birmingham's own Sean Hannity"), 100WAPI.com website promo, ABC news at 1800 and abruptly disappeared, presumably due to pattern change (HF-MI)
 - WKOK PA Sunbury 1/10 1625 Strong semi-regular signal here with ad for Lennox, "Talking Points", Wall Street Journal Report, Coldwell banker ad, local Accuweather and CNN news at 1630. (TF-NH)
- **1080 WOAP MI Owosso** 1/16 0823 Fair with "Life's Been Good" by Joe Walsh "on the Big 1080 in Michigan...", <u>Big1080.com</u> website promo. (**JJR-MI**)
 - KNDK ND Langdon 1/16 1009 Fair with station promo "More of the Borderlands Most Wanted Country is next on Maverick 105," ads for Langdon Chamber of Commerce giving phone number with 701 area code, Case-International Harvester dealer in Grafton, "Maverick 105" jingle and C&W songs. (JJR-MI) Presumably "Maverick 105" is their FM // on 105.something. Mike
- **1110 WUPE** MA Pittsfield 1/10 1636 Oldies, DJ noted that the station plays hits from the 1960's, 70's, and 80's, "Woopie Radio" slogan, Berkshire News Network area news at 1645 and then Fox News. (TF-NH)
- 1140 WRVA VA Richmond 1/6 1629 Geico ad, traffic reports, lots of news, weak signal, Jay Hart was the news announcer, surprised to hear WRVA here as the station's directional pattern goes away from NH. (TF-NH)
- **1150 WMRD CT Middletown** 1/10 1629 good signal with ads for McDonalds, Connecticut Broadcasting School, (????) Data Service, Middlesex Community College, local Accuweather, dual ID for WLIS-1420 and WMRD-1150 into Dennis Miller Show. **(TF-NH)**
- 1170 KJOC IA Davenport 1/17 2005 Presumed over WFDL and what remained of WWVA (apparently off or on reduced power) with trueoldieschannel.com website promo into "Fire and Rain" by James Taylor. (MKB-ON)
 - WFDL WI Waupun 1/17 1819 Over nulled WWVA with mix of EZL and oldies, station promo "Stevie Wonder, Johnny Mathis...they're all here...AM 1170 WFDL" into "Year of the Cat" by Al Stewart. Still on at 1900. Seems like they forgot to sign off. QSLed as WLKE in 1980. (MKB-ON)
 - +++ 1/17 1911 With WWVA absent or at least inaudible, a rare opportunity to log something else on this channel other than daytimers WDIS and WFPB. Clear "AM 1170 WFDL" after what sounded like a Johnnie Ray number (a *real* oldie); continued with Louis Armstrong vocal. Had been sitting on this one for almost an hour as it tangled with presumed KJOC, which looped in the same direction and was also playing oldies, so it was often hard to tell which station was playing which song. (BH-MA)
- 1190 WOWO IN Fort Wayne 1/6 0100 In WLIB mix with Coast to Coast AM, ToH ID and station promo "Hi. This is George Noory. Another hour of 'Coast to Coast AM' is next on news talk 11-90 WOWO", then a website promo "Connect live on the internet at wowo.com", "News now W-O-W-O Fort Wayne" into news. This is the first time I recall hearing the call sign said as separate letters instead of similar to a word "woe-woe". (KK-VA)
- **1200 WRKK PA Hughesville** 1/18 2028 Local ad "Park Pizza, 1701 Memorial Avenue in Williamsport. Open daily at 4 PM ... call them at 322-9024 and enjoy the great taste of Park Pizza." Continued to extol the virtues of the pizza joint, then vanished into a morass. **(BH-MA)**
- **1230 WXCO WI Wausau** 1/15 1800 Poor in mess with ads for Hadley's Office Products and a Savin dealer, ToH legal ID into CBS news. (**JJR-MI**)

- **ON Oakville** 1/6 0328 In WKDL mix with gospel songs, man with website promo "Check out our website at joy1250.ca", woman with station promo "...overnight on the Whiteoaks Communications Family of stations... CJYE 1250 and...1320..." **(KK-VA)** *The* 1320 *is* CJMR *in nearby Mississauga. Mike*
- **1270 WMKT MI Charlevoix** 1/13 1707 Very good signal, all alone. Weather report and ID, "WMKT and 92 FM" Ads for cruise to Bahamas and for employment opportunities at Radio MGB. Back into Michigan based talk program. **(HJH-PA)**
 - +++ 1/17 1606 Over usual WXYT and WHLD groundwave with local weather, "there's your forecast from 1270 AM and 92.1 FM WMKT", promo for live coverage of Gov. Rick Snyder's State of the State address. (MKB-ON)
 - WXYT MI Detroit 1/18 2015 Out of political speeches by Mich. Governor and Dem. Senate leader. "Now we're going to go to our sister station WWJ with Paul Snyder for a little recap ..." Snyder took over: " ... morning host on our sister station Radio WXYT 1270, who is across the hall here in our Southfield studios ..." They fretted about some difficulties with their audio hookup. (BH-MA) *Apparent format change from all-sports to news-talk. Mike*.
- **1300 WWCH PA Clarion** 1/13 1930 ID heard loudly on crowded frequency, "WWCH 1300 AM." Had Pittsburgh Penguins coverage. New and much needed. **(HJH-PA)**
- **1320 WATR CT Waterbury** 1/20 1600 Under WDER; "...Good Time Oldies, 1320 AM WATR Waterbury." (BC-NH)
 - WICO MD Salisbury 1/18 1800 Fair in WDER null; "WICO Salisbury, WICO Delmarva's Talk Station, 92.5... WICO," into news. New log. (BC-NH)
 - KHRT ND Minot 1/16 1000 Fair but steady with steady with ToH call letter ID and preacher. (JJR-MI)
- **1330 CJYM SK Rosetown** 1/16 0839 Poor until lost to WHBL with local weather (-22C today), several SK temperatures, oldies. **(JJR-MI)**
- **1340 KRBT MN Eveleth** 1/16 0757 Poor but steady over others with promo for "Bill Bennett's Morning in America on KRBT AM 1340." (**JJR-MI**)
- **1360 WTAQ WI Green Bay** 1/13 1735 Ad for Allstate Insurance then weather report. ID as "97.5 and 1360 Newstalk WTAQ". Returned to the Sean Hannity Show. Alone on channel. **(HJH-PA)**
- **1380 KLIZ MN Brainerd** 1/16 0758 Poor but over others with near-ToH call letter ID, "The Fan" slogan. (JJR-MI)
 - **WABH** NY Bath 1/17 1800 Out of ESPN Radio with fast "WABH Bath" ToH ID. At first I thought they meant Bath ME until I checked the AM Radio Log. (BH-MA)
 - WKDM NY New York 1/18 1855 Over CKPC and ESPN sports talker with Chinese talk, alternating man and woman, with electronic music in background, near-ToH legal ID in EE by man at 1902: "WKDM AM 1380 New York." (MKB-ON)
- **1390 WEGP ME Presque Isle** 1/17 1559 Over Fox Sports talker (presumably WNIO) with "The Talk of the County" slogan, local weather, "serving northern Maine and western New Brunswick, 1390 WEGP" ToH ID into Fox news. **(MKB-ON)**
- **1420 WIMS IN Michigan City** 1/15 2000 Poor in nice fade up with ToH ID, "The Talk of the South Shore" slogan and run-down of guests scheduled for next week. (JJR-MI)
- 1430 WNSW NJ Newark 1/17 1626 Voice of Russia programming in EE with lengthy discussions about the Stop Online Piracy Act, the death penalty, and other weighty matters. NOAA Space Weather Outlook

Issued January 17 – For the period January 18-February 13, 2012

Solar activity is expected to be at low levels with a chance for isolated M-class activity from Region 1401, 1402 (N27, L=215, class/area Dho/270 on January 15) and old Region 1389 (S23, L=087), which is expected to return to the visible disk on January 21.

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at normal flux levels during January 18-February 3. Normal to moderate levels are expected from February 4-7 following a coronal hole high-speed stream (CH HSS). Normal levels are expected for the remainder of the period.

Geomagnetic field activity is expected to be quiet on January 18. Conditions are expected to be at quiet to unsettled levels with a chance for isolated active periods on January 19-20 due to a coronal mass ejection (CME) observed early on January 16. Mostly quiet conditions are expected to return from January 21-February 1. Quiet to unsettled conditions are expected from February 2-4 due to a recurrent CH HSS. Predominately quiet conditions are expected from February 5-8. A second CH HSS is expected to become geoeffective on February 9 bringing quiet to unsettled conditions. Mostly quiet conditions are expected on February 10-11 before becoming quiet to unsettled for the duration of the period due to a third CH HSS.

From the *Peoria Journal-Star* – January 18, 2012 http://blogs.pjstar.com/mindingbiz/ (by Steve Tarter)

After being daytime only for 60 years, this Peoria station will get a night life

AM radio went out with eight-tracks and bell-bottoms, didn't it? And what about your daytimer AMs? These are stations that only operate by day, mandated by the Federal Communications Commission to turn off their signal at night. \

Yet WPEO-AM 1020 rolls right along in Peoria, Illinois. The little station, with its Christian talk format, has been operating — on and off — since 1948. The station has progressed through a number of formats over the years, offering up Top 40 hits in the late 50s and early 60s when WPEO's morning voice was Harry Harrison (before the "morning mayor" left for New York City to rule Gotham air waves for 40 years).

The station found religion in 1970 and has been spreading the word ever since. Station GM Bob Ulrich, who started there as a summer intern in 1972 and has been at the station helm for the past 25 years, noted that change is coming.

"After 42 years, the (Pennsylvania-based) Pinebrook Foundation has sold the station. We're now under local ownership," said Ulrich, identifying John Wieland of MH Equipment in Mossville as the new owner. "We'll carry on just as before," he said, noting that the ownership change won't result in any changes in format for the station.

Two years after the FCC allowed AM stations to use FM translators, WPEO is also getting closer to having an FM signal, allowing the station to operate at night, said Ulrich. "I found an FM translator in Clinton, Iowa that I was able to purchase," he said.

But the FCC requires WPEO to test their FM signal at various spots between Peoria and Clinton — for two months at a time at each location — in order to insure the station's FM signal doesn't conflict with others in the market. "I'm not sure when it's going to be here," said Ulrich of his FCC-sanctioned FM signal.

When it does arrive, Ulrich will have a new decision to make: what to put on the air at night on his FM band? FCC rules require him to simulcast the daytime AM programming on the FM but the nighttime is wide open. "We could pick up something off the satellite or we could go local," he said. With the advent of FM, WPEO would start streaming on its website, added Ulrich.

My suggestion for the evening FM format? Go to an adult-standard instrumental mix with an emphasis on movie themes.

From *AllAfrica.com* –December 28, 2011 (by Isa SA'idu)

Kaduna — The only Kaduna state-owned AM Radio station has been off transmission for about five months, a development that has made reporters and other workers of the media house redundant, Daily Trust can reveal.

Our investigation revealed that the state radio made its last transmission in August.

A staff, who pleaded for anonymity, said: "As you can see we are redundant. We make ourselves busy by reading Newspapers and relaxing under tree shades. We don't go anywhere looking for news. Even at organised events, nobody bothers about our presence.

"Sometime when we introduce ourselves as staff of the KSMC AM Radio, they chase us away because they know that our medium is off air. The AM Radio has stopped transmission in Ramadan (August). Before that time the station has been on and off.

"We learnt that the only thing needed for the station to come back to life would cost only about N2m. To my own understanding there is misplacement of priority because they recently bought computerised equipment for adverts at about N10m. What would they advertise since the station is off air?"

Another source confided in Daily Trust that the predicament of the radio station was as a result of the clash of interest that exists between the Managing Director of the media house, Mrs. Tamani Yusuf, and the state Commissioner of Information, Alhaji Sa'idu Adamu.

When contacted however, Alhaji Adamu debunked the insinuations, saying that damage of parts of the station's transmitter was the reason behind the closure of the Radio station.

"Without a genuine reason there is no way we would allow our most reliable channel of passing information to our people to remain closed for a very long time. The transmitter of the radio station is antilock that was bought from a US company, Hariss. We have applied for the purchase of those parts but the company has to fabricate them.

"Had it been that it is something that we can just buy, I would have sought for permission from my governor to go and buy them. I want to assure you that very soon we would get those parts and the station would resume transmission. For the main time, we have four FM stations fully working", Adamu said.

It's Not Broke So Don't Fix It

In the Oct. 19 issue, Dan Mason of CBS Radio says he's concerned about AM radio. Bruce Reese of Hubbard says convert AM to digital and problems go away.

The problem that needs to go away is input from large corporate owners. Every time they buy into some "newfangled" idea, it costs me money, but nothing changes other than my bottom line.

We have a 1 kW AM, analog, gospel and sports programming. None of my listeners complains about not hearing us in digital.

Citadel, Clear Channel and others stay in the bankruptcy line because they buy into every piece of junk that is presented to them. The FCC isn't much better.

Most of the radio mess is a result of too many worthless 100 kW FMs, the FCC allowing FM/AM combos to be split and sold off, the destruction of local radio by the corporate giants and translators being bought up and held for more profit.

Our station is profitable, sounds good, pleases our community and we have fun.

What needs to happen is simple. No FMs over 25 kW. Every standalone AM gets an FM translator that when assigned is a part of the AM license and can never be sold away from the AM and must simulcast 100 percent of the time.

Our station is in the Baton Rouge market, which like many other markets has way too many radio stations because of corporate ownership. I would like to have a simple 100 watt translator to cover our area at night, but because of corporate manipulation of the FCC, the FM spectrum in Baton Rouge and New Orleans overlaps and there are no FM allotments for anyone. Our people suffer and no one cares.

I pray I live long enough to see the corporate giants finally buy themselves into total bankruptcy and have to divest themselves of about 90 percent of their holdings.

We like serving our little area. Our EAS plan is second to none. Our local governments can activate an EAS and access our transmitter for an unlimited amount of time and not have to listen to some overpaid moronic program director whine. We have been EAS-compliant for months and welcomed the national test. Our local system has been tested and works flawlessly. Our people are safe. There is not one radio station in Baton Rouge or New Orleans that will outshine us in an emergency situation. Katrina, Gustav and tropical storm Lee proved this beyond a shadow of a doubt.

So I say leave us alone to do what we do best: serve in the public interest with our analog signal that works just fine. It's not broke so don't try to fix it.


