ON THE AIR

- **1400 KCOW NE Alliance** CP on the air to adjust antenna feed system and correct coordinates to 42-06-22/102-53-17, remains U1 1000/1000.
- **1490** KLZN CA Susanville New station on the air with U1 950/870.

Also note that the new 33rd Edition *NRC AM Log* has several stations "on the air" that I don't believe have been reflected in prior AM Switches – KJJI-1190 White Bluff AR and KFJL-1400 Center Point OR, both of which are listed as "licensed" in the online FCC database, and KPSF-1200 Cathedral City CA, which the FCC still lists as a CP using "program test authority," but has been heard on the air. KPSF, which will be U4 5000/1300 when fully licensed, has temporary authority to broadcast with U4 2500/600 while some kinks are worked out in the antenna system.

MOVING TOWARDS THE AIR

- **820 WBKK MN Wilton** CP for new station with U4 10000/750 was granted program test authority on 9/5; should be testing soon if it's not already.
- **1400 KRAM UT Vernal** CP for new station with U1 1000/1000 applied for a license to cover and program test authority on 9/12; should be close to coming on air.

OFF THE AIR

- **1550 WKJQ TN Parsons** License cancelled and calls deleted at licensee's request; had been silent since 7/2/2012.
- **1560 WINV FL Beverly Hills** License cancelled and calls deleted at licensee's request; had been silent since 10/9/2011.

GRANTS TO EXISTING STATIONS

- **1260 KWNX TX Taylor** Granted CP to change CoL to Elgin TX, site/power unchanged.
- **1280** KRZE NM Albuquerque Granted license renewal and reinstated station call letters.

APPLICATIONS FROM EXISTING STATIONS

- 1190 KQQZ MO Desoto Has a CP for U4 25000/650, CoL to Fairview Heights IL and, as previously reported, applied to amend the CP to U4 10000/650. The amendment had originally specified that the CoL would revert back to Desoto, but KQQZ has now amended the application to clarify that it would still involve changing the CoL to Fairview Heights.
- **1550 KXTO NV Reno** Applies for U1 2400/90, diplexing from the KFOY-1060 towers.

CONSTRUCTION PERMITS CANCELLED

- NV Reno This CP for a new station expired on 9/14. The station applied for a last-minute amendment to the CP earlier this summer, hoping to diplex from the KPLY-1060 towers, but both KUZZ and KOAC objected and the FCC turned down the application citing interference to those stations. The FCC hasn't deleted the CP from the database yet, but it probably will soon.
- **1010 KXEN MO St. Louis** CP for U4 50000/420 expired on 8/26 and is deleted; the station's transmitter site is being sold. KXEN intends to file a CP to move to a new site

as soon as one is located. It has applied for, and received, an STA to operate from the WGNU-920 site with U1 350/125, should that become necessary, but – as Artie Bigby confirmed with the KXEN General Manager after hearing an item on the STA on Glenn Hauser's *World of Radio* show – KXEN is still operating with the licensed U4 50000/500 at the existing site.

- **1160 WCFO GA East Point** CP for U5 50000/138 expired on 8/6 and is deleted; remains U4 50000/160.
- **1320 KSCR OR Eugene** CP for U1 600/40 expired on 8/28; station has applied for a new CP for the same parameters.
- **1400** KRVZ AZ Springerville CP to move to 1370 kHz expired on 8/12 and is deleted.
- **1470 WMGG FL Dunedin** CP for U2 750/800, CoL to Egypt Lake FL expired on 8/6; station has applied for a new CP for U4 2800/800, also CoL to Egypt Lake FL.
- **1500 CP NV Winchester CP** for new station returned by licensee on 9/11 and cancelled.

SPECIAL TEMPORARY AUTHORITY

- 890 KYWN ID Meridian Applies for silent STA; went silent 9/19 for financial reasons.
- **1080 KWAI HI Honolulu** Has a CP to correct its coordinates and antenna pattern, which are incorrect in the current license. To satisfy the CP, it needs to conduct tests to

recertify the antenna system, and to do *those* tests, a total of 14 stations need to go off the air for 6 hours on 2 consecutive nights. The engineering firm wants to do this on a Saturday and Sunday

night, "as early in the evening as is practical." The stations are KSSK-590, KHNR-690, KGU-760, KHVH-830, KHCM-880, KIKI-990, KLHT-1040, KWAI-1080, KZOO-1210, KNDI-1270, KKEA-1420, KHRA-1460, KHKA-1500, and KREA-1540. In the meantime, KWAI was granted an STA on 9/7 to keep operating at variance from the incorrectly specified license for another six months. Honolulu DXers, expect the mother of all silent periods soon!

- **1300 WIBR LA Baton Rouge** Applies for a silent STA; the transmitter was destroyed in a 2008 tropical storm and the station's new owners are trying to revive it; it started operating in July 2012 under an STA for U1 150/150, but the temporary transmitter failed and the station has been silent since 8/7.
- **1310 KKNS NM Corrales** Station will lose lease on its transmitter site on 9/30; it has requested an STA to operate from a 60′ electrical metal conduit at 300 56th St., Albuquerque NM with around 200 watts until a new site can be found.
- 1320 KSDT CA Hemet Applies to renew its STA (which expired a while ago); says it has been operating since at least 2004 with reduced power while it tries to develop a permanent solution to longstanding zoning problems preventing its operation at full power, and that it intends to file for a CP with a permanent solution soon.
- **1340 WMTE MI Manistee** STA item in 79-30 is this, not Manitee FL.
 - **KTSN NV Elko** Applies to extend silent STA; has been silent since 1/24 but is still waiting to get the transmitter back from the manufacturer.
- 1370 KZSF CA San Jose Applies to extend its STA for U1 1000/1000; the building housing the transmitters, phasing, and directional antenna monitoring equipment was destroyed in an October 2010 brush fire and repairs are still incomplete.
- 1410 WMSX MA Brockton This station lost its transmitter site and went silent on 8/8 and has now been granted an STA for U1 250/39 from a longwire antenna. The station has identified a new site and will apply for a CP to move there permanently when final leasing issues are resolved.
- **1470 KDEB CO Estes Park** Silent station informed the FCC that it resumed operations 9/18; then went silent again 9/20, telling the FCC it lost the lease on its tower site.
- **1550 WAZX GA Smyrna** Requests silent STA; has been silent since 9/3 because the "programming source is unavailable."

DO YOUR HOMEWORK

The FCC noticed that five stations that were due to file renewal applications on April 1, 2012 had failed to do so. So, on August 27, the FCC sent each station a letter (certified mail) saying that its license had been cancelled and that it must cease broadcasting immediately. The stations' reactions have varied, and only one license has been reinstated so far; here's the status on each:

850 WPFD TN Fairview – The station filed a (late) renewal application and then applied for a silent STA, stating that the owner had noticed the station was off the air, and when it inspected the rural transmitter site, he discovered that the transmitter was missing. Really. If anyone sees WPFD's transmitter, let them know.

1

960 WQLA TN La Follette – The station filed an STA application on August 31, with a copy of its license renewal application (submitted on March 30) and its cancelled check to the FCC. The FCC promptly reinstated WQLA's license and call letters.

1280 WKYY KY Lancaster – The station eventually filed its renewal application, explaining that the majority owner of the corporation that owns the license died some time ago and the current ownership doesn't have the paperwork it needs to get right with the FCC. The station received an STA to resume broadcasting on 9/14.

1380 WHEW TN Franklin – The station filed its late renewal application, no explanation given, and requested an STA to resume broadcasting.

TN Woodbury – The station refiled its renewal application, explaining that the fees it paid with the original application weren't accepted by the electronic FCC system because of a prior problem that has been resolved. It also applied for an STA to resume broadcasting.

Shawn Axelrod has collected these Canadian changes from the CRTC:

590 CFAR MB Flin Flon – Applies for an FM station at 102.9 MHz FM, but retaining the AM station as a repeater for the new FM.

610 CHTM MB Thompson – Applies for an FM station at 102.9 MHz FM, but retaining the AM station as a repeater for the new FM.

680 CHFA AB Edmonton – The station has a CP to move to 90.1 MHz, and has been operating on 90.1 MHz // AM since 9/1; the CBC "Espace Musique" station that had been on 90.1 has moved to 101.1 MHz, which used to be a "nested repeater" for CHFA. The original CRTC decision provided that CHFA had to sign off on AM 90 days after the FM came on the air, but some think that since no new FM station actually came on the air, 680 might be able to stay on.

740 CFZN ON Toronto - Application for a nested repeater on 88.1 MHz FM denied.

860 CJBC ON Toronto - Application for a nested repeater on 88.1 MHz FM denied.

1050 CKSB MB Winnipeg – Applies to move to 88.1 MHz FM.

1240 CBXX AB Rainbow Lake – LPRT applies to move to 101.5 MHz FM.

CJAR MB The Pas – Applies for an FM station at 102.9 MHz FM, but retaining the AM station as a repeater for the new FM.

1450 CBWI AB Grand Cache – LPRT applies to move to 92.3 MHz FM.

1460 CBKC AB Fort Vemilion – LPRT applies to move to 105.1 MHz FM.

1480 App ON Markham - Application for new station here daytime and on 1490 kHz nighttime is denied. The ghost of CHYR remains undisturbed.

1540 CBXD AB Edson – LPRT applies to move to 95.3 MHz FM.

1560 CBKD AB High Level – LPRT applies to move to 99.5 MHz FM.

1570 CKMW MB Winkler – Has a CP to move to 103.7 MHz FM; applies to move to 88.9 MHz instead.

690 CKGM QC Montreal – Slogan now "TSN Radio 690."

760 WLCC FL Brandon – Format to SS:REL, "Radio Luz."

790 WAXY FL South Miami – Slogan now "104.3 the Ticket" // WMSF-104.3.

800 CHRC QC Quebec – The station's owners have announced their intention to shut the station down, perhaps in October. (*Le Soliel* 9/14, via Dan Sys via Shawn A.)

820 CHAM ON Hamilton – Format now Comedy, slogan now "Funny 820."

MA Boston – Will cease simulcast with WEEI-FM-93.7; FM will keep the Red Sox, Celtics, and NFL games (regular season and playoffs) as well as all the local WEEI sports talk shows, while the AM will carry the national ESPN programs, including baseball playoffs, NBA, and college basketball coverage. The split will debut with "Mike and Mike" broadcasting live from Gilette Stadium in Foxboro on 10/5 at 0600 ELT. (*Radio Insight* via Shawn A.)

870 KJMP CO Pierce – Drops ESPN SPT for OLD.

- **950 WXLW IN Indianapolis** Format to TLK "Freedom 95.9" // WFDM-FM-95.9, add networks TRN/DR/P/CM.
- 960 WHAK MI Rogers City Format to Rock/OLD "The Wave" // WHAK-FM-99.9.
- **970 WNED NY Buffalo** This NPR station is being purchased by the owners of WDCX-FM-99.5 "Life FM" REL station, which it will eventually relay. The new owners have reserved the callsign WDCX to use on 970 when the sale is complete.
 - WMPW VA Danville Slogan now "Country Legends 103-point-7."
- 990 KAYL IA Storm Lake Format to SS:AC "Juan AM 990."
- 1020 KDYK IA Union Gap Format to SS:AC "Juan AM 1020."
- 1040 WJNE NJ Flemington Now SS:SPT // WEPN-1050.
- **1050 WEPN** NY New York Now SS:SPT // WJNE-1040, no longer // WEPN-FM-98.7 which is where the former English-language ESPN format went.
- **1080 WYHY KY Cannonsburg** Add networks SRN/SMN.
- 1150 WLLI PA Huntingdon Slogan is "Hometown Radio Willy 1150."
- **1160** WCCS PA Homer City Drops ESPN for Fox Sports Radio (FSR).
- **1230 KBCR CO Steamboat Springs** Format to C&W "Big Country Radio" // KBCR-FM-96.9; add DG network.
 - KLVT TX Levelland Delete "High Plains Radio Network" slogan.
- 1240 KALY NM Los Ranchos de Albuquerque Format to OLD "Sound Souvenirs."
- **1300 WBOW IN Terre Haute** Slogan "News Talk 98.5"; networks DR/DG/Ru/P/CM/TRN/B. **WOSW NY Fulton** Drops Disney for C&W.
- 1310 KTWN MN Glencoe Add network: Li.
- 1320 WENN AL Birmingham Format to SPT (ESPN) "ESPN 97.3 the Zone."
 - WJAS PA Pittsburgh Add network: N.
- 1330 WRAA VA Luray Slogan to "The Valley's Hottest Country"; network drop C, add Fox.
- **1340 WWLF NY Auburn** Now just // WOLF-1490 (no longer // WOSW-1300). **KIJV SD Huron** Add // K237EL-95.3.

760 KKZN CO Thornton – 9/8 0359 – Good, very minimal QRM, with Leslie Marshall Show just ending, short feature "On Business with Brian Banmiller," legal ID including slogan "Colorado's Progressive Talk" into CBS news. The Double Kaz did just what it was designed to do, completely taking out WJR to the east and leaving KKZN in the clear! Long needed call change, ex-KRZN, and previously only heard during their DX test of 10/4/93. (BD-WI)

780 KCEG CO Fountain – 9/11 0114 – Music under WBBM OTR; nulling WBBM, it's the song "16 Tons," but not quite the bass resonance of the original Tennessee Ernie Ford; 0517 ID as "Songs You Remember, KCEG 780"; into brief banjo tune. It's the new Pueblo CO station as widely reported, but my first official log of it. NRC AM Log shows 720 watts at night, 24 hours. "The Ranch" with C&W, so that format has already changed. UnID, Tentative, Not Sure

- 9/11 0107 "Red Eye Radio" is starting, weak signal from E/W, so my first **770 UNID** suspect is KKOB-NM. Yes, it's the only affiliate on 770 (per web site http://redeveradioshow.com/sectional.asp?id=24651). But now the dilemma: here near the null of Albuquerque toward WABC, is it a remnant of the main 50 kW signal from the North Valley or the 230-watt non-directional night-only fill-in co-channel booster with no separate call sign in Santa Fe? I'll take the latter. This was about 13 seconds behind another Red Eye Radio (RER) on 760, i.e. WJR (also on KFMB San Diego, but not until 0700 UT; never heard here. See also 820 log.) BTW, the station list above has very handy link to the full program schedules of each station (if they have one!), showing Red Eye Radio is also on KKOB's substation KTBL 1050 in Albuquerque; why? Well, it starts at 11 pm local there, while KKOB doesn't start until midnight weekdays, according to the schedule dated August 13, 2012, O yeah? This is Tuesday and it *is* on 770 already at 11+ pm MDT. Or does this mean it's really some other 770 station not yet on their roster? KTBL stands for Talk-Business-Life featuring such wackos as Glenn Beck and Mike Huckabee elsewhere. (GH-OK)
- **820 WWBA FL Largo** 9/11 0119 Tentative; I notice another station with WBAP nulled, and it's also on "Red Eye Radio"(!) but about 5 seconds behind WBAP. NRC AM Log lists one other '`RER'` affiliate on 820, WWBA, which is 1 kW at night. Program website confirms it's the only other 820 affiliate. I was afraid I would have to click on every 820 state on the map to be sure, but pick a state such as Florida and the whole list appears, then easily searched. RER is the recently renamed trucker show, ex-'Midnight Radio Network,' and it originates at WBAP. **(GH-OK)**

SEP 19 0559 Weak music in WSB null, 0600 full ID for XHCSI 89.5 y XECSI 750, then choral national anthem. Not bad for 250 vs 50000 watts. [Hauser-OK]

CDI stands for Comisión Nacional para el Desarrollo de los Pueblos Indígenas; brief mañanitas tune and on to other talk rather than birthday greetings. SEP 15 1216 Mañanitas long version on and on, no doubt XETAR, as also heard a few minutes earlier in native language; now weak but mostly clear. Sunrise skip from northwest Mexico was below average today. Enid LSR 1214. [Hauser-OK]
- MEXICO XETC Torreón, Coah. SEP 8 1201 Slow timecheck for 6:58 = almost CDT, ID including FM 91.1, federal PSA for SCT (Secretaría de Comunicaciones y Transportes which includes equivalent of FCC), then full ID for 91.1 with 25,000 vatios, and 880 (sounded more like 800) with 10,000, street address in Torreón, Coahuila. Calls went by too fast to catch, so refer to Cantú: XETC Kiuu + FM 91.1 10,000 1,000. [Hauser-OK]

- **MEXICO** XEQD Chihuahua, Chih. SEP 13 1202 Chihuahua anthem, so it can only be this one per Cantú: XEQD *Romance* + FM 95.7 1,000 250. [Hauser-OK]
- **MEXICO** unID SEP 15 1205 Choral XE national anthem ends, but ID tough copy with ACI and CCI; mentioned W, and Exitos, I think, but W Radio affiliate list at www.wradio.com.mx includes nothing on this frequency. Per Cantú the only XE with a W in its call is XESW R.Madera, 5 kW daytimer. [Hauser-OK]
- MEXICO XEFQ Cananea, Son. SEP 8 1216 Promo an *IMER* program Saturday at 9 a.m. hora del centro [so inconveniently must subtract 2 hours in Sonorazona; Arizonora?], then local announcer with 18.7 degree temp on 8 September. Has to be the only *IMER* station on 980: XEFQ. SEP 15 1202 Temp and time "5:02 en Cananea, Sonora," refers to "radio pública" more than once, ID in passing as XEFQ. It's the *IMER* station whose formal name *La Voz de la Ciudad del Cobre* was not heard today. SEP 18 1202 News report on "digitalization" of *IMER* stations in Mexico City being completed, so this must be the *IMER* station again, XEFQ. [Hauser-OK]
- MEXICO XET Monterrey, NL SEP 8 1149 Local news including murder victim found in a remote area on La Loma, which is an antenna site, i.e. Monterrey NL, where Wiki says the local government's channel 28 is located. Temp is 27 already; i.e. XET. Not to be confused with the Cerro de la Silla, Monterrey's major landmark. Hearing Spanish on 990, one must be careful to distinguish XET from KFCD in The Metroplex, which dominates after Enid sunrise, 1209 UTC today before which it was only 14 here, refreshingly cool. [Hauser-OK]
- MEXICO XEFV Cd. Juárez, Chih. SEP 18 1204 National anthem ending and Cd. Juárez mentioned, making slow SAH with KTOK, nulled as best I could. So it's the usual XE SRS occupant XEFV. SEP 19 0559 KTOK is conveniently in dead air, allowing clear "La Rancherita" slogan to be heard especially when nulled, before KTOK remodulates just prior to 0600. [Hauser-OK]
- MEXICO XEHES Chihuahua, Chih. SEP 12 1202 Choral national anthem, so I stand by for full ID/sign-on at 1204, but fading and only fragments caught 5-letter call, "para todo el estado de Chihuahua," 5 mil watts, also 95+ FM. Almost matches Cantú listing: XEHES *Romántica* + FM 94.1 Chihuahua, Chih. 5,000 250. [Hauser-OK]
- **MEXICO** XEGYS Guaymas, Son. SEP 17 1223 Music, poor signal, "90.1, la número uno." Cantú shows XEGYS *La Primera* + FM 90.1 5,000 250. [Hauser-OK]
- MEXICO XED Mexicali, BCN SEP 9 1217 Promo for a fútbol show lunes a las 2 de la tarde "aquí en la radio de tu California," and XED mentioned a bit later, i.e. Mexicali BCN. Cantú lists as a 10 kW daytimer (same as XEBCS in La Paz), but IRCA has XED at 10/1 kW, 24 hours, and WRTH 2012 shows it as 10 kW fulltime. Which of these three is correct? [Hauser-OK]
- **MEXICO** XEEP México, DF SEP 17 0504 World news in Spanish, looping N/S with dominant signal, including clips of PBXVI in French from Lebanon at 0507; and later somebody in English soon voice-overed; 0513 *R.Francia Internacional* ID in passing. At least on weekdays, *R.Educación* has long relayed news from RFI at local midnight = 0500 UT, when it used to be simulcast on SW. (Likely recorded several hours earlier as RFI is not known to have any Spanish broadcast itself at 0500.) [Hauser-OK]
- **CUBA** *R.Angulo*, Holguín SEP 14 0400 Under WBT; presumed with choral national anthem, the only Cuban listed on this frequency. [Conti-NH]
- **MEXICO** XENAS Navojoa, Son. SEP 20 1155 DJ in Spanish, northeast/southwest; 1157 fades down just in time for SHVA full ID at 1200 with phone numbers; 1210 I catch DJ with a 5:10 timecheck, so it's in the UT-7 zone. Since the Arizonan is not Spanish, that leaves only this in Cantú: XENAS *Unica* + FM 95.5 1,000 500. [Hauser-OK]
- **CUBA** *R.Rebelde*, multiple sites SEP 14 0300 Over WRVA and *R.Surco*; sounder and titulares news. [Conti-NH]
- **CUBA** *R.Bayamo*, Bueycito SEP 15 0400 Through WWDJ and CKOC; signature theme music and doorbell chimes. [Conti-NH]
- **BERMUDA** VSB2 Hamilton SEP 10 2329 Bible Broadcasting Network ID; over others. [Connelly*O-MA]

- MEXICO XEP Cd. Juárez, Chih. SEP 18 1217 Enid LSR today, Radio México Noticias, from Ciudad Juárez, also greeting listeners en El Paso, Las Cruces, Univérsity Park, but not Enid. XEP has no problem overriding Tulsa around LSR, more so than other 1220+ stations, with its odd 38 kW daypower, vs 200 watts at night, but I wonder about its direxionality if any. Maybe the pending new NRC Pattern Book will show it. [Hauser-OK]
- MEXICO XERF Cd. Acuña, Coah. SEP 18 1219 Glowing report on IMER digitalization of its 9 stations in the DF having been completed, lauded even by Pres. Calderón himself's soundbite (pato cojo hasta el 30 de noviembre). Must be continuation of report started earlier on 980 XEFQ, q.v. They enumerated 94.5, 105.7 and 107.9 but did not hear any other FMs or AMs mentioned specifically. IMER website www.imer.com.mx shows only 7 stations in the DF, the others being 660, 710, 1220, 1350, so these are presumably now IBOC too; the "digital" system not specified, but AFAIK, DRM lost the battle, and IBOC is already running on a few commercial border stations (FM only?). Previous news was that all IMER stations nationwide would be digital by yearend. This program is from the "Sistema Nacional de Noticias" (a.k.a. Antena Radio?). 1570 soon losing out to another Spanish at 1222, ESPN. [Hauser-OK]

- 1620 **CUBA** unID SEP 15 0359 Under *R.Rebelde*, choral national a minute ahead of *R.Rebelde* anthem. [Conti-NH]
- 1620 **U.S. VIRGIN ISLANDS** WDHP Frederiksted SEP 11 0000 Caribbean-accent man with WDHP ID and studio mailing address; popped up over Cuba. [Connelly*O-MA]

INDIA: While many stations are closing down MW and SW stations, *All India Radio* (AIR) commissioned its new 1000 kW MW transmitter at Rajkot on Sept 10.
