WAUK WI Jackson – 3/3 1512 – NBA on ESPN sports talk, "5-40 ESPN" slogans and a Wisconsin Honda ad. Barely on top with CBEF gone. Last logged as WRRD. It looks like they're going to be the predominant one during the day here with CBEF gone. (HF-MI)

CBGA1 QC Grande Anse – 3/4 1731 – Presumed (CBEF-Windsor now gone from 540) with male host in FF, news feature segments including phone interviews; jazzy music bumpers between segments. Many mentions of Quebec throughout. Into presumed news at ToH. **(HF-MI)**

560 WFIL PA Philadelphia – 3/4 2040 – Talk about prayer and relationships, slowly lost under WGAN and CFOS. **(TF-NH)**

640 CFMJ ON Richmond Hill – 3/4 2055 – Weak signal with ads for car dealer and realtor mentioning Toronto's 416 area code, "AM-640" slogan, then "AM-640, time to talk about it", lost briefly at 2100, quickly back with "AM-640 News", and female announcer giving "AM 640 Toronto Radio" non-ID. Interesting catch as the 50,000 watt signal from the station's eight towers in Granby, ON is tightly directional toward the North Pole. Back in the day when they were CFGM, a

C&W station on 1320, they operated out of a storefront studio on Yonge Street in the northern Toronto suburb of Richmond Hill. The signal was broadcast from a long gone 13-tower antenna system in Mississauga. (TF-NH) Since losing the Toronto Maple Leafs broadcast rights (flagship now shared between CHUM-1050 and CJCL-590), CFMJ is virtually irrelevant in the Toronto market. Mike

- 1179 **CUBA** *R.Rebelde*, unknown site MAR 3 0712 Off-frequency making a het against 1180s. Again I check the nulls and conclude it's from the northwest/southeast, not the northeast/southwest. My previous log of this happened to be when Spain was inbooming to New York on 1179, and Conti thought I was getting it too, along with 1521 from Spain, not Saudi Arabia. But my 1179 is definitely not from Europe's direxion, and most likely one of the multiple Rebelde Cubans straying. [Hauser-OK] MAR 9 1000 Het against 1180 *R.Rebelde* and WHAM, measured 1179.000 kHz; presumed an off-frequency *R.Rebelde* per Hauser/*DXLD* logs. [Conti-NH]

NOAA Space Weather Outlook

Issued March 11 – For the period March 11-April 6, 2013

Solar activity is likely to be low through the period. A slight chance for M-class activity exists through 16 March while Region 1689 remains on the disk, and again from 21 March - 03 April with the return of old Region 1686 (S12, L=263).

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at normal to moderate levels through 28 March. Moderate to high levels are possible from 29 March - 04 April with the return of a recurrent coronal hole high speed stream (CH HSS). Normal to moderate levels are expected for the remainder of the period.

Geomagnetic field activity is expected to be predominately quiet to unsettled. Active periods are possible on 28 March due to CH HSS effects.
