# AM Switch

After a lot of talk over the last few years, FCC Acting Chairwoman Mignon Clyburn announced

in a speech to the National Association of Broadcasters 2013 Radio Show in Orlando on September 18 that she has circulated a Notice of Proposed Rulemaking aimed at the renewal of AM broadcasting. Although the notice itself doesn't seem to have been published by the FCC yet, the



notice contains the following six proposals, according to Chairwoman Clyburn's speech:

"One, opening a one-time filing window, limited to current AM licensees and permittees, which will allow each to apply for one new FM translator station to fill in its service area.

"Two, relaxing the AM daytime community coverage rule to allow existing AM broadcasters more flexibility to propose antenna site changes.

"Three, and similar to the second proposal, relaxing the AM nighttime community coverage standards, which will also provide broadcasters, who may have difficulty finding suitable sites, relief for towers and directional arrays.

"Four, eliminating the AM "ratchet rule," which requires an AM station to "ratchet back" its nighttime signal to reduce interference to certain other AM stations. The rule, while intended to reduce nighttime AM interference, has instead discouraged service improvements and has apparently resulted in a net loss of interference-free AM, nighttime service.

"Five, permitting wider implementation of Modulation Dependent Carrier Level, or 'MDCL' control technologies, which allow broadcasters to reduce power consumption. We propose to allow AM stations to implement MDCL operation by simply notifying the Commission, rather than having to seek experimental authorization or waiver.

"And six, modifying AM antenna efficiency standards by reducing minimum effective field strength values by approximately 25 percent, thus allowing the use of shorter AM antennas."

FCC Commissioner Ajit Pai, who has been making something of a name for himself as a champion of revitalizing AM radio, issued this statement:

"I applaud Chairwoman Mignon Clyburn for circulating a Notice of Proposed Rulemaking aimed at revitalizing AM radio. The item outlines many promising ideas for improving the service offered by AM broadcasters and reducing the regulatory burdens placed on AM stations.

"AM radio is older than the Federal Communications Commission. It has been an integral part of American culture for decades. But the AM band faces many challenges today, which is why I proposed one year ago tomorrow that the FCC launch an initiative to revitalize it. Since then, I've heard from AM broadcasters and listeners all across the country asking the FCC to take action. Today, thanks to Chairwoman Clyburn's leadership, we have taken the first step in responding to their voices."

We'll let you know when the FCC actually publishes the proposal in the <u>Federal Register</u>, as well as how to submit comments for FCC consideration. (Check the FCC web site at <u>www.fcc.gov</u>, or <u>www.federalregister.gov</u> for the official published version.) Comments can be on the proposals in the FCC's notice, or can suggest alternative approaches.

In other FCC news, applications for new low-power FM stations are being accepted from community and non-profit organizations during the window of October 15-29, 2013. There hasn't been a window for new AM station applications since 2004, and the FCC is still sorting through some of the more complex situations where multiple, mutually inconsistent applications were filed in 2004, so don't expect a new AM window any time soon.

For those who use the online FCC database – The listing for KHPY-1670 Moreno Valley CA was changed this week from U4 10000/9000 to U1 10000/9000, but this is in error – the actual license (which can be found on the web site with some digging) still says U4. (Did I mention that you need to get that 34th Edition of the NRC *AM Radio Log*, as updated weekly in *DX News*, if you want the most accurate and up-to-date information on U.S. and Canadian AM stations?)

### **SPECIAL TEMPORARY AUTHORITY (STA)**

**580 KMJ CA Fresno** – Granted STA to operate U1 5000/5000 from its old (i.e., 1941-2002) transmitter site during repairs at the new site.

960 WHYL PA Carlisle – Nothing at the FCC web site, but Dave Schmidt reports station is operating with U3 22/22 (night power all the time).

1010 KSIR CO Brush – Transmitter site was completely flooded on 9/16 during the historic Colorado flooding and is presumed a complete loss; applies for STA to broadcast via two FM translators (K223BV-92.5 Atwood CO, ordinarily // KTAD-89.9, and K280EQ-93.1 Fort Morgan CO).

**1460 WPON MI Walled Lake** – Granted STA for D1 25/ (that's right!) from a 25-foot temporary mast at 42-32-40/83-33-35, so the silent station won't lose its license before it completes its CP to move a new permanent site.

1470 KDEB CO Estes Park – Granted STA for D1 30/ from a temporary longwire, so the silent station won't lose its license – it has lost its tower location and hasn't found a new one yet.

**1560 WMBH MO Joplin** – Granted STA from a temporary longwire antenna, 133 feet long and 18 feet high, at a different site (37-05-37/94-34-51); application says power will be 500 watts fulltime, yet the station is licensed for only U1 250/9 – why?

Applications to extend existing STAs were <u>received</u> from WXQW-660 Fairhope AL (pattern out of tolerance or reduced power); WDMC-920 Melbourne FL (U1 1250/250); KSDN-930 Aberdeen SD

(U1 1250/250); KCKN-1020 Roswell NM (U4? 1000/1000 from auxiliary transmitter); WLNO-1060 New Orleans LA (U1 5000/1250, Hurricane Isaac 2012 damage); WENY-1230 Elmira NY (reduced power); WALO-1240 Humacao PR (U1 1000/5000 to overcome QRM from station in Barahona, Dom. Rep.); WFNS-1350 Blackshear GA (reduced power); WRSS-1410 San Sebastian PR (U1 250/250); WKHZ-1460 Easton MD (day pattern out of tolerance); and KBLA-1580 Santa Monica CA (U1 12500/12500 while KYPA-1230 is relocated to diplex with KBLA, but that relocation seems complete).

**540 WKFN TN Clarksville** – 9/7 2134 – Good in KWMT null with Austin Peay Univ. FB vs. Vanderbilt. Nice to get this one at last, now chasing after WFLF and WDAK. **(RD-NE)** 

**CA** Los Angeles – 9/2 0822 – "KFI, stimulating talk radio," PDT TC after 5 am, making slow SAH less than 1 Hz with KWPN OK, so KFI is still audible with it nulled well after sunrise 1204 UT here today. A bit surprised to hear this as there were no other significant skywave signals below 920 by this time, and no XEs at all on the lower half. **(GH-OK)** 

**650 WSM** TN Nashville – 9/11 0116 – Very good with Johnny Cash's 1959 single "Frankie's Man, Johnny," then chatter by DJ Marcia Campbell during her all-night program. (RD-MO1)

690 KFXN MN Minneapolis – 9/16 2136 – Good on peaks in CKGM null with what sounded like Vietnamese music. Took comparing it to the webstream for me to be able to count it. WQNO in New Orleans (whose night pattern must be out of whack) took over shortly thereafter. (RD-IA)

**690 CBKF-1 SK Gravelbourg** – 8/30 0139 – Québecois interview stands out in the mix of other signals with KGGF KS open carrier. First thought is CBF Montréal, but that's long gone, its replacement anglais. Loops NNW anyway, so this has to be CBKF-1, Gravelbourg, Saskatchewan, the CBC = SRC Première Chaîne outlet which NRC Pattern Book 2005 shows with a minor night lobe in this direction, otherwise mostly northward. A predominantly French town? Supposed to serve also Swift Current, Moose Jaw, even Regina? Hearing any French on 690 is certainly a rarity here. **(GH-OK)** 

740 KVOX ND Fargo – 9/16 2329 – Fair in CFZM null with Minnesota Twins BB, which normally airs on sister station KFGO-790. (RD-IA)

830 WFNO LA Norco – 9/4 0202 – "La Caliente 830" ID by super-hype voice actor (SHVA); no legal ID heard in break from non-soporific Mexican music. Per Wikipedia, "On March 11, 2013, WFNO changed moniker to 'La Caliente 830am'." WFNO is rather regular with WCCO nulled. Don't you believe their 750-watt night pattern is supposed to be a circle tangent to the SSE with the null toward me to

- the NNW (And you'd think there would be a nominal notch north toward WCCO). **(GH-OK)**
- **860 CBKF-2 SK Saskatoon** 9/8 2331 Good in CJBC null with its own FF program, "Sphere," running about 4 sec. ahead of the webstream. **(RD-NE)**
- 880 WMDB TN Nashville 9/9 0808 With KRVN N/S nulled, all I hear is "La Ranchera" slogan. I was about to file this as unidentified till I googled La Ranchera 880 and found story on allaccess.com that WMDB "has tweaked its brand from 'El Sol 880' to 'La Ranchera'." FCC AM Query shows 2.5 kW day, TWO WATTS night, pace WCBS, always non-directional. September SR/SS: 0730/2000 ELT. Also has PSRA protecting WCBS (and/or CMAB!) of 47 watts in Apr/Sep/Oct; 2 to 10 watts other months except Feb with a hefty 500; and N/A May-Aug. (GH-OK)
- 920 KBAD NV Las Vegas 9/2 0817 "... right here on 920, The Game," ads with 702-AC phones. Good thing I got the latter, as 2012 NRC AM Log shows no slogan for KBAD, but it was/is sports format with Fox SR, 5/0.5 kW. Neat, as Nevadans are rare here; city-to-city distance 953 miles. A few minutes later I was still getting KFI 640 LA CA before low-band skywave fadeout, which lasts a bit longer mid-band. Later in the hour, KYFR in IA resumed dominating 920 here, although it could have earlier, with September sunrise at 0800 ELT. It's easy to spot with religion and lots of quasi-classical sacred music. (GH-OK)
- **920 KVEL UT Vernal** 9/6 2253 Fair in KYFR null with Roosevelt Union vs. Uintah HS football. **(RD-NE)**
- **920 CFRY MB Portage la Prairie** 8/24 0048 Fair in KYFR null with ID: "You're listening to CFRY...," then into Glen Campbell's "Bonaparte's Retreat." Not heard from any QTH since the DX test on 1/30/1995. **(RD-NE)**
- **970 KQAQ MN Austin** 8/14 2306 Finally heard at the Iowa City QTH after all those times of going after it during the 1990s proved to be fruitless. Fair under WGTK with fragments of an ID: "...southern Minnesota's...radio, 970 KQAQ." (**RD-IA**)
- **1010 WMIN** MN Sauk Rapids 9/16 2059 Good with Jack Jones' 1963 hit "Wives and Lovers," then ID: "Uptown 10-10, WMIN, Sauk Rapids." (RD-IA)
- 1070 KNX CA Los Angeles 8/31 0819 Remains barely audible after sunrise with KLIO Wichita nulled, already promoting a 2-hour show on Thursday, October 3, "Health Care Uncovered" on how to get involved in the Affordable Care Act. (GH-OK)
- 1190 KQQZ MO De Soto 9/11 2210 C&W music, in/out with call ID heard on fade-in. (JR-OK)
- **1220 KDOW CA Palo Alto** 8/13 0747 Bloomfield Report and other biz features; ID at 0758: "We're watching the economy because it's your money; the Bay Area's Business Radio AM 1220 KDOW," followed by another station promo and ID; faded near ToH so no legal ID heard; local KLDC came on at 0801, covering the frequency. A needed call change here, ex-KNTS. **(JW-CO)**
- **1220 KMVL TX Madisonville** 9/11 2145 Nostalgia music, call ID and sports news. The carrier was at 1219.825 KHz. (JR-OK)
- **1240 KWAK AR Stuttgart** 9/10 2140 Call ID with oldies. Good signal on graveyard frequency. **(JR-OK)**
- **1240 KWLC IA Decorah** 9/6 2339 Atop with Johnny Cash's "Sam Hall," then chatter by college-age female DJ. Webstream was about 30 sec. behind. **(RD-NE)**



Would expect this to be KLRG in Arkansas, but unclear why they would mention that station with no direct connection. Perhaps a syndicated program also on it. (GH-OK)

960 UNID -- 8/30 0101-0105 – During Fox-hole of local KGWA running open carrier only, this time on the SRF-59 I am able to hear \*without\* nulling KGWA, a station with sports news and scores in English; bearing on it is NNW/SSE. Unknown which network but all-American so can't be CFAC Calgary which I have DXed before in this window thru KGWA. Now the guessing begins. Based on last year's NRC AM Log with format info, most likely is KOVO Provo UT with FSR, and which the old Pattern Book shows with a minor lobe this way. But it's more NW than NNW. Another one I have yet to ID is KROF in Abbeville LA (Lafayette market), listed as talk format if not sports, 95 watts non-directional. KNEB Scottsbluff NE direction also fits with 350 watts, but supposedly C&W format. I can hardly wait to recheck these formats in the new NRC AM Log. (GH-OK)

- MEXICO XEPL *La Super Estación*, Cd. Cuauhtémoc, Chih. SEP 11 1212 Mexican music, losing out to KFRM by 1214. No doubt the only northwest Mexican, XEPL. That's one with some Low German, but no announcements heard today. SEP 19 1203 Choral national anthem finishes, full ID for XEPL on 91.3 and 550, 24 hours, "La Súper Estación"; 1204 consumer program called 'Radio Express'. [Hauser-OK]
- MEXICO XEXZ Zacatecas, Zac. SEP 8 1151 After song lyrix "alma de niña, cuerpo de diosa," ID mentions 93-3, so the only match there in Cantú is XEXZ *Lupe* + FM 93.3. [Hauser-OK]
- MEXICO XEBJB Monterrey, NL SEP 8 0520 Mexican music is dominating, southwest-ish, then PAN ad, next break 0524 a promo for Monterrey Televisión, so it's XEBJB, supposedly 500 watts night per 2013 WRTH and 2012 IRCA Mexican Log. SEP 12 1142 PSA string, mostly federales, "escucha Noti-Radio 570," sounder, then mentions Monterrey, so as expected it's XEBJB, a.k.a. just "Radio 570" en Cantú, IRCA and WRTH; and a departure from the norteña/ranchera format as in IRCA Log. Also produces a low rumbling het, as it's slightly off-frequency to the hi side. Often it's just the het bothering other stations such as KSNM which I had suspected of being the culprit. It's not unusual for mostly musical XE stations to include a morning news block and this may be one of them. [Hauser-OK]
- 590 **CUBA** *R.Musical Nacional,* Santa Clara SEP 10 0500 Over/under WEZE and CJCL; classical music through the hour, parallel 1140 kHz. [Conti-NH]
- 610 **MEXICO** XEGS Guasave, Sin. SEP 10 0548 Promo for 106.1 FM, maybe "La GS," what a nice FM/AM match, as in Cantú XEGS *La Ley* + FM 106.1. [Hauser-OK]
- MEXICO XEBU *La Norteñita*, Chihuahua, Chih. SEP 9 1205 Mexican national anthem goes to Chihuahua state anthem, so as expected, XEBU, dominant XE on 620 here. Tho this time it's under sports talk in English, surely KTAR Phœnix; my nearest 620, KMIK *R.Disney*, Plano (hijacked from KWFT Wichita Falls), is easily overcome, tho on daytime groundwave it conspires with 640 Moore to inundate 630 with IBOC noise; otherwise Denver or St. Louis might barely make it. [Hauser-OK]
- 660 **MEXICO** XEACB *La Lupe*, Cd. Delicias, Chih. SEP 10 1207 Some Mexican is playing "Mañanitas"; 1209 time check for "6:07 en La Lupe." [Hauser-OK]
- MEXICO XETOR *R.Ranchito*, Torreón, Coah. SEP 9 1201 Just as I start SRS MW session, ID as "Radio Ranchito, del Grupo Radio México." This signal quite weak compared to many more XEs still skywaving in the low band from further west. SEP 12 1159 Grupo Radio México has job openings, qualifications specified, then full ID for *R.Ranchito*, street address, etc., Torreón, con mil vatios. SEP 19 1201 Full ID atop the channel but never very strong. [Hauser-OK]
- MEXICO XEORO Guasave, Sin. SEP 11 1210 Local wakeup host with saludos a pescadores, ganadores (fishers, cattle-raisers), mentions Guasave, norte de Sinaloa, so it's XEORO, 1/0.5 kW per Cantú. 1212 promo a Saturday show at 11:30-1; 1215 losing to sports talk in English, presumably KNBR. [Hauser-OK]
- SEP 10 1141 Just a hummy carrier, and still so at 1210; loops 700 **MEXICO** unID southwest/northeast. Suspect Mexico; XEGD Chihuahua would fit for that. Previously logged XEETCH further northwest in Sonora with real modulation. SEP 11 1200 - Before 1200 UTC I am again hearing that open carrier with a hum, while several northwest Mexicans are still propagating in the 600s and 700s. SEP 12 1145 - Woman and man with news in Spanish from datelines all over the country, loops southwest (discounting northeast). Suspect same station as I have been hearing recently with nothing but hum, likely XEGD but can't completely rule out XEDKR. Retune 1201 UTC, probably same station and now Jalisco is less likely, almanac for 12 de setiembre including: something about Katharine Hepburn with a movie clip in English; 1953 Stalin to Khrushchev; 1989 Luna-2 launched; 1989 Germany algo; 1998 peace in N Ireland; 2010 Chile miners rescued; 1204 UTC "Noticias MVS" acknowledging Canal 5 and 97.3 FM. This however originates with 102.5 XHMVS in the DF. I also logged MVS news April 25 but couldn't find an affiliate on 700; see DXLD 13-18. [Hauser-OK]
- 710 **MEXICO** XEDP Cuauhtémoc, Chih. SEP 11 1210 Discussion of August (or Sept?) 4+ Richter earthquakes near Parral and Jiménez (short versions of town names), no doubt usual XEDP. [Hauser-OK]
- 720 **MEXICO** XEDE Saltillo, Coah. SEP 12 1150 "La Kaliente" slogan with 105.7, i.e. this by itself now, but which all evening is the SAH nemesis of WGN, per Cantú XEDE *La Kaliente* + FM 105.7. [Hauser-OK]

- MEXICO XEAVR *R.Fórmula*, Veracruz, Ver. SEP 19 1144 Mentions Grupo Fórmula, SEP PSA, ad for ranchera CD to celebrate independence, 1146 a *R.Fórmula* full ID but too much interference; includes an FM frequency with an 8 in it and 720 AM. Therefore per Cantú it can only be this one, sunrise now late enough for the east coast still to be propagating: XEAVR *R.Fórmula 1er Cadena* + FM 89.1. [Hauser-OK]
- MEXICO XEWGR *Exa FM*, Monclova, Coah. SEP 14 0502 Coahuila state anthem is playing, roughly opposite direxion from WBBM which could not be nulled, but enough signal by comparison, unlike at 0505 when WBBM is starting 'When Radio Was' with music theme. Therefore, it's XEWGR, the only Coahuilense on 780, 5/0.25 kW, 24 hours per IRCA Mexican Log. KSPI has been behaving itself lately without open carrier all night, tho it would be nullable. [Hauser-OK]
- 800 **MEXICO** XEROK Cd. Juárez, Chih. SEP 15 1149 Big slow SAH between XEROK and KQCV, 50 per minute equals 5/6 of one Hz separation. [Hauser-OK]
- 850 **CUBA** *R.Reloj,* Nueva Gerona SEP 10 0501 Under WEEI and WFTL; RR Morse code. [Conti-NH]
- MEXICO XEM Chihhuahua, Chih. SEP 14 0503 Classic rock in English, so it must be a Mexican: yes, 0505 ID as *Milenio Radio* and another tune in English. KOA nulled but hardly necessary. [Hauser-OK]
- MEXICO XETAR Chihuahua, Chih. SEP 8 1206 Talk in Indian language, but pronounces XETAR in Spanish; soon live DJ back in Spanish mentions La Voz de la Sierra Tarahumara, which is in Guachochi, Chihuahua. SEP 10 1213 Obviously XETAR playing a "Mañanitas" version by Chipmunks (doublepitch voices), hee hee, including English "happy birthday to you" twice or thrice. So there's another exotic language on this indigenoustation. [Hauser-OK]
- MEXICO XEV Chihuahua, Chih. SEP 17 1158 "Grupo Fórmula" promo, slow SAH with KRVN. Ergo it's XEV; by 1200 losing out to a cappella hymn, probably KLRG Arkansas. [Hauser-OK]
- MEXICO unID SEP 10 1215 "La Rancherita de..." slogan, CST time check for 6:14, young woman DJ, then 6:15 time check and federal PSA for reforma educativa, so no doubt it's a Mexican. Zone means it has to be a change for one of these two in Cantú: XEV *R.Fórmula*, or XEPNK *Planeta*. The "Rancherita" in Los Mochis is listed as 1450, XECU which might have swapped; however, Cantú has no Chihuahua-city AM or FM stations by that name, so it's a market ripe for its own Rancherita. At this time there was not much KRVN from north but nulled it anyway. Not to be confused with mere non-diminutive "La Ranchera" newish identity of WMDB Nashville as heard yesterday a few minutes earlier. One is relying on neither station ever varying its slogan. [Hauser-OK]
- CUBA *R.Progreso*, Chambas SEP 13 0515 Spanish discussion of cathedrals and their addresses in Habana; DF also fits for Cuba. 2013 WRTH shows 200 kW *R.Progreso* and one low-power elsewhere on 890; 200 kW, the highest MW power now listed for Cuba, also applies to one of the numerous Rebelde transmitters on 710 at same site, and another site on 1180. This 890 does not have the punch would expect from all those kW. Not much signal from WLS at the moment, and the co-channel interference in Spanish is normally from gospel-huxter KVOZ, thought to be failing to protect WLS at night and even running day power of 10 kW ND at night instead of 1 kW direxional. Worse, it's almost opposite here from Chicago, making it hard to null in favor of WLS. *R.Progreso* soon fades and later KVOZ is back. [Hauser-OK]
- 900 **MEXICO** XEOK Monterrey, NL SEP 16 1142 Two men are chatting and laughing, good dominant signal, XEW? Switch to reporter about crimes/accidents in the Estado de México, and an item about buses. This is Independence Day, so likely to be programming disruptions, more stations relaying output from the DF than usual, as heard on several other frequencies from other sources. Promo for "Siempre en 88.9," 1146 adstring. Of the six 900s in Cantú, five have other FM frequencies, no 88.9s, and one without. But in the FM list, that slogan chex out as XHM *Siempre 88.9* México, DF, which I got on FM DX years ago when it had some other identity. So which station on 900 would be mentioning it more than once? The DF lineup shows XHM is in the Grupo Acir, so the 900 would unlikely be XEW. Which 900s are in Grupo Acir? 2012 IRCA Log shows the only one is XEOK Monterrey, 10/0.25 kW, which is certainly likely now on day power. [Hauser-OK]
- MEXICO unID SEP 19 1206 Choral national anthem running late or a very long version, loops southwest, 1207 full ID mentions Cuauhtémoc, 98.3, maybe ACIR Radio group, and maybe "Radio Impacto." Cantú has another but related slogan: XEDT *Hits FM* + FM 98.3. Googling XEDT leads to yet other names, possibly outdated: *R.Divertida*, and *La Reina*. However, not on the ACIR station list nor any other in that city. [Hauser-OK]

- 910 **CUBA** *R.Cadena Agramonte*, Camagüey SEP 10 0800 Fair; ascending notes marking the hour, canned ID, "Desde la cuna de el mayor transmite Radio Cadena Agramonte, Camagüey, Cuba." [Conti-NH]
- 920 **MEXICO** unID SEP 17 1201 Instrumental national anthem, nonetheless multi-verse, and losing out to interference before any ID. Which XEs are in the UTC-6 zone, likely 6 a.m. time to be antheming? One of these two per Cantú: XEQD *Romance* + FM 95.7 or XECQ *La Nueva Ranchera* + FM 104.1. [Hauser-OK]
- 980 **MEXICO** XEDCH *La Romántica*, Cd. Delicias, Chih. SEP 19 1209 Choral national anthem ends, either late or very very long version, long pause, and 1210 announcement does not seem like full ID but unreadable. Yet assuming it's in the UTC-6 zone, playing anthem around 6 a.m. local, Cantú shows only XEDCH. [Hauser-OK]
- MEXICO XEFV Cd. Juárez, Chih. SEP 6 0600 Choral national anthem playing here too, and it too is over by 0602 retune when back to other music; at times dominating KTOK, and from experience I know this one is XEFV, no daytimer despite Cantú as such; altho there are another Chihuahuan and two Sinaloans also in UTC-6. [Hauser-OK]
- MEXICO unID SEP 6 0600 Choral national anthem, with co-channel interference and SAH, already over at 0602 retune and may have missed an ID. I was hoping there would be only one XE in the UTC-6 zone since anthem habitually plays at local midnite (except UTC Mondays when it may accompany earlier 'La Hora Nacional' instead), but IRCA and Cantú show there are two: XEYC Cd. Juárez, and XEMPM Los Mochis. [Hauser-OK]
- 1060 **MEXICO** XEEP *R.Educación*, México DF SEP 10 0500 Over/under KYW and presumed *Radio 26*; choral national anthem. [Conti-NH]
- 1110 **CUBA** *R.Angulo*, Holguín SEP 8 0600 Over/under WBT; announcement of telephone numbers including 424975 which matches numbers for *R.Angulo* reported by Gert Nilsson and "Onda Cero" program per Henrik Klemetz. Thanks to Andrew Brade at *RealDX*. [Conti-NH]
- MEXICO unID SEP 8 1218 Pause in music for nothing but a 6:17 time check in Spanish, with north/south Omaha nulled, but avoiding IBOC noise from east/west 1170 KFAQ Tulsa only by off-tuning to 1178 or 1179. In Cantú there are two in the UTC-6 zone: XEUBS *Radio UABCS*, and XEJK *Ke Buena*. Likely the latter as it unseemed non-commercial. Soon faded out. [Hauser-OK]
- unID SEP 17 1207 Spanish with language lesson about words: colateral; "protagónico" does not exist despite related words protagonista, etc. 1208 on to Mexican news about tormentas tropicales hitting both coasts with clips of various officials; 40,000 turistas affected in Acapulco; 1215 losing out to co-channel interference. Certainly sounds like a Mexican, but some U.S. stations do too; loops close to east/west indicating one of these unlikely XEs: XEMBC Canal 1190 AM or XEPZ R.Norteña. Another possibility is the one U.S. Spanish station westward: KNUV Grupo Fórmula, La Radio Excelente. [Hauser-OK]
- MEXICO XECF *La Mexicana*, Los Mochis, Sin. SEP 17 1217 Spanish ad in pesos, SAH of about 5.5 Hz with probably Wichita, loops WSW/ENE; ad for Universidad del Pacífico Norte with phone number, two or three gobierno del estado PSAs, mentioning Sinaloa, "información al momento" by calling phone number. Then lists several AM and FM stations including 1270, 102.7, 94.3, 101.3, 93.3, 1410, including Mazatlán, Los Mochis, on "cadena en vivo," so doubtless it's the only 1410 Sinaloan. [Hauser-OK]
- MEXICO unID SEP 16 1158 KOKC has heavy interference making a fast SAH in Spanish, talking about el Dia de la Independencia, 1159 woman wrapping up her show. Too much KOKC interference to catch any ID as KOKC goes from WSJ to CBS World News Roundup at 1200. Can't null out one or the other, but by proximity likely one of these: XEVUC *La Norteñita*, or XEYP *Imagen*. Not the first time I have had such an unID; unlikely to be a U.S. station as none in the area, nor listed as Spanish even in Texas. [Hauser-OK]
- MEXICO XEVT Villahermosa, Tab. SEP 11 1131 Man and man (instead of usual woman and man) with news in Spanish vs noise level, and those annoying on-and-off local bursts every few minutes at 1134 and 1137; 1135 a bit stronger with 6:35 timecheck; 1138 mentions industria petrolera; 1139 peak with a string of addresses mentioning Villahermosa. 3 x 970 XEVT Tabasco is indeed still here for another season. Thanks to VL8T staying on 4910, now it's easy to home in on 2910 which is 2 MHz lower on the FRG-7. [Hauser-OK]

Hauser tuning Japanese: 747 & 774 kHz, JBA carriers from the northwest, Sept 11 at 1149, no doubt the NHK powerhouses for the first time this season; also 828 at 1154 UTC. Meanwhile, quickly stepping thru the MW band on up to 1220 on 9 kHz spacings with off-tuned BFO to detect carriers, also found some on 1134 and 1152 kHz. I had been looking for the NHKs several mornings, but maybe too early or too late. This is also prime time for 90 and 60m DX from PNG and Indonesia!

Not to mention lots of Mexicans on 10-kHz spacings. Neighbor Richard N. Allen out of Perry OK with a better antenna has also been hearing the NHKs for a few days shortly before our sunrises, currently in Enid 1211 UTC. Sept 12 at 1151 UTC, JBA NW carriers doubtless from the 500 kW NHK-2 outlets, 747 JOIB Sapporo, and 774 JOUB Akita. TP carrier search Sept 15 at 1141-1145 UT finds some JBAs on 747, 774, 828, 972, 1053. I really have no doubt that the first three are NHK Japan, and little doubt that the other two are South Korea. Sept 16 at 1149 UT: JBAs on 738, 747, 774, 972, 1053, i.e. likely respectively: Tahiti, Japan, Japan, South Korea, South Korea. Sept 17 at 1150 UT: JBAs on 774, 972; after finding 120, 105, 90 and 60m quite unproductive with only JBAs there. 774 and 972 were also the only two neighbor Richard Allen was hearing today over a longer timespan.





### NOAA Space Weather Outlook Issued September 16 – For the period September 16-October 12, 2013


Solar activity is expected to be at very low to low levels through the outlook period.

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at high levels 19 -

23 September and 29 September -07 October. Flux levels are expected to be at normal to moderate levels the remainder of the outlook period.

Geomagnetic field activity is expected predominately at quiet levels. CH HSS effects are expected on 16 - 18 September, 22 September, 26 - 28 September and 10 - 11 October where quiet to unsettled levels with isolated active periods are expected.
