Construction permits expired and cancelled:

1430 KCWK NV Laughlin – CP for new station expires 9/28 and is deleted.

1490 KBZB TX Alpine – CP for new station expired 10/6 and is deleted.

The expiration date of the CP for KVSM-1380 Santa Maria CA was extended from 8/18 to 9/30; no word yet if they got the license to cover application into the FCC before the shutdown but we should hear something soon about whether this one will be going ahead.

Two new station CPs are expiring soon: CP-1240 Prescott AZ expires 10/26 and WSGD-1230 Summerville WV expires 10/29.

Ron Schiller writes: "Took a run up to Cedar City, UT today (22 October) and can confirm that both KOBY-940 and KENT-1400 are silent (the latter contrary to a report published in DX News). However, there is a relay of KZNU-1450 St. George operating on 1400 from, I think, Cedar City, IDs as KZNU-1450 and 93.1 FM, no mention of 1400, with a TLK format."

Thanks, Ron – FCC info is not always accurate, so it's good to hear from members on the ground who can confirm what is really happening. According to the FCC, the license of KOBY-940 was cancelled on Nov. 19, 2012 at the licensee's request – it's not on the FCC silent list because it's on the "totally gone" list. The FCC also says KENT-1400 was silent from 2/6 to 6/19 of this year, and was sold in May to the same folks who own KZNU-1450 (among other stations). So perhaps it was actually KENT that you heard relaying KZNU? The KENT licensed transmitter site is south of Parowan, the city of license, about a third of the way to Cedar City along I-15. Wouldn't be the first time a station like this never gave a local ID. David

540 WKFN TN Clarksville – 10/25 2115 – Over WGR-550 slop with Clarksville Wildcats v. Kenwood High School football, ad for Gary Mathews Motors in Clarksville. Almost certainly running 4000 watts day rig for the game. **(MKB-ON)**

670 WWFE FL Miami – 10/21 2101 – Out of Spanish ads and promos with "This is WWFE 670 AM Miami" and into noticias. Battling Rebelde tooth and nail throughout; no sign of WSCR. (BH-MA)

760 WVNE MA Leicester – 10/21 1759 – In multi-station mix (WJR, WCIS, UNID sports talk and SS) with program promo: "'Family Live Today' with Dennis Reed is coming up next after the 6 o'clock news here on WVNE" into news. **(KK-VA)**

WCIS NC Morganton – 10/21 1818 – In multi-station mix with station promo by woman: "You're listening to music and Christian programming. You'll find it all at 'The Cross' AM 7-60 'The Cross'." (KK-VA)

780 WCKB NC Dunn – 10/23 1840 – In WAVA/WBBM mix after WAVA signoff with "Family Matters Minute," female announcer: "The Providence Quartet' on WCKB. That's 'Pray For Me'. Before that we heard from the 'Downeast Boys' with 'Amen'." 1844* sign-off announcement by male: "This is radio station WCKB in Dunn North Carolina now concluding its broadcast day. WCKB is owned and operated by North Carolina Central Broadcasting Incorporated of Dunn and operates at 7...." (KK-VA)

790 WSGW MI Saginaw – 10/24 1758 – In multi-station mix with station promo: "Your home for RocketGrab.com deals. This is WSGW Saginaw-Bay City-Midland, a NextMedia station. Now... TV 5 news at 6." (KK-VA)

WLSV NY Wellsville – 10/24 1754 – In multi-station mix (WPIC, WNIS, WSGW, UNID SS) with C&W songs, man with "AM 7-90 WLSV" ID. (KK-VA)

WPIC PA Sharon – 10/24 1759 – In multi-station mix with ToH ID by male: "You are listening to news talk 7-90 Sharon-Hermitage, a Cumulus station." (KK-VA)

800 WSVS VA Crewe – 10/17 0700 – ToH ID: real country music for real people like you, 800 AM WSVS." Underneath CKLW-Windsor and CKLQ-Belleville. Another station with Mexican music was also present. **(NjW-ON)**

- CKLW ON Windsor 10/20 0415 Bubbling up with Coast To Coast AM, almost perfectly synched with local 970 WFLA. Spots for CTV and the Leaf Grill from 0430. WPLK, Palatka, FL sometimes co-channel. (TLK-FL)
- **810 WCKA AL Jacksonville** 10/20 0434 Charlie Pride "Kiss An Angel Good Morning" then male canned "Coast to coast Classic Country on Alabama's 810 and 94.3 FM" into a song by, uh, Alabama and local spots. Big local signal, surely running their 50 kW day power and not night 500 watts. **(TLK-FL)**
- **820 WWFD MD Frederick** 10/21 1758 Fair-to-good signal with a very interesting song couldn't call it rock and roll but it was a very upbeat tempo song and I knew it wasn't gospel WGGM from Chester, VA. After the song came a multiple station ID mentioning WWFD-Frederick, MD. For being on 4300 watts and my location being more than 370 miles away I thought this was quite a catch. (GC-NC)

 - CKDQ AB Drumheller 10/21 0629 Alone, and fair to good, with country music matching Internet stream, and eventually "Q Country, Q91" slogan at 0633 and segue into more music. (BT-PEI)
- **950 CFAM MB Altona** –10/19 0728 Tail-end of song by Gordon Lightfoot, commercial for the Southland Mall in Winkler and local news. (**NjW-ON**)
- 960 WERC AL Birmingham 10/17 0702 Faded up over KZIM/WFIR with woman saying "Newsradio WERC 105.5." (NjW-ON)
 - **KLTF** MN Little Falls 10/19 0731 Item from the Linder Farm Network, ID and time check, woman with local news. (NjW-ON)

- **1030 WONQ FL Oviedo** 10/18 0502 Fading up to excellent, hammering WBZ, out of high energy Latino music into ID and slogans in Spanish, then English call letters: "WONQ, Oviedo, Orlando, La Grande." and back to music. **(BT-PEI)**
 - ++ 10/18 2200-2305 Under WBZ; Haitian programming, announcements in accented French and kompas/zouk music, parallel WONQ website stream. Seemed too strong to be on night facilities. New log. (BC-NH)
- **1090 WCAR** MI Livonia 10/23 0600 Under WBAL; Notre Dame football promo, "WCAR AM 1090..." and NBC Sports Radio update. New log. (BC-NH)
 - WTNK TN Hartsville 10/19 0658 C&W songs, ToH ID. Soon faded out, leaving behind KAAY-Little Rock. (NjW-ON)
- **1130 WDFN MI Detroit** 10/18 1814 Under WBBR with sports talk, "Detroit's sports line on 1130 WDFN The Fan"; college football chatter and more IDs. **(BH-MA)**
- **1140 WBXR** AL Hazel Green 10/21 0715 ID: "11-40 WBXR, radio that changes the way you live" into the Seeking the Lost International Radio Broadcast with Ricky Berger. (NjW-ON)
- **1180 WZQZ GA Trion** 10/21 0700 Under WHAM-Rochester with legal ID that mentions "Chattooga County Radio." News sponsored by an insurance agent in Summerville. (NjW-ON)
- **1230 WMPC MI Lapeer** 10/21 2006 Over graveyard jumble with local weather, "...and that's your forecast from WMPC," then back into mush. **(MKB-ON)**
 - WCLO WI Janesville 10/23 0729 Faded up with local news and ID and weather for Southern Wisconsin from the "news 3 weather center." (NjW-ON)
 - CFGN NL Port aux Basques 10/20 2201 Weak but audible, with country song rolling through the top of the hour and eventual slogan, "News, weather, sports, and great country music, CFCB," then into promo for a financial management workshop. Not new here, but not previously heard at night, with 250 watts. (BT-PEI)

Back in September of 2010 my Musing about a powerline noise problem was published in *DX News* (Volume 77, No. 30). In summary, conducted powerline noise had seriously degraded my BCB reception. National Grid and the FCC basically left me high and dry without any recourse as they offered no help or hope to solving the problem.

In an effort to find the source I scoured my neighborhood and surrounding areas with a portable radio and a Radar Engineers RFI locater without success. Eventually I gave up on actively searching.

Well, a couple weeks ago a National Grid truck pulled up in front of my home. Unfortunately I couldn't stick around to find out what they were doing, but I did observe them pulling the fuse disconnect from the distribution line to the transformer on the utility pole there, killing our AC power. Upon returning home, the crew was gone and nothing looked different, except that the fuse disconnect had been changed to one of the new polymer types. I didn't notice if others in the area had also been changed, however.

It occurred to me once inside to check if this had any impact on my noise problem. Turn it on and ... I sat at my radio in disbelief ... this was the source! Even though a National Grid rep had scanned this area with his ultrasonic sniffer and I had scanned it with my RFI locater there was no indication of trouble ... except on my receiver!

The moral to this story is that powerline noise is not easily detected by even professional equipment, so it's kind of understandable why utilities dont like RFI problems. Then on the other hand, if National Grid knew what the answer to the problem was, it took them two years to fix it.

710 WDSM WI Superior – 10/20 1844 – Very good in KCMO null with Green Bay Packers football // WTMJ-620 with Wayne Larivee on the play-by-play. "AM 710 WDSM" ID noted in commercial break at 1854. **(RD-NE)**

TX Universal City – 10/11 0809 – Studio talk show pauses for Grupo Radio Centro plug, romantic song in English, loops WSW, so no doubt the only Mexican in the northwest, per Cantú: 720 XEJCC Extremo 7-20 Cd. Juárez, Chih. 1,000 1,0000 [sic] then mixing with another Spanish station much further east which I can still hear by nulling the first one, but that's not XEDE in Saltillo now, instead KSAH Universal City TX, since San Antonio mentioned, and 0816 ad in Spanish for A-1 Car Stereo, on I-10, also has 877- toll-free number. KSAH is listed with ESPN Deportes, but this may have been a local show as well as local ads. **(GH-OK)**

- **730 CKAC QC Montreal** 10/19 0745 NEW, Male announcer speaking French. Only French speaking station on this frequency listed in *AM Radio Log* 34th edition. (**JDS-MN**)
- **740 WDGY WI Hudson** 10/17 0832 Good with CCR's "Proud Mary" via True Oldies Channel, and confirmed by webstream. TOC's website shows WDGY as their only current affiliate on 740. **(RD-NE)**
- 760 WJR MI Detroit 10/19 0758 Traffic report into weather ending with "Currently forty-two degrees at news talk Seven-Sixty WJR." Followed by ABC news. (JDS-MN)
- 790 WAYY WI Eau Claire 10/19 0804 After multiple local commercials "The old saying goes here in Wisconsin. If you don't like the weather, wait five minutes, then hit OK. But, if you don't want to wait for the latest weather information, log onto WAYY Seven-Ninety dot com. We've got the very latest 5-day forecast." (JDS-MN)

- 920 KVEL UT Vernal 10/20 0816 From NW/SE, dominant signal goes from Michael Medved far-right talk show to a break with ID for KVEL, Vernal UT, also on

104.5 (translator), ad string including a security system, Laity Lodge referring to Tom Landry, some football coach, thehighcalling.org, local sheriff vs. texting & driving; ad for something in Roosevelt [UT], local reference to "The Basin," steak dinner for only \$22.99 in Fort Duchesne, Palmer's American Car Care also in "The Basin." Vernal is in exotic NE Utah's scenic dinosaur country. 1 kW night pattern goes mostly NNE, while 5 kW day pattern is non-directional, surely already on now, way

before sunrise. KYFR Iowa is barely audible with KVEL nulled. (GH-OK)

950 KOEL IA Oelwein – 10/21 1910 – Fair with weather forecast from KWWL Channel 7 in Waterloo, then into George Strait C&W song "The Cowboy Rides Away." Iowa logging # 59 at this QTH. (RD-NE)



But I suppose it could still be WBBZ as own website does not account for anything in the overnight hours. (GH-OK)

- SCOTLAND Clyde 2, Glasgow OCT 21 0207 Good, over the jumble, with Supertramp's "Give a Little Bit," the Clyde 2 ID and segue into song by Adele.

- 1161 **SCOTLAND** *Tay AM*, Dundee OCT 21 0208 Fair, with parallel of *Clyde* 2 programming, Supertramp's "Give a Little Bit," but not enough signal to determine whether it ran its own ID package. [Taylor-PE]

Hauser transatlantic carrier search: JBAs OCT 20 0055: only 783, Mauritania? And 882, Canary Islands? I lean toward the latter rather than Europeans due to the lower-latitude paths, and they seem to come together. OCT 22 0552, now still before sunrise in W Europe: 909 and 774 kHz, looping northeast/southwest. The big sig on 909 easily heard further east is BBC Radio 5 Live, synchros adding up to 400+ kW; on 774 the big sigs are too far east in Egypt and Iran.

Hauser transpacific carrier search: OCT 18 1152, JBA on 774; at 1153, JBA on 882. JBAs OCT 20 1147 on 747, 774, likely the 500 kW NHK Japanese. OCT 23 1237-1242: 693, 774, 828, 873, 972, 1053 kHz.

- MEXICO XEWA W Radio, San Luis Potosí, SLP OCT 20 0850 Fair under domestics with nonstop techno beats, parallel excellent 900 kHz. No Nicaragua het (not on yet). [Krueger-FL]
- 610 **HONDURAS** *R.América*, Tegucigalpa OCT 23 1108 Very poor, parallel to strong 630 for just a moment during telco female news item. *R.Rebelde* Cuba and the unidentified Mexican co-channel. No other *R.América* parallels located. [Krueger-FL]
- MEXICO XEBX *La Primera*, Sabinas, Coah. OCT 23 1118-1131 Pointing central/south-ish Mexico, nonstop schmaltzy Mexican band (tuba-intensive) instrumental covers of goofy old songs such as "Man on the Flying Trapeze" until blocked by local 620 WDAE iBOC at 1131. OCT 24 1103 Mexi-tunes vocals and instrumentals from tune-in, 1117 male and female chatter, bad local noise. OCT 25 1120 Tune in to Mexi-tunes, then male "La Primera" slogan and again at 1129 just before iBOC wiped out. [Krueger-FL]
- HONDURAS *R.América*, La Ceiba and/or Choluteca OCT 22 1044 Transmitter abruptly up at 1044 mid-song, and continuous Spanish ballads segued. Faded and local noise by top of hour, back in with ballads, then male announcer around 1124 but blocked by local 620 WDAE iBOC at 1130. OCT 23 1043 Transmitter up, segued ballads until 1100 then nice "Radio América, HRN... 23 de Octubre..." into vocal, news and commercials 1103-1108, ID, back to vocals. Very good signal until killed by 620 iBOC at 1131. OCT 24 1044 Transmitter up, same format till 1100. Sign on must be with automated timer that's lost time or isn't set correctly, well at least the 2013 WRTH lists 610 flagship as 1030 UTC sign on. But http://radioamericahn.net/programacion appears to indicate 0500 local, and http://radioamericahn.net/cobertura which I think I shared years' ago shows their alleged current channels on AM/FM. Also audible was a very low growl, low side. Looking at a SEP 4, 2012 log of mine, I had the second transmitter audible slightly delayed. So suspect that is the source of this. [Krueger-FL]
- MEXICO unID OCT 22 1055 A reference to the location of Hurricane Raymond, "kilometros... y kilometros... Acapulco..." Orchestral version of national anthem, no ID 1059, instead straight into ballad, then slow talking male and female talking about a restaurant, food, other patter. [Krueger-FL]
- 650 **CUBA** *R.Progreso*, Ciego de Avila OCT 19 1059 Still rapidly 'sheet metal noise' wobbling. Fix it, Arnie! [Krueger-FL]
- MEXICO XEFZ ABC Radio, Monterrey, NL OCT 23 1214 Nuevo León state PSA, then ID as ABC Radio, Monterrey, with FM and AM frequencies, phone numbers, but did not hear any callsigns; then news headlines. [Hauser-OK]
- MEXICO XECS *La Mejor*, Manzanillo, Col. OCT 19 1110-1137 An XE with anthem at 1100, too weak to ID, then another with anthem from 1103. Which if either was this is unknown, but this one faded up to decent level with Mexi-tunes, male canned "la Mejor" between songs. Eventually crushed by my local 680 splatter as this one also began fading. [Krueger-FL]
- 690 **MEXICO** XEMA *La Mejor*, Fresnillo, Zac. OCT 24 0531 ID mentions Zacatecas, so must be XEMA. A state seldom heard here. With SAH from KGGF Kansas open carrier amid other interference. [Hauser-OK]
- MEXICO XEGD *La Poderosa*, Hidalgo del Parral, Chih. OCT 20 1203 Big hum on open carrier again, previously tracked to XEGD. OCT 21 1159 Music right across hourtop, no national anthem, 1203 finally ID as "La Poderosa" and again at 1205, more music. Making SAH of 76/minute = 1.27 Hz with WLW roughly opposite. So XEGD has decided to modulate with something other than hum as 24 hours ago. [Hauser-OK]
- MEXICO XEDE *La Kaliente*, Saltillo, Coah. OCT 18 0457 Full ID for XHDE FM 105.7 and XEDE AM, 0458 national anthem, mixing WGN with SAH of 192/minute = 3.2 Hz. No sign of the real KSAH at the moment. Kudos to XEDE for holding its own with 250 watts vs 50,000. [Hauser-OK]
- MEXICO XEJCC Extremo 720, Cd. Juárez, Chih. OCT 18 1231 Fox-logo fanfare, then woman talking about someone who took off their clothes; phone keeps ringing in background; WGN almost nulled. Seems further west than Saltillo, ergo XEJCC. [Hauser-OK]
- vest/southwest east/northeast, suggesting KAMA El Paso which is Spanish, but supposedly not religious, but it's Sunday morning and any station might do that temporarily. However, NRC Pattern Book shows both day and night it's all-westward from there. Don't see any other likely U.S. Spanish stations even eastward. Rarely hear any

- Spanish on 750. The most likely Mexicans in Cantú: XEOH *La Jefa*, or XECSI *Éxtasis Digital*. [Hauser-OK]
- MEXICO XEACH *R.Fórmula Primer Cadena*, Monterrey, NL OCT 18 1200 Fórmula promo with an 866- phone number to hear it "en la Unión Americana" from 7 to 8 a.m. Mexican central time, i.e. a U.S. toll-free number. [Hauser-OK]
- MEXICO XEDD Montemorelos, NL OCT 20 1208 Donald Duck is really bad this morning vs KQCV, except where I can get a tight null on it pointing right at XEDD, previously traced to La Voz del Pato Donaldo; it's so distorted that I am not sure if it's talk or music now, but lean toward the latter. Strangely, not much from XEROK with KQCV nulled. [Hauser-OK]
- MEXICO XEM Chihuahua, Chih. OCT 23 1229 With KOA nulled, Brazuguese is startling, but it's a clip during news, soon followed by Pres. Obama in English, and someone in English with a French accent, none of it directly translated, probably about spying; then to narration in Spanish during Milenio Noticias, 7:30 time check, so from DF TV feed? Then ID as *Milenio Radio* listing FM frequencies in several cities: including 103.7 Monterrey, 99.5... 95.3 Tijuana, 99.3 Saltillo, 103.7 Chihuahua; followed by further promos for the last one, as we already knew this would be XEM, where it's only 6:30 a.m. Next week will be confusing, as most of Mexico goes off DST a week before we, and the border cities do. [Hauser-OK]
- MEXICO XENL *R.Recuerdo*, Monterrey, NL OCT 20 1211 R.Recuerdos jingle, auto time and temp as 7:11, 16 grados, then ranchera. Loops almost north/south, and there is another Spanish song further west with this nulled, too many possibilities for that; no problem from KKOW Kansas at the moment. Cantú, IRCA and WRTH agree it's singular, so did I mishear it? Means memory/memories. [Hauser-OK]
- 910 **CUBA** *R.Cadena Agramonte*, Camagüey OCT 20 0859 Male canned, "Transmite Radio Cadena Agramonte, Camagüey, Cuba" into soft Cuban vocal. [Krueger-FL]
- 940.174 **MEXICO** XEMMM 940 Oldies, Mexicali, BC OCT 20 1224 Usual het looping east/west always audible around sunrise here, but never with any audio, no doubt XEMMM per mwoffsets as of 3.5 years ago. And not to be confused with 50 kW XEQ in the DF which is always off to the low side of 940 by a similar amount. [Hauser-OK]
 - 940 **PUERTO RICO** WIPR *Máxima 940*, San Juan OCT 21 2300 Fair; promo/ID, "WIPR San Juan, Máxima 940 AM... en Twitter..." [Conti-NH]
 - unID OCT 20 1226 As I tune in, 4(?) chimes, but not all-descending as with XEW/XEK. This is mixing with XET *La T Grande*, and other co-channel interference, and unthink it's from Mont'y as never heard when surely listening to XET. [Hauser-OK]
- MEXICO XEMPM *Exa*, Los Mochis, Sin. OCT 23 1235 ID for 98.9, time as 6:35, so the match on UTC-6 time zone and FM frequency in Cantú, although they also mentioned California; no BCS on 1030, but they should have listeners across the Sea of Cortez. [Hauser-OK]
- MEXICO XEYC *R.Fórmula*, Cd. Juárez, Chih. OCT 24 1240 Several news items about Chihuahua city, with sounders between them, heavy co-channel interference; then promos "alta definición" on 103.3 FM coordinated with 1430 AM, and four different Fórmula HD channels. (Wouldn't that require a second FM transmitter? I may have missed the other one.) There is no 1430 anywhere in Chihuahua state, nor a 103.3. That obviously refers to the Fórmula flagship in México DF, where HD is widely transmitted (no 1430 there either). [Hauser-OK]
- MEXICO XEEP R. Educación, México DF OCT 20 0928 Nice classic reggae with Toots & the Maytals "Spiritual Healing" into "Pressure Drop" then female ID at 0934 UTC. [Krueger-FL]
- MEXICO XECPN *La Poderosa*, Piedras Negras, Coah. OCT 20 1236 From south/southwest, "La Poderosa, Radiorama," with teléfonos en cabina, federal PSAs including one from Comisión Nacional de los Derechos Humanos; 1238 teléfonos again including an 800-number, song. Dominating vs the co-channel interference. [Hauser-OK]
- 1450 **CUBA** *R.Mayabeque*, Güines OCT 20 1124 Very poor under WSDV Sarasota, with Cuban flute solo, parallel not much better 1140 kHz. [Krueger-FL]
- 1450 **MEXICO** unID OCT 20 1103 National anthem in progress, male XE calls after, but unable to copy in the co-channel, very weak. This one will be tough at best to ID. [Krueger-FL]
- 1530 **MEXICO** XEUR *R.Fiesta*, México DF OCT 20 1031 Spanish pop vocals, female canned slogan 1034 and 1040 kHz. [Krueger-FL]
- 1610 **ANGUILLA** *Caribbean Beacon*, The Valley OCT 20 0942 Poor with the usual University Network ranting by the Mrs. Scott, parallel 6090 shortwave. [Krueger-FL]

PORTUGAL: 1035 *StarFM*, Belmonte, St.º Estêvão, is silent since end February or so. I was then explained, that a certain aluminum core, modulation transformer had to be replaced, not simply rebuilt, so there was an expectation for resuming operation in April. After all these months, I decided to get more information from my contact within the station, and he explained his department was not allowed that expense, especially when along with the transformer certain other peripheral items should be replaced too. A 100~120 kW unit operating at a fraction of its power, e.g. 10 kW, does not mean power consumption is about the same as that of an ordinary 10 kW - it's somewhat higher. This made my contact try to convince their administration to "freeze" the 100 kW unit for some time and install a 10 kW unit as it would at least save on electricity costs, but on the other hand a new 10 kW transmitter would push the expense over the amount needed for modulation transformer. The answer was "no." So 1035 will be on the air again only if and when conditions allow it. [Carlos Gonçalves, *mwmasts*]

NOAA Space Weather Outlook

Issued October 21 – For the period October 21-November 16, 2013

(From http://www.swpc.noaa.gov/ftpdir/weekly/WKHF.txt)

Solar activity is expected to be at low levels with a chance for isolated moderate level events through the forecast period.

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at moderate to high levels on 21 Oct, normal to moderate levels on 22 Oct - 10 Nov and moderate to high levels on 11 - 16 Nov.

Geomagnetic field activity is expected to be at quiet to unsettled levels on 21 - 22 Oct and unsettled to active levels on 10 - 13 Nov due to recurrent CH HSS effects. Predominately quiet levels are expected for the remainer of the outlook period.

FCC Prepares Vote On Foreign Ownership

At its November 14 Open Meeting, the FCC will vote on a proposal to allow foreign investment in broadcast companies in excess of 25% on a case-by-case basis.

Acting Chairwoman Mignon Clyburn sent a release stating: "Today (October 24), I circulated a declaratory ruling that clears the way for increased access to capital and potential new investors for the broadcast sector. Approval of this item will clarify the Commission's intention to review, on a case-by-case basis, proposed transactions that would exceed the 25 percent benchmark that restricts foreign ownership in companies holding broadcast licenses. I look forward to working with my colleagues toward a final Commission vote next month."

The only group currently with a waiver for such foreign ownership is News Corp. for the Fox Television Stations. That waiver was granted in 1996, ten years after Rupert Murdoch's company first purchased the former Metromedia stations.

NAB President/CEO Gordon Smith made the following comment regarding the proposal: "NAB applauds Acting FCC Chairwoman Clyburn for proposing that the commission should consider foreign investment in U.S. broadcast properties the same way it considers such investments in other telecommunications properties. This is fundamentally fair and will serve the public interest. Permitting new potential sources of capital for American radio and TV stations will strengthen our ability to continue providing compelling news, entertainment and sports programming and to remain competitive in a multichannel digital world."

The proposal comes following the termination of the controversial sale of 93.5 KDAY Los Angeles to a group financed by China's Phoenix Satellite Television. (*RadioInsight via Bill Hale.*)
