620 WJDX MS Jackson – 10/1 2200 – Fox Sports programming. **(DBJ-TN)**

690 WJOX AL Birmingham – 10/25 0743 – Fair, steady, no CKGM. "Jox 94.5" Fox Sports Daybreak. (JJR-WI)

690 WQNO LA New Orleans – 10/10 0600 – Holy Mass; ID as "New Orleans Catholic Radio." (**DBJ-TN**)

790 WQXI GA Atlanta – 10/11 0600 – ESPN SportsCenter program. (DBJ-TN)

860 KONO TX San Antonio – 10/23 0600 – Oldies music announcement for 101.1 FM. QRM from CJBC Toronto in French. **(DBJ-TN)**

890 KQLX ND Lisbon – 10/24 1926 – Poor in WLS null, Johnny Cash song, "Ag Info 890 KQLX" after song. (JJR-WI)

930 KAFF AZ Flagstaff – 10/23 0847 – In tight WKY null, country music, English announcement, TC as 5:47, 1250 segué. Only fit in the UT-7 zone per NRC AM Log is: KAFF Flagstaff, C&W, 5000/31 watts, PSRA 500, always non-directional. But PSRA start-time of 6 am local MST would not come until 0900. (GH-OK)

930 WMGR GA Bainbridge – 10/19 0430 – ESPN radio sports programming. Format change? (DBJ-TN)

950 KWOS MO Jefferson City – 10/23 1930 – Talk and then to ID as "Newsradio 9-50, KWOS," then local news. **(FO-OK)**

960 KMA IA Shenandoah – 10/23 1934 – Help wanted ad for truck drivers in Shenandoah. (FO-OK)

970 WKCI VA Waynesboro – 10/29 2059 – Poor below local WHA (which runs 51w ND at night), with unID talk program, LID // WKCY 1300 Harrisonburg VA into Fox news at ToH. Used slogan "NewsTalk 970." Long needed call change dating back to 11/2001. Had the Double Kaz pointed 100 degrees for this one. (BD-WI)

1000 KKIM NM Albuquerque – 10/23 0829 – Call letter ID and into *Focus On The Family* show. **(FO-OK)**

1050 KLOH MN Pipestone – 10/23 0818 – Mention of "here in Pipestone." I have heard KLOH several times, their antenna must be directional right at the Oklahoma Panhandle. (FO-OK)

- **1110 WTOF** AL Bay Minette 10/18 0410 IRN news program, gospel music. ID as "AM 1110 WTOF Bay Minette, AM 1360 WMOB Mobile." NRC *AM Radio Log* lists as D1 10,000; are they now 24 hours? **(DBJ-TN)**
- 1140 KLTK AR Centerton 10/24 0836 "Radio Las Américas, 11-40" ID after norteña music, loops about ENE/WSW. No such slogan listed for a Mexican and there aren't

any westward from XEMR Monterrey, the nighttime dominator. The SS in Arkansas is "La Más Mexicana" --- or was --- Google soon leads to Rogers AR now branded with this new slogan, broadening its scope. 0:5 kW ND daytimer. Must be a fairly recent change, as still with old slogan in NRC AM Log 2013 and the last time I logged it. Per own website, also look out for "La Más Perrototota y Punto," "Pura Música Perrona." The new name may have more to do with Supermercados Las Américas than continental

outreach, whose ads are splashed all over the page; new station owner? FCC AM Query still shows licensee as La Mas Mexicana LLC. (GH-OK)

- 1150 WJRD AL Tuscaloosa 9/28 0800 Oldies music; announce as "True Oldies Channel." (DBJ-TN)
- **1260 KWYR SD Winner** 10/25 0812 Poor "in Chamberlain, Winner & Mitchell" into ad about Crop Insurance. All alone. (**JJR-WI**)
- **1280 WODT** LA New Orleans 10/18 0115 Spanish sports talk from SE/NW, no doubt WODT with its major 5/5 kW lobe to the NW, now with ESPN Deportes, as the original WDSU is long-gone. (GH-OK)
- 1280 KPRV OK Poteau 10/25 2059 Fair and in the clear, with song "Goin' Out of my Head" into LID. This was immediately followed at 2000 by a somewhat louder LID from WWTC, into SRN news. At this point KPRV was still in but considerably below WWTC with music. So evidently WWTC had been experiencing dead air allowing KPRV to slip in and be logged. NEW! (BD-WI)
- **1330 WCVC FL Tallahassee** 10/17 0800 Holy Mass, ETWN programming. Another to mark off the unreported list. **(DBJ-TN)**
- **1350** WRWH GA Cleveland 10/18 0400 Local Fox newscast, local weather. (DBJ-TN)
- 1360 KHNC CO Johnstown 10/30 2159 Good with light QRM from KSCJ, with Bible reading of John 1:19-21, reading of the Preamble to the Constitution, LID including slogan "The Lion" and a lion's roar into IRN/USA Radio news. NEW! A big thank you to Neil Kazaross for posting a tip on the NRC list that this station was on day power. (BD-WI)
- **1360 KKBJ MN Bemidji** 10/25 0800 Poor "in Bemidji, North Minnesota's favorite" No calls heard. Fading-choppy. WTAQ nulled. (**JJR-WI**)
- 1380 WMJR KY Nicholasville 9/20 0500 Holy Rosary led by Bishop of Lexington. (DBJ-TN)
- **1400 KART ID Jerome** 10/31 0956 Johnny Cash's "I Walk the Line"; 0959:50 legal ID: "Real Country... 1400 KART Jerome...;" sounded like network news at ToH but could not tell which one. Poor reception. **(JW-CO)**
- **1450 KYNT SD Yankton** 10/28 2302 Poor but above the GY jumble, with AC music, LID into ABC news. A nice GY relog, 408 miles. **(BD-WI)**
- **1460 KXPN NE Kearney** 10/30 0848 Area scores, including high school volleyball and the Tri-City Storm (US Hockey league); signal up and down with area sports; weather at 0859; dual legal ID at 0900 for KXPN-1460 and KICS-1550. Generally fair. **(JW-CO)**
- **1550 KLFJ** MO Springfield 10/28 1921 Many items about Branson, ID as "Branson Radio" at 1922. (FO-OK)
- 1570 WTRB TN Ripley 10/2 2100 Cardinals baseball, local ads. (DBJ-TN)
- **1590 WCSL** NC Cherryville 10/26 0429 Poor to steady but choppy signal. WAKR nulled, end of song, calls! 1590 #29, NC #53 NEW! (JJR-WI)
- 1640 KZLS OK Enid 10/28 1925 Oldies mx, ID at 1927 as "16-40 AM, True Oldies." Call change logged. (FO-OK) 10/31 0849 Oldies music, local ads, OKC traffic; seemed to be local programming from "Hank FM 99.7" at this time rather than True Oldies feed; legal ID at 0859 as "...KZLS Enid-Oklahoma City." Fair signal, mixing with KBJA, which was slightly better here. Ex-KOAG. (JW-CO)

UNID

700 UNID -- 10/20 1518 – On car radio at a hotspot for MW in a mall parking lot, I am hearing not only Spanish from KHSE in The Metroplex, but something very weak underneath making SAH of about 2 Hz. Looking at 700 map, it has to be the further Texan, KSEV in Tomball (Houston market), 15 kW day power,

although not much toward us in either station's pattern. Short for SEVen hundred, I suppose. Could those between Dallas and Houston confirm the SAH? Otherwise, less likely would be remnant sky- or even groundwave from WLW, a bit far and this is only half a sesquihour after local mean noon, Sun at zenith. This would be a slightly more possible in Dec or Jan. Without KHSE in the way, almost same direction, KSEV might have a better chance here on groundwave. (KTRH 740 is of course totally blocked by KRMG – and I rarely hear anything but KRMG at night on 740 except CFZM Toronto). (GH-OK)

740 UNID -- 10/23 0826 – I finally manage to hear some Spanish briefly under KRMG Tulsa before it goes to day power/tower. May have mentioned "Radio Santa Fe" or similar syllables. Don't find any Mexican or US station with such a name; NRC AM Log does show KIDR Phoenix AZ as Spanish religion, but I can't find a website for it. (GH-OK)

750 UNID -- 10/20 0805 – Rosary in Spanish; loops about WSW/ENE, suggesting KAMA El Paso which is SS, but supposedly not religious, but it's Sunday morning and any station might do that temporarily. However, NRC Pattern Book shows both day and night it's all-westward from there. Don't see any other likely US SS stations even eastward. Rarely hear any Spanish on 750. The most likely Mexicans in Cantú: 750 XEOH La Jefa + FM 96.1 Cd. Camargo, Chih. 1,000 750 750 XECSI Éxtasis Digital + FM 89.5 Culiacán, Sin. 5,000 250. (GH-OK)

760 UNID -- 10/20 1520 - On car radio at a hotspot for MW in a mall parking lot, I am hearing not only the religion from KCCV Overland Park KS (Kansas City market) as usual, but something very weak under, making SAH of about 4 Hz. The second and third nearest 760s are KMTL 10 kW ND Sherwood AR, and KTKR 50 kW San Antonio TX, but direction mostly west and east-southeast. So which one is 4 Hz from KCCV? There is no reference for such needed information. Another possibility for such trace signals would be local overload or mixing products, but in Enid we have only three MW locals which could be easily ruled out if I had enough on the traces to compare them. FWIW, I always check 670 and 720 for Chicagoans in the daytime, which have made it before. Now at 1925 UT, 670 bears only KLTT Denver, and a very weak signal on 720 could be WGN, or KSAH San Antonio. (GH-OK) Online MW Offsets list has both KKZN-CO and WJR-MI heard on 759.9970 in October – DY.

940 UNID -- 10/20 0825 – After noting the 940+ het from XEMMM in Mexico, partial ID in its null as "94 [something] Country." Nothing similar in the NRC AM Log 2013. (GH-OK)

NOAA Space Weather Outlook

Issued October 28 – For the period October 28-November 23, 2013

Solar activity is likely to be at moderate levels through 06 Nov when Region 1882 is expected to rotate around the west limb. Predominately low levels are expected until Regions 1875 and 1877 return around 11 Nov. Chances for moderate activity increase at that time and will persist until 20 Nov when activity is expected to decrease again to low levels for the remainder of the period.

A chance for a proton event at geosynchronous orbit exists through 06 Nov as Regions 1875, 1877 and 1882 move across the western hemisphere.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at normal to moderate levels through 10 Nov. An increase to moderate to high levels is expected from 11 - 18 Nov following a recurrent coronal hole high speed stream (CH HSS). Normal to moderate levels are expected for the remainder of the period.

Geomagnetic field activity is expected to be unsettled to active with isolated minor storm intervals on 28 Oct due to a combination of the 24 Oct CME associated with the M9 flare and the CMEs associated with the two X flares observed on 25 Oct. Unsettled to active conditions are expected on 29 Oct with a chance for minor storm periods due to continued CME effects along with the arrival of the CMEs from the 26 Oct M flares. Mostly quiet to unsettled levels are anticipated from 30 - 31 Oct as CME effects wane and only a weak CH HSS. Predominately quiet conditions are expected from 01 – 09 Nov. Quiet to unsettled conditions, with possible isolated active periods, are expected from 10 - 13 Nov with the arrival of a recurrent positive polarity CH HSS. Predominately quiet conditions are expected for the remainder of the period.



Mark Connelly pointed out that by accumulated power, my previous log of 774 would most likely be the RNE Spain synchros adding up to some 400 kW.

Hauser transpacific carrier search: OCT 25 after finding 2-7 MHz from Asia propagating poorly today, did not expect any on MW, but there they are: usual JBA carriers at 1203-1205: 693, 747, 774, 972, likely Japan and Korea South. Today's sunrise here not until 1248. OCT 26 1151-1157: JBA on 594, 693, 747, 774, 882, 972, 1143. 774 and 972 are slightly stronger than the others. I decided to sit on 972 at 1200 trying to detect a S Korean timesignal, but inconclusive. OCT 27 1157: JBA on 702 from south of due west; 774 from northwest. 702 presumably 2BL Sydney NSW, whose true bearing is 251 degrees at 13860 km (date correct, overlooked for previous report). U.S. NEW STATION CONSTRUCTION PERMITS – STATUS REPORT

The FCC web site shows 58 outstanding CPs for new stations as of November 1, 2013.

Of these, 9 CPs have applied for "licenses to cover" (LTCs) (i.e., have built the stations); some have applied for or been granted program test authority (allowing them to broadcast on a provisional basis), and some have been heard on the air:

- 740 KCIK Kihei HI (U1 5000/5000) Applied for LTC 9/12/2013.
- 1120 KTXW Manor TX (U4 5600/155) Applied for LTC 1/4/2013; granted PTA 4/5/2013.
- 1200 KPSF Cathedral City CA (U4 5000/1300) Applied for LTC 3/23/2012; granted PTA 4/13/2012; reported on the air.
- 1240 KRJW Altamont OR (U1 1000/1000) Applied for LTC 8/14/2013; granted PTA 9/27/2013.
- 1340 WWNH Madbury NH (U1 250/250) Applied for LTC 6/26/1989; was on air; now silent.
- 1350 KUSG Agana, Guam (U1 250/250) Applied for LTC 7/17/2012; granted PTA 10/22/2012.
- 1400 KRAM Vernal UT (U1 1000/1000) Applied for LTC 9/12/2012; granted PTA 12/12/2012.
- 1490 KHTC Malmstrom AFB MT (U1 1000/580) Applied for LTC 1/20/2011; reported on the air.
- WIGT Charlotte Amalie, USVI (U1 920/920) Applied for LTC 4/1/2013; applied for PTA 4/2/2013.

An additional 7 CPs on the web site have expired and are presumably under appeal – KJJL-540 Pine Bluffs WY, 550 Reno NV, WQTH-720 Claremont NH, WZNH-870 Fitzwilliam Depot NH, KUCU-1060 Farmington NM, KPWL-1370 Newport WA, and WJOE-1450 Lake City FL.

3 CPs on the web site expired recently; especially with the government shutdown, they may have gotten LTC applications in before the deadline – WSGD-1230 Summerville WV, 1240 Prescott AZ, and KVSM-1380 Santa Maria CA. You should see AM Switch notices of LTC applications or deletion on these CPs soon.

The remaining 39 CPs are still within their original 3-year window.

23 of these CPs are set to expire in 2014: 640 Terre Haute IN (has application to move to Peotone IL); 880 Wasilla AK; KDPP-890 Oliverhust CA; KEGC-1030 Elk Grove CA; WZBR-1120 Coral Springs FL; KCKQ-1180 Reno NV; 1180 Jacksonville OR; 1210 Osceola IN; 1230 Terre Haute IN; KBEV-1230 Beaver UT; 1330 Prescott Valley AZ; 1400 Paukaa HI; 1420 Rowe NM; 1450 Craig CO; KMCA-1450 Hilo HI; 1460 Shawano WI; 1520 Fultondale AL; KDCO-1550 Golden CO; 1550 Midland TX; WIVS-1560 Village of Superior WI; 1570 Fritch TX; WODJ-1590 Big Rapids MI; 1590 Paradise NV.

12 more will expire in 2015: KBLN-830 Grants Pass OR; 1010 Reno NV; 1020 Star ID; 1100 Lebanon OR; KSPK-1180 Walsenburg CO; 1250 Kahului HI; 1260 Keaau HI; 1340 Rothschild WI; 1360 Tyonek AK; 1400 Juneau AK; 1540 Southchase FL; 1580 Red Bluff CA.

And only 4 have been granted (so far) in 2013 to expire in 2016: 780 Draper UT; 1020 Blue Mountain NV; WNCR-1190 Red Oak NC; 1310 Anchorage AK.

The FCC still has a number of outstanding applications from the last application window in 2004, and it seems likely that a few more CPs will be granted from those applications. In most cases there are mutually exclusive applications to be resolved. I haven't done an exact count, but it seems that, of the CPs that expired in 2013, probably three-quarters or so expired unbuilt. It often seems that applications get the CP first and then try to find financing for the station when they get the CP – or try to sell the CP after it's been granted – and more often than not it doesn't work out.
