75 Years Ago: From the February 27, 1939 issue of *DX News* – Ike Davis in Elkart, Texas experienced his best-ever "Down Under" morning on Feb. 18, with a couple dozen Australia and New Zealand stations logged.

50 Years Ago: From the February 22, 1964 issue of *DX News* – Glen Kippel in Palm Springs CA noted receiving Beijing-1040 daily on his car radio at 5 a.m.; Mike Bugaj in Middletown CT got a big package in the mail from NDR-1586.

25 Years Ago: From the February 27, 1989 issue of *DX News* – Roy Millar's lifetime graveyard channel loggings appeared in GYDXA, including more than 20 Eastern time zone stations heard in Washington State.

1570 WIZK MS Bay Springs – Granted STA for D1 1000; transmitter problems prevent full power operation and silent station needs to broadcast to preserve license.

Applications to extend existing STAs were <u>received</u> from WETC-540 Wendell-Zebulon NC (parameters at variance and/or reduced power); KFXD-630 Boise ID (parameters at variance); WQNO-690 New Orleans LA (U1 2500/1250 from temporary antenna); WLRO-1210 Denham Springs LA (night pattern at variance); and WSMN-1590 Nashua NH (unspecified).

1570 KBRI AR Brinkley – Silent since 10/8/2013, tower taken down when a garbage truck ran into one of the guy wires.

Formerly silent informing the FCC that they are back on the air:

1570 WIZK MS Bay Springs – Silent since 2/10/2013, back on the air 2/8 with STA.

Last issue we ran the latest FCC silent list; maybe the FCC now reads *DX News*, because they took the hint and dropped WQOM-1060 from the silent list (as we pointed out, the station has been on

the air for years). Additionally, Bruce Conti notes that WHFB-1060 and WKAL-1450, both on the FCC silent list, are on the air, while Dave Schmidt observes that WSRY-1550 is silent, but not on the FCC list.

Fines: WLS-890 Chicago IL, fined \$44,000 for failing to disclose that 11 broadcast items sounding like news reports were actually paid advertisements.

Other FCC news: The FCC received around 150 comments regarding its proposals for revitalizing the AM radio service, and has extended the deadline for reply comments to March 20.



Bruce Portzer on IRCA e-maillist (via DB) writes: Family Radio outlet KARR-1460 Kirkland WA, will leave the air at the end of February. According to on-air announcements, the shutdown is due to "a number of factors", most notably the non-renewal of the lease for the transmitter site.

It's not clear whether this is related to Family Radio's financial difficulties. KARR's transmitter site is in the middle of a residential area, so the property owner may have other (more financially rewarding) uses in mind for the land.

It will be interesting to see what impact there will be on Radio Disney KKDZ-1250, which shares the site with KARR at night."

DX LOGGINGS

590 KXSP NE Omaha – 2/1 1400 – Daytime DX, weak under KLBJ with ESPN sports news with Omaha given as location. (**JR-OK**)

590 WROW NY Albany – 2/12 2259 – Fair, dominating normally crowded frequency just before ToH, with nostalgia music, singing jingle LID into CBS news. I have heard this one with weak signals below WKZO and/or CJCL several times lately, but the singing ID's are hard to read. Tonight, no problem. NEW! **(BD-WI)**

610 KCSP MO Kansas City – 2/2 1410 – aytime DX with news and ads in the Kansas City area, weak under strong IBOC QRM. I thought I heard them ID as WDAF, their old call which I remember, having grown up in Kansas City. (JR-OK)

690 KGGF KS Coffeyville – 2/8 2031 – Open carrier, dead air obviously from my nearest, KGGF, allowing WLW IBOC noise to be heard unimpeded by ancient amplitude modulation. This *could* go on for hours and hours, as heard from KGGF in the past, e.g. during a ballgame except no ballgame, just the local commercial inserts; and OC overnight. I haven't bothered to log it lately, but it's still signing off with patriotic music other than NA, and taps shortly after 0100 (local midnight), but not cutting the carrier then. (GH-OK)

730 WZGV NC Cramerton – 2/12 0619 – Poor;-no CKDM, for a change. ESPN fare. "ESPN 730 Charlotte" at :25 past the hour. (**JJR-MI**)

810 WQIZ SC St. George – 2/12 0614 – Poor in WGY null. EWTN *Sunrise Morning Show*, nationwide weather report. Only EWTN affiliate. **(JJR-MI)**

850 WEI MA Boston – 2/11 2259 – Fair below KOA, with LID including slogans "ESPN 850" and "ESPN on WEEI" into ESPN Sports Center at ToH. NEW! A very big surprise. Although this station is 50 kW, its pattern throws almost all of its signal either to the northeast or out into the Atlantic. (BD-WI)

880 KLRG AR Sheridan – 2/11 0903 – "Gospel 880, KLRG and K233BF, 94.5 FM, Sheridan-Little Rock" (rather than KHAC despite NM/AZ on 770 and 660). WTFDA FM Database confirms the parallelism, but CoL of K233BF is really Greenbrier, with 185 watts. That's way north of LR beyond Conway AR on Hwy 65, and unlikely to reach LR at all. Of course, Sheridan is as far south of LR, but 50 kW daytime will certainly do the trick on 880. (GH-OK)

960 KNEB NE Scottsbluff – 2/7 0859 – "Bringing you the Farm and Ranch Expo February 7 and 8, this is 960 KNEB Scottsbluff-Gering, your trusted voice for news;" ABC news followed at 0900. Fair in QRM with local KRWZ-950 IBOC still turned off. (JW-CO)

970 WWRK SC Florence – 2/12 0611 – Fair & rather strong. "Swagga" radio slogans. Hip Hop/R&B music. Alone on freq. (JJR-MI)

1070 CHOK ON Sarnia – 2/13 2157 – Poor with weather for Eastern MI, with temperatures in both Centigrade and Fahrenheit, then quickly fading into some very weak UNID's. Usually either Wichita or Hannibal come in or rarely Indianapolis, although the only times I have gotten WFNI were in the morning. CHOK runs 10 kW with an airplane propeller pattern aimed NNW/SSE. Rare. **(JEL-MO)**

1110 KYKK NM Humble City – 2/14 0906 – Area news; call letter ID mentioning also 100.5 FM. Fair at best and mixing with a fading KFAB. **(JW-CO)**

1210 KGYN OK Guymon – 2/13 0841 – Ad for Macy's, so what's this? Surely not KGYN, no Macy's in little Guymon OK --- yes, it is KGYN, since next ad is local for mace! KGYN has been behaving itself lately, not really audible at night with null toward NYC. Official FCC February SR/SS is 0830/1930. It's also audible weakly on daytime groundwave. **(GH-OK)**

1350 KWMO MO Washington – 2/11 0705 – Poor; news sounder w/woman and "KWMO" clearly heard. In/out. (JJR-MI)

1380 KSRV OR Ontario – 2/11 1045 – With clear "Oldies 1380;" ID and music of that genre. (RS-UT)

1400 KCYK AZ Yuma – 2/11 1040 – "Outlaw Country," country music atop Las Vegas station. (RS-UT)

1410 WNWZ MI Grand Rapids – 2/11 0654 – Poor "More Music Mornings" ... Rite-Aid ad, 2 PSAs. "...from Grand Rapids, you are listening to 1410 on AM;" Once WGRD years ago, not heard here in years! **(JJR-MI)**

1410 CJWI PQ Montreal – 2/13 1918 – Poor signals fading up over CKSL with lady in French // their internet feed. Nice way to celebrate International Radio Day with a brand new catch! **(SMA-MB)**

1550 KUAZ AZ Tucson – 2/11 1055 – NPR programming well atop the frequency. **(RS-UT)**

1570 WWCK MI Flint - 2/13 0059 - Poor to fair, complete fade at times, some QRM from

suspected fellow MI station WFUR, with *The John Batchelor Show*, ad for michiganbacktowork.com, partially readable LID into ABC news at ToH. Partial legal included station's website URL supertalk1570.com (calls were readable, though not city). Night power is only 179 watts ND, not far below its 1 kw ND

daytime facilities. NEW! (BD-WI)

1580 KOKBOK Blackwell – 2/8 1937 – Talk about OSU basketball, during game? atop some QRMusic (MusiQRM?), so must be KOKB Blackwell, part of Triple Play Sports originating in Stillwater. BUT: its usual sibling, KOKP 1020 Perry is not //, instead Fox Sports Radio, and so is the third station, KOSB 105.1 FM, nominally Perry, which I can easily hear. Normally the three match, but optionally split away for games, especially when two or three are playing at once, but why put OSU BKB only on the farthest station from Stillwater, which is allegedly only 49 watts at night? O yeah, maybe a blackout in hometown. Website is down when I try to check on game schedules, as if I cared for any purpose but this log. 2/10 1637 – KOKB is dead air as heard on the car radio, enough carrier to quieten the channel compared to some neighbors modulating. Recheck about 24 hours later on Feb 11, it's back to sports talk. (GH-OK)

1600 KIVA NM Albuquerque – 2/12 1930 – Seemingly alone with string of local ads for hot tubs, Italian restaurant, etc. (**RS-UT**)

TX Waco – 2/6 1340 – Daytime DX, weak signal under electrical interference with ESPN sports news. The loop had to be oriented just right in azimuth and elevation to obtain reception. (JR-OK)

1680 WPRR MI Ada – 2/6 2200 – Political talk with right wing slant along with call ID and news. ID given as "Public Reality Radio." (JR-OK)

UNID

870 UNID -- 2/8 2027 – Country love song with WWL talker nulled, but fading. From NRC *AM Log*, best bet by format, proximity, direction and legal night operation is: KPRM Park Rapids MN, 40/1 kW. **(GH-OK)**

1680 WQOQ596 VA multiple locations – 2/10 0500 – Through WTTM open carrier; repeating message, "You are listening to V-Dot Highway Advisory Radio on 1680 AM ... license numbers WQOQ385 and WQOQ596 ... dial 511." **(BC-NH)**

CATCH THE DRIFT

1379.7 WFNW CT Naugatuck – 2/10 1550 – Loud het against 1380.0 WNRI with local 1370 WFEA nulled; Portuguese pop/folk music parallel web stream. Measured at 1379.714 kHz. (BC-NH)

LOGGINGS

560 WQAM FL Miami – 2/12 0000 – Fair; "WQAM Miami-Ft. Lauderdale, and WPOW HD2 Miami, download the iRadioNow app at WQAM dot com," and CBS Sports Radio sports flash. **(BC-NH)**

KWTO MO Springfield – 2/12 0059 – On top of channel with nobody challenging them. Promo for Mon-Sat show on "KWTO Springfield-??" then into CBS news. New log. **(FV-OH)**

600 WREC TN Memphis – 2/12 0059 – Very tough copy, with occasional QRN. After playing it back a few times I could hear "EC Memphis" and then into what sounded like the Fox Radio News theme. New log. **(FV-OH)**

CKAT ON North Bay – 2/10 0601 – Good; "Today's best country, Country 600 CKAT North Bay," and "Today's best country, Country 600 CKAT, North Bay's news and sports leader," into local news. (BC-NH)

MO Saint Louis – 2/12 0059 – Good copy of KYFI alone on channel with ID, "You've found the right station for B.B.N. KYFI, St. Louis," then into gospel song. **(FV-OH)**

720 WHYF PA Shiremanstown – 2/9 1659 – In WGN mix with EWTN religious programming, man with "Sharing our faith ... AM 7-20 WHYF Shiremanstown Harrisburg ..." ToH ID. **(KK-VA)**

730 WJTO ME Bath – 2/12 1640 – "Chanson d'Amour," "Rock and Roll Waltz," other oldies mixed with CKAC, WACE, and others, very weak signal, cluster format is characteristic of this station, signal gone before owner (and NRC Member) Bob

- Bittner's classic legal ID at the top of the hour featuring seagulls and the sound of surf, a first for me! **(TF-NH)**
- WZGV NC Cramerton 2/9 1625 Presumed in WTNT/CKAC mix with Clemson Tigers v. Syracuse Orangemen college basketball game. (KK-VA)
- **740 WNOP KY Newport** 2/9 1759 In CFZN, WRNR and oldies (probably WMBG) mix with religious singing, male "this is Sacred Heart Radio 7-40 WNOP Newport ... online and mobile streaming at sacredheartradio.com" ToH ID. **(KK-VA)**

- 870 **CUBA** *R.Reloj*, multiple sites FEB 12 0300 Good; "Radio Reloj," beep, "Exactamente diez de la noche, en el año 56 de la revolución transmite Radio Reloj, desde la Habana, Cuba." [Conti-NH]
- 1040 **CUBA** unID FEB 12 1100 In a jumble of signals; Cuban wobbling and choral national anthem. *R.Mayabeque* the only Cuban listed on 1040 kHz. [Conti-NH]
- MEXICO XEMR Monterrey, NL FEB 10 1350 I am trying again to hear any Spanish from Kansas City. There is dominant Spanish here but considerable interference, which could be from KC, but more likely from opposite XEMR, which is holding up later than usual today. - MEXICO unID FEB 9 1158 Anthem up, damaged by WAVS power up. FEB 10 1150 Mexi-tune, anthem from 1156-1159, with another weaker Mexican beginning the anthem just as this one was ending. Unable to copy any IDs. [Krueger-FL]
- 1210 **CUBA** *R.Rebelde*, Chivirico, Santiago de Cuba FEB 9 1212 About a second behind the strongest 1180 *R.Rebelde*. [Krueger-FL]

Our frequency is 4760 kilo Hertz on the 60 meter shortwave band. – Moses Nyantee," but this leaves me along with my 1566 story. Maybe a take over from TWR and ELWA is not aware of it? [Stefan Schliephacke, MWC via Jim Renfrew]

SPAIN: *COPE* Puertollano, Ciudad Real, had closed its medium wave transmitter due to electricity costs. The 5 kW transmitter with call sign EAK-23 was broadcasting on 1134 kHz. This network continues having MW coverage in this province through the main Ciudad Real outlet of *COPE* (EAK-22, 1269 kHz, 10 kW), as well on 97.5 FM. [Guillermo Sáez, mediumwave.info via Jim Renfrew]

SPAIN: *Radio Inter*, EAJ-29, 918 kHz from Madrid, Spain, is being observed broadcasting since 2200 UTC (23 hours local) China Radio International in Spanish, but not parallel with short wave 7210, 7250, and 9645 kHz. 
