State of the NRC Report

Allow me to introduce myself, especially to newer members who may not know me. I've been an NRC member since March, 1975. My first official NRC duty was when I volunteered to do the "International DX Achievements" column and run the awards program (which has since disappeared). I served for a few years as "Musings of the Members" editor, and then I became publisher in 1988, hosted a convention in 1989, and continued to publish DXN for some 22 years. Before I retired from 34 years of teaching (English, Spanish, journalism), I started writing young adult novels and now have eight self-published e-books up on various venues.

My health. Most of you know that I'm dealing with cancer. On January 21 I had half of my colon removed (which made me an ex-English teacher with a semi-colon) and am now undergoing chemo treatments to control the cancer which metastized from my colon to my liver. The prognosis is "good," and I don't foresee my health being a factor in my ability to head this group and make rational decisions.

In fact, I've suggested to all NRC BoD members to be thinking of BoD replacements in the future. None of us is getting younger, and I've always been an advocate of "young" blood to bring in new ideas.

NRC Convention? It's getting a little late, but not too late for someone to step up and volunteer. Seriously, if I can do it, you can, too. Ideally, two people and possibly more would be needed to run a convention, especially if you downsized it a bit from what we've had in previous years. If you volunteer – we'll guide you through the steps. Ernie Wesolowski has an excellent guide, and a number of us can answer questions. The minimum convention would include arranging for a meeting place/hotel, a time span from perhaps Friday night through Sunday morning, a banquet Saturday night (with or without speaker) plus the business meeting and auction that evening, and maybe the quiz on Sunday morning. Tours, assembling goodie bags, and other time-consuming events I'd consider as optional, and frankly if we could all sit around and chew the fat all day Saturday, I'd be happy. Merger? The NRC listserv had a recent lively discussion about IRCA and the NRC merging, probably because this year is the 50th anniversary of the formation of that club (congratulations!). And ... not going to happen, not as an equal with compromises, anyway. IRCA is a strictly democratic organization; the NRC has traditionally been run as a corporation (and indeed is incorporated in the State of Kentucky), with the Board of Directors making decisions as needed. I estimate that all but about 25-30 of IRCA's members are also NRC members, but a handful of them traditionally have expressed great distress during any talks about mergers. Frankly, I've enjoyed my membership in IRCA (since about 1979) and feel that both clubs are unique enough to offer choices to those who join either or both and am against a so-called merger, as such. Finally, if the BoD of IRCA wants to talk merger, we're happy to accept their offer to discuss.

So, who's doing what? Wayne Heinen has handed leadership duties to me, but don't call me "boss" nor Topeka "HQ." We're still diversified. Wayne will continue to handle subscription/membership duties, archiving past copies of "DX News" and posting them on e-DXN.com, NRC Publications (although he would like to see someone take over these duties), product sales and PayPal duties, Internet hardware liaison (to host the listserv, nrcdxas and e-DXN), and editing the NRC AM Log. Kraig Krist is now fully in charge of e-DXN and the NRC listserv.

Tests coordinator. Currently, the NRC and IRCA are looking for a joint test coordinator who would be a member of both clubs. The coordinator should be able to contact stations, explain the nature of tests, and follow up on and validate all test activities with qualified station personnel. News of all tests should be sent to the NRC DXN editor and posted directly on e-DXN in a timely matter. If you're interested, you should send a simultaneous request to myself and IRCA's President: Phil Bytheway phil tekno@yahoo.com.

College sports editor. We need one. Apply to David Yocis @ NRCDXNews@gmail.com.

e-DXN. We are going to streamline e-DXN, removing or combining some redundant forums and adding several. For example "Formats" has been incorporated into "AM Switch," so the "Formats" forum will be removed.

Veries to be scanned. We could use several more volunteers to help scan veries to be displayed on nrcdxas.org. Apply directly to Wayne Heinen: sales@nrcdxas.org.

My philosophy. The buck stops here. I'm as transparent as I can be. I delegate as needed to the responsible person – editor, BoD member, whatever. I communicate quickly (best way to contact me is via e-mail: plsBCBDXER@aol.com. I don't argue, but I'll be happy to discuss. I know where the skeletons are. As I stated above, don't call me "boss"; I'm a leader but more of a coordinator and facilitator. Finally, let me know if you have new ideas; if they simply aren't viable, we'll move on to new ones.



780 KCEG CO Fountain – 3/9 0232 – ID announcement: "This is KCEG, AM-780, Fountain, Colorado, your radio ranch;" into promo for "Old Country Church" then CWM mx. Mixing w/WBBM. Fair to good. **(RV-TX)**

790 KNST AZ Tucson – 3/8, 1954 – *Cigar Dave* program, local ads, TOH ID and into Fox news, local news and station promos. Fair-poor in shadow of local blowtorch XEROK-800. **(RV-TX)**

810 KLVZ CO Brighton – 3/8 1933 – Promo for *Channel Mom* program; "...on the place where loves lives, KLVZ." and into more promos, all ending as described above. Fair in peaks mixing w/unID SS. (RV-TX)

- **810** WHB MO Kansas City 3/8 1927 Local ads for Metcalf Bank, Robert Brogdan Buick-GMC, and Grand Summit Golf & CC. Gone at 1929 with presumed power change. It was relatively a boomer while it lasted. (RV-TX)
- **810 WGY NY Schenectady** 3/14 0400 Accuweather and traffic report, news. ID: "Newstalk AM 810 WGY." **(DBJ-TN)**
- **830 KFLT AZ Tucson** 3/9 0948 Music, then "Family Life Radio" ID, i.e. KFLT Tucson AZ, 50/1 kW U2, which is now officially on ND day pattern after 0930 in March. 770, KKOB Albuquerque also still in. **(GH-OK)**
- **830 KUYO WY Evansville** 3/14 0859 Casper ad; legal ID at 0859:57: "Classic Christian Radio KUYO Evansville-Casper"; SRN news came next. Fair signal in WCCO null. (JW-CO)

- 980 KMIN NM Grants 3/3 1003 "Country Morning Show on K-Mine, 980 AM or 96.7 FM" and webcast on http://kminecountry.com "tell your family, friends, lover(s), wherever your are, Moriarty, New Mexico or Hobart(?), Oklahoma; request line 505-285-5598. Website has a station history, photos of staff and equipment. This is KMIN, Grants NM, west of Albuquerque on the way to Gallup. 980 is 5000/230 U1, well into daytime now, while 96.7 is K244DT, also in Grants. I was thinking this station had maneuvered to get into Albuquerque via some relay. "Mine" refers to uranium mines in the area, once a mainstay of the local economy despite a few health hazards. Actually, I was checking for a closer 980 enchanter, KICA Clovis NM, reported recently reactivated as an ESPN outlet duplicating 1010 KTNZ Amarillo TX -- but no sign now of KICA, which is 1400 watts day, also non-directional. (GH-OK)
- **1010 WKJW NC Black Mountain** 3/14 0732 Fair @30/9. Obits w/many Black Mountain, Ashville announcements. Dominating. (**JJR-WI**)
- **1080 KGVY AZ Green Valley** 3/1 0855 "Classic Rock 105, The Cackle"? Not sure of last word. Always fun to hear music on 1080 overcoming KRLD talk, like nostalgic Green Valley AZ; just after 1400 UT full ID as "Rockin' the Castle Valley, 105, KSLL is rockin", atop KRLD, and then "Black Betty" song. **(GH-OK)**
- 1080 KSLL UT Price 3/1 0855 10 kW daytimer // translator which gets top billing! K285AB 104.9 per NRC AM Log; Castle is spelt Kastle there, and it employs AM stereo. Apparently unrelated to plain old KSL, but the similar identity can't hurt. It's a new month with everyone's sunrise shifting half an hour to half a sesquihour earlier than in February, in this case officially 0830. Price area, between Provo and Green River on US 6, is known as Castle Country (with Cs), evidently inspired by rock formations rather than Mormon fortifications: http://www.castlecountry.com/ My learning experience from this log. (GH-OK)
- 1090 KMXA CO Aurora 3/1 0857 Poor signal with romantic music in Spanish, looping NW/SE which rather rules out Mexico, but fits perfectly for format and direction of KMXA; 50/0.5 kW, whose official March sunrise is already 0815, so should have been solider thence? No, day pattern exhibits two lobes/wings to the west and northeast, "nothing" toward us (while tinier night pattern goes WNW). (GH-OK)
- 1110 KYKK MN Humble City 3/5 0845 IRN USA Sports for a triminute, the middle one being a work-from-home ad. This with KFAB tightly nulled. 0848 back to some talk show, about Twitter. 0855 "KYKK weather forecast", so as suspected in my previous log it's this Humble City NM 5 kW ND daytimer (Hobbs market, SE corner of NM). Presumably named after a now defunct Permian oil company which eventually led to Exxon. (GH-OK)

Weatherford is in the Dallas area. New! (JELMO)

- **1280** WTMY FL Sarasota 3/13 2100 Oldies music; several IDs heard: "AM 1280 WTMW." New format? (DBJ-TN)
- **1290 KUMA OR Pendleton** 3/17 2358 Ad for Morrow County Grain Growers, followed by two more local ads; legal ID at 2359:50: "Local and national news...if it's news, you'll hear it here...News Talk 1290 KUMA Pendleton;" ABC news followed at ToH. Fair in QRM. **(JW-CO)**
- **1290 KIVY TX Crockett** 3/17 2208 Nostalgia tunes, occasional call letter ID. In and out (mostly out) over the next hour, mixing with several. (JW-CO)
- **OK Clinton** 3/6 0859 Program for sporting event "on our sister station Coyote Country 95.5," then a mention of newstalkkcli.com; legal ID at 0859:54 by male voice: "News, opinions, and ?? KCLI AM-FM Clinton-Cordell, NewsTalk KCLI," followed by Fox news. Fair in the noise. **(JW-CO)**
- **SD** Sioux Falls 3/10 2059 Good, way over a couple of weaker UNID's with CL, city, mention of two FMs, News Talk. Their 5 KW night pattern has a major null in our direction so they may have been on day power. Rare. (JEL-MO)
- **TX** Cameron 3/13 0900 Fair signal, on top of the channel mixed with KCKM, then into multi station ID as KRZI Waco,1660 Waco, KTON Cameron with ESPN Network. Run overnight recordings on this frequency, all I heard was unwanted KNSS, KS and a couple of Mexicans, but no firm ID on either. (JN-TX)

I can hear KCKM just about any morning as its 12 kW daytime ND gets out very well despite much closer and daytime groundwaver KNSS Wichita KS. Official SR/SS in March are 0900/2100 EDT, as it's way west of the meridian and should be in the MST zone UT -7 instead of CDT UT -5. I'm checking it out today as prelude to the big DX test scheduled with same day facilities, 3/22 at 0100-0130. This test is a direct outgrowth of an unsolicited verie I got from KCKM last year. (GH-OK)
- **1410 WIHM IL Taylorsville** 3/14 0600 ID EWTN Radio, into Catholic ETWN programming. **(DBJ-TN)**
- **1490 KTOP KS Topeka** 3/5 0201 CBS Sports Radio is atop the pileup and looping NE/SW. Likely one of my closest, listed as on that network, KTOP. **(GH-OK)**
- 1500 KPGM OK Pawhuska 2/28 0952 I am checking the daytime occupant, KPGM, and find it to be running 7 seconds *ahead* of source // 98.1 WWLS-FM OKC (or rather COL suburb The Village -- where I lived 1954-1961y), so KPGM is in the WWLS Sports Animal sphere of influence rather than that of closer KYAL Tulsa; usual weak marginal 1500 signal. WWLS ID in passing heard on 1500, then at 0954 UT, KPGM ID as Pawhuska-Bartlesville, consult http://bartlesvilleradio.com where it's obvious this cluster has the local market

tied up, also with the 1400, 100.1, 104.9 stations, plus Classical Bartlesville on HD2 of KYFM 100.1! **(GH-OK)**

- **1530 WCKY OH Cincinnati** 3/9 2130 ESPN programming, then ID as "Cincinnati ESPN 1530." Station calls not heard. Fairly good signal. Have not heard this station for a long time. **(GH-KS)**
- 1550 KUAZ AZ Tucson 3/3 0910 Cokie Roberts & Linda Wertheimer discussing politics, so 100% sure it is a rare NPR station on AM, KUAZ Tucson AZ, a 50 kW ND daytimer, whose March hours are 1330-0130 UT. Looking thru KUAZ' correspondence file at FCC AM Query, UA notified that they were starting IBOC on May 13, 2010. NRC AM Log 2013 does not show it now as IBOC. Nor on the topazdesigns.com roster, not even formerly. I did not notice any IBOC noise around 1537 or 1563, but was not looking for it at the time. KUAZ also has a PSRA of 39 Watts from Oct thru March, N/A the other months as already on from 6 am local with full power; limiting station being XEBG which is 10/1 kW in Tijuana per IRCA. KUAZ also has PSSA of 39 watts every month, as late as 0330 UT in March, 0430 UT in June and July. (GH-OK)
- **1550 KXEX CA Fresno** 3/15 0900 Simple legal ID in English a few seconds past ToH; not sure what followed. Poor in the mix. **(JW-CO)**
- **1550** KDCC KS Dodge City 3/15 0859 Gal with legal ID, followed by Fox news. Fair in QRM. (JW-CO)
- **1550 WDLR OH Delaware** 3/12 0651 Poor "QT1270 + WDLR" announcements over & over. Weather: high in 50s. Two jocks. **(JJR-WI)**
- **1560 KGOW TX Bellaire** 3/11 0748 Fair though steady, on top. "Texas Ford Dealers, Yahoo Sports Radio 1560" back to Yahoo content. **(JJR-WI)**
- **1590 WRCY IN Mount Vernon** 3/14 0656 Poor; steady upon tune-in. "1590 WRCY" into Ring of Fire/Johnny Cash. No WAKR which has always dominated. Second new 1590 in 2 days! OLD C&W NEW! (JJR-WI)
- **1590 WKTP TN Jonesborough** 3/12 2346 Poor though up upon tune in "ESPN Tri Cities" into ESPN fare. Hung around for TOH, but never heard ID. WAKR not as strong as I've been used to. Almost dismissed as ESPN on WPVL. Glad I stuck around. NEW! **(JJR-WI)** *This one has been running ND with reduced power for a while now, but probably for not much longer get 'em while you can. DY*.
- 1650 KBJD CO Denver 3/18 0825 Always on the lookout for elusive XEARZ, Radio ZER near the DF, I am getting Spanish so listen a while: plug for Iglesia Alfa y Omega en Miami, Florida; loops NW/SE, "16-50 AM" ID, QRM, then plugs a location on Cherry Street, i.e. Denver's KBJD which is Spanish religion, rather than El Paso's KSVE with ESPN Deportes. (GH-OK)
- **1720 Undercover Radio** 3/9 0213 Poor signals with some music and ID. Thanks to the HF Underground for postings so I knew when they were on. http://www.hfunderground.com/board/index.php/board,3.0.html is the web site that is of great help for Shortwave and AM Pirate stations. First time heard here. New. **(SMA-MB)**

- 1190 UNID -- 3/2 0906 Female Spanish report on drugs in Sinaloa, interjecting "Milenio"; loops E-W; guess could be XEPZ Juárez --- but then at 1409 UT a CST TC as 8:09, so that's out. US station? KNUV Tolleson AZ is SS, but also in MST zone; heard before, might be that with a network TC from the Center. Per NRC AM Log, only other 1190 SS is WMEJ, 5 kW daytimer in Mississippi, a bit late for that. (GH-OK)
- 1500 UNID -- 3/1 2034 Interesting music I find when nulling KSTP, lingering ~5 Hz SAH, sounds like K-pop or J-pop, but fading. Looking thru NRC AM Log, the only ETHnic (Asian) station possible would be KSJX, all the way from San José, CA! It's 10/5 kW U4, day pattern with a considerable lobe eastward, night pattern with a deep cardioid null toward KSTP (which aims westward to protect WFED), official March KSJX sunset is not until 0215 UT, yet high-end at month-begin should be skywavable eastward by now as real SJ sunset today is only 0202 UT. Googling indicates KSJX is primarily Vietnamese, but http://mrbi.net lists it as Vietnamese/Other, and very few of the Multicultural group stations have own websites for any further research. Could the SAH be a clue? It's usually dissatisfying to consult http://www.myradiobase.de/mediumwave/mwoffset.txt as despite its length, it's worldwide and far from

complete as to US stations, in fact only 6 of them on the list at 1500, but does include these two: KSJX at 1499.9994 and KSTP at 1500.0014; i.e., only 2.1 Hz apart, but the KSJX reading is from 5+ years ago. (GH-OK)

1560 UNID -- 3/3 0912 – "I Shall Not Be Moved" (or was it We--?), styled as if it were a Christian hymn rather than a Civil Rights anthem; loops NE/SW, no problem yet from OKC comedy, but fading out as the song ends. Most likely KLNG Council Bluffs IA, 10 kW ND daytime, which is religious, but there are also some MO and TX stations, and in KS, KABI Abilene which is NOS. (GH-OK)

I joined the NRC in the mid 1980's and, except from a brief 2 year absence around 1989, I have renewed every year. I grew up in Wheeling WV and was bitten by the AM radio listening bug in my early 1960s HS days after accidentally tuning into LSU Tiger FB on WWL 870KHz. After college I taught HS Mathematics for a year and then (mostly in the Washington DC area) worked in various IBM mainframe (+ other vendor's) computer analysis and SW application development jobs until 2007 when I took early retirement. Although I requested a few dozen DX confirmations in my early radio listening days, I am mostly a just a listener to MW AM news, conversation, and sports. My favorite DX news columns are AM Switch, DX Toolbox, Domestic DX East&West. I also enjoy reading the Musings and other various news articles. Since, in recent years, the NRC started disclosing radio related websites I have used them along with e-DXN to compliment my paper copy of DX News. Although I use e-DXN occasionally, I would like to use it a lot more, but I must confess that I have had trouble figuring out how to use its capabilities to greater advantage. I mostly just browse the e-DXN material.

Regarding listener's reception reports, Musings, and other information published in DX News, I would like to see more mention and use of some details contained in the FCC internet sources. These include the azimuth angle from the tower site to the listener's location, the corresponding signal strength (in mv/m) directed along that azimuth, the equivalent ERP (this would be calculated from the mv/m value), the great circle distance from tower to listener's location, the percentage of signal path's length that travels over water etc. I intend to include some of these details in my future DX News inputs.

NOAA Space Weather Outlook

Issued March 17, 2014 – For the period March 17-April 12, 2014

Solar activity is expected to be low with a chance for M-class activity through 26 Mar. Moderate levels are likely with a slight chance for X-class activity from 26 Mar through the remainder of the period as old Region 1996 (N14, L=052) returns to the visible disk followed by the return of Region 2002 (S19, L=326).

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be {sic}.

Geomagnetic field activity is expected to be quiet to unsettled on 17 - 18 Mar due to anticipated coronal hole high speed stream (CH HSS) activity. Mostly quiet conditions are expected from 19 - 29 Mar. Quiet to unsettled conditions are expected from 30 Mar to 01 Apr due to recurrent negative Bz. The remainder of the period is expected to be quiet with the exception of 09 Apr, which is expected to see quiet to unsettled conditions due to effects from a recurrent CH HSS.

- MEXICO XEUDO Los Mochis, Sin. MAR 9 0125 Spanish ballads, "Radio U de O Universidad de Occidente" slogan and parallel XHUDO 89.3 FM. Sudden change in strength at 0127 (power change?). Poor overall. [Vance-TX]
- **MEXICO** XEIK Piedras Negras, Coah. MAR 9 0030 Spanish pop music, ID for XHIK 96.7 FM (no AM callsign) and "Radio Zocalo" slogan, then into ads. Fair. [Vance-TX]
- MEXICO XENL Monterrey, NL MAR 18 1208 Between songs gives quick phone number, "llámenos"; romantic music, 1212 PSA string starting with "un minuto contra el cáncer" with unminuto.com website which forwards to 1minuto.org sponsored by INCan = Instituto Nacional de Cancerología --- then something in Monterrey, federales for some Consejo, and the Senado; jingles I can't understand but one sounds like "Radio A." Cantú shows it's XENL *R.Recuerdo*, Monterrey NL, 5/2 kW. Has overcome interference including nearby KKOW Kansas. [Hauser-OK]
- 939.88 **MEXICO** XEQ Mexico, DF MAR 19 1000 Good; jocular talk, "la mera mera," through the hour with truck air horn sounded several times. [Conti-NH]
 - **MEXICO** XEFAMA Cd. Camargo, Chih. MAR 10 0502 During KGWA Enid Fox-hole of open carrier, mix of ABC News, which would be KGKL San Angelo and/or KMA Shenandoah, and a Mexican state anthem, the first few notes of which match the cadence of Chihuahua's. Therefore, presumed the only Chihuahuan on this frequency, XEFAMA, listed in IRCA as 10000/100 watts, but surely not on night power to be heard thusly. WRTH and Cantú show night power 1000 watts, which is more like it. Previously have IDed XEK Nuevo Laredo, but this was not the Tamaulipas anthem. 0500 UTC however would not be local midnite in Camargo which is still on MST of UTC-7 unlike Juárez on UTC-6 or -5 in N Laredo. Did not hear any Mexican national anthem before or after this. Sked may be skewed on local Sunday nights due to 'La Hora Nacional' which airs originally at 0400-0500 UTC Mondays = 10-11 p.m. CST/HCM. [Hauser-OK]

- MEXICO XEUAS Culiacán, Sin. MAR 16 0800 ID by a woman, "Radio Universidad A Sinaloa" ('A' stands for Autonoma) during dead-air period of local KHRO-Fox AM. Looks like Sr. Hauser isn't the only one lucky enough to have a 'Fox hole'. [Vance-TX]
- MEXICO XEQIN San Quintín, BCN MAR 11 1500 Well after sunrise, presumably the Spanish station atop (300 mile north) powerhouse KSL. This is a 10 kW daytimer, south of Ensenada. Don't know who else it would be at that time. About 510 miles southwest of St. George, Utah. At same moment 1000 KOMO Seattle still booming in at 850 miles. Will try again to ID. [Schiller-UT]
- 1390 **MEXICO** XEKT Tecate, BCN MAR 9 0833 Norteño music, ID with callsign, location, and XHKT 88.5 FM parallel. Poor to fair when above the pile. [Vance-TX]
- BAHAMAS ZNS1 *R.Bahamas*, Nassau, New Providence MAR 13 0004 Bahamian-accented enthusiastic preacher, male live "You're listening to... This is AM 1540, the National Voice of the Bahamas" at 0128. Worth noting the preacher was on a local Tuesday early evening. [Krueger-FL]
- MEXICO XEARZ Zer Radio, México DF MAR 15 1050 Easy listening guitar solo, 5 + 1 time sounders at 1100. Clarinet solo cover of "I Left My Heart In San Francisco" then a few seconds of male announcer in Spanish at 1106 and back to more instrumentals including a cover of Wham! "Careless Whisper" and Kenny G "Going Home" (original version). At 1130, male canned, "XEARZ Zer Radio... 5000 watts de potencia... Ciudad de México," then into another easy listening instrumental. Slight WHKT co-channel. MAR 14 1100 Instrumental but very weak with WHKT and the Tampa I-275 HAR dominating the channel. First log of this one for me, and a surprise. [Krueger-FL]
- **MEXICO** unID MAR 18 1245 As I am monitoring KKLF which has just flipped from 24/7 1700 comedia en inglés to Tejano, I am very surprised to hear some unmistakable notes of the Mexican national anthem, "Mexicanos al grito de guerra," mixed with the music from KKLF. No Mexicans are known on 1700 except in BCN, which functions as a U.S. station with sports in English, and this is not from the west. Quarter-hour is also a very odd time for any Mexican to be national-antheming, unless it's signing on/off. Strongly suspect we have a new XE on 1700 kHz! KVNS Brownsville is coming in well even later than this, so Mexico westward from that longitude should also be propagable. MEXICO: The *Traveler's Guide to American Catholic Radio* lists 790 XEVA *R.Maria*, Villahermosa, Tab., 920 XELT *R.Maria*, Guadalajara, Jal., 1110 XEWR *EWTN* Cd. Juarez, Chih., and 1700 XEFCSM *R.Maria*, Mérida, Yuc. along with several FM stations. Overt religious, including Catholic broadcasting is supposedly prohibited in México. Per Israel González Ahumada, the Mexican government has been very restrictive, so it is probable that this station is registered as a civic association, not a religious association. Several religious organizations in the past invested in cultural groups in order to operate without governmental harassment. [Glenn Hauser, *DX Listening Digest*]

UNITED KINGDOM: Changes affecting the "Gold" network. From 24 March 2014, *Gold* will only be available on four MW frequencies: 945 Derby, 999 Nottingham, 1458 Manchester, and 1548 London. Missing the glory days of Top 40 radio

I got to thinking the other day how radio has changed over the years. Not that the subject is ever very far from my mind.

I grew up in what might be called the glory days of at least two formats, old enough to remember both Top 40 radio at its best, as well as what was once called "progressive" and later "album-oriented" rock radio at the height of that format's popularity. So I know that every time I write a column regarding what I like about radio, or perhaps more accurately what I miss about radio, I am dating myself.

Not as much as I could, though, as Top 40 actually had a renaissance in the early 1980s when stations like Chuck Martin's K-WEST 106 (now KPWR, 105.9 FM) or Gerry DeFrancesco's KIIS-FM (102.7) adopted the format.

Both stations were great examples of Top 40 radio; while K-WEST didn't make it, KIIS-FM shook up the industry with its amazing success, including ratings of over a 10 share, compared with what was then and is now again considered successful: anything over a 3 percent share of the audience.

Aside from my memory and my rose-colored glasses, there are elements of radio that truly have been lost. Things that I miss, that I believe were some of the reasons that radio was once so important to generations of kids, are now so very not.

Do kids listen to radio? Certainly, yes. Do they love radio and identify with any station? Hardly. So here are things I wish radio would do better or do more often:

- First: I wish more stations would play music on AM radio. Stations I loved growing up included some Top 40 greats: KHJ, KRLA, KEZY. And there was even AOR, such as when Dave Forman took KEZY into an AOR/alternative format. Music can sound good on AM with a clean signal and a good radio.
- I miss call letters. The great stations of the past all had them: the already mentioned KHJ, KRLA and KEZY. And there are obviously more: KMET, KLOS. Yes, many stations still use calls, but the trend here and nationwide is to use "clever" names: Hot 92.3. Power 106. My-FM. Whatever 98.7 calls itself now. Names are OK, but they lack something in my mind. Even UCLA's student campus station KLA lost all of its history and respect when it decided to call itself "Bruin Radio." Yuck.
- I miss entertaining DJs, or more accurately, DJs who were allowed to entertain. The jocks on KHJ and KMET were all-important friends to us growing up. Does anyone even know the name of the afternoon drive DJ on a typical station today? Why can't the Sound's talented on-air staff talk about the records they play instead of a mystery voice?
- I miss weather reports. And surf reports.
- I may be alone here, but I miss news on stations other than news and talk stations. News that was important to teens and young adults is one of the reasons that KMET connected so well to its audience when Sam Bellamy programmed the station. And one reason why KMET is so fondly remembered 28 years after it left the air.
- DJs who were allowed to talk about things without a music bed under them. It used to be called "clutter" when you had unimportant elements in the way of programming; now it is the way it's done. Are we listeners that impaired that we need music playing while the DJ tells us the details of the upcoming hour of programming?
- What about real competition? KMET would pass out bumper stickers at a concert sponsored by KLOS. KHJ would fly a banner over an event sponsored by KRLA. Stations would try to scoop each other in getting the latest record from the hot artists. Those competitive rivalries made radio fun for the listeners, and for the station DJs and staff as well.
- Fun, easy to win contests. My friend Jeff Holyfield and I still talk of the time he won WAM
 — Walking Around Money from Ten-Q in the 1970s calling in from a rotary-dial phone.
 Everything now is so convoluted, it loses its fun factor. Makes you wonder if today's
 programmers ever even heard what I would consider good radio.

Jeff was lucky, of course; my parents wouldn't let me dial long distance, anyway.

I have more wishes for radio, and I am sure you do too. Let's compare notes ... send an email to me.
