#### **CALL LETTER CHANGES**

The buyers of WMSK-1550 Morganfield KY have reserved WUCO for when the sale is complete. No changes these last two weeks, so our remaining 3-letter calls are all still safe! Dave Schmidt notes that the WIP calls are not gone, as they remain on WIP-FM-94.1, but the AM is now WTEL, as we reported last time. WTEL is of course an historic Philadelphia callsign too, on 860 kHz until 1998 (and again briefly in 2000), but still ....

Santa's list got longer Monday (12/8) as Westwood One's syndicated Adult Standards format and the non-commercial Family Radio network both switched to all-Christmas formats. (These are expected to return to normal NOS and REL respectively after Christmas. –wwh)

Entercom Communications has purchased Lincoln Financial Media's fifteen stations for \$105 million. The properties included are: Atlanta - Hot AC "Star 94" WSTR and Sports "ESPN 790 The Zone" WQXI Denver - Country 98.5 KYGO, Comedy "Comedy 103.1" K276FK, Sports "104.3 The Fan" KKFN, Rhythmic CHR "KS 107.5," Oldies "Cruisin 950" KRWZ, and Sports "1600 The Zone" KEPN Miami - AC "101.5 Lite-FM" WLYF, Classic Hits "Magic 102.7" WMXJ, and Sports "104.3 The Ticket" 790 WAXY/104.3 WAXY-FM San Diego - Alternative "FM 94.9" KBZT, Country 97.3 KSON/92.1 KSOQ, and Soft AC "Easy 98.1" KIFM.

With Entercom already owning three FM's and one AM in Denver, the company intends to divest one FM to stay under ownership limits. The company will begin operating the Lincoln stations under a Time Brokerage Agreement in late January following Justice Department approval of the

**TX** Austin – 12/12 0937 – Talk about police using undercover officers to arrest protestors about police shootings. As a retired officer, I have heard enough of that subject, so tuned out. **(FO-OK)** 

**610 WAGG AL Birmingham** – 12/3 1825 – Fair, Christmas music, requests to #741-XXXX "at WAGG" and atop frequency. (JJR-WI)

610 WTEL PA Philadelphia – 12/14 1959 – Fair with light QRM, with the Sunday Night Football pregame show on the Eagles Football network, LID including slogan "Delaware Valley's 610." Needed recent call change. Gone from the Philadelphia AM dial is the heritage three-letter call WIP, after a constant local presence since 1922. The only consolation is the return of heritage Philadelphia calls WTEL which have been mostly on but sometimes off since 1930. (BD-WI)

**830 KLAA CA Orange** – 12/3 1917 – Talk about NFL players protest about the Ferguson, MO incident. ID at 1929, "AM 8-30, KLAA," ad for Orange County's premier advertising agency, REVENMEDIA.com, and ad for Computer Guys of OC. This is new one for me. **(FO-OK)** 

880 KHAC NM Tse Bonito – 12/5 0800 – Poor with moderate unID QRM, with a song by a male in unID language (most likely Navajo), into a legal ID in EE by a man who then began a reading from John chapter 1. This station has been on my most wanted list since several years back when they were staying on day power nights and being heard widely throughout the country. At that time my efforts were always being foiled by strong WCBS QRM. No problem this time while using the Double Kaz pointed west. NEW! Only New Mexico AM #5, the first new one using the Double Kaz. (BD-WI)

**900 KFLP TX Floydada** – 12/11 0812 – "All-Ag News," fading by 0818. Must be Floydada TX flagship of this minor network, KFLP, which once had a big dog relay here in

Enid, 1640 while it was known as KOAG, for less than a year, one of many successive formats that have FLoPped. Well, website its www.allagnews.com seems timely and with podcasts available, but nothing about any other stations relaying, so belay that about 'flagship.' KFLP itself is only 250 watts day, 7 watts (ha, ha) night. Official sunrise in December is not until 0845. FCC Correspondence File does show they have a PSRA of 3.0 watts(!) most of the year, surging to 6 or 5 watts in June and July, the "limiting station" being XEW! What's the point of a PSRA which is LOWER than the authorized night power? (2) XEW hardly needs any protection from Floydada considering there's now a station in between in

Monterrey NL plus four other XEs on 900, unclearing 900 for XEW's alleged 250 kW. (3) What's the point of ANY AM station running less than 10 watts, with loads of QRM on every channel at night? (**GH-OK**)

- 910 KCJB ND Minot 12/11 0816 Outro to American Story with Tom Brokaw, says it's on at 7:15 am and in the 1 and 5 pm hours [ergo cited in CST which inhabits NW ND, while the SW corner is on MST], then Minot ads, so it's KCJB getting out well again before sunrise. This 5 kW signal has opposite patterns day and night: SW and NE respectively, so must be on day pattern now, despite official December & January FCC sunrise not until 0930! Nothing in FCC Correspondence Folder about a PSRA. As for Tom's show, must be only a minute or two; first time I had almost heard it, but started over a year ago per: www.hollywoodreporter.com. Supposedly only on "select Clear Channel stations" including WOR and KFBK. No surprise he's heard from ND, his home state. (GH-OK)
- 930 KRKY CO Granby 12/5 1833 Fair to good in KYFR splash with "KRKY" and "101.9" clearly heard in local promo. (RD-NE)
- 930 KCCC NM Carlsbad 12/3 1847 Oldies, ID at 1850, "KCCC 9-30, Carlsbad's Pure Gold Station." (FO-OK)
- 960 KNDN NM Farmington 12/3 1832 EE ad for Walmart, then into Navajo talk. (FO-OK)
- 970 KIXL TX Del Valle 12/12 2300 Fair-good not strong but all alone with Relevant Radio 970 slogan and Del Valle announcement and then several people saying, "I'm a Texas Catholic." and into stuff about Lone Star State Catholics. (NK-IL)
- 980 KMIN NM Grants 12/3 1828 ID as "K-mine," ad for Furniture Zone, at 1829, talk about Grants Mainstay Project. Good evening for New Mexico stations here. (FOOK)
- 990 KRKS CO Denver 11/29 1021 Program about wekids.org program in Denver, SRN news at 1030, call letter ID at 1031. (FO-OK)
- **890 KRSL KS Russell** 12/10 1659 Poor but in the clear with C&W music, LID "Home to all the Country Classics, we are KRSL Russell, a White Communications station" into AP news at ToH. NEW! No sign whatsoever of CBW, a rare no show. This came 15 minutes before this 250 watter was scheduled to drop to 30 watt night power, so well timed as well. **(BD-WI)**
- **1010 WMOX MS Meridian** 11/30 1807 ID as "Meridian's Talk Radio, WMOX," then into talk about, guess what, the Ferguson incident. Nice surprise as not heard here often. **(FO-OK)**
- **MO Springfield** 12/7 1801 Poor, faded in to replace "The Mighty 1060" KNLV, with jazz music, LID back to music. NEW! I now have logged all six Springfield MO AM's, including both graveyarders. **(BD-WI)**
- **1070 KFTI KS Wichita** 12/3 1735 Fair "Classic Country 92.3" Mickey Gilley, ads 1740 drop 1742. No WTSO. (**JJR-WI**)
- 1080 WNWI IL Oak Lawn 12/5 0833 Talk in Polish, which is not something you hear every day around here! vs KRLD, loops NE/SW. It's the Chicago-market WNWI (address in Riverdale; both on the south side of Chicago), 3000/2600 watts U2. Night pattern goes north, day pattern ND. December & January sunrises are officially 0815. Also hearing Spanish on 1200 at this time over WOAI, i.e. WRTO Chicago, conversation about películas, presumably from Univisión América. BTW, for a 50 kW 'clear' less than 400 km away, KRLD 1080 is sometimes remarkably weak. Day pattern is ND, but we get more on cardioid night pattern with a deep null toward Hartford, even off the side of the heart. (GH-OK)
- Fox." Best heard with N/S KSAL KS nulled, but DF on this one is more like ENE/WSW. I hunt around for likelies: not Osage Beach MO, which is news/talk; could be KDEF Albuquerque reactivated? Nothing certain about that. KNED McAlester OK is country, and BTW website claims 1150 to be in stereo, not so indicated in the NRC AM Log. Finally find a match at KHRO El Paso TX, http://www.fox1150.com/. It's 5000/380 watts U1, i.e. always non-directional. FCC AM Query however, shows day hours in Dec are 0900-1900. No PSRA info. Enid Sunrise today: 0833, to reach 0843 in a month. (GH-OK)
- 1170 KYET AZ Golden Valley 12/12 0758 Henson Cargill's "Skip a Rope," followed by a "Cactus Country" slogan and more music; male voice with legal ID at 0802:20 "KYET Golden Valley, AM 1170 Stereo, Cactus Country your Classic Country station," followed by AP news. Fair/good over the next half-hour with a fading KFAQ nulled and semi-local KJJD not on yet. Obviously not on 1 watt night power, as they should have been. (JW-CO)

- **1230 WCDS KY Glasgow** 12/12 2200 Poor with call ID and city announcement thru mess. New! **(NK-IL)**
- **1250 KDEI TX Port Arthur** 12/13 2200 Fair and clear with gal giving Radio Maria network ID and list of stations. Not much QRM for a bit. Rare. **(NK-IL)**
- **1260 KWYR SD Winner** 12/3 1806 Fair with ABC news, Northern Ford.com, "Country 1260 for Winner/Chamberlain." (JJR-WI)
- **1280 WMCP TN Columbia** 12/9 1900 ID at top of hour; "This is 12-80, WMCP" and then faded away, but good enough for new one in the log. **(FO-OK)**
- **1290 WCBL KY Benton** 12/13 2100 Fair under huge pest WIRL with call ID after area ads. New! **(NK-IL)**
- **1310 CIWW ON Ottawa** 12/3 1806 Poor though WIBA nulled. "1310 News time 6:06," Canada news stories. **(JJR-WI)**
- 1370 KWTL ND Grand Forks 12/13 0959 Legal ID at 0959:50: "This is Deacon Nick Revere from St. William Parish in Twin Valley, Minnesota and you're listening to Real Presence Radio AM 1370 KWTL Grand Forks-East Grand Forks..." and into EWTN programming. Fair with not much QRM. (JW-CO)
- **1390 WZZB IN Seymour** 12/16 2017 Poor but in the clear for several minutes before being overwhelmed by WGRB, with girls' HS basketball game Trinity Lutheran (of Seymour) Lady Cougars vs. Austin Lady Eagles, Austin ahead 35-25 at start of third quarter. Station is 1 kw days, 74 watts nights. NEW! **(BD-WI)**
- **1410 KDKT ND Beulah** 12/10 0905 Weather forecast, call letter ID; then "...you're listening to the Dan Patrick Show on KDKT Sports Radio 1410...," and into the show. Fair but soon faded, with no sign of several closer stations. A new one here, ND #31. **(JW-CO)**
- **1410 WIZM WI La Crosse** 12/5 1859 Legal ID at 1859:55: "1410 WIZM La Crosse. Wizzem news time is 6:00" and into CBS news. Fair, mixing with a Spanish religious station, possibly KERI. (**JW-CO**)
- **1420** WOC IA Davenport 11/28 1800 Fox news, sports and call ID. (JR-OK)
- **1420 WACK NY Newark** 12/17 2359 Fair to good and in the clear with an ad for NAPA/Goebert Auto Supply of Newark and Lyons, LID "1420 WACK Newark with the best in talk and sports" into "Yahoo Sports Minute" sports newscast. Great night for eastern conditions, but still a real surprise to hear this one so loud in the clear. Station is directional day and night, 5 kw days 500w nights. NEW! **(BD-WI)**
- **1430 WYMC KY Mayfield** 12/13 2100 Fair-good in mess with call ID after oldies and 93.9 and Mayfield announcement. New! **(NK-IL)**
- **1430 WRDN WI Durand** 12/8 0755 Poor on a crowded band with quick fade-up call letter ID "You're listening to *WRDN Morning Farm Report*" into an ad for *The Country Today* ag newspaper ("The Country Today" offers more variety than any other agricultural newspaper in Wisconsin...). Semi-local WBEV was still on nighttime directional pattern at the time, so that helped bag this one. NEW! Wisconsin AM #105, leaving only seven to go. **(BD-WI)**
- 1450 KZZJ ND Rugby 12/1 1830 Atop with local sports report sponsored by North Star Community Credit Union and Rugby Lumber, both of Rugby. First time heard here in over 3 years. (RD-NE)
- **1470 KYYW TX Abilene** 12/11 1758 Geico ad, then legal ID: "News Talk 1470 KYYW is online with news and weather at 1470kyyw.com. KYYW Abilene." ABC news followed. Fair, briefly. **(JW-CO)**
- **1490 KXLQ IA Indianola** 11/18 1851 Fair with promo for Hawkeye Huddle sports talk program "Tuesdays from 5-6 on 1490 The Jock." The bed music for the promo was the Iowa Marching Band's rendition of "In Heaven There Is No Beer." **(RD-NE)** That's why we have to drink it here! DY.
- **MO Rolla** 11/19 2200 Atop with Missouri S&T (yes, that's the name of the college!) basketball vs. Univ. of Missouri-Kansas City. Confirmed via webstream. After being off since Monday evening 11/17, my local on 1490, KOMJ, returned to the air with the full 1 kW at 1713 ELT on Friday 11/21. The silence was nice while it lasted, as I am now in double digits on each of the 6 GY frequencies from here in South Omaha. **(RD-NE)**
- **1490 WJJM TN Lewisburg** 12/12 2200 Poor with call ID and city announcement atop. New! **(NK-IL)**
- **1490 KZZN TX Littlefield** 11/17 2259 Atop briefly with C&W song, then ID: "This is KZZN, Littlefield, the Voice of Lamb County." Station picked a great time to

surface! 2nd Texas graveyarder at this QTH, and my best logging so far this season. **(RD-NE)** 11/26 1645 – Very weak in loop null of KMFS (Guthrie, OK). C&W music with commercial for Littlefield area. Lost in fade out very soon after. **(JR-OK)** 

**1490 KCPX UT Spanish Valley** – 11/26 2120 – Weak and fading. Only caught ID then signal was lost. New here **(JR-OK)** 

1510 WLAC TN Nashville – 12/9 1800 – On car radio, just as I tune in, the het from always-off-frequency KCTE Independence MO goes off as it must have complied with nighttime shutdown, after mentioning ABC Sports? (Do they now have a dedicated sports radio network too?), leaving the channel to ESPN which would be WLAC. KCTE's official daytime hours in Dec are 0830-1800. (GHOK)

1540 KXEL IA Waterloo – 12/14 0846 – Phones, address and website for Assemblies of Yahweh being given from NE/SW. Obviously it's KXEL in Waterloo IA, which is on the few-station roster as of Oct 2013 at assembliesofyahweh.com but at a different time, Sundays at 11:30-12:00 pm [CST] whatever that meant, before noon or before midnight? KXEL's web site does not provide a plain old program schedule, just a bunch of secular talk shows without giving the times! WMLK may have been off shortwave 9265 for years and years, but we can still hear defunct Elder Jacob O. Meyer? or his successor with a similar voice/accent. The only other US stations are WWSM-1510 Lebanon PA; KBXD-1480 Dallas TX; WWVA-1170 Wheeling WV; KAAY-1090 Little Rock AR. (GH-OK)

**1550 WDLR OH Delaware** – 12/3 1902 – Poor with CBEF nulled. OLDies which faded at ID time. 1902 ad for dehumidifier and nice "WDLR" into oldie. **(JJR-WI)** 

1550 KMAD OK Madill – 12/8 1315 – C&W music in phase null of KYAL (Sapulpa, OK) with ads for Ardmore which is close to Madill. KYAL was

fading in/out making reception difficult. IDs as KICM. New here. This unreported station has now been heard. (JR-OK)

**1570 KZLI OK Catoosa** – 12/8 1345 – Call in health talk with Tulsa and OK city weather. New here. **(JR-OK)** 

**1570 WTRB TN Ripley** – 11/26 2140 – C&W with call ID. I heard this station before in 2004. (JR-OK)

1590 KGFK MN East Grand Forks – 12/15 0138 – As I tune by, immediately hear ID as "95-7 The Force" (?), but searching this leads nowhere on the WTFDA FM database, nor Googling. The answer is in the NRC AM Log, searching 1590 by eye, line by line, to find: KGFK East Grand Forks MN, U4 5000/1000, is // K239BG, "95-7 The Forks." NRC Pattern Book shows at night it's supposed to be from SW to NE, null to the SE. Day pattern would be better for us, cardioid with null to the WSW. Yet another station allowing the translator tail to wag the dog of an AM frequency. (GH-OK)

**1600 KRVA TX Cockrell Hill** – 12/9 2133 – Dominant signal is Vietnamese talk, and loops NNW/SSE, so no doubt it's KRVA, The Metroplex TX. Maybe it's their 930 watt night power vs 25 kW days, but at night, 1600 is normally a tossup between Denver and St Louis here. Conditions maybe a bit auroral vs the northerners. **(GH-OK)** 

#### <u>UNID</u>

630v UNID -- 12/7 0149 – Some station making rumbling low audible heterodyne against the others, and I can get a good DF on it, close to east/west ---- which would seem to rule out Mexico, but point to stations in northern AL, northern GA or maybe NC. Several other channels suffer from LAHs, maybe Mexican, such as 780 vs WBBM. (GH-OK)

#### TIS/SPECIAL

**IL Petersburg** – 12/13 2001 – Poor-very poor in peaks thru CHHA in a slight fade. Announcements of "Long Nine Banquet.. Aug. 3, 1837..moving the state capitol from Vandalia to Springfield" clinches this as the Menard County info station after some research. Was audible maybe 1% of the time over a couple of hours. New and quite a shocker! **(NK-IL)** 

**TX** Austin – 12/3 2145 – Continuous NOAA weather, current observations and forecast for Austin area. new here (IR-OK)


1750 WH2XDE

NY Victor – 12/6 2100 – I peak the FRG-7 with east-west longwire on this frequency and strain to hear any trace of me on WH2XDE, the experimental 1 kW station in Victor, Ontario County, New York run by Jerry Whitney who says he has been airing WORLD OF RADIO UT Sundays at 0200 UT. By 2112 I might hear a trace of me, but maybe wishful imagination. Later in semihour on DX-398 and PL-880 I can't hear even a carrier, which is normal here almost 2 megameters away (1894 km = 1177 miles). Victor is just SE of Rochester on the NY Thruway. But I hope others are hearing it closer to the area. (GH-OK) (Editor's Note: See DX Listening Digest #14-50 for Glenn's complete report on this station)

  - WATT MI Cadillac 12/6 1702 Surfaced amid jumble with Fox news and "...on Rush Radio 1240 WATT" promo. Fox News and Rush Limbaugh go together like baseball and hot dogs. (MKB-ON)
  - **WOON RI Woonsocket** 12/4 1637 Ads for Lumber Liquidators and US Postal service, message from two Woonsocket councilmen, weather for area at 1647. **(TF-NH)**
- **ON Oakville** 12/1 1920 Focus on the Family program, ID's for CJYE, PSA for Forgotten Children, commercial for Toronto Aquarium, into more preaching. **(TF-NH)**
- **1270 WQTT** OH Marysville 11/30 2302 Mostly poor but good at this time. Full ID, "WQTT Marysville, news, music, sports…keep it on all day long…," ABC News then a song by Chicago. (HJH-PA)
- **1280 WODT LA New Orleans** 12/14 0552 FOX Sports Radio with two talking heads, poor with tight WTMY, Sarasota semi-nulled. **(TLK-FL)** 
  - **WNAM WI** Neenah-Menasha 12/6 1706 Over usual sports talkers (WHTK-Rochester et al) with local weather, "...on AM 1280 WNAM" station promo and "WNAM" jingle. (MKB-ON)
- **1310 WORC MA Worcester** 12/8 1650 ESPN Spanish Sports, lots of yelling in SS by male and female announcers, reference to sports event in downtown Providence, no sign of usual CIWW-Ottawa. **(TF-NH)** 
  - WGH VA Newport News 12/17 2018 Fade up with female canned "Back to more contemporary favorites on Star 13-10" into soul-gospel flavored vocal, lost to dominant Radio Enciclopedia co-channel. (TLK-FL)
- **1320 WJAS PA Pittsburgh** 12/11 1905 Over nulled CJMR groundwave with local weather, "Talk radio 1320 WJAS" ID into Dave Ramsey show. Recent format flip from NOS "Memories Station" in current NRC Log. **(MKB-ON)** 
  - WCVR VT Randolph 12/8 1647 Old country music, "no place like home for the holidays Real Country" slogan into Frosty the Snowman, by George Strait,

- commercial for Mid State Sports, promo for WCVR's new web site, "Real Country 1320" slogans, nice clear WCVR ID by male announcer, more old C&W. 66 watts working hard to visit NH. (**TF-NH**)
- **1340 WMDR ME Augusta** 12/3 1640 Praise music, plenty of allelulahs, mixed with somebody with the Howie Carr talk show, only station around here on 1340 with that format. **(TF-NH)** 
  - **WMID** NJ Atlantic City 12/8 1703 Atop with old rock music, clear ID by woman for "AM-1340, classic oldies, WMID" into "To the Aisle." (TF-NH)
  - WIRY NY Plattsburgh 12/8 1712 Obituaries and funeral notices in Plattsburgh and Ticonderoga over WMID for several minutes including funeral times and places, where to send memorial donations, mentions of funeral homes who must love the free publicity. Real local radio! (TF-NH)
  - WSTJ VT Saint Johnsbury 12/8 1608 Nostalgic satellite-fed stuff, identical to Westwood1 feed to local WPNH, WFTN, and WFEA. Not heard here before as it is on the other side of the mountains, soon gone, back at 1643 over WMDR. (TF-NH)
- **1350 WCRM FL Fort Myers** 12/14 0759 Good with live Haitian Kreyol male chorus, live Kreyol preacher with mentions of Ft. Myers on a local Sunday morning. **(TLK-FL)**
- **1360 WMOB AL Mobile** 12/15 1759 Over usual sports talkers (e.g. WSAI-Cincinnati) with tail-end of gospel program, "when you write...be sure to mention the call letters of WMOB." **(MKB-ON)** 
  - WCHL NC Chapel Hill 12/14 1657 Presumed with sports program called "Sports Focus" with discussion of NC high school football and mention of Chapel Hill. Very loud signal. No call heard. (HJH-PA)
  - **WMNY PA** McKeesport 12/14 1700 Faded up from nothing to a good level during multi-call ID. Went into NBC news. **(HJH-PA)** *Changed to WGBN on 3/1. DY.*
  - WHBG VA Harrisonburg 12/14 1659 Replaced WCHL when it faded out. Nationwide Insurance ad mentioning agent in Harrisonburg then ad for "It's A Country Thing" in Waynesboro. Faded rapidly and WMNY-PA took over. No call noted. (HJH-PA)
- **1380 WABH** NY Bath 12/1 1945 NBC Sports, Home depot commercial, AM-1380 WABH" ID, commercial for Quicken Loan, then into Westwood One broadcast of NY Jets–Miami Dolphins game from the Meadowlands, almost at local strength running 450 watts. (**TF-NH**)
- **1390 WEED NC Rocky Mount** 12/13 1900 ID as "WEED 1390, Rocky Mount, Jammin' Gospel. Good at times with a very weak WFBL tonight. Rare. **(HJH-PA)**
- **1410 WRTZ VA Roanoke** 12/12 1649 Many WRTZ ID's and playing the Oldies. Ex-WRIS. **(SC-IN)**
- **1420 WAOC FL St. Augustine** 12/14 0710 ESPN junk, 0718 ad block with locals on the back end, including Dirt Cheap (can deliver coquina concrete) and Daytona Kia. Good with WBRD, Bradenton mostly nulled. **(TLK-FL)**
- **1450 WTSA VT Brattleboro** 12/8 1628 Ad for Holiday Inn Express for your holiday party, "AM-680 [sic] WTSA" ID, ads for Dicks Sporting Goods and Subway Sub Shops, soon gone into the mess. **(TF-NH)**
- **1490 WWPR FL Bradenton** 12/7 0650 Fair with Black preacher, gospel vocals, "You're listening to WWPR" non-legal ID at 0701, more preaching. **(TLK-FL)**
- **1600 WAOS GA Austell** 12/10 1910 Mexi-Spanish vocals, Atlanta area commercials and "La Mejor" slogan at 1926. Co-channel several others, though this was the most dominant. **(TLK-FL)** 
  - **KLEB LA Golden Meadow** 12/10 1910 Briefly atop the mix with French-Cajun regional vocal, parallel station website live stream. Besides WOAS, an unidentified black gospel and WHTY, Riviera Beach, FL with Haitian Kreyol programming, and weak sports (possibly WKWF) in the mash-up. **(TLK-FL)**
  - WEHH NY Elmira Heights-Horseheads 12/9 1714 Over usual WWRL/WAAM combo with nostalgia songs from the 1950s (if not earlier), "where all the good songs have gone, WEHH" slogan. (MKB-ON)
- **1630 KCJJ IA Iowa City** 12/1 1950 Weak signal, talk, mention of KPRN, then "AM-1630...Iowa," into local news from Davenport and other Iowa locations, Iowa sports at 2004, and then "That's KCJJ news and sports," weather by a CBS meteorologist, and the visit to NH ended as the signal faded, nice for 1000 watts. **(TF-NH)**

#### PAN-AMERICANDX

- MEXICO XEGS Guasave, Sin. DEC 5 1312 Radio Viva ID, federal PSAs, 1216 mentions Culiacán, loops southwest. So the usual XEGS using the Chávez group slogan not appearing in the listings, but here: www.chavezradiocast.com/?page\_id=433. At this time probably parallel 650 XETNT. Some co-channel from another 610 Spanish further east, probably XEBX. Can't say I've ever heard the official name of XEGS, "La Ley." [Hauser-OK]
- MEXICO XEACB Cd. Delicias, Chih. DEC 5 1321 Romantic music in Spanish, loops southwest (and no sign of KTNN, not cheating today tho 880 KHAC is in); 1324 time check for 6:23, then 6:24 and temp as 7C, vals music; 1327 another break with 6:27 time check, temp down to 6, another song; some co-channel interference perhaps Monterrey, but this is certainly the only UTC-7 station, 3/1 kW, "La Lupe" and IRCA lists format as ROM. By 1337, KSKY is overtaking, as it just sunrose at 1330 UTC from 700 to 20000 watts, both with a minor lobe right at us. DEC 6 0700 Chihuahua anthem is playing, which is all we need to log it again as XEACB. Makes slow SAH with something, probably KSKY Dallas, which I can hear sloganing "The Answer" by nulling the XE. [Hauser-OK]
- MEXICO XEDP Cd. Cuauhtémoc, Chih. DEC 5 1339 String of federal PSA's including one in an indigenous language, Chihuahua mentioned and then Cuauhtémoc too. Lower XEs have started to fade out by now, and this one will soon with our sunrise at 1328 UTC. XEDP Dec and Jan sunrise is 1400 UTC. FCC AM Query includes Mexicans; I rarely check it for them, but I decide to this time: Strangely, they have three different XEDPs: facility 101134 as 5/0.1 kW at 28-30-00 N, 106-55-02 W; XEDP1, facility 122766/122767 at the same coordinates but 7/0.25 kW; and a second site for plain old XEDP with 7/0.25 kW at 28-25-04, 106-48-22. Note these are a considerable distance apart, and could also explain sometimes way off-frequency to the low side, and sometimes not (like today, no het on KCMO et al. at all). [Hauser-OK]
- 900 **MEXICO** XEDT Cd. Cuauhtémoc, Chih. DEC 15 0646 Noise peaks northeast/southwest, presumed the open FM STL still being retransmitted on AM from XEDT. [Hauser-OK]
- 940 **CUBA** *R.Progreso*, Sancti Spíritus DEC 11 0124 Fair-good over WINZ, parallel 640 kHz. [Krueger-FL]
- MEXICO XEBCS La Paz, BCS DEC 12 1300 National anthem, then man with sign-on at 1302: "Estas escuchando La Radio de Sur California..." and mentioning 1050 AM, 99.1 FM, and address. Rough copy over the next half-hour with tropical music and other types, mixing with XED, which usually dominates here around sunrise; same ID noted at 1333. A new catch here, the first new XE in about 3 years. XE #232 but only #5 from BCS. [Wilkins-CO]
- MEXICO XERDO Reynosa, Tamps. DEC 17 0400 For the past couple of nights I noted a signal on the high side of 1060 in Spanish and since XEEP was also noted as usual and since KIJN had been noted running all night earlier in the season, I didn't pay any attention to it. Last night it was quite strong and certainly didn't sound like religious Spanish programming, and wasn't XEEP so I paid more attention to it. My Perseus measured the frequency as 1060.076 kHz. At 0400 UTC I recorded a nice ID with calls, "La Raza" slogan, 7000 watts, and an address in Reynosa. Their move from 1450 licensed to Matamoros is complete and I expect this station to be widely heard. [Kazaross-IL]
- MEXICO XEXX Tijuana, BCN DEC 12 1404 National anthem, followed by ID: "Estas escuchando X-E-doble X..." mentioning power and other data, largely unreadable in the mix; a prayer followed, I believe. [Wilkins-CO]
- 1450 **CUBA** *R.Mayabeque*, Güines DEC 7 1104 Cuban vocals, female DJ, parallel 1140 kHz. Under "Sunny 1450 & 1320" WSDV Sarasota. Listed 1 kW. [Krueger-FL]
- MEXICO XEQI Monterrey, NL DEC 10 0228 Recitation with music background, outroed as "barras de Carranza" with audience approval, then a real song as signal fades vs WLAC. Had looped toward Monterrey so again assuming it's XEQI as I still await a definite ID. [Hauser-OK]



#### NOAA Space Weather Outlook

Issued December 15, 2014 – For the period December 15, 2014-January 10, 2015

Solar activity is expected to be at low to moderate levels through the forecast period.

There is a slight chance for a proton event at geosynchronous orbit through the forecast period.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at moderate to high levels through 22 December. Moderate to high levels will also be possible 29-30 December, 03-05 January, and 08-10 January in response to recurrent high speed solar wind streams.

Geomagnetic field activity is expected to be at unsettled to active levels through 20 December. Unsettled to active levels, with a chance for minor storm conditions are expected on 28 December through 09 January in response to recurrent high speed solar wind features.

#### DXpedition at a radio astronomy observatory: Want to join me?

(Oct. 12, 2014 – SWLing.com Blog): Yesterday evening, prior to my presentation at the Pisgah Astronomical Research Institute (PARI), I took the opportunity to do a little portable shortwave listening on the PARI campus.

One of the great things about listening to shortwave, mediumwave or longwave at a radio astronomy site is the blissful absence of *any* radio noise. Radio astronomy requires seriously RF-quiet conditions, and all the better for SWLing, too. My little Tecsun PL-380 receiver easily detected most everything on the 31 meter band; All India Radio (and the Voice of Korea on the same frequency), for example, was as strong as a local station.

Next year, in October 2015, I might just organize a radio listening DXpedition at PARI. It would be a wonderful opportunity to DX in an RFI-free environment in the beautiful mountains of western North Carolina, on the 200+ acre campus of an active radio astronomy observatory and former NASA tracking station. (Really, *how cool is that?!?*)

PARI has agreed to handle all of the arrangements, and even provide some dorm rooms and camping space to the first registrants. There will be a fee for the event (to pay for the facilities and PARI staff time) but any profit would benefit PARI's science education mission. The fee would be based on the number of attendees and how many nights we operate—I'd aim for two nights, on a Friday and Saturday (October 9 & 10, 2015).

Note: the autumn foliage, for which the NC mountain region is famed, will be at or near its peak during the time of the DXpedition.

#### With sale, KOMJ to add commercials and DJs to the mix

(Omaha *World Herald*, Dec. 17, 2014 via Ernie Wesolowski) – The sale of radio station KOMJ 1490 AM spells the end of commercial- and disc jockey-free AM radio in Omaha, but many of the same artists and songs will still be heard.

KOMJ is being sold by Wyoming-based Cochise Broadcasting to Omaha's Walnut Radio, with the Federal Communications Commission approving the deal this week.

The sale is expected to close early next year, said Steve Seline, managing partner of Walnut Radio, which operates Fremont's KHUB 1340 AM and KFMT 105.5 FM and Blair's KBLR 97.3 FM.

Cochise Broadcasting, owned by a wealthy music aficionado named Ted Tucker, played music from the 1940s through the 1970s almost without interruption. Tucker has said he operates the station as a public service.

Seline said commercials, disc jockeys and brief news announcements will be part of the mix after the sale closes. He also said the music played on the station will "please the people already listening" to KOMJ.

"We know there are a lot of loyal listeners," Seline said.

Staples of KOMJ have included big band and swing-era favorites, 1960s fare such as Jay and the Americans, along with plenty of Motown artists and 1970s singer-songwriters.

The only other voices heard are occasional station promotional announcements, a weekend current events program, and only recently, a rare commercial for a health care plan.

Industry trade journals have reported the purchase price as \$450,000. Seline declined to comment on the price. Email and telephone inquiries sent to lawyers for Cochise Broadcasting were not returned.

KOMJ attracted FCC scrutiny last year, after the airwave regulator said it could not locate a studio for the station. It is still a mystery, but with a vast digitized record collection, owner Tucker could be broadcasting from almost anywhere with electricity and computers.

Seline said KOMJ will broadcast from one of Walnut Radio's other stations while attempting to find a permanent studio.

"Everyone says KOMJ skews toward older people," Seline said. "But I have found a surprising number of people who are younger than you would expect."

#### FCC Notice of Proposed Rulemaking – Online Public File Obligations

On December 18, the FCC issued a Notice of Proposed Rulemaking that would expand the "online public file" requirements to include broadcast radio stations. Radio stations have long been required to maintain a public file at its main studio location, and the FCC is proposing to require stations to now put all the files online, at a site to be hosted by the FCC.

Television stations have been recently required to maintain the public file online, mainly to ensure that the public can readily access the "political report" of political advertising run on the station. Several campaign finance disclosure groups asked the FCC to expand this requirement to include cable and satellite services, and the FCC is agreeing to move forward and decided to include radio stations in the proposal as well. As it did with television stations, the FCC is proposing to initially require only larger stations in the top 50 markets to move their files online, with the remaining stations receiving an additional two years to comply.

Some of the materials that the FCC currently requires to be included in the public file are already online at the FCC web site – including authorizations, applications, contour maps, ownership reports, EEO reports, and letters of inquiry. Stations would be required to upload the quarterly "public issues list," time brokerage agreements or joint sales agreements, and the political file. This last includes a record of all requests for broadcast time by candidates for political office, as well as the schedule of time purchased, including when the ads actually aired, and the rates charged.

The Notice will be published in the *Federal Register*, probably in January, followed by a 30-day public comment period. The full text is available at the following link:

From an e-mail Kraig Krist received from Jeremy Wilkinson KE4WLK, CE of WRUS Russellville KY: "The station is owned by Logan Radio, Inc. and has been locally managed and owned for the last 61 years. We just installed a new BE 2.5KW AM transmitter – relegating the once main Harris SX-2.5 to backup status and rendering the 61 year-old original and backup Gates BC-1F to the shred heap. ... WRUS uses a 1/4 wavelength folded uni-pole antenna on a grounded tower located in the town of Russellville KY. The transmitter power is changed three times daily to coincide with the sunrise and sunset time of the local area along with pre-sunrise and post sunset authority. High power or daytime level is 1800 watts – PSSA or medium power is 480 watts – night-time or low power is 59 watts with UN-modulated carrier."
