

The off-frequency Mexican het doesn't help until I null it, and then there's Colorado music CCI. (GH-OK) Yeah, this super-local often doesn't mention AM now. Cubs are now on WBBM and I think IBOC is often dropped for home games. When Cubs are on 780, news continues on 105.9. 73 KAZ too close to WGN and WBBM. (NK-IL via ABDX via GH-OK)

800 CKLW ON Windsor – 4/28 0247 – Secular talk show in English with KQCV OKC nulled, presumably CKLW Windsor with Coast to Coast AM' [and beyond border-to-border], and same thing one word later on 790, probably KFYO Lubbock TX, among half a dozen other 790 affiliates. The 800 QRM will get a lot worse if PJB3 succeeds in upping power from Bonaire to 450 kW. (GH-OK)

900 KHOZ AR Harrison – 5/14 0614 – Fair @ 30/9, "Harrison's own AM 900 KHOZ." 1st new log on 900 since 1996! NEW! (JJR-WI)

910 WLAT CT New Britain – 4/29 2200 – Good; peaks semi-dominant with "La Mega" slogans and local announcements and SS tropical mx. New here in IL. (NK-IL)

960 WRFC GA Athens – 4/18 2240 – Poor with WSBT nulled. Southern ? Baseball. "960 the Ref" +ads, NEW! (JJR-WI)

RADIO ALELUYARosenberg-Richmond – 4/28 0214 – Spanish announcer is uttering a long list of AM and FM frequencies, towns in Texas mostly with Anglo names (like Livingston, but never any call letters), and then with "cabina" phone numbers, including for 980 and a different one for newly added 1590 in Houston market – but he adds, don't call now, as nobody is there (no hay nadie) at 1590 or even on 980 itself, which is evidently really duplicating some FM station. Then reference to radioaleluya.org. **(GH-OK)**

990 CBW MB Winnipeg – 4/18 0205 – Opening news magazine, "The Monocle Daily, live from London on Monocle 24"; little problem from usual opposite nemesis XET Monterrey; could they really be directional south for a change??? Monocle is a new one on me, but is now one of the contributors to CBC Overnight, along with ABC, BBC, DW, PRI and RTE. The "winter" sked of CBC Overnight on R.

- One (http://www.cbc.ca/radio/pdfs/R1-Overnight-Winter2015-schedule.pdf) shows 'Monocle Daily' [sic] really airs Saturdays only at 1-2 am. This sked claims times are Eastern, as of March 9, implying that although for Winter, DST has been taken into account. Yet, we know better that the times are Eastern ONLY in the Eastern zone! Delayed an hour for CBW in Central, etc., etc. (GH-OK)
- 1010 KSIR CO Brush 4/19 2124 As I tune in, good carrier in a pause, then under modulated ID as "KSIR, Brush-Fort Morgan" and rejoin ESPN Radio for Sunday Night Baseball. Dominates 1010 at the moment. Is 25000/280 watts U3, so still on day power, until 2130 per FCC. From NE Colorado, both day and night patterns are tight to the E and WSW, not favorable for here, but not exactly in a null. (GH-OK)

With a call like that, when it first appeared I guessed it was in Buffalo OK, just across the border. **(GH-OK)**
- **1050 KXCA OK Lawton** 4/28 1655 Oklahoma City ads with sports talk and call ID. Weak but good reception. KGTO, which normally dominates the frequency was weak due to springtime propagation. New here. Unreported station is now reported. **(JR-OK)**
- **1110** WTBQ NY Warwick 4/20 0058 Fair-good; peak ending an oldie and then ID. Daytimer on at night for a couple days. New! (NK-IL)
- 1140 KHFX TX Cleburne 4/19 2120 Station stuck with 4 syllables looping over and over; then dead air; 2121 recovers with 2122 as "Radio Pentecoste," praise music. Seems SSW. Each has two major possibilities in the NRC AM Log: C&W: KLTC Dickinson ND 5000/5000 W U2; KCWM Hondo TX 500/226 watts U1 ESPN: KXPN Kearney NE 5000/56 W U1; KCLE Burleson TX 10000/700 W U4 Now which pair are 6 Hz apart? Otherwise, KCLE & KCWM most likely. (GH-OK)

4/24 0202 – Crooner in English, 0205 gospel song, loops WNW/ESE. Format and direction rule out the usual closer suspects, so I wonder if it's WLOR Huntsville AL, 50000/44 watts with UC/OLD format per NRC AM Log? Day pattern is circle tangent southward. WPFC Bâton Rouge LA, 5000/42 watts U1 with UC:GOS/REL also possible though DF seems further counterclockwise. (GH-OK)

1660 UNID -- 5/2 2120 – Dominant signal has NOS announcer and "Sunny Side of the Street," loops NNE/SSW. Most likely KQWB West Fargo ND, but it was last known to be Classic Country format; rather than "KMBZ" business format from KC/MO. **(GH-OK)**



- 690 **MEXICO** XEN *La 690*, México, DF APR 25 1101 Male, "... en La 690, lo mejor de semana," into phone interview with man regarding Central American gang violence. [Krueger-FL]
- 690 **MEXICO** unID APR 25 1102 Mexican anthem audible way under XEN, nothing else copied. [Krueger-FL]
- MEXICO XEQN Torreón, Coah. MAY 3 0628 Heavy LAH to KRMG, and with Tulsa nulled I can make out some Spanish: "Radio Fórmula, 740" promos, 0630 back to female talk show, someone on phone. - 1090 **MEXICO** XEAU Monterrey, NL MAY 13 0507 Spanish talk from south/southwest is dominant, about Mexican politics, better off-tuned to 1088-1089 to minimize 1080 KRLD IBOC. Presumed XEAU *Milenio Radio*. [Hauser-OK]
- 1100 **CUBA** *R.Angulo,* Mayarí APR 26 0735 Fair under WTAM, parallel 1110 atop WBT. [Krueger-FL]

No proton events are expected at geosynchronous orbit.

The greater than 2 MeV electron flux at geosynchronous orbit is expected to be at normal to moderate levels with high levels possible from 13-18 May and again from 21-23 May due to coronal hole high speed stream (CH HSS) activity.

Geomagnetic field activity is expected to be at unsettled to active levels from 11 through 14 May with periods of minor storming (G1-Minor) likely on 12-13 May due to a combination of a corotating interaction region followed by a CH HSS. Unsettled to active levels are also expected from 18-19 May and 02 -03 June with possible periods of minor storming on 18 May due to multiple recurrent CH HSS.





Filling the GAP: WGAP-1400 AM radio goes back to its roots

Swap N' Shop, old-time country music, Sunday preaching and a focus on Blount County's unique local flavor are making a comeback — WGAP-1400 AM radio has returned to its roots.

Jim and Johnnie Sexton, owners of Blount Broadcasting Corporation, purchased WGAP in May 2014 and have been renovating and upgrading the station, with all upgrades scheduled for completion within the next 60 days. The studio is located on Hannum Street in Alcoa.

A quick tour of the facility showed a lot of action packed into a small space. One room is devoted to creating commercials. Jim said, "We put music or whatever background noises in the commercials. We do the programming for the day. Everything that goes on the air here is recorded. We've got a scheduler that runs the schedule, and we can tell the computer when we want something to run and that particular thing runs at that point. In a day's time, we've probably got 600 to 800 transactions in the active file." The schedules are set each morning for the next day's broadcasts.

A separate room is used when local musicians are in the studio. Sexton said, "This is where we put the pickers. We're going to start doing a lot more of that. ... There are tons of local people who are artists."

"Genuine Country"

The control room is manned by announcers Blue Ridge Bob Lewellyn or Eddy Roy with the aid of a computer system. Jim Sexton said, "You can actually select a song or let the computer select it. If you let the computer select it, it's got all this criteria it uses for picking the song." Other devices are for the Emergency Broadcast System, supplement support equipment, telephone equipment where calls can be made on-air. "Everything that happens, happens right here," Sexton said.

Lewellyn, a Blount County native, said, "Mainly I spin the music and talk on the radio and cut up. Eddy and I do some things together on here, cut up a little bit in the mornings." He paused to announce, "And that was the Texas Troubadour Ernest Tubb and Loretta Lynn ... You're tuned to genuine country ..." before saying with a grin, "Now, that's real country music. What they play nowadays in not country music. I don't know what country it's from, but it isn't country music."

Sexton said, "Bob is a walking dictionary about country music facts, who wrote what, all that kind of stuff." Lewellyn said, "I've loved it ever since I was a kid. I just barely got through math class, but I sure do know my country music!" Before he got into radio, Lewellyn said he was a drummer, a singer, a guitar player, a bass player and a harmonica player. "I also played on the Grand Ole Opry with Del Reeves," he said. "That's a big thrill for a farm boy from Greenback."

Started in 1945

Sexton said WGAP goes back to March 1945, when the Federal Communications Commission issued a construction permit for WGAP on 1400 kilohertz to George Dempster – who at one time served as a city manager and mayor of Knoxville and is probably best known for the invention of the Dempster-Dumpster trash receptacle – and V.H. McLean. The operating company was Gateway Broadcasters.

WGAP changed hands several times over the years. Sexton said the studio had been located on Court Street in Maryville, but when a Knoxville group purchased the station, there was no local studio and all programming came from West Knoxville. A Clinton businessman then purchased the station. Sexton said the move to Clinton resulted in WGAP losing the identity it had accumulated through the years.

"Nobody around here really was listening to it, and we had very few callers that came in on the Swap N' Shop type of programs," Sexton said. "It was not a local station until we bought it the

middle of last year, around May. The thing was a junk heap ... It's taken all this time, and we're still not through with it. The transmitter that was installed down there at the transmitter builder, I installed when I was 15 years old, in 1960." The transmitter is located behind New Midland Plaza, he said.



Focus on Blount

WGAP will serve the market with music, news and sports, focusing on the interests of Blount County residents in keeping with the original goals of the station. Johnnie Sexton said, "One of the first questions people ask when they hear about WGAP is, 'Are you going to do Swap N' Shop?'" She is pleased to say, yes, the former favorite is returning.

Country music "oldies" from great artists such as Johnny Cash, Loretta Lynn, Conway Twitty and Eddie Arnold are on tap, as well. NASCAR races and sports, especially the local sports, will also be broadcast.

Jim Sexton spoke of reinstating a practice dear to his heart. When he was a teenager in high school and later in college, he worked at WGAP.

"In those days, each high school in the county provided one or two people to do a 15-minute radio show once a week, and I was selected to do that radio show," Sexton said. "So that's where I kind of got my feet wet in broadcasting and I sort of had an interest in it." Although he pursued a career with Delta Airlines instead, he never forgot the old WGAP and wants to bring it back to Blount.

"We're going to bring back a lot of that," he said. "We're going to invite the high schools to send people out to actually do the 15-minute shows.

"We're going to make the station mostly a transmission of local things," Sexton continued. "What's happened is the radio business has gotten non-localized. Everything is coming from somewhere else. There's nothing wrong with AM radio stations but they have kind of fallen by the wayside in the last few years."

Testing, testing

Sexton said the FCC has authorized so many AM radio stations that the frequencies cross. That may be a thing of the past if AM transmitter carrier synchronization is implemented, however.

Sexton said, "Kintronic Labs in Bristol makes radio stations. They build all the equipment. The laboratory over at Oak Ridge got some funding to research AM radio, and they have found a way to improve AM radio so that they stop interfering with each other, and the range of each one was increased. Well, WGAP was part of that test.

"What this report basically says is, you can double your range on a typical radio station. This has been submitted to the FCC and it's been submitted to the National Association of Broadcasters. But we ran all these tests and what we've proven is that this concept works. ... The FCC would have to require every radio station in the country to do this, so we're trying to make it inexpensive, less than \$1,000, to make this change."

Using a GPS system, WGAP and two other radio stations, one in Puerto Rico and one in the Tri-Cities area, were synchronized. Sexton said the intent was to see if the range of the station improved or worsened, and the range improved dramatically.

"The FCC is trying to improve AM radio," Sexton said. "One of the reason there's been so much noise in AM radio is because of computers. Every time someone purchases a computer, you're damaging AM radio – AM radio picks up these wave forms. But there's ways that can be diminished and this system is one of them."

The Sextons are focusing on quality in sound, programming and logistics to move WGAP back into the position it once held in this community. As Sexton said, "Good country music tells a story." WGAP's story is still being told – stay tuned to 1400 AM to hear all about it.
