In light of the recent FCC "AM revitalization" order, it's interesting to see a couple AM "Class B" stations this week (WNZF-1550 and KMIK/KHEP-1580) apply to downgrade to Class D. I wondered whether these applications have anything to do with Class C (graveyard) and D stations getting the first crack at a translator move window. I doubt it; WNZF already has a translator (W292DE-106.3) and KHEP has a longstanding tower problem and a new owner to fix it. But a number of stations with longstanding STAs (especially those that have lost translator sites and can't find new sites that meet FCC coverage rules) have stated they will apply for downgrade CPs when the new rules take effect. So stay tuned!





I went to the KRVN web site and sure enough KAMI is listed as a sister station right at the top. I believe this to be one of my previous UNID stations on 1580 solved. **(SMA-MB)** 

**1610 CHHA ON Toronto** – 11/1 0147 – All-Spanish from Toronto, "CHHA, Radio Voces Latinas", décimoprimero aniversario promo, celebrating 11 years on air, 416 AC phone, then promo 16-10 AM, y su departamento de ventas. **(GH-OK)** 

**1650 KFSW** AR Fort Smith – 10/23 2159 – I find the Sallisaw station with silly ballgame, evidently hi-school football involving Springdale (a NW Arkansas town) and Morristown?/North Side? The play by play announcer has a perfect opportunity to insert a legal ID circa 2200 but still has not by 2202. I want to know whether KFSW is still calling itself KYHN! CCI from a station promoting Oklahoma (presumably college) SBGs on Fox Sports 1 that's got to be KCNZ-IA, the only Fox Sports Radio affiliate on 1650, and also a regular here. 10/24 2059 – Promo for Hook & Hunt Show Saturday morning at 5-7 am CT, but runs over and overridden by bong and CBS News at 2100; no ID hearable. Try again at 2204 after another newscast: promo for another show on "Big AM 1650 KYHN", a.k.a., at least to the FCC, as KFSW. Still as KYHN all over the website too, http://kyhnradio.com/ 10/25 0159 – Sallisaw station still with singing ID as "KYHN, Fort Smith." It seems two of the three Canadians on 730 specialize in traffic reports, French and English. I suppose it could even be another Mexican. (GH-OK)

10/23 2203 – surprised to find some Spanish talk slightly above the graveyard pileup. I get it on the E-W ALA-330S antenna, but not on the N-S NVLW, which means it is approx. but not necessarily exactly from the east/west. Some ads; 2206 I seem to miss a full ID which mentions a frequency ending in punto cinco, i.e. an FM simulcast, "una estación (tropical?)" or something similar, "todo lo que gusta", 2207 seems to go into music as it is fading into the din. Ideas? (GH-OK)

- **1360 UNID** -- 10/24 2210 Screaming Pentecostal gospel, loops ESE/WNW, dominating and with a LAH; seems out of the ordinary. I'll bet it's WMOB Mobile AL, 9000/200 watts. **(GH-OK)**
- 10/24 2204 Mexican music is dominant, on the E-W antenna. Usually we get a mix of Kansas City, West Fargo and Waco, more or less N/S, all with silly sports in English. NRC AM Log also lists three SS 1660s in the conterminous USA: California, Florida, but strongly suspect this is KXOL Brigham City UT, or rather DKXOL, which the FCC thinks has been Deleted, BUT has been widely reported continuing to operate. (GH-OK)
- **10/29** 2023 Ranchera music on east-west antenna briefly and then lost. I suppose it's DKXOL Brigham City UT, as sunset there is about 5 minutes later. **(GH-OK)**



- 980 unID OCT 29 1253 Romantic music in Spanish, good signal looping west/southwest; 1254 non-ID like "980, a la torre"(?), more music; fading by 1256 UTC. Probably usual XEFQ Cananea, Sonora. [Hauser-OK]
- 990 **MEXICO** XET Monterrey, NL OCT 11 0358 Huge signal with banda music, "La T Grande de Monterrey" slogan, full ID included doorbell chimes and "HAP" in Morse code. I don't know the significance of "HAP" in Morse code, but should be a good way to ID this station. [Knight-TX]
- MEXICO XEOY *R.Mil*, México, DF OCT 11 0358 Excellent signal with música romántica, call sign (sounded like X-E-Oye), gave address and website www.radiomil.com.mx, back to music. [Knight-TX] OCT 24 0500 Under WMVP; children's choral national anthem. [Conti-NH]
- 1030 **MEXICO** XEYC Cd. Juárez, Chih. OCT 24 0213 Spanish talk, federal and state PSA's, 0215 ID as *R.Fórmula*. [Hauser-OK]
- MEXICO XEEP *R.Educación*, México, DF OCT 23 0630 Looking for possible KXPL El Paso at night from the west, not since 0230, but instead from the south, weak ID from *R.Educación*. Also with a LAH from XERDO Tamaulipas, off-frequency as always; almost. [Hauser-OK] OCT 24 0500 Over/under KYW and unID 1062 het; children's choral national anthem. [Conti-NH]
- MEXICO XEPOP Puebla, Pue. OCT 18 0112 Fair signal with "Radio Fórmula" and "Fórmula 1120" slogans, "en la capital Puebla" mentioned by man. Into program of English pop music from 1980's. New catch! XE#58. [Knight-TX]
- 1140 **CUBA** *R.Surco*, Morón OCT 24 1000 Over/under CBI and WRVA; salsa music, canned ID, "Transmite CMIP Radio Surco, desde Ciego de Avila, capital de la locución cubana." [Conti-NH]
- 1170 **COLOMBIA** HJNW *Caracol Radio*, Cartagena OCT 25 1022 "Amanecer en América" news magazine, excellent, with frequent *Caracol Radio* jingles. Checking for D. Crawford's 0025 UTC *R.Rebelde* here (possibly Trinchera relay) but no luck this hour, or earlier at 0400 when nothing Cuban, including the national anthem spun by most stations at local midnight, airs. Daytime, it's just a weak WKFL Bushnell for me. [Krueger-FL]
- 1180 **CUBA** *R.Rebelde*, multiple sites OCT 11 0358 Fair signal with apartment-complex hash. Rebelde musical jingle, ID, mentioned noticias, then into Cuban national anthem, Rebelde jingle again at 0402 UTC. [Knight-TX]
- unID OCT 24 0203 Surprised to find some Spanish talk slightly above the graveyard pileup. I get it on the east/west ALA-330S antenna, but not on the north/south NVLW, which means it is approx. but not necessarily exactly from the east/west. Some ads; 0206 I seem to miss a full ID which mentions a frequency ending in punto cinco, i.e. an FM simulcast, "una estación (tropical?)" or something similar, "todo lo que gusta," 0207 seems to go into music as it is fading into the din. Due to the DF, I have discounted from the outset that it could be a Mexican, but check IRCA Log anyway and find that of the 13 stations on 1240, three of them do have FM's in .5 and not all of them are 1 kW or less like in the U.S. Only 1/1 kW XEWG Cd. Juárez would be close enough to westward, but no FM known. Cantú also had the three others with XXX.5 FM of the 12 he listed. CiJz is common here on many other frequencies including 1300, so maybe that's it. Distance almost a megameter, 946 km or 588 statute miles. [Hauser-OK]
- MEXICO XEAW Monterrey, NL OCT 11 0358 Excellent signal with mariachi music, ID by woman: "Esta ud. escuchando XHAW transmitiendo en 100.3 megahertz de frecuencia modulada con 50 mil wats de potencia y XEAW en 1280 kilohertz de amplitud modulada con 10 mil wats de potencia desde Monterrey, Nuevo León, México. AW, unica en su género. Principio Radiofonico. Multimedios Radio. Las once." Back to music. [Knight-TX]
- 1370 **MEXICO** XEHG Mexicali, BC OCT 31 1300 National anthem; ID at 1301 as "XEHG 1370..." with the rest unreadable. Poor in the interference. [Wilkins-CO]

MEXICO XEJPV Cd. Juárez, Chih. NOV 1 0041 – Gospel huxter in Spanish, roughly eastwest, very poor, 0042 into song and soon lost. Only Spanish religion in NRC AM Log is KVAN in Washington, no way; so how about México? Yes, XJPV is religious per IRCA Log. And per my log of over a year ago: OCT 21 0547, Radio Viva, 100% música cristiana. [Hauser-OK]

#### TRANS-PACIFIC DX

Transoceanic 9-kHz-plan carrier searches on the DX-398: OCT 26 1232-1235 – Just before sunrise here at 1249, JBA carriers: 774 from northwest; 702 and 882 from west; 612 not sure which angle. OCT 29 1145 – I awaken, so right to the DX-398 for a transpacific carrier search, starting as always with 774 which is memorized in USB offset mode – there it is, a JBA carrier from the northwest, and stronger than all the others I detect in the next few minutes: 747, 702, 693, 594, 873, 972, 1053, 1125, 1143 kHz. Back to 774 at 1159 straining to hear a trace of the NHK time signal at 1200, but cannot. Sunrise here not until 1252 UTC. NOV 5 0711-0714 – First noted het on 620, i.e. 621.0 kHz; then found het on 710 too, i.e. from 711; and JBA carriers on 738 and 882 kHz. Sunrise in Santa Cruz de Tenerife, Canary Islands was 0719 UTC today, likely source of 621, and maybe 882 though WRTH flags it as low power; 711 could be Morocco, while 738 more likely Tahiti from the other worldside, looping WSW/ENE. My DFing is quite approximate, and the true bearing of Tahiti from here is 232° (exact southwest being 225°); and of Canary Islands is 71°. NOV 5 1250-1253 – Another search after I awaken; first check 774 but nothing there; however JBA carriers on 747, 738, 702 from the west, and 792 kHz. My guesses: 747 Japan, 738 Tahiti, and 702 from Australia. Our sunrise today 1258. [Hauser-OK]

Greetings once again from the Heart of the Continent and welcome to the DX Tool Box Column number 75. I would like to remind my readers that the DX Tool Box is a bit of a catch all column, so if you have something radio related that does not seem to fit the other columns please feel free to send it here.

**This Month's Radio Saying: "**Ride the Radio Waves."

#### The Way Back Machine:

I received the email below from a total stranger in October and wondered what it was about as the email was titled just "Hallicrafters". I opened the email and it read:

"I was going through my father's estate when I came upon a Hallicrafters S38. It had your call on the back. I've restored it and it works great here in Glendale AZ. Rick Bodley"

My reply back to Rick was as follows:

"Wow that is crazy and wonderful at the same time. I had that unit way back when in the late 1980's early 1990's. I have attached a picture of me from back then in my little radio room in the basement of our old house so I know it was before 1988 when we moved into our current home. The radio has made quite the lengthy trip from Winnipeg MB to Glendale AZ but I am sooooo happy to know that it is still going and making someone happy. I hope your dad enjoyed it back in the day as well. You made my day here. Thanks so much for the great story."

I would like to thank Rick for looking me up on line and then emailing me the pictures and the story about my old radio. You never know where your old equipment may end up but it sure is nice to know it is still making someone happy.

#### **Antenna Question**

A question for those knowledgeable on antenna issues:

For a couple of decades, I used a random wire antenna of approximately 160 feet with my FRG-7 for DX'ing the BCB. I fed it through an MFJ-956 Antenna Tuner, with great results. The "random" part of this equation is that I live on a small piece of suburban property that requires that the wire be strung in a non-linear fashion, thus limiting my ability to string it out in what amounts to little more than a zigzag. Still, it worked well, and I was able to peak it at the desired frequency. Recently, I had the opportunity to nearly triple the length of the wire, although still strung out in a haphazard zigzag, half-ass formation. I was expecting an increase in signal-capturing capability. That seems to have happened on the frequencies at the lower end of the dial. However on the upper end, especially the graveyard frequencies, I now notice that there are a couple of peaks at each frequency. I realize that I should choose the peak that is the most profitable. But I wonder if there is an explanation for why there are now two tiny little peaks on (say) 1490, instead of one broader peak that I was used to before? Is there something I can do to mitigate this "problem"? (Aside from





shortening the wire back to a shorter length). The peaks are so tiny that it's often difficult to reel them in and square them up.

Re: Interference Source LED Light bulb

I have been plagued by nasty harsh "line noise" type interference for past couple of months. I finally decided to see if something in the house was causing it. I found it pretty quickly. It was an LED light bulb that must be going bad. I have 2 of them in ceiling fan. I was amazed at how much hash this thing threw out and how much distance it covered. It was picked up even by external antenna (inverted vee). I got the LED bulbs as I thought it would be radio friendly. The other one is quiet, so something must be going wrong in the offending bulb. If you are using these and have mystery hash interference in the AM band, you might check them. Mine was a Utilitech LA190M, 5 watt bulb that replaced 60 watt incandescent from Lowes. Probably 2 years of use. FYI Russ Johnson

Bob, If you like SW at all get the CC Radio SW the audio is superb and the AM section is super hot.. add in a loop and you're good to go. It does not have the ham band in it but it is a bit cheaper than the CC Radio2E. CCrane customer service says the audio on the 2E is slightly better than on the SW, which, as you say, is solid. Am now leaning towards the 2E. They say FM reception on the SW might be a little better because the whip is slightly longer.

Paul, actually a bit torn between deciding on which of the two you recommended. I dabble in SW, but also have a fully working SONY 2010 here. Does the CC-SW have the same signal strength meter as the 2E?

The SW is cheaper and if you look hard enough you can find it even cheaper on eBay occasionally. I love the CC Radio SW. I haven't had a 2E though.

Re: AM Revitalization Order Issued by FCC

I apologize in advance for the length of this post. After a quick read of the Order, here's what I think are the highlights:

The FCC proposes to eliminate skywave interference protection. The FCC proposes to eliminate 3rd-adjacent frequency protection. Things that WILL happen:

During 2016, an AM licensee may acquire ONE FM translator operating above 92 MHz, move it up to 250 miles, and move to any technically suitable FM frequency. The translator must relay the AM station for at least four years. During 2017, an FM translator filing window will be open, only for Class C ("graveyard") and Class D ("daytimer") AM stations. Stations that got a translator in the 2016 move are not eligible. As soon as that window is resolved, another window will be opened for ALL AM stations that didn't get a translator in the 2016 move.

Existing stations will only be required to provide a strong (5mV/m) daytime signal to 50% of the population or area of the city-of-license. New stations or existing stations moving to new cities must continue to meet the old standards. (80%)

Existing Class A, B, or C stations will not be required to provide a strong nighttime signal to ANY of their city-of-license. The old standards were the same 80% as for daytime service. New stations or existing stations moving to new cities must have a nighttime reach of 50%.

A "ratchet rule" that requires Class A or B stations modifying their signal to reduce skywave interference will be repealed. MDCL, a means of reducing utility bills, will be approved for general use. Minimum efficiency of transmitting antennas is reduced by 25%. Stations may use an inefficient antenna with increased power.

Things the FCC proposes to do but hasn't done yet:

Eliminate all protection of skywave signals.

Change the method for calculating interference caused by a new station. (roll it back to the pre-1991 method)

Reduce interference protection from stations 10 or 20KHz away. Repeal all protection from stations 30KHz away. (you could have 570 and 600 in the same city)

Reduce daytime interference protection to Class B, C, and D stations.

Currently, FM translators' service area must be contained within either 25 miles of the AM transmitter site or the AM 2mV/m signal contour, whichever is lesser. FCC proposes to change that to whichever is \*greater\*.

Translators' service area would still be within 40 miles of the AM transmitter.

Certain directional antenna measurements may be simplified.

Partial proofs & antenna modeling.

If an AM station with a directional antenna believes the system may be out of tolerance, or if certain repairs are made, the station must take measurements to prove it's working well enough.

A computer modeling method for AM antenna systems is proposed to be approved for general use.

Undeleted regular-band affiliates of X-band stations. FCC proposes to delete the regular-band affiliates of 22 X-band stations that are still operating in both bands. That was supposed to end five years after the X-band signal signed on. Stations may ask that the X-band station be deleted instead.

Ideas on which the FCC is soliciting comment:

Should more X-band stations be authorized? Who should be preferred? Completely new stations? Stations moving from standard band? All-digital stations? Should regular-band stations moving above 1600 be required to \*immediately\* surrender their regular band license upon completion of the X-band signal? Should facilities other than 10,000/1,000 U1 be authorized? Maybe, only "simple" directional antennas of three or fewer towers? Should the main studio rules be relaxed? Should AM stations be allowed to co-locate their studios with co-owned stations in the same market, even if they're too far from the city-of-license of the AM station?

#### From: Russ Edmunds

Alas, translators aside, much of what's included above for AM probably won't be of much help, because while attempting to fix one problem, it creates others. Removal of skywave interference protection at night will only create more interference, permitting less efficient antennas at greater power will do the same. Reducing coverage requirements for COL also has the potential to increase interference. The FCC still hasn't learned that much of what it did in the prior 4 decades caused the demise of AM. In short, there are too many stations, too close together, operating full time, and too many of those at flea powers. If they really wanted to improve the quality of AM, they'd thin the herd, but since the big group owners and their lobbyists would raise hell about it, that won't happen. Russ Edmunds 15 mi NW Phila
