of the National Radio Club's AM Radio Log. Many stations have a Construction Permit (CP) for changes to their facilities. It is assumed that these changes will eventually be employed, so are depicted as such. Additionally, several Mexican stations located adjacent to, and near, the United States border are included, as well as stations on 810, 1240 and 1540 in Nassau, Bahamas.

Naturally, a non-directional signal travels as far as possible, depending upon the transmitter's output power through a single tower. Directional patterns are used to avoid interference to other stations on the same or adjacent frequencies, and may require as many as twelve towers to achieve this. Pattern plots in this book are reproductions of those shown by the FCC, and backed up by those generated by a computer program written by NRC member Neil Adams. Each illustration closely reproduces the pattern's shape and bearing. However, the size does not reflect the actual coverage areas due to many variables: frequency; a directional

pattern (if used); the electrical tower height; ground conductivity; terrain; weather; atmospheric conditions, and interference from other stations. Your ability to hear any station, of course, is based upon these factors plus your receiving equipment.

PATTERN PLOTS: Daytime patterns are illustrated with a dashed line; Nighttime patterns by a solid line; Critical Hours patterns are depicted by a solid line with small circles at various intervals. Many stations, mostly on 'clear channels', operate during what is referred to as 'Critical Hours'. These periods are from sunrise to sunrise plus two hours, and sunset minus two hours to sunset. This is when the ionosphere transitions from nighttime to daytime (morning), or daytime to nighttime (evening) conditions resulting in greater coverage for a station than what would be expected using their licensed daytime power. Licensed 'Daytime' operation during these periods would cause interference to co-channel and adjacent-channel stations. So, the FCC has implemented Critical Hours periods for stations who agree to operate during those periods with (normally) a power level lower than that licensed during the daytime, and in some cases utilizing a directional pattern. Currently, no Canadian or Mexican station is licensed to operate using a Critical Hours operation.

Ul and U3: Patterns for stations which operate with the same power day and night, designated in the AM Log as Ul (non-directional) or U3 (same pattern all hours), are depicted with a single, solid line. Many stations with the same power all hours and designated DA2 by the FCC and U4 by the NRC, but have identical parameters. Those patterns are also drawn with a single, solid line.

Except for four, all stations on 1230, 1240, 1340, 1400, 1450 and 1490 kHz are licensed to operate non-directional all hours, so no patterns are drawn for them. Patterns are illustrated, however, for the four using a directional signal. All non-directional signals less than 500 Watts are depicted by a small, equally-sized circle.


All stations in Alaska and Hawaii operate non-directional full time, except one. That being in Nome, Alaska on 850 kHz (directional only during Critical Hours operation; see pattern on Page 64). All stations in Alaska, Hawaii and Northwest Canada are designated on the List pages by an A, H or C, and their locations are plotted on Page 238.

Every attempt has been made to place the listed number adjacent to the corresponding dot of the

city so as not to interfere with the pattern or a state/province line. Where not possible, or in the case of space restrictions, an arrow has been utilized to match the number with the location of the station.

Section 312(g) of the Communications Act (as amended in 1996) provides that the FCC shall cancel the licenses of stations that have been silent for a full year, with limited exceptions to promote "equity and fairness." On August 30, the FCC published a notice stating that it would forgo cancelling the licenses of stations in Puerto Rico and the U.S. Virgin Islands that have been silent since September 2017 due to Hurricanes Irma and Maria, until March 9, 2019, if such stations file applications for a "silent STA." Some stations that have been silent all this time (such as WDHP-1620 above) are just filing their official notifications now.

But still uncertain if this is the source of the Star-Spangled Banner (and not to be confused with the SSB as sung by Dolly Parton, also at this hour as aired on WAKM, Franklin, TN as previously heard here). No apparent functioning KXJK website audio stream located, but I found that the free download (soon to be deleted) TuneIn app has it, so today I sat on 950 kHz while streaming the audio. First Light (Westwood One News) audio feed until 0658, then AM 950 and 106.5 FM Hometown Radio and KXJK ID on the stream, into the orchestral anthem. Audio stream about 22 seconds behind the anthem squeaking through on 950. Male with ID into local weather and news after. (TLK-FL)

- WGUN GA Valdosta 9/14 2054 Urban Contemporary evening dance-oriented show, female mentioning "The Magic 950 Valdosta" (slogan is supposed to be "Magic 95"). This is the one initially heard as one on the many unidentified stations closer to local sunrise, usually with heavier injection of R&B Oldies such as The Four Tops, R B Greaves, Billy Preston. (TLK-FL)
- WAKM TN Franklin 9/12 0559 Male with WAKM ID, fade, up a couple minutes later with female "AM 950 Hometown Radio" and parallel the station website stream with John Denver's "Rocky Mountain High," Conway Twitty, Ricky Van Shelton, "Making Believe" by Emmylou Harris. #### What Would It Take to Get You to Listen to AM Radio?

https://www.dailynews.com/2018/09/04/radio-what-would-it-take-to-get-you-to-listen-to-am-radio/Longtime readers of this column know I'm a bit crazy when it comes to AM radio.

Unlike many – seemingly, most – owners managers or programmers, I believe that an AM station can compete if it pays the right format. And in my opinion, that usually means music – music that can't be found on FM. Do that, and you can attract new listeners, including young people who have not had an AM station that programmed to them since the 1970s.

As I said a few weeks ago, I've been writing this column since 1987, and not once has anyone ever told me that they don't listen to AM because of issues with audio quality. People tell me they don't listen because, with rare exception, the programming just isn't appealing.

But don't take my word for it. Here are some of the responses you sent to me in answer to the question: Would you listen to an AM station if it played something you wanted to hear?

"What would it take to lure listeners back to AM radio? The answer is quite simple. Give them what they want to hear!" – Tom Murphy

"To me, the most important thing about me is the radio content/format, not necessarily the broadcast quality. As long as KSRF plays 60's and 70's music, I'll be listening" – Randy Ouchi

"You can't hear new music or certain styles on any station; I'd definitely listen to AM if they played new music, metal or Prog. So would my friends in school." – Sean Rogers

"I agree with you; the AM band should have better formats. Since we already have an oldies format, I think it would be great if we had a format on the band that would play music from the Classic Rock Era (1964-1990). We really need to have more music formats on the AM radio band." – Russell Cinque, Jr.

"AM has nothing that would interest anyone my age. My friends don't even listen to FM stations, either. We get our music online. If an AM station played new songs and new bands, I'd definitely tune in." – Kayleigh Marcus

"Up until 6 months ago, the only things I listened to on AM radio were broadcasts of Kings and Ducks games. Then when my favorite FM station went off the air, I discovered K-SURF. While I love their format, I would be thrilled if there were an AM station that played songs from the '60s, '70s and some '80s that were not so pop, but more folk-oriented. Joni Mitchell, Leonard Cohen, Judy Collins, Joan Baez and some of the lesser-known artists like Bob Lind, Hedge & Donna, Eric Andersen etc." – Susanne Gilmore

"I haven't listened to an AM station for years until you told us about K-SURF. I haven't listened to KRTH since. I love, love, love this oldies station! I have it on all day at home and in my car. What a wonderful change from all the FM stations playing songs I'm sick of. I only wish it had better reception." – Pat Games

"There are way too many commercials and very little content. What I believe would make for better programming is a mixture of local news, interviews of people with interesting stories or new books, with various music intertwined." – Bill Fisher

"How about a station that blends classic country with new country? Done right, this could fill a big void, as great artists like Alan Jackson and Toby Keith no longer can get played on the current FM channel." – Steve Keller

"I would listen to AM if they played something I liked. Maybe give exposure to some artists that aren't played anywhere else, especially if they play real instruments. There are lots of good songs you can't hear on the radio" – Antonio A.

"Offer something that isn't already on the radio. '50s music. '60s music. How about a comedy station? Something new can just be something old, made new again." – Veronica Ross

There you have it. Programming will bring people of all ages back to AM radio, especially in an era when the FMs are all too scared to take chances. AM stations – like FM stations in the 1960s – have nothing to lose … and everything to gain.

Once programming is in place, we can tackle the technical issues and find that in spite of its reputation, AM can provide good, perhaps excellent, audio quality. That topic will be covered in a future column.

### Farewell Silver Dollar Radio

After 80 years the KWAL-AM 620 radio station signed off for the final time at 11:59 p.m. on Saturday night.

The third oldest radio station in the state had been a hub for mobile information over the years providing local listeners access to election results, school lunch menus, school closures, regional and national news, and local sports.

The station in its current form came to be after Paul Robinson and other investors bought the station from Lee Black in the fall of 1971 and reopened the station in 1972.

In 1977, Robinson hired his right-hand man and local legend George White, and the two have been riding the waves together ever since.

Over the years, Paul and George would be seen doing just about everything together, the

chemistry between the two evident when listening to any of their broadcasts.

Over the years the station experienced the financial hardships that are being felt by nearly every smaller media outlet across the country, but KWAL would power through them.

"The internet is killing small business," Robinson said. "The other day I got an ad on my phone for Levis jeans. You can buy directly from Levis now. What does that do to Sears, J.C. Penney or Macy's? What does that do to the little mom and pop businesses that are selling Levis? These are businesses that advertised and sponsored with us and it's killing them."

Besides lost revenue to the internet, KWAL suffered a death blow when the Federal Communications Commission (FCC) declined to renew the station's extension to utilize their single radio tower at 250 watts and would only allow them to operate at 60 watts.

What that means is they would only be able to power a signal as far as Silverton.

They had a second radio tower, but in 2016 the tower was destroyed after an inattentive driver clipped the guy wire, pulling the tower down into the South Fork Coeur d'Alene River.

That second tower was vital for the station, allowing it to operate at night on a lower strength signal, so as to keep the signals from crossing with signal in Spokane, western Montana, and even as far away as Portland, Ore.

After the tower was destroyed, the FCC allowed the station to use the remaining tower to broadcast at 250 watts, which kept the signal strong enough to broadcast from Kingston to Mullan.

"It was enough for us to cover the local towns," Robinson said. "And it kept us out of the western Montana area and over the hill. We had six months to get a new tower up and after those six months, we got an extension. I think we got four extensions."

Unfortunately, the driver who pulled the tower down also hit some power poles that caused the power to go out in the Sunny Slopes area and after the power company got their cut of the insurance money, there wasn't enough left for KWAL to pay the near-\$200 thousand it would take to get a new tower and then have it set up and calibrated.

Even as they stare retirement in the face, the two DJs look back fondly on their time behind the mic, but will miss one thing in particular.

"I'm gonna miss sports the most," White said. "We saw so many good athletes over the years. We are going to miss calling the ball games."

*Pubklisher's Note*: Two comments on this article. First, contrary to what is stated in the article, the FCC's official renewal of KWAL's STA (dated July 24, 2018) specifically allows for an STA power of 250 watts at night for the usual 6-month period, running until January 2019. If the FCC in fact reduced the STA night power to 60 watts, there's no record of it in the FCC online system.

Second, until the station turns in its license to the FCC (or is silent for a full year), don't count on it being permanently dark. I've seen many newspaper articles announcing the permanent closure of a station, only for a buyer to turn up who wants to keep the station on the air under new ownership. In other words, don't believe everything you read, and don't cross KWAL out of your *Log* just yet!

Also, fans of Scott Fybush's Tower Calendar will remember the two towers of KWAL (when both were standing) as they were photographed with Interstate 90 actually crossing between the towers.
