On January 24th WSKW went full-time by moving to 1160. Our daytime power is 10,000 watts, with nighttime output of just under 1,000 watts. We bought a new solid state transmitter from Nautel of Maine in Bangor. It's their Amphet 10 model, also on the air in the States at WKDJ and WGSF in Memphis, WAKR in Akron, KLZ in Denver, WONE in Dayton, WKOK in Sunbury, PA, WKIE in Richmond, KSSK in Honolulu, KSAH in San Antonio, KFAR in Fairbanks, WNLC in Waterford, CT, in addition to numerous facilities throughout Canada, Australia, and South America.

On the air at WSKW, we knew the Amphet 10 was a wonderful unit but didn't expect response from Poquonock, CT. Based on your detailed log of specific programming, it was indeed Skowhegan's AM you heard. For the record, our city of license is 14 miles northwest of Waterville. Skowhegan is an Indian name meaning "place to watch." With your reception of AM 1160, it's also a "place to listen."





Thank you for your interest in the "Biggest Little Station in New England". We here at WSME are always glad to receive reception reports from National Radio Club members and other interested listeners. This letter will serve as verification of your reception of WSME on .2 Feb. 1959....at.2:31 to 2:41 am during our xmtr. test....programming.

WSME has been in operation since November 9, 1957. From dawn to sunset, we program top news coverage and commentary, highly "listenable" music, and community service features, all of local origin. Commercially, we are affiliated with Maine's Lobster Network; the combined listening audience of Lobnet's eight stations comprises ninety-five percent of Maine's market.

The Town of Sanford received nationwide publicity five years ago as the "Town that Refused to Die". For many years, the economic health of our community of 17,000 had been almost totally dependent on the operation of a single textile mill, Goodall-Sanford, Inc., makers of the famous Palm Beach cloth. When, in 1954, this textile mill followed a New England trend of consolidation and movement to the South, the citizens of Sanford were left virtually without income. In the tight-belt period that followed Sanford's economic collapse, the tireless efforts of Sanford's civic leaders brought new industry to town, slowly at first, then with a new enthusiasm and vigor. Today, Sanford is healthier than ever and still growing.

We thank you once again for your interest in WSME and the town to which we belong. I will welcome any further correspondence.




WYNZ(AM) transmits 24 hours a day with a 5-kw Continental xmtr (daytime nondirectional, nighttime directional), plus an older RCA BTA-5T 5-kw auxiliary xmtr and a phasor (antenna pattern switcher) made by CSP, Inc. of Doylestown, PA. Our live personality format uses the increasingly-popular syndicated taped "Music of Your Life" service (traditional adult MOR pop hits of 1938-1975), complemented by CBS Radio affiliation, our own superb four-person local news department, and our status as Greater Portland's outlet station for the Boston Red Sox, Boston Celtics, Boston Bruins, and New England Patriots.

We also co-own and operate a sister FM station, WYNZ-FM (100.9 MHz; 3-kw ERP), nicknamed "Y101", with a semi-automated soft adult rock sound. Both stations have had monumental impact in this market in the past year, much to the delight of many folks.







Thank you very much for your long and interesting letter reporting reception of this station at you listening post in Walnutport, Pa. Both the reports are correct. I know that the report of our frequency test broadcast was correct in all respects because I was on duty that evening and the voice you heard was that of yours truly. The report for October 28th was correct because the morning man is supposed to start his sign-on at 0557:30.

We have been on 790 kc with 1000 watts since last February 5th. Since that time we have only received two reports further away than yours. One was from Cincinnati, Ohio, and the other was from Dubuque, Iowa. We have also had a report last October 13, from a Mr. J.W. Brauner in Valier, Pa., but I don't know just where Valier is.

Equipment here at WRUM is Gates throughout. Transmitter is a Gates BC-1F operated by remote control from the studio location approximately 4 miles away. We have a 330 foot guyed tower on a 750 foot hill for an antenna tower. This is the highest radio tower above sea level in the State of Maine. Studio equipment consists of a Gates SA-40 control board (somewhat modified by myself), Gates turntables, and three Ampex 600 tape recorders. We are an independent operation with no outside tie-ins except for special events so all programming originated at our studios at 89 Congress Street in Rumford.

Rumford is in the Vacationland and Lumbering section of Maine so that we are surrounded with heavily wooded hills, some over 3000 feet high. That is the reason we threw away all theory and put our antenna tower on top of a high hill instead of in a low swampy spot. It seems to have worked. Our local signal in our service area is very good and extends out much farther than we had expected.





WASY is a 5000 watt AM during daytime broadcast hours and operates at 2500 watts during nighttime hours. 




