



Enclosed you will find the 10th Anniversary Folder of our sister station WPEL. I trust this will be of interest to you.




Thanks for your letter of Sept. 15th. We are a brand new station having just gone on the air Sept. 7th at 10 AM. Up until March 31st, 1982, W.E.N.D. occupied this frequency. they went on the air in 1960.

After going through 5 different owners they finally turned it off and we got the chance to play around. We put an FM on the air in Johnstown 2 years ago and we wanted to try our luck at an AM.

What you heard is nothing compared to what you will be hearing soon. The old station had all junk equipment, a lousy old transmitter with no processing. We changed all that. The only thing we took from the old station was the main transmitter which was wired wrong and feeding the tower improperly. We are on it now after making some major changes but we have a new state of the art Harris transmitter (MW-1) coming in within a week or two. Please get back to us after we are on line with the new transmitter.

W.A.J.E. is a 1,000 watt daytimer on 1580, a Canadian clear channel. We have applied for extended hours and will probably get them sometime this spring. At present this station operates with Critical hours. Critical hours are when the F.C.C. requires us to reduce power at certain times of the day. During the month of September, we must cut power at 5:45 PM, so when you caught us we were only at 250 watts. We have also applied to do away with the critical hours and should be able to in the near future.



We have just recently installed and put into operation a grounded tower unipole antenna system changed from a $\frac{1}{4}$ wave length, series fed, ground-plane system with an apparent improvement in our radiation pattern. Our main transmitter is a McMartin 2.5 Kw which is in operation daytime at full power from sun-up till sundown. Our pre-sunrise power is 339 watts daily from 6AM Eastern Standard Time till sundown. After sundown we go on with a 30 watt signal from a small solid state LPB AM-30 which incidentally is manufactured in your area in Frazer, Pa.

I wish to thank you for your correspondence dated 10 January 1980, and to express my apologies for taking so long to reply. To put it simply, we here at WSKE are extremely busy in preparing for our birthday celebration coming up on 15 March... and things are just piling up on all sides.

Please accept this letter as confirmation of your reception of WSKE from 501PM to 515PM EST on 9 January 1980. Your log of WSKE's performance was accurate with one small exception:

WSKE is located "just south of Everett off Route 26."

It is easily understood that you thought you may have heard "Route 126" as interference from WHN is to be expected in your area... and it's also amusing, because Route 126 is found on the outskirts of Breezewood, just 8 miles to the east of Everett.

WSKE is equipped with a Wilkinson solid-state transmitter which is designed with two power settings:

1000 watts for normal daytime operation...
and 250 watts for pre-sunrise operation.

WSKE has been in operation since 15 March 1963, and was granted authority by the FCC to increase to 1000 watts using a two-tower directional array on 31 July 1979. With this power increase came the need for more space, mainly to accommodate the phasing equipment necessary for our directional signal. So, we moved approximately 100 feet to the north of our old building and put up a new modular unit designed by the WSKE management.

It was good to hear from you, especially the part on your monitoring of the test from WCHE. At the time you were tuned in, and noted the identifications, that was none other than myself on the air checking out the studio equipment to make sure that everything was in working order there. I was very surprised at the results from this test, with reports being received from Chapel Hill and Rocky Mount, NC, Tampa, Fla., plus receiving phone calls from RI, MASS (ERC at Cape Cod) and Mike Heppie in Houston, MISS. In all, a very rewarding test.





Thank you for your reception report of radio station WKRZ-AM on the morning of January 26, 1982. Your data does indeed coincide with the program log kept by our announcer on this particular morning. Therefore, I am confirming your reception of WKRZ-AM from 9:57 AM to 10:59 AM EST, 1/26/82.

Our AM facilities include one RCA BTA-1R, 1950's vintage (main) transmitter, one RCA BTA-1S, 1972 (standby) transmitter; we use a Dorrough Electronics DAP-310 audio processor to assure maximum negative and positive modulation. The antenna system consists of a 200 foot self-supporting tower with base insulators at 20 feet above the ground and 180, 180 foot copper radials burried about one foot in the soil as the ground system. We realized a 20 millivolt increase in A contour signal level as the result of the installation of a new tuning unit at the base of the tower and recalculation of the antenna resistance in November of 1981.

This is to verify your report of reception of Radio Station WBVP on August 10th.


Station WBVP is located in Western Pennsylvania, just north of the junction of the Ohio and Beaver rivers.






