

THE RF STAGE DRIVING THE 40 WATT MODULATED AMPLIFIER IS ALSO COLLECTOR MODULATED TO IMPROVE LINEARITY. THE TRANSMITTER USES ONLY TWO TUBES OF A SINGLE TYPE AND ARE ARRANGED IN A HIGH EFFICIENCY LINEAR AMPLIFIER CIRCUIT IN WHICH ONE TUBE, CALLED THE CARRIER AMPLIFIER, SUPPLIES ESSENTIALLY ALL OF THE TRANSMITTER OUTPUT POWER IN THE ABSENCE OF MODULATION. AS MODULATION IS APPLIED, THE OTHER TUBE, CALLED THE PEAK AMPLIFIER, BEGINS TO CONTRIBUTE POWER UNTIL AT 100% MODULATION, EACH TUBE IS SUPPLYING ONE-HALF THE PEAK POWER OUTPUT OF THE TRANSMITTER.

WE OPERATE AS A DA-2, REGIONAL AM BROADCASTING STATION UTILIZING SIX TOWERS, THREE DURING THE DAY AND SIX AT NIGHT.







The tone testing you heard was from WDOG between 1:52 and 1:54 am on that Monday,




My Dear Mr. Geary:

All of us here at WGCA were very pleased to hear, from you. And I must say your equipment must really be superlative. I'm sure that you really enjoy your hobby. We here at WGCA really do enjoy radio, too.

WDAB-AM broadcasts daytime on 1580 khz utilizing a Continental Electronics 315R-1 AM transmitter which has been in service at the station since 1986. Our signal is non-directional and originates from studios in Travelers Rest, South Carolina which is an adjoining community to Greenville, South Carolina. We are authorized for 5,000 watts during the daytime but you are correct in your assumption that the reason you lost the signal at 6:30 pm was because of our reduction in power to 1,000 watts due to sunset in the Eastern Time Zone. Our tower is 252' tall and is located adjacent to the studio.

WDAB began broadcasting almost 30 years ago as WBBR-AM. My associate and I acquired the station in May of 1993 and changed the call letters to WDAB (*Dabney-Adamson Broadcasting*). We are an "All News" station featuring the CNN Headline News format. On weekends we carry some sports and cultural programming in addition to the news broadcasts. We hope to begin our own local news production before the end of 1994.

Greenville, South Carolina is located in the eastern foothills of the Great Smoky Mountains approximately 130 miles NE of Atlanta, Georgia and 100 miles SW of Charlotte, North Carolina. We are less than one hour from the mountains and about three hours distant from the Atlantic coast... a great place to live!

We are located in the Northwest corner of South Carolina. We are about 150 miles ENE of Atlanta, Georgia, and about a hundred miles east of Charlotte, N.C..

We operate on an assigned frequency of 1440 kilohertz AM, with a directional pattern at night. We run 5000 watts both day and night. At night, we have a 4 tower directional array beaming our signal in a south easterly direction.
