

# Whether you play music or talk — September II changed your station

NITED WE STAND.

This is no short-term shift — we've just begun a national

dialogue about religion (especially Islam), race/national origin, and war that will last for months — even on a music station. For example: Suddenly Dr. Laura breaks format to bring on a respected Muslim leader to take phone calls. And meanwhile, Laura's getting bumped

that's evident all over the dial: Patriotism is back, big-time. Lee Greenwood's "God Bless The USA" is getting airplay on ACs and CHRs as well as country stations. And everybody's giving away flags.

# After September II, Radio glimpses its potential

Not only have radio stations — and especially the big consolidated groups — cajoled listeners to raise tens of millions of dollars for the Red Cross, the Twin Towers Fund and other disaster-related charities. They've been especially creative in doing it. M Street has seen plenty of fresh ideas, from Ebay auctions of unused station giveaways (see JacobsMedia.com), to "Bribe us to play your requests" weekends, to multi-

station morning show remotes at malls. The Clear Channel fund alone has raised over \$9M, and Infinity, Emmis, Cox, Greater Media and Entercom are just some of the groups who have speedily assembled fundraisers. In Norfolk, Entercom GM Eric Mastel was tired of the negativity about the economy, postattack, and he put an extra \$100 in the paychecks of 80 employees, as long as they agreed to spend the money in local

stores (great publicity for the stations, too). Another get-the-economy-going promotion sprouted in Philadelphia, where WMMR jock Razz is flying to 10 different cities in two weeks to get Americans back on airliners. Radio mostly did a solid job with the news in the days immediately after September II. Now it's flexing its muscles to do some good works — an ability some stations had forgotten they possess.



# WASHINGTON THIS WEEK

Bush may try to make some political points with his final FCC nominee.

Both the Hispanic Congressional Caucus and the Congressional Black Caucus are boosting their own candidates for the fifth Commissioner's chair. Bush and the Republican Party have been courting Hispanics, and they could make another move in that direction by nominating somebody like Joe Garcia. After all – departed Commissioner Tristani repeatedly identified herself as an Hispanic-American, and some people would look on a Hispanic replacement as a way of "keeping the seat." Garcia's the executive director of the traditionally powerful Cuban-American National Foundation. Meanwhile M Street hears the Congressional Black Caucus is interested in Julie Rones, currently Senior Counsel at the U.S. Telecom Association, and a seasoned D.C. attorney.



### Bush appoints VOA host Robert Reilly as Director.

Reilly was an advisor to the Reagan White House and began doing a weekly foreign policy talkshow for Voice of America in 1990. Now — he'll run the joint.

VOA has absorbed criticism from the right for its insistence on airing an interview with the chief

Taliban mullah and failing to take advantage of the situation in Afghanistan. VOA has been running VOICE OF AMERICA without a permanent director



since Sanford Ungar left on June 29 to become president of Goucher College.

#### Andy Levin may still be the leading candidate for Tristani's old seat.

The longtime telecom policy specialist for House leader John Dingell continues to rack up support, with influential Dems like House Speaker Dick Gephardt and Massachusetts Representative Ed Markey behind Levin. He's even got some big-name Republicans on his side, including Billy Tauzin (R-LA) and Fred Upton (R-MI). Another dark-horse name is floating around, with the backing of Montana Senator Conrad Burns: Montana Public Service

Commissioner Bob Rowe. (There's also the consideration of balancing the Commission, geographically.) That fifth seat — the second and final Democratic seat - may not make a lot of difference on a 3-2 Republican Commission. But we're sure that lone Descrat Mike Copps would enjoy having a little commany on the 8th floor. And this is not shaping up to be a partisan Commission not yet.

## Cross-ownership reform may be the only thing the NAB and the newspaper publishers have agreed on in years.

Both industry associations want the vintage rule dumped in the recycle bin for good. We now know that comments on the Notice of Proposed Rulemaking adopted September 13 are due by December 3 (and we expect the NAB to wait until the last day to file, as usual). Reply comments are due January 7, 2002. Powerful groups in both broadcasting and newspaper publishing strongly want restrictions removed - but we've seen little agreement about the impact, if the 26-year-old rule is clipped. Some think newspaper publishers will be more aggressive, while others think big broadcasters will move in on newspapers. The most logical combinations would be newspapers and TV given the operating economies from combining at least some newsroom functions. M Street continues to believe there are some small-market newspaper operators waiting to pounce on local radio.

National Religious Broadcasters chooses Northwestern Radio's Wayne Pederson as its new President/COO.



The board unanimously chose Pederson to replace longtime

association executive Dr. Brandt Gustavson, who died of cancer in May. Pederson will start working with the NRB on a part-time basis, then move from St. Paul to Manassas, VA to fully assume the reins by January I. He's been overseeing Northwestern College's 8-station radio group and its Skylight program service - and has been associated with Northwestern's radio efforts for 34 years.

# THE TAYLOR REPORT

Arbitron greenlights the full Philadelphiamarket test for the People Meter.

ARBITRON

The PPM gets a second good report card,

with the latest batch of ratings released from the Wilmington, DE test market, covering the mid-Summer. The PPM still shows higher AQH audiences for TV and cable (compared to Nielsen). And "equivalent" total-day AQH audiences for radio (compared to Arbitron's diary measurements). And — just as in the first batch — high daily cume for radio. But lower TSL. Radio's morning-drive and midday AQH ratings are lower with the People Meter. Evening, overnight and weekend AQH ratings are higher. This second batch of results from Wilmington includes some demographic info, for the first time. Read the report at www. Arbitron.com.

More fallout from September II: Arbitron cautions that Phase I of the Fall survey could come up a little short in diary return. There may be a "small shortfall" in the Fall survey, especially in Phase I, due to disruptions in normal calling operations and the Postal Service airmail transport, producing a smallerthan-usual number of in-tab diaries. But diary return for Summer looks good — good enough for Arbitron to say that diary in-tab sample for Summer 2001 will be normal. That leads Arbitron to announce that it's keeping to its originally-announced schedule for releasing Summer results, beginning on October 12 with New York, Los Angeles and three more markets.

The glass ceiling still exists in the GM's office.

Women now comprise more than half the radio salesforce, and nearly one-third of all sales managers — but the progress stops there. That's according to a new study based on M Street data, just released by the Most



Influential Women group. 15% of stations in the top 100 markets are managed by women, up from 13% last year. MIW and Nassau exec Joan

Gerberding says "there is still a glass ceiling in radio." And back in the programming department, "we continue to be extremely concerned that there is so little opportunity for women in programming." Read up on the study at "RadioMIW.com."

Don't forget the local United Way/United Fund.

We'll say it, because they're too darn nice to speak up for themselves. But we've heard from several local United Way/



United Fund efforts — and they're panicking because of the enormous attention paid to the Red Cross, etc. are getting after the September II attacks. They're 100% behind those efforts. But the local charities — not just United Ways and United Funds — are very afraid they're going to lose radio support at their most critical time of the year. There's also fear of "donor burn-out" — affecting all kinds of fundraising, both local and national.

The show must go on in New York City, and that includes Valerie Geller's 8th annual Producer's Workshop.

The Bayliss Foundation notes that one of the ABC reporters covering the World Trade Center story is 1992 Bayliss scholarship recipient Steffan Tubbs. (BaylissFoundation.org)

#### RIP, Dave Hicks.

The longtime station owner and former NAB Radio Board Chairman dies of cancer, just short of his 63<sup>rd</sup> birthday. For years, Dave owned CHR WKFR-FM in Battle Creek/ Kalamazoo, and he was the current licensee of rocker WRBR-FM in South Bend. Hicks passed away September 25 in Petoskey, MI.

The following items are based on recent, noteworthy ownership-transfer applications filed with the FCC. The information is based on FCC contracts filed with the Commission and made public within the last few weeks. Market and revenue information is based on data culled from Duncan's American Radio and from M Street's own databases. When known, broker notices are included. Fax releases to Tom Taylor, (609) 883-5696.

# Monterey, CA:

Mapleton Communications' third market will be Monterey, where it's buying the famous progressive country "K-Pig" and its siblings. It's a big deal for Mike Menerey and associates: they're acquiring the New Wave Broadcasting cluster that claimed nearly 15% of the market's Duncan-estimated \$21.4M in 2000 revenue. Not to mention — the world-famous Internet radio pioneer KPIG. Here's the current New Wave cluster: KPIG, Freedom, CA at 107.5 (a class A, like all of these). Dance CHR KBTU, Carmel at 101.7. Modern AC KCDU, Hollister at 93.5. Modern AC KHIP, Felton at 93.7 (simulcasting KCDU). And modern rock KMBY-FM, Gonzales at 104.3. Mapleton also inherits a joint sales agreement with J&M Broadcasting's classical KBOQ, Carmel at 95.5 MHz. Los Angeles-based Mapleton will LMA the cluster before closing. Brokers: Kalil's Frank Higney for seller New Wave, and Media Venture Partners for the buyer.

# Akron, OH:

Clear Channel buys WHLO (640) from Salem. Amazingly, it turns out there still are stations in Ohio that Clear Channel could acquire, and WHLO (I-kw day, 500-w night) is one of them. Price is \$4.5M, compared to the \$8M that Salem paid for both WHLO and then-WTOF-FM back in 1996. WTOF-FM, Canton (98.1) became WHK-FM, which figured as a player in the complicated three-way deal last year between Salem, Clear Channel and WCLV owner Radio Seaway. WHLO's doing religious and southern gospel for Salem. Duncan's American Radio estimates it billed \$450,000 in 2000.

# Boston, MA:

The Catholic Archbishop of Boston buys WCCM, Lawrence, MA (800) for \$1.5M. It doesn't take any divine vision to infer that WCCM will drop talk and adult standards and begin some kind of Catholic-themed programming - reportedly Spanish-language. WCCM has I-kw day and 224-w night (protecting a couple of Canadian stations at night). It does a nice job covering the north side of Boston in the daytime. Seller is local owner Pat Costa, whose Costa-Eagle keeps WHAV, Haverhill (1490) and WNNW, Salem, NH (1110). Broker: Mike Bergner.

#### Lenoir, NC:

Billy McClatchey launches his new company with three separate deals in western North Carolina. Charlotte-based McClatchey has an experienced hand on board: wife Donna, the daughter of Raleigh station owner Don Curtis. She grew up in the family business, and later did radio sales in Charlotte. McClatchey is quite literally buying all three stations licensed to Lenoir: Oldies WJRI, a I-kw fulltimer at 1340 owned by Donnie Goodale. Country WKGX, a 5-kw daytimer at 1080, owned by Rooster Bush's Furniture City Broadcasters. And country WKVS, a class A FM at 103.3 MHz, owned by Foothills Broadcasting. The principals of the FM are Wallace Respess and John Beal, and they put it on the air in 1992. Broker George Reed of Media Services Group repped the seller in the WKVS sale.

# TRANSACTION BRIEF

#### Central California:

A non-com religious FM at 106.1 in the commercial band will likely become a commercial operation as a result of this sale. La Favorita Broadcasting buys class A KCFA, Arnold, CA for \$900,000. Seller is St. Paul, MN-based Northwestern College. Buyers Nelson Gomez, Debbie Gomez and Ricardo Torres have interests in regional Mexican KBYN, Arnold (95.9), and Nelson Gomez has an interest in KNTO, Livingston, CA (95.9), which simulcasts with KBYN. Much of that programming is shared with KAFY, Bakersfield (1100), owned by the two Gomezes and Torres. Those three are also about to take over KSKD-FM, Chowchilla, CA (93.3). You might put 2 and 2 together and notice that Northwestern College is both selling this California FM and losing its head, as Wayne Pederson leaves to run the National Religious Broadcasters. We understand that Northwestern has no intention of selling its other radio properties.

#### McAllen-Brownsville TX:

Local non-profit Iglesia del Pueblo is paying \$1,050,000 for KIRT, Mission, TX at 1580. We hope the church won't mind if we make a small bet that KIRT (1-kw day, 302-w night) will undergo a conversion from regional Mexican to Spanish-language religion. Seller is Edward Gomez.

# Cheyenne, WY:

Brothers Vic Michael and Van Michael (and their wives) are buying a couple of stations, just as Vic is selling two Cheyenne FMs to American General Media for \$5.35M. Those are oldies KRRR and KRQU. Now Vic and Van team up to acquire the Cheyenne combo of oldies/sports/talk "K-Ray" KRAE at 1480 (with 1000-w day, 65 night). And modern rock "Z105" KZCY, a class A at 104.9. Seller is Tom Bauman's KRAE, Inc. Vic owns other radio real estate in Wyoming — and obviously doesn't have a non-compete with AGM.

# Statesboro, GA:

Michael Oesterle and Communications Capital Managers spend \$3.2M around Statesboro and Sylvania, GA. They're buying Sam-Mac's four-station cluster of hot AC WMCD at 100.1. News/talk WWNS at 1240 (I-kw, fulltime). And the mostly-simulcast Sylvania, GA country combo of WSYL at 1490 (I-kw, fulltime) and WZBX, a class A at 106.5. We spotted one interesting kicker in the contract: If Oesterle's able to upgrade WMCD to a CI, and then later sells it, Sam-Mac gets 25% of the net proceeds.

#### Riverside-San Bernardino, CA:

California Spanish-radio operator Abel De Luna shells out \$1.7M for contemporary Christian "Spirit FM" KAEH, Beaumont, CA at 100.9. It's a Class A facility, and the seller is RGB Communications (Barbara Brindisi).

## Santa Rosa, CA:

Abel De Luna's Moon Broadcasting pays \$1,275,000 to make "La Furia" KTOB (1490) its second station there. De Luna's currently the licensee of regional Mexican KRRS (1460). This deal adds La Furia KTOB, Petaluma, CA, a 1-kw full-timer at 1490. Seller is David Devoto's Petaluma Broadcasting.

## Jonesboro, AR:

"K-Love" cracks the Jonesboro market with the \$1.3M purchase of two FMs. The stations are KOCY, a C3 at 105.3 licensed to Hoxie, AR. And KJBR, a class A at 93.7 licensed to Marked Tree, AR. The pair is currently simulcasting classic country for seller Pollack Broadcasting. Back in July, William Pollack agreed to sell his Jonesboro-market sports KNEA (970) and oldies KKEY (95.9) to Clear Channel for \$2,050,000.

#### Flint, MI:

The fast-spreading contemporary Christian K-Love expands to Flint, first in an LMA with Jon Yinger's WGRI, Flint (88.9), followed by an eventual deal for Educational Media to buy WGRI for \$450,000. The LMA replaces WGRI's current black gospel format with the noncommercial "K-Love", now heard in more than 40 U.S. markets. Seller Jon Yinger retains a commercial station in Flint, which is religious WSNL at 600 KHz. Broker on the deal for WGRI: John Pierce.

#### Winona, MN:

Jerry Papenfuss pays \$IM to buy the only station he doesn't own in Winona. It's soft AC "Lite FM 101" KHME, which will be sold for the second time this year. Marathon sold it to Family, who's dealing it to Papenfuss. Jerry's other interests in Winona are country KAGE (1380), AC KAGE-FM, oldies/talk KWNO (1230) and country KWNO-FM, Rushford (99.3).

#### **Utah:**

Millcreek Broadcasting (Chris Devine and Bruce Buzil) pays \$2,260,000 for another FM in the Beehive State. That's KCUA, Coalville at 92.5, which has a CP to upgrade from Class A status to C3. Seller is Community Wireless-Park City, and at the moment it's simulcasting non-com KPCW, Park City, UT on KCUA — which we expect to change under Millcreek.

"After looking at several options, we decided on the VADIS platform and DC consoles from KLOTZ," says John Decker, Chief Engineer, Capstar Communications, Tucson. "Why? First, our install would be much faster since most of the plant wiring could be reduced to a simple Ethernet line and a fiber optic cable connecting each room with our rack room.

# RADIO GOES TO WAR

The war against terrorism is changing everything in radio, from the way stations open the mail very carefully - to the way they read the Summer and Fall Arbitrons ready to explain to clients why news and maybe talk stations are going through the roof. The war is also changing basic station operations: Got enough fuel for the emergency generator? Got emergency programming in case you need to evacuate the building? (Albany's WGY had to do that twice, on the same

Saturday morning.) Got instructions for staff to call 9II and the local FBI after a security threat? Stations are not only looking at the mail differently, they're also checking visitors coming in the door — and in the case of Cox Radio's WBAB/WBLI on Long Island, locking the door while authorities investigate an anthrax scare. M Street predicts heightened security at station remotes and promotions, too. But President Bush wants America to keep going about its daily business, and do it with new savviness — and that's the best prescription.

Perhaps "produce more consolidation" would be more like it: But M Street predicts you'll be seeing everybody from Mel Karmazin at Viacom/ Infinity to major newspaper publishers advancing the argument that the pain being endured by media outlets justifies further relaxation of FCC ownership rules. And further consolidation, period. Karmazin has already said that he's entitled to some relief because of the \$200M of lost revenue and extra costs that Viacom has seen since September II. We just saw one company's pain produce a major change: In Seattle, Barry Ackerley and family sold off their media empire of radio, TV and outdoor to Clear Channel for \$800M. # Cutbacks hit radio from the bottom to the top

Budget problems are forcing out top Infinity lieutenant John Gehron, who's leaving by the end of the year as Senior VP and chief programming resource. Budget cuts are doing the same to lots of weekenders, overnighters and evening jocks, as stations lock in syndicated fare or plug in the Prophet System or some other

voice-tracking technology to import programming from outside the station. It's not just people: Vendors report that some marketing campaigns have been curtailed or cancelled for the Fall Arbitron. And execs are scrutinizing travel & entertainment budgets (if they still exist) and facilities and engineering expenses. The trick is: Don't cut to


the bone, and thus endanger the longterm growth prospects. But today's mostly public companies don't have much leeway. One other very prominent top-level change: Sirius Satellite Radio founder David Margolese is out, the victim of delays in the consumer launch and a sagging stock price.

# WASHINGTON THIS WEEK

Yet another fight over EEO: 33 civil rights groups petition the Supreme Court to bring it back.

The ACLU, NAACP, NOW, the Urban League, Rainbow/PUSH Coalition, and the National Association of Black Owned Broadcasters are just some of the organizations asking the High Court to reinstate a portion of the FCC's EEO rules. David Honig of the Minority Media Telecommunications Council argues that the EEO policies are "universally credited with opening the electronic media to minorities and women." The courts have recently junked several versions of the rules that started in 1969 - most recently the set crafted by ex-Chairman Kennard. The civil rights coalition will try to interest the Supreme Court on three different grounds. And it says the EEO rules are about recruitment, not quotas, and therefore pass constitutional muster.

The former Mike Rice stations — now dark by FCC order — may soon return to the air under interim operators.

The FCC shows it's working on selecting interim operators for five currently-dark frequencies in Missouri and Indiana. The Commission announces that it's gotten an informal objection to an app for an interim facility at 98.3 licensed to Columbia, MO — which used to be Mike Rice's modern rock "Buzz" KFMZ. Rice no longer holds the licenses the FCC revoked (or the CPs and apps he had interests in). But he does retain the physical assets, such as transmitters, towers, studios, etc. An interim operator could buy or lease those from Rice - or could build its own. The interim operator situation is important in Terre Haute (home of the former WBOW, WZZQ and WBUZ) and Missouri (home of the ex-KFMZ and KBMX) - That's because M Street believes it will be years before the FCC designates new permanent operators for any of them, which must be done via auction. In his most recent filing, Mike Rice describes the FCC's treatment of his case as "persecution."

VOA, the punching bag. Conservatives especially are teeing off on the D.C.-based foreign broadcasting service that normally operates in relative peace and quiet. Not now: Critics think it hasn't been tough enough, journalistically, on the Taliban and Osama bin Laden. The Voice of America says its most important attribute is its reputation as a fair and accurate news service that isn't influenced by U.S. government policy. Its detractors hope incoming Director Robert Reilly will turn things around to their liking. And Republicans like California House member Ed Royce are calling for the creation of a new "Radio Free Afghanistan" service.

After five years, the FCC is still trying to shut down Michigan pirate Rev. Rick Strawcutter and his "Radio Free Lenawee 99.3FM."

The government's frustrated attempts show again how hard it is to deal with committed pirate operators who may not offer the FCC much leverage. Strawcutter is both a church pastor and the active mail-order seller of some very controversial videotapes, some of which advocate white supremacy and extreme positions on gun rights. Now the U.S. Attorney's office has asked District Judge Gerald Rosen to issue an injunction against Strawcutter and allow the government to confiscate equipment.

Keep your eye on Wayne Pederson, new President and COO of the National Religious Broadcasters.

He's looking to expand the NRB's ties with its younger members: "Some of them view the NRB as institutional, and we have to get them involved." And Pederson will be looking at the Internet: "It's time to enlarge the tent [in religious broadcasting] for the Internet." Pederson's also reaching out to the newest class of broadcasters: "Low Power FM will be a part of things. . . It's a reality, even though we had some concerns." The NRB could see memberships from the new LPFM licensees, many of whom are church-related. Pederson succeeds legendary leader Dr. Brandt Gustavson. After 34 years at Northwestern College in St. Paul, he's relocating to Manassas in January.

An unprecedented display of cooperation by public radio stations is raising money for WNYC-FM, New York.

The FCC just granted a waiver so that Bill Kling's idea — to piggyback onto the fundraising process at Minnesota Public Radio — could become legal. Not only that, attorney Richard Bodorff at Wiley Rein & Fielding tells M Street that the Commission is offering similar waivers to any non-commercial FM that wants to apply. We're already hearing about stations like the University of Cincinnati's classical WGUC (90.9) taking up the challenge. You need FCC permission first, and here's how to get it: drop an e-mail to Peter Doyle ("PDoyle@FCC.gov") and to Michael Wagner ("MWagner@FCC.gov"). Include Facility ID number, nature and duration of the fundraising effort, and recipient of funds raised. We think it's a terrific idea, since WNYC-FM lost its transmitting facilities on September II. It has since launched a \$4M emergency fund, and was already facing an early-2002 deadline for a \$3.3M installment payment on its license.

# THE TAYLOR REPORT

We said on page I that radio is at war - and news and news/talk stations may be the beneficiaries in the ratings. M Street's analysis of the first big-market Summer Arbitrons shows some truly startling gains for news stations in the days after the September Il attacks. All-newsers WINS and WCBS, New York, KYW, Philadelphia and similar stations are seeing some increases that may foretell a Fall survey period that looks like the Gulf War of 1990-91. Emmis Jeff Smulyan even tells analysts that advertisers may "discount" the Fall book somewhat when it hits the street in January. In the short term, interest in breaking news benefited all stations, no matter what format: Arbitron found that both cume and TSL (Time Spent Listening) rose immediately on September II, in both New York and Los Angeles. The jump was biggest for 25-54s and 35-64s. Nonnews stations held steady, while all-newsers tended to show heavier listening. Arbitron's Owen Charlebois says radio is "the medium people can turn to for news, information and a sense of community." More at "Arbitron.com."

shocking revelation that he's battling severe deafness. Before his disclosure, managers had been complaining to us

that "Rush sounds different." And he did — but not because he had nodes on his vocal cords or there was some oddball processing in the audio chain. Now that Rush has come clean, he sounds like "the old Rush" — and he sounds just as sarcastic as ever, ridiculing favorite "liberal" targets like Rosie O'Donnell for cancelling shows because of the anthrax scare. Rush may be on an uncertain journey as he seeks

medical (and perhaps surgical) treatment of his Auto-immune Inner Ear Disease. But we believe strongly that his fans will be cheering all the way (even if he can't hear them). And he intends to continue broadcasting: "The word 'retire' is not in my vocabulary."

Country radio should benefit from the new patriotism. It's not just that Lee Greenwood's "God Bless The USA" is flying out of stores that ordinarily sell rock and rap. Part of the appeal may be the desire to return to bedrock values — something many Americans associate with country music. Billboard/Airplay Monitor Country Editor Phyllis Stark notes another reason why country may prosper this Fall: "Country traditionally does better when the economy's down."

Crystal Awards voters are going to have the toughest time ever —



because radio continues to innovate when it comes to the September II attacks and the war on terrorism. We're impressed with the spontaneous idea that swept everybody in Milwaukee radio in just a few days, and sent morning shows from 15 different stations to New York. Stations owned by Clear Channel, Entercom, Journal, Milwaukee Radio Alliance and Saga all sent their staffs into the air, thanks to a quickly-arranged deal with Midwest Express Airlines. Meanwhile, almost every radio group has established its own relief fund for victims in New York and Washington and they're keeping up the effort. Makes you proud, doesn't it? RAB's Gary Fries: Top radio execs "must return to the front lines" and lead the sales effort. Last month in New Orleans Fries was chastising the industry for its "deer in the headlights" reaction to the advertising slowdown. Now he's issued an "Open Letter to the Radio Industry" and challenging the very top leadership of radio groups to get back into the trenches and lead. That's because Fries says many radio salespeople are "emotionally bruised and reluctant to conduct business aggressively with customers and prospects." Therefore "Let's make a commitment to stop lamenting about how business is and start doing what needs to be done. . . It's time for leaders to start leading, and it's time for all of us to get moving." Full text at www.RAB.com. The RAB's also trying to craft the agenda for its 2002 conference at Disney's Coronado Springs Resort in Orlando to meet the needs of a country - and a sales effort - at war.

The Dallas Cowboys may be struggling, but the Dallas-Ft. Worth market has no trouble pushing Philadelphia out of the #5 slot in the new Arbitron rankings. That's the highest-profile change in the newly-issued rankings by population — based on new data from Census 2000. Elsewhere: Washington, D.C. rises from #9 to #7. Detroit falls from #7 to #10. Minneapolis (now #16) and San Diego (down to #17) trade places. More — including new updates for black and Hispanic population changes — at "Arbitron.com."

Music Of Your Life champion Al Ham dies. Nobody had more passion than Al did for adult standards and the great artists of his format. He used to talk about playing "the music of romantic optimism." Ham died in Florida, following complications from an operation related to his cancer treatment.



The following items are based on recent, noteworthy ownership-transfer applications filed with the FCC. The information is based on FCC contracts filed with the Commission and made public within the last few weeks. Market and revenue information is based on data culled from Duncan's American Radio and from M Street's own databases. When known, broker notices are included. #### Seattle, WA:

Clear Channel finally reels in the Ackerley stations with an \$800M acquisition of the whole company. The stock deal brings CC four stations in Seattle, plus Ackerley's deal to buy KFNK. Not to mention 21 TV stations, and major outdoor portfolios in Boston, Washington State and Oregon, plus Ackerley Interactive. Seattle was by far the largest market where CC had no foothold. From Ackerley, it's acquiring urban KUBE (93.3). Rhythmic oldies KBTB, the former KJR-FM at 95.7. Sports KJR at 950. And Tacoma-licensed sports KHHO (850). There's a fifth station in Ackerley's sphere of influence, and it's modern rock KFNK, Eatonville at 104.9. Ackerley's got a Joint Sales Agreement with Bedrock, plus a purchase option. Ackerley also brings along 21 TV stations. The TV markets and stations are: Syracuse (WIXT-TV). Rochester, NY (WOKR). Utica (WUTR). Binghamton (a duopoly with WIVT and WBGH). Elmira (WETM). Watertown, NY (WWTI). Bakersfield (KGET). Fresno (KGPE). Salinas-Monterey (duopoly of KION and KCBA). Santa Maria (KCOY). Santa Barbara (KKFX). Santa Rosa (KFTY). Eureka (KVIQ). Eugene (KMTR). Coos Bay, OR (KMTZ). Roseburg, OR (KMTX). Bellingham, WA (KVOS). And Fairbanks (KTVF). Will radio stations in markets like Rochester need to be sold? That requires complicated engineering signal-overlap studies.

# Chillicothe. OH:

WKKJ has a Columbus-friendly CP, and Clear Channel is buying it from Frank Wood for \$17.5M. Clear Channel's now ready to add the station that Jacor didn't buy back in early '99, when Frank Wood acquired it through his Secret Communications - and LMA'd it to Mark Jorgenson's Concord Media. The station is "93 Country" WKKJ at 93.3 MHz. It has several future options. For sure, it's got a CP to move closer to Columbus, by dropping power from 50-kw to 18.5-kw and raising antenna height. Other possibilities include a city of license move to Ashville or Williamsport. Terms: Frank "Bo" Wood gets \$14M cash on January 2, with the rest at closing. Wood bought it in 1999 for \$6M. Clear Channel's substantial Columbus grouping includes country WCOL-FM (92.3).

# Albany, NY:

Ed Levine's Galaxy buys "Z-Country" WHTR, Corinth, NY for \$2.4million. Levine's assembling whatever he can around the Albany market, now that he's poised to close on TeleMedia's WABY/WKLI-FM. The Z-Country deal is with Vox Radio Group (Bruce Danziger and Jeff Shapiro). The trick here is that WHTR is up for a bit of a move-in: from 93.5 to 93.7 with new city of license Scotia, NY. The FCC issued a Notice of Proposed Rulemaking on April 20 about that Table of Allocation change.

### Phoenix. AZ:

Jim Hilliard buys Jack Mortenson's KXEG (1280) for \$2.3M. KXEG is currently doing both English and Spanish language religion for seller Mortenson, and the facility has 2500 watts day, 49 night. Hilliard's James Crystal Enterprises already owns in-market talker KXEM. Tolleson, AZ at 1010 KHz — which until recently was named KXEG.

### Southern Minnesota:

Jim Ingstad's back in buying mode, paying \$900,000 for KCHK-AM/FM, New Prague, MN. Ingstad's one of three Midwest-based brothers who've historically been quite active in buying and selling stations. At the moment Jim's only interest is KBGY, licensed to Faribault, MN. So this just-filed deal with Northland Radio may be the start of Jim's next growth curve. In New Prague, Ingstad's acquiring KCHK at 1350 (ethnic and classic country) and Class A KCHK-FM at 95.5 (oldies).

# South of Minneapolis, MN:

Cumulus deals away KOWO (1170), KRUE (92.1) and KQPR (96.1) to Greg Jensen. Cumulus originally got these from Jim Ingstad, and now it spins them off for \$1.9M. Jensen's Hometown Broadcasting gets country KOWO, Waseca, MN (1170/1-kw day, 60-w night). Hot AC "Star" KRUE, Waseca (92.1/class C3). Plus classic rock KQPR,

Albert Lea, MN (96.1/class A). But this is a "pass-through" deal, as you'll see in the next story —

Greg Jensen will keep one of the three Cumulus stations and hand off the other two to Main Street Broadcasting (John Linder and Lynn Ketelsen). Jensen hangs onto classic rock KQPR, Albert Lea, MN at 96.1. But says goodbye to the combo that's licensed to Waseca, MN: country KOWO at 1170, and hot AC "Star" KRUE at 92.1. Linder and Ketelson have local interests in KTOE, Mankato (1420) and KOWZ, Blooming Prairie (100.9).

#### Puerto Rico:

Radio and TV owner Pedro Roman Collazo buys WIBS, Guayama (1540), for his fifth AM on the Island. This deal's between the estate of WIBS owner Wigberto Baez Santiago, and Roman Collazo, who holds quite a collection of licenses in Puerto Rico, including WMTI, Morovis (1580), WVOZ-FM, Carolina (107.7), WAVB-TV, San Juan and WVOZ-TV, Ponce. Roman Collazo's is paying \$300,000 for the I-kw daytimer. WIBS does Spanish-language talk and standards.

# Las Vegas, NV:

David Peschau's Continental Radio Broadcasting pays \$2M for talker KRLV (1340). Don't confuse your radio Continentals: Peschau's "Continental" is not the same as the Indy-based Continental Broadcasting Group that has WEDI/WSYW. Peschau is from La Crosse, WI. One-kw fulltimer KRLV does talk and news for seller Fred Weinberg. Peschau's LLC includes Las Vegas-based Donald Brown, and Phoenix-based Serena Ventures. Broker: Terrill Fischer of Norman Fischer & Associates.

#### Northern Utah:

Chris Devine and Bruce Buzil (as "3 Point Media") buy oldies KNFL, Tremonton (104.9) from Morgan Skinner for \$1,725,000. Chicago-based Devine and Buzil are building assets around Salt Lake — and some of that activity may be to create a move-in, by controlling outlying frequencies. Morgan Skinner's KNFL is a full class C that had been doing classic hits until it re-focused to oldies. Broker is Greg Merrill of Media Services Group.

Kent Frandsen's Sun Valley Radio buys "Glant" country KGNT, Smithfield, UT (103.9) for \$775,000. The locals call this area along the Utah-Idaho border "Cache Valley" — and Sun Valley Radio has a considerable cache of stations there already. Its six current facilities are: CHR KVFX, AC "Q92" KBLQ-FM, talk/sports KVNU, "Memories 1390" standards KLGN (all licensed to Logan). Plus Idaholicensed "Kix" country KKEX, Preston, and classic rock KLZX, Weston. So country "Giant" KGNT, a class A facility, makes #7. Seller is Morgan Skinner's Legacy, and the broker is Greg Merrill of Media Services Group.

# South of Indianapolis:

It's a swap meet, as Findlay Publishing scores another Indiana FM in an exchange with Marty Pieratt. Findlay — doing business in radio as White River Broadcasting — fattens its local holdings with "Magic" AC WWWY, Columbus, IN. While Marty Pieratt picks up news/talk WNVI, North Vernon, IN (1460) from Findlay — along with \$1.2M cash in exchange for WWWY. "Magic" is a class A at 104.9 and it joins other Findlay properties like country WKKG, Columbus (101.5) and oldies WINN, North Vernon (106.1). Pieratt winds up with WNVI plus that cash.

#### Coastal SC:

The Pearce family asks the Mass Media Bureau for speedy handling of its app to buy WJZX, Port Royal, SC (99.7). Here's why: they'll lose the financial advantage of a tax-free exchange if they don't reinvest their money in a qualified broadcast investment by December 12. The Pearces' Apex Broadcasting is buying smooth jazz WJZX from Pegram Harrison's Barnacle Broadcasting, and it's one of those booming southeastern full Class C's. WJZX spills into both the Savannah and Charleston Arbitrons. Broker Don Sailors worked for seller Pegram Harrison.

#### De Ridder, LA:

Houston Pearce and Dean Pearce pay \$400,000 for adult alternative "Wave" KROK, a C3 at 92.1. Seller is Doug Stannard's West Central Broadcasting. Check how many other Louisiana stations the Pearce-owned Apex is piling up: It has attributable interests in KHLA, Lake Charles, KVEE, Lake Arthur, KJEF-FM, Jennings, and KLCL, Lake Charles.


#### Lancaster, PA:

The Association for the Blind sells "Vision" WVZN to a local Spanish religious operator. WVZN, Columbia, PA at 1580 will remain a non-commercial AM, but will change programming — from music, interviews and talk programmed for the local sight-impaired population, to Spanish-language religion. The Association for the Blind bought then-dark WNZT in May 1997. Now it will go back to relying on its closed-circuit and cable delivery. Wilson Cortez and Amelia Cortez are the principals of buyer Esfuerzo de Union Cristiana, and they're paying the association \$165,000. WVZN has 500-watts daytime, 5-watts night.

# No deal in suburban Boston (Lawrence, MA):

The Boston Archdiocese's deal to buy WCCM from Pat Costa and the Lawrence Eagle-Tribune newspaper falls through. Partly because of money ("significant financial constraints") and partly because of personnel changes at the archdiocese, the \$1.5M deal is dead. The church was planning to use WCCM, Lawrence, MA (800) to reach the area's Spanish-speaking population. WCCM is currently doing talk and standards.

# Is More Deregulation The Right Medicine?

Forget Cipro - the medicine of choice for Mel Karmazin and Lowry Mays and some other titans of radio and TV is another dose of good old-fashioned deregulation, such as they got in 1992 (with radio duopoly) and 1996 (with the Telecom Act). What's on the agenda? Viacom's Mel Karmazin wants the eight radio station local limit lifted (he tells analysts "it doesn't sound right to us"). He'd like the FCC to kill off the restrictions that limit his same-market TV-radio combinations, which are the rules that may force Clear Channel's Lowry Mays to divest some radio and/or TV stations out of the \$800M Ackerley purchase. Karmazin wants further relaxation of the TV duopoly rules, to allow Viacom to own

two of the most powerful local stations, instead of one and an also-ran. FCC Chairman Powell protests that he's not

in favor of dereg just for the sake of it but on Monday (10/29) he launched a new enterprise labeled the "Media Ownership Working Group." And the Chairman says "the current rules, standards and principles do not take any account of very dramatic changes in the media landscape." We'd say that he's very seriously pursuing deregulation.

# Newspaper-broadcast cross-ownership may be the rule Powell challenges first

The Chairman will have plenty of support when he tackles the 26-year-old prohibition on in-market combinations of daily newspapers and radio or TV properties. He's clearly laying down a written record to alter one or more ownership rules, and we believe the two

cross-ownership rules (one for radio, one for TV) will be his first target. The newspaper publishers and the NAB have both pushed hard - and philosophically, Powell probably agrees they're outmoded and don't reflect reality. As long as the Senate stays pre-occupied with the war - and anthrax is giving everybody in Washington the willies - the FCC won't get much of a fight from Democrats on Capitol Hill like Senator Fritz Hollings. Our prediction? Democratic Comm. Mike Copps votes against it, but Powell wins on cross-ownership, 3 to 1.



# WASHINGTON THIS WEEK

The abducted children's "Amber Plan" gets a big Washington rollout.

Amber Hagerman's mother turned the death of her 9-year-old daughter into something positive for other families - and the Amber Plan has just received its nationwide debut at the National Press Club. On hand were Rep. Nick Lampson, chair of the Congressional Caucus on Missing and Exploited Children, and John Walsh, host of "America's Most Wanted" and founder of the National Center for Missing and Exploited Children. M Street's written previously that some groups privately harbor misgivings about the plan, wondering if piggybacking onto the EAS plan and allowing participation by so many local police forces is the right prescription. But politically, the Amber Plan - whose name now also stands for "America's Missing: Broadcaster Emergency Response" may be impossible to resist. And it has plenty of fans.

Deregulation dead ahead, as Chairman Powell debuts the "Media Ownership Working Group."

The FCC's ownership policies got some expert scrutiny — and we met a new task force of agency heavyweights — when Chairman Powell hosted a roundtable discussion of the Commission's current media policies on October 29. Powell says the FCC's ongoing Media Ownership Working Group is the first step in developing a "solid factual and analytical foundation" for re-evaluating current regulations. "This is not going to be an academic exercise", Powell told the visiting panel of economists and academics, but a "rebuilding of the factual foundation" for the FCC's regulations. Panelists included several former FCC and DOI staff now in the private sector, as well as current representatives of the Justice Department, the Consumer Federation of America, the Wharton School, Fordham University and the University of Maryland. The FCC created a web page with detailed information on the roundtable and its panelists at: www.fcc.gov/ownership.

Short-term, Sirius and XM get new restrictions from the FCC - but may eventually get to do local origination.

The FCC tells both satellite radio services they must coordinate use of their ground-based repeaters with additional groups of spectrum users, based on complaints of potential interference. Sirius and XM already bear the burden of providing info to other

WCS band licensees. Now the FCC has laid on a requirement that Sirius and XM share info with nearby MDS (Multipoint Distribution Services) and ITFS (Instructional Television Fixed Service) operators. If there's interference to existing MDS or ITFS signals, the satellite radio folks must reduce power immediately. But long-term, XM and Sirius might get FCC permission to originate local programming. At the October 17 Kagan seminar, attorney Frank Jazzo notes that the FCC has prohibited local origination in its temporary authorization for terrestrial repeaters. But attorney Lew Paper warns "It's hard for the FCC to stand in the way of these new services developing." He suspects that long-term, satellite radio "will be authorized to do whatever they want, as long as they don't interfere with existing services."

Clear Channel wants extra time to handle divestitures from the \$800M Ackerley deal.

And M Street finds an FCC filing by the Minority Media and Telecommunications Council that supports the CC logic. Both basically argue that the ailing economy is particularly grinding on minority owners, and if the FCC wants to see some of the divested radio/TV stations wind up in the hands of minority or other non-traditional owners - it should give CC a break. The typical time limit for divestitures is 6 months, and Clear Channel's asking for 12. M Street notes that CC doesn't automatically have to spin off radio stations in markets where it's adding a TV from Ackerley. It might decide to spin off the TV outlet, instead. CC cites precedents to bolster its case for a longer temporary waiver: The FCC gave Gannett a 12month waiver when it was digesting Multimedia back in 1995. And the FCC went for an 18-month temporary waiver when CBS was doing its deal with Midwest Communications. What Clear Channel may really be hoping for is a change in the regs, so it wouldn't be forced to divest excess stations.

No mail today: The FCC changes its mailhandling rules, just like all other federal agencies.


The Commission will no longer take either handdelivered or messenger-delivered paper filings at The Portals in southwest Washington, D.C. They'll need to be directed to its Capitol Heights, MD facility. The agency says it's "looking at an alternative site

Media Strategic Research closes up shop for the second time.



That comes eight months after SMR was rescued from dire straits by a cast of "angels" that included Jimmy de Castro, David Kantor, Alfred Liggins, Jeff McClusky, Jeff Trumper and Canada's Standard Radio. Exec Amy Vokes blames a "cash flow crunch precipitated by the terrorist attacks of September II and their economic after-effects." Most of SMR's work volume had been coming from callout research. But it was counting on "significant fourth-quarter revenues" from its new "Touch Direct Marketing" subsidiary. SMR laid off virtually all of its staff and will sell off its assets.

Afraid to open the mail - but more willing to participate in research.

That's the paradoxical profile of Americans we see in several recent studies. It's clear that the anthrax scare is scaring direct mailers, and maybe Arbitron. But look at the other side of the September II crisis: A new DMR study finds listeners more willing to participate in marketing campaigns. "Accept rates" measuring the percentage of those who agree to listen to a particular station — are up 10.3% from Spring and 9.9% from a year ago. DMR's Tripp Eldredge says rock (+41.3%) and country listeners (+24.8%) are markedly more willing to "say yes." Accept rates are higher on the East and West coasts than central or midwest regions. Here's the opportunity, Eldredge says: "Stations that take the opportunity to reach out to their listeners during this time will find consumers more open."

The two strategies that really worked on September 11:

Owning the news image, and letting listeners on the air to talk. Stations like WINS and WCBS, New York that have a strong news image were clear winners in Arbitron. But another approach also worked, say consultants Valerie Geller and Randy Kabrich: Identifying

with the story on a basic human level. Kabrich points to Scott Shannon at WPLJ, who knew that "people were scared. Shannon was smart enough to cover it with news and information — but then open up the phones and let the people take control."

Minnesota public radio listeners are giving generously - to New York's WNYC.

Minnesota Public Radio obtained permission from the FCC to piggyback fundraising for WNYC-FM onto its own pledge drive --- and it finds Minnesota listeners are eager to help. MPR's Craig Curtis says "more than half of our callers are making additional gifts to WNYC, and at all levels of membership." New York needs the support: Its FM transmitter was lost in the World Trade Center disaster, and it's facing a \$3.3M payment on its license in early '02.

This is one kind of "workout" you don't want any part of.

M Street has it on good authority that one mid-sized broadcast group has been moved into the workout division of its lender. That's a situation virtually no broadcast group has faced since the early '90s. We've reported that some groups are "out of covenant." But some groups are now blowing payment terms. Bush Administration policy is to use kid gloves on basically healthy companies. But banks are penalized by the stock market if they do the usual thing and increase their loan loss reserves. One thing we know for sure: potential buyers have plenty of dry powder (at least in equity) and are hoping to pick up some bargains, if radio and TV stations are forced back onto the market.

Premiere is charging for online listening to Dr. Laura and Art Bell online, and ABC is charging for premium news content.

"DrLaura.com" says that "Dr. Laura had no voice in this decision, and she is puzzled that some want to blame her personally, or worse, accuse her of venality." Both Drlaura.com and ArtBell.com promise dramatically

before." Price for Dr. Laura.com is \$6.95 a month for access to current and archived content. Another Premiere breadwinner, Rush Limbaugh, has been moving toward subscriber-based delivery for months. Meanwhile, "subscription" is the hot concept at ABCNews.com: "Effective immediately, high bit-rate breaking news programming from ABC is now only available through RealNetworks' RealPlayer GoldPass subscription service." Cost? \$9.95 a month.

Time to experiment with potential new formats.

We'd like to pass on the words of Bonneville group head Bruce Reese, at the October 17 Kagan Radio Summit: "We haven't done a lot of programming moves as a result of consolidation. We should very carefully, smartly, with a business plan, take some risks in programming — especially if we're to retain the younger listener." In Chicago, it's the older male listener that Bonneville is after with the new low-key "Drive" format - which is also pulling women.



The following items are based on recent, noteworthy ownership-transfer applications filed with the FCC. The information is based on FCC contracts filed with the Commission and made public within the last few weeks. Market and revenue information is based on data culled from Duncan's American Radio and from M Street's own databases. When known, broker notices are included. ### Fresno. CA:

Hispanic Broadcasting finally cracks the Fresno market by purchasing move-in KAJZ from Ed Hoyt for \$5M – or maybe eventually \$5.5M. Fresno is a vibrant Hispanic market, and that's the potential that Hispanic Broadcasting sees - though Entravision, Lotus, Rak, Radio Unica and even Infinity are already busy doing Spanish-language formats there now. KAJZ is poised to move in from Merced, relicensing to North Fork, and moving up the dial from 107.7 to 107.9 MHz. In separate deal Hoyt sold his other three Merced stations to Mapleton for \$4.3M: "Oldies 97.5" KABX-FM, news/talk KYOS at 1480, and AC "Big 106" KIBG. As for KAJZ — we expect its smooth jazz to vanish once HBC takes over. Broker on the deal was Greg Guy of Patrick Communications.

### Willcox, AZ:

East of Tucson, Lakeshore Media -Chicago-based Chris Devine and Bruce Buzil — buys KHIL and KWCX-FM. licensed to Willcox. The FM involved is a directional Class C2 at 104.9. licensed for 730 watts, but at a tremendous height above average terrain: 3175 feet. Though the transmitter is east of Willcox (and away from Tucson). William Konopnicki's Cathy Ann Enterprises put KWCX on the air in early '99. Devine and Buzil have been savvy planners when it comes to other FMs, so this is one to watch. Format-wise, KWCX does soft AC as "Magic 104.9." While sister KHIL is classic country. The AM is a 1250 KHz facility licensed to Willcox, with 5-kw day, 196-w night. Price is \$1.1M, and brokers on the sale are Kalil & Co.

### Flagstaff, AZ:

Flagstaff-Prescott is now an Arbitronrated market (#157), and Ed Seeger's group pays \$3,875,000 for KVNA-AM/ FM there. We've noticed that Seeger's name is often linked to intricate move-in schemes — so keep an eye on what happens to KVNA-FM. It's a big Class C at 97.5 MHz, currently doing AC as "Sunny", and the current owner — Grant Hafley's Yavapai Broadcasting — has had it for less than a year. He acquired KVNA-AM/FM along with rocker KZGL. Cottonwood from Regent when it motored away from Flagstaff. It appears that Hafley's making a tidy profit on the resale — and he's keeping KZGL, to boot. In the general area, Hafley's Yavapai also holds country KVRD, oldies "Cloud" KKLD, and standards KYBC, Cottonwood. But let's get back to the buying group: Ed Seeger, James Fort and Andrew Guest are the principals of Arizona Radio Partners, LLC. Brokers on the deal are American Media Services and Tucsonbased Kalil & Co.

### Elizabethtown, KY:

FM talker WULF, Hardinsburg (94.3) sells for \$1,150,000. Buyer of "Powertalk" is Skytower Communications-94.3, LLC, coowned by Bill Evans and Marilyn Evans. For the Evanses, WULF represents a double-up for their hot AC "Quixie" WQXE in Elizabethtown. They're also involved with country WGGC, Glasgow, KY, down near Bowling Green. This latest purchase is WULF, a C3 at 94.3. Seller Terry Forcht does business as Key Broadcasting, and he's still got 18 stations in Kentucky, Illinois and Indiana, including country WACF in the Terre Haute market. Broker on the \$1.150,000 sale of WULF: Ed Henson of Louisville-based Henson Media.

in Washington, D.C. to accept delivery of filings on a more permanent basis." Meanwhile, for plain old mail, keep using the Portals mailing address for the FCC but better still, do your filing electronically. The Commission still wants documents sent via the Postal Service or overnight delivery (FedEx, UPS, etc.) to be addressed to the Portals at 445 12th Street, SW. But they won't be opened there. The FCC will transport them to Capitol Heights. The Public Notice (DA 01-2436) supersedes rules permitting the hand filing of documents at the Portals.

Stations get a temporary 60-day break from the Public File rule because of anthrax worries and mail-handling concerns at stations.

Mailed-in comments and suggestions are supposed to be placed in the station's Public File — and you can bet that an unannounced inspection by an FCC field agent will include a request to see the Public File. But the FCC buys the NAB's argument that these are extraordinary circumstances, given FBI warnings about mail. And it grants a 60day waiver so as to "minimize any public health risk to station personnel."

### Doubtful the FCC will change its controversial local-market definition.

There's just very little interest in modifying the rules that many experts have called illogical. Kagan seminar speaker Lew Paper says "the DOJ has always regarded the FCC market definitions as idiotic." But there's no hue and cry about changing the "cockamamie way" the FCC uses two different definitions, at different points in the process of determining how many stations can be owned. Attorney Paper says "the train has left the station" on localmarket definition, and "it's inconceivable they'd go back. The FCC is a day late and a dollar short." ■

### TRANSACTION BRIEF

### Green Bay, WI:

Cumulus converts its multi-year LMA of WDUZ/WQLH to a buy. Looks like Lew Dickey and Bill Laird hit one of the "windows" in their long-term LMA, and Laird took advantage of his "put" option to require Cumulus to buy the combo for \$7M. Stations are sports "Fan" WDUZ. a one-kilowatt fulltimer at 1400 KHz. And hot AC "Star 98" WQLH, a class CI at 98.5. The sizable Cumulus-owned cluster already contains stations such as regional "Fox" rocker WXWX/WWWX. But the overwhelming radio presence in the hometown of the Packers and Lambeau Field is Midwest Communications. Duncan's American Radio estimates that Midwest pocketed 55% of the market's 2000 radio revenue of \$15.2M.

### Sterling, CO:

Northeast of Denver, Phil Adams deals newly-upgraded AC KPMX, Sterling for \$695,000. Phil's "Adams Entertainment Group" has owned KPMX for over a decade — but that's about to change. Something that's already changed is the KPMX technical facility: It recently upgraded from a class A at 105.5 to a C3 that's up the dial one notch, at 105.7. Phil Adams sells standalone KPMX to JMS Broadcasting, which will LMA it before closing. The three principals of

JMS are equal one-third partners: Alexander Creighton, Kevin Shaffer and Ross Miller.

### Charleston, SC:

The taxman is at the door for the Pearce family, so their Apex Broadcasting buys modern rocker WAVF, Hanahan, SC for \$6M. Seller is the group formerly known as Emerald City Radio Partners, and the station is WAVF, a Cl at 96.1. We say "the taxman's at the door" because Houston Pearce and Dean Pearce have a December 12 deadline to reinvest proceeds of a previous sale — or lose significant tax benefits. The Pearces' Apex recently agreed to buy Florence and Charleston-area country WHLZ, Manning, SC from Cumulus, and Savannah and Charleston-area smooth jazz WJZX, Port Royal from Pegram Harrison. Kalil brokered this most recent transaction, for WAVE.

### Downstate Illinois:

Bud Walters expands with three stations from Roger Coleman and Steve Samet. After a full 50 year career in broadcasting, and a stint serving on the NAB Radio Board, Roger Coleman is retiring. His partner in seller Discovery Group LLC is Steve Samet — who's currently serving on the NAB Board as

the rep from Illinois. Samet still owns three Illinois stations east of the Quad Cities, including WZOE-AM/FM. The real estate involved in this deal is the area where Interstates 70 and 57 intersect, around Effingham, IL. Bud Walters — another familiar face in the NAB Boardroom — is paying \$2,375,000 for Discovery Group's three properties. Those are talker WCRA, Effingham, a I-kw daytimer at 1090. Country WCRC, Effingham, a class B at 95.7. And AC WCBH, Casey, a BI at 104.3. Walters is the principal of the Cromwell Group.

### Superior, NE:

On the Nebraska-Kansas border, Cory Kopsa buys the country combo of KRFS-AM/FM. Kopsa owns no other stations at the moment, but sellers Herbert Hoeflicker and Ruby Hoeflicker do. Together, they own country KDNS, Downs, KS, and Ruby owns 100% of the stock of oldies "Z96.3" KZDY, Cawker City, KS. But they're selling the simulcast of Superior-licensed KRFS, with 500 watts day, 44 night, at 1600 KHz. Along with class A KRFS-FM at 103.9. Buyer Cory Kopsa pays \$130,000 plus another \$20,000 in a consultants' fee to the Hoeflickers.

"After looking at several options, we decided on the VADIS platform and DC consoles from KLOTZ," says John Decker, Chief Engineer, Capstar Communications, Tucson. "Why? First, our install would be much faster since most of the plant wiring could be reduced to a simple Ethernet line and a fiber optic cable connecting each room with our rack room.
