"Greetings,

# NWVRS Archives

Several items were donated to the Archives recently. Bob Campbell donated two books: *This and That* by Art Kirkham (a program Art started on KOIN in 1932) and *The World and Other Strangers* by John Salisbury from his daily newscasts on KXL in 1970. Bob also found a record by Jane Powell from 1949 entitled *Romance*. Jane, who was originally known as Suzanne Burce, began singing on KOIN at the age of seven in 1936. In the early 1940s, the Burce family moved to Hollywood and Jane became a radio star, then she went on to the silver screen where she met fame and fortune.

We received three issues of Radio Amateur Magazine from January, March and April 1920. They are labeled Volume 2, Numbers 3, 5 and 6. We also received programs for the following: the Oregon Amateur Radio Association's 9th Annual Convention in Salem, Oregon in 1940 and the 14th Annual Convention of the Northwestern Division of the Amateur Radio Relay League in Yakima, Washington in 1939.

We received two Antique Wireless Association Monograph reprints: *The Federal Telegraph Company 1909-1920* and *A Technological Survey of Broadcasting's "Pre-History" 1876-1920*. In addition, we received a diagram of *A Modern Amateur Wireless Station* originally printed in the *Supplement to Modern Electronics* from Sept. 1912. Thanks for all your contributions.



# Play It Again, Sam!

Panasonic RF-1110E: Part II of II



At this point I have to put in a word for my test equipment. My distortion meter is the fully automatic Hewlett-Packard 339B, a huge convenience over the all-manual 332A and merely auto-nulling 334A predecessors. You can pretty much set it and forget it.

Although the HP 8640B is a fine FM generator, alone it can't deviate more than 80kHz at 10.7MHz. Mating it to the 11710B Down-Converter blows this limit apart, because all modulation is retained at the lower frequency output. Since the 8640B's max deviation goes up with frequency, at the 11710B's input (60.7MHz) there's plenty to sweep with.



One clever thing about the 11710B that wasn't in the 11710A or in the discrete technique it replaced (involving a 608 VHF generator and a mixer) is the timebase output. When the 8640B gets its master clock from the converter, the converter output frequency is as accurate as the converter's crystal, even though the output is the difference between two frequencies that may differ by as little as 10kHz, because there aren't two different crystals with imperfectly-cancelled error. I went through the math once and it made my head hurt, but it was beautiful just the same.

The RF alignment was straightforward, with antenna and oscillator coils to adjust at the low end and trimmers to adjust at the high end. This got me an FM alignment that's better than new. I can understand Panasonic not using the technique because it's slow. Still I'm proud to have the best RF-1110 in the world. I discovered a station I had not been aware of before, KQSO at 102.9, a one-watt rig in Newburg operated by radio amateurs. They play a lot of 1950s pre-rock vocals, which had Diane out of her chair doing interpretive dance accompaniment!

I tuned up longwave and mediumwave with no complications. The antenna is itself the adjustable low-frequency element on radios using a ferrite bar - you heat it and slide the coil up and down -, but this one tracked 600kHz spot-on with no changes.

Then I turned my attention to shortwave, and discovered that it was dead wrong, maybe straight from the factory. It appears that this model has a design deficit. It's impossible to get the oscillator high enough to track the dial at 18MHz; with the trimmer at absolute minimum, the pointer still has to be positioned a couple hundred kilohertz high. (On the other hand, the middle frequencies all read low, so maybe like the Philco 48-461, the trouble is in the dial markings.) It was clear that some harried final-assembly tech simply plopped the pointer onto 18.0 and twiddled until he got signal. Unbeknownst to him, he had tuned the set to the image, with the oscillator running below the signal instead of above it. Meanwhile, down at 6MHz there's plenty of adjustment range, and he got it right. In the middle... chaos.

I readjusted the trimmer to minimum, and took the dial to be "as good as it's going to be". It's not really bad, it's just not perfect.

Finally, I had my fill of the scratchy bandswitch and gave it a shot of GC Contact Cleaner With PolyPhenyl Ether, which is supposed to lubricate the contacts besides just cleaning them. It's good, but there was a side effect. When I turned the radio back on, the FM was two megahertz off! I got a grip on myself and waited. The next day it was only 1MHz off. I expect it to be back to normal in a week. AM was not affected.

With these modifications and adjustments, this is a darn good radio. For only having a two-gang tuning cap (that is, two for AM, two for FM), it's unusually sensitive and selective, and its sound quality is excellent. It might even bump my Superadio II off the nightstand. I smell a "comeback challenge" in the future!

# K7OVF: Oregon's Very Finest

Herbert W. Cook Jr. began transmitting in 1932 when he used an old Fada Neutrodyne receiver as a transmitter at the Cook family home on 9639 North Smith Street in the north Portland community of St. Johns. It was easy as this young experimenter discovered to bypass the neutralizing capacitors to eliminate any neutralization effect, connect a microphone between the grid and ground of the first tube of the audio stage, turn up the gain to the point the set starts oscillating, and tune to a clear broadcast frequency to begin broadcasting by talking into the microphone to the neighbors.

His later audience was to yell at the Portland Police radio cars as they drove by his parent's house. Great fun for young men in their late teens as my father Arthur Wilfred Redman related many years later. Listening to the Cook station was almost as exciting as quietly rapping on the speakeasy door to buy beer and wine from the local German brew master during prohibition.

Portland Police were equipped with radio receivers in April 1932 to receive police calls on 2.42 MHz; the first frequency of KGPP that stood for Government Portland Police. There were no transmitters in the police cars and all communication was one way. When the police needed to communicate to the central precinct, they would drive to the nearest police telephone box to place a call.

It was doubtful whether the Portland police ever heard Herb Cook because neither the FCC nor police ever showed up at the Cook household due to the low power and limited range of the adapted Fada transmitter. My father who lived five houses to the north at 9029 North St. Johns Avenue heard Herb, as the family called him, over their favorite radio; an Apex brand with a built-in short wave converter. Another early 1930's radio experience my father recalled was the achievement of tuning on forty meters for the first time and hearing Sparks, Nevada.

Herb served aboard a ship during World War II in the Pacific and spent time in Occupied Japan. In the late 1950s he became a legal broadcaster and received his amateur license K7OVF dubbing his station "Oregon's Very Finest." He also had a mobile transmitter in his 1959 Cadillac Coupe Deville where he drove my father and me to the old Portland Airport on Marine Drive to watch the planes and describe the NW Vintage Radio Society Call Letter

Vancouver, Washington Fourth of July fireworks over the radio. He was a Collins man considering them the best manufacturers of both receivers and transmitters.

Mr. Cook retired from various factory jobs in North Portland and moved to Arizona in the late 1980s. Both the original Cook residence on N. Smith Street and my grandparent's home on St. Johns Avenue have been razed and replaced with new houses. Herb Cook returned to Portland becoming a silent key in 1996.

### Word For Word

A Sample Question and Answers for Radio Operator License Examination Guide was reprinted in National Radio News Apr-May edition 1944. This was for the commercial radio operators test. Must read the entire answer to appreciate!

Sample question (2-334) Explain what technique you would employ in giving assistance to a person who was in contact with high voltage.

*Ans.* Turn off the current if possible-free the victim from contact with the high voltage as quickly as possible, protecting yourself while doing so. Then stretch out the victim on the floor or ground in a position permitting adequate ventilation. Quickly feel with your finger in his mouth and remove any foreign bodies, that is tobacco, false teeth, etc. Pull out his tongue so that it does not interfere with breathing.

If the jaws are locked tight, do not waste time trying to force them open-the important thing is to commence artificial respiration as quickly as possible, being sure that there is no tight –fitting clothing about the victim's neck, chest and waist.

Send for a doctor as quickly as possible, but by all means continue artificial respiration without interruption until natural breathing is restored or until a physician arrives. In any event, continue for at least four hours or until rigor mortis sets in.


