
From The Bench of WRNO

Gas Gate Tubes

Inflated Tube Count or a Classic Example of a Solution in Search of a Problem

Every once in a while a radio magically walks across our bench whose circuit defies all logic. Introducing the Airline 14BR-735 seven tube two-band built by Belmont Radio Corp (BR) Chicago in 1941. Notice the 6T7G between the I.F. and first audio with its grid to ground, its plate and cathode joined together and tied to the cathode of the 12SQ7. Does this make sense or just a clever way to *inflate* the tube count?



Think of it as nothing more than a diode with its grounded grid acting like a diode's cathode. This diode going from the AVC line to ground will now conduct when an AVC controlled tube grid turns positive. Something we don't typically see. Without the gas gate, a gassy tube will drive other AVC controlled grids positive. The increased current may go critical, damaging tubes and power transformers along the way. Crosley and Philco both used the 6H6 tube for gas gates even if not labeled as such.

Many times we see tube testers go off scale showing tubes *better* than new spec. Actually, this could just be a gassy tube showing increased current, and therefore *always* to be eyed with suspicion.

So, until next time from the *Wednesday Radio Night-Out Bench* and for truth, justice and the American way, keeping tube counts honest everywhere!

The Board of the NWVRS was called to order by President Mark Moore at the Elmer's Restaurant at 9660 SE Stark St. at 6:30 pm. The minutes of the June 6, 2012 meeting as printed in the *Call Letter* were approved.

Financial Report

Ed Tompkins reported the bank signature cards are progressing with his plan to go by the bank tomorrow and drop them off. Ed will be able to sign checks and documents for the club.

Club Correspondence and Promotions

James contacted RadioDaze and asked if we could link our club. The response is yet to come. Mark suggested we place their link and other appropriate links on our website.

Website

Mark reported that he and Pat Kagi got together to update the club website. Pat had added some large photos that made the website unstable so he made the photos smaller which made them more compatible with most people's computers and adjusted the spacing. Mark saved the

photos of old swap meets back to 2000 in a PDF format before the old website was discontinued and Mark and Pat got them posted on our new website. Mark will delete some of the old links, and Pat will have some new stuff to add.

Mark also reported that we need to purchase a thumb drive for backups and when the website grows, we will need to invest in an external hard drive

Swap Sales/Advertising

Several members suggested that Mother's Day may be affecting attendance at our May radio sale. Mark suggested moving the sale to April, and this would make our swap and sales events every six months. Dick and Liles normally handle the advertising so we'll enlist their help to get the word out. Most of the tables for October's sale have already been paid for.

Special Audit

We discussed our options for conducting an audit of our financial records. We could pay an outside accountant several hundred dollars or we could ask several of our members to do one. The audit committee should be made up of individuals who do not write the checks or submit periodic expenditure requests. Ed indicated that most audits contain a sampling of transactions that are scrutinized, i.e., one month sampling of the checking account. Ed can instruct folks on what to do. Then we would expect them to look for any unusual transactions. Ed estimated it would involve a couple of hours work. It was suggested that a past officer be appointed. Several capable members were suggested.

Membership

Foreign memberships have cost the club money due the conversion of Canadian funds into U.S. funds. Mailing costs for the newsletter are higher to foreign countries as well. It was suggested that we update our membership application to include the verbiage that dues are payable in U.S. funds.

Lifetime memberships were discussed. There are many factors in determining the cost of maintaining our membership including life expectancy. For some, the figure may be lower than others. To offer this as an incentive to members of any age to prepay dues might require payment of up to \$1,000 or more. The board declined to setup a Lifetime Membership category at this time and suggested that our new Membership Chair may want to give it further study.

Rick Walton is moving to the east coast at the end of the year so we'll need a new Membership Chair. We need a volunteer to step forward to help..

Christmas Party

We expect to appoint a committee to plan the Christmas Party. We are always looking for volunteers.

Next Board Meeting

Our next board meeting will be on October 10, 2012 at 6:30 pm at Elmer's Restaurant at 9660 SE Stark St.

Mt. St. Helens: The TV Reflector

Alfred Abraham lived at 9803 N. Hudson in 1948 in the North Portland community of St. Johns. He was a television experimenter who owned a scanning disc and assorted short wave radio receivers before World War Two according to my father Arthur Wilfred Redman who lived in St. Johns for sixty-seven years. It is not known what stations Mr. Abraham received in the 1930s but Wilbur J. Jerman was broadcasting television on his experimental station W7XAO in 1930 on 2.75-2.85 MHz in Portland.

Also, Portland had the world premiere of the Farnsworth mobile television unit on September 25, 1939. This transmission and reception of television took place for two days at the tenth floor auditorium of the Meier and Frank store. More than 250 acts, including local talent KGW radio entertainers, Meier and Frank fashion models, amateurs and spectators themselves were televised.

In 1948 when Seattle station KRSC went on the air Mr. Abraham decided he wanted to watch television and he bought a television and outdoor antenna. He pointed his rooftop antenna towards the western slopes of pre-1984 Mt. St. Helens in the hope of receiving the Seattle broadcasts by receiving TV signals after they were reflected of the glacier slopes of the then 9600 foot peak. He received signals from station KRSC some 148 air miles away when the normal range for television in the 1940s was only 20 to 30 miles.

Robert A. Landsburg, the engineer in charge of the Seattle station, believed that the Federal Communications Commission monitoring station at 2310 NE 148th Avenue received the first Seattle-based television program in Portland. "Several local stores which handle television receivers have tried," Landsburg said, "but I have heard of none which had success." Of course Landsburg never heard of Alfred Abraham.

The FCC on December 19, 1948 headed by engineer in charge J.I. Skov invited Portland newspapermen to watch a television show from Seattle on their twenty-six tube receiver. Oregon Journal reporter

Rolla J. Crick described the event. "It came. We saw. It remains to be conquered. That's television in Portland. It's clear, considering."

"First a test pattern of black lines in geometric designs flashed on the 54- square inch screen. Following this, the screen showed a sign bearing the Seattle station call letters then came the show."

"It was a movie of the radio show 'Stop Me if you've heard This One.' Some of the time the various persons in the show appeared as sharp clear images on the tiny screen. Most of the time, the image was blurred with tiny white flecks of light. It appeared as one would expect a picture to look in a snowstorm."

"At times, the image would disappear altogether. At these times audio was very bad. At other times, a series of lines would paint weird geometric designs across the screen through which the characters in the radio show could barely be seen."

It was never stated whether the FCC pointed their antennas at western slopes of Mt. St. Helens. Landsburg warned the reporters not to judge television by what they could see and make allowances for interference from noises such as car ignitions. "After all," he said "we are not supposed to be able to get it. The fact we are able to receive it is remarkable."

The same could be said for Alfred Abraham who wanted to watch television in the late 1940s. Whether he was the first to receive Seattle station KRSC in Portland cannot be determined but the fact he did was remarkable.

Girl Selected For Televisor

From the Oregonian of September 25, 1939, page 5.

A "telegenic" young Vancouver, Washington woman Miss Lenore McCallum Sunday became first of the group of entertainers to be

chosen for appearance in the Farnsworth television demonstration beginning today in the tenth floor auditorium of the Meier and Frank's store.

Miss McCallum, a singer, will perform before the television camera, and her voice and image will be flashed before the public audience invited to see and hear Portland's first demonstration of the "wireless talking picture." Store officials said the occasion would be the world premiere of the Farnsworth mobile television unit.

The audience will witness transmission and reception of television, will be "televised" themselves and hear an explanatory lecture by Arthur Halloran, authority on television, store executives said in a announcing program.

Shows will be given hourly, starting at 10 am.

Note: The premiere Farnsworth mobile TV demonstration was held over for an additional day according to the September 27, 1939 Oregonian on page 8.


